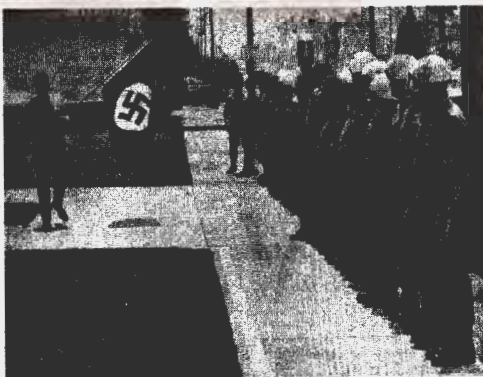
## "Operation Beachhead" — D-Day Minus 4

## Local Nazis Plan Protests Against City Policy, JDL

EL MONTE — The National Socialist White People's Party ground will hold joint rallies with the Jewish Defense League every other week unless city officials stop a policy of harassment, party leader Lt. Joseph C. Tommasi said Saturday.

Tommasi and 31 party members marched to City Hall Saturday and delivered a petition which demanded that city officials stop their policy of harassment. Police said the march passed without incident.

"We will start our rallies at city parks Sept. 23," Tommasi said, "and by the fifth rally we will have thousands of persons there."

## Deficit by Amtrak Not Huge Loss

WASHINGTON (AP) — Amtrak lost \$111 million during its first year of operation, its financial report says, but the deficit isn't as large as originally predicted.

Amtrak, the National Railroad Passenger Corp., was created a year ago to run the nation's passenger trains at a profit. But at its creation its officials predicted it would lose \$154 million in the first year.

But Amtrak's preliminary report shows that 12 months ending March 31, 1972, the actual loss on operations was \$111 million, or 72 percent of the original estimate.

5 August — Lt. Joe Tommasi reports a very successful demonstration in front of El Monte city hall on Saturday, 5 August.

Over 40 Stormtroopers accompanied Lt. Tommasi when he delivered a petition demanding that city officials cease their unwarranted and illegal attempts to force the local Party headquarters out of the El Monte community.

The language of the petition made it plain to city hall that any further legal action against the NSWPP would result in regular public rallies throughout the area, creating a situation in which things would automatically begin to happen.

The city's action against the L.A. unit stems from its close cooperation with the criminal JDL terrorist organization last January in attempting to suppress National Socialism in the area.

Interestingly enough, Jewish bagel bravado melted before the possibility of a "Nazi" reckoning in El Monte. The local offices of the criminal JDL closed suddenly in El Monte, after receiving word that area National Socialists were planning to reciprocate the kind of demonstration that the JDL, in collusion with city officials, conducted against El Monte headquarters last January.

## PRESBYTERIANS PINPOINT OBJECTIONS

# EM Church Protests Nazi's Presence Here

In a letter dated July 28, the congregation of the First Presbyterian Church, expressed strong objection to the Nazi Party Headquarters being located on Peck Road.

Copies of the letter were addressed to members of the City Council of El Monte, religious and community leaders, the press and governmental representatives.

Efforts to close down the headquarters have been fruitless since a clash between the Nazi Party members and a contingent of Jewish Defense League members in a suit in Federal District Court next week against the City Council for allegedly violating their civil rights during joint meetings with the JDL last spring—was \$121,984.

The letter is signed by the Session of the First Presbyterian Church of El Monte, which is located at 11608 Valley Boulevard. The Rev. A. Dale Rose is the pastor.

In the context of the letter, it is pointed out, We question that order, justice and community solidarity will be served by dismissing them as a few misguided extremists or by remaining silent. Thus, we write to illustrate our abhorrence at their presence, which we believe to be potentially and actually defeating to the spirit of good will and neighborliness so sought after in El Monte.

The complete text of the letter follows:

"We are writing to you because we would like to oppose the type of moral degradation we believe to be exhibited by the presence of the Nazi Party Headquarters and its attending doctrine in our community. We acknowledge that ours is a free country allowing the expression of diverse and

extremist groups. We understand the City Council had made many attempts to deal with this difficult situation involving the Nazi Party."

"We believe in the laws, constitutional processes and values which make our country exceptional. However, we do not see Nazis respecting the same values which presently provide them sanctuary. We question that order, justice and community solidarity will be served by dismissing them as a few misguided extremists or by remaining silent. Thus, we write to illustrate our abhorrence at their presence, which we believe to be potentially and actually defeating to the spirit of good will and neighborliness so sought after in El Monte. We deplore the Nazi stress upon hatred, racism and violence to achieve their distorted ends. We are perplexed that we have been caught in a situation whereby they use the cover of our community respectability for the freedom to encourage hatred and disruption in other communities."

"We wish to counter their desire to alienate people by races and ethnic differences by re-affirming our concern for brotherly love. We affirm the sense of mutual respect for all men under the creating and sustaining love of God, and we pray for a healthy integration of our community's diverse races and ethnic groups. We commend you in your constant watch over their influence and activities. We pray our protest against them will enforce your desire to persevere; so, if ever the situation should develop whereby they may be judged unlawful and destructive in

community peace and well being, you will be swift and wise in your attending the situation."

"We trust other religious bodies deplore the Nazi distortion of values and Godlessness as deeply as we do. We encourage them to re-affirm with us the word of truth over falsity and ab-

lightment over perverted racism, as clearly depicted by the signs and messages disseminating out of the Nazi Party Headquarters on Peck Road."

**Nazi Paper Seller Loses**  
EL MONTE — A man charged with selling a Nazi newspaper without a business license lost a round in Municipal Court when the judge overruled arguments opposing prosecution.  
Judge filed a writ of habeas corpus on the misdemeanor charge of selling the newspaper without a license. The charge carries a maximum penalty of six months in jail or a \$500 fine.

The demurrer stated: "In other words, the license officer may refuse a license if he does not approve the contents of a newspaper. This action has no standard and is vague, void and unconstitutional."
