Stormtroopers Picket McGovern Headquarters in Gainesville

A picket of 13 Stormtroopers picketed the McGovern presidential campaign headquarters in Gainesville, Fla., on 15 October. The demonstration, led by Eugene Hough, newly-appointed provisional state coordinator, consisted of 13 National Socialists carrying picket signs and distributing leaflets.

Some of the placards read: "McGovern: Commie Dupe," "Stamp Out Communism in America," "White Power," "McGovern + Nixon = Race Mixing Swine," and "White Is Beautiful!"

The demonstration, which had been arranged in advance with the local police, lasted for approximately an hour and a half. During the demonstration Comrade Hough was interviewed by several newspapers, and radio and TV newsmen. The activity was later reported on TV in Gainesville. The whole area has been left buzzing by the news of the open National Socialist action.

A number of people gathered — a few shaggy-looking McGovern supporters, many interested passers-by, and one irate Jew. The hebe attempted to incite several hippies who had arrived on the scene and were indulging in their usual juvenile repertoire of obscene words. Then the kike started spewing forth venomous epithets while Hough was in the middle of an interview with a newsmen.

When Hough went over to set the mealy-mouthed Maccabee straight, the Jew immediately withdrew from the scene and hid on the edge of the crowd, where he resumed his rantings. At this point, a towering Southerner who recently joined the Party went over to the Jew and challenged him. True to form, the sheenie beat a hasty retreat, leaving the air polluted with final shouts of anti-White obscenities, and kicking garbage cans over in frustration as he scampered down the street.

American Nazis Picket Gainesville McG Base

GAINESVILLE (UPI) — A group of 13 American Nazis picketed McGovern For President headquarters in this university city yesterday, and although the McGovern workers were not concerned, there was some hot debate in the street.

Some University of Florida students traded arguments with the members of the National Socialist White People's Party, including one of the men who was dressed in grey uniform and Hitler-type mustache. The others wore brown shirts and swastika armbands.

FRANK HUFF, of Tampa, identified himself as the leader of the group which was formally the American Nazi Party.

Huff said his group opposed both Democratic candidate McGovern and President Nixon because they were "Traitors." He said that McGovern, more than Nixon, "typifies the anti-white attitudes in Washington."

Hecklers shouted back at Huff when he outlined his program for sending black Americans to Africa.

"I'm not saying we should put the niggers on boats and sink the ships half way across the ocean. I suggest we pay them — pay the people a fee to go back to Africa," Huff said.

"WHO ARE YOU to tell the blacks what they should do?" one student shouted.

Huff replied, "Take that

there Vietnam money and use it to send them to Africa, that's all."

While the picket line paraded in front of the McGovern office attracting curiosity seekers he said the Nazis wanted to rid America of all "foreign traitors" and he said, "in any such operation there will of course, by definition, be many Jews, but don't worry there'll be their share of gays also."

"Gay" is a Yiddish word for gentiles.

When a reporter sampled crowd reaction to the demonstration one woman said, "I agree with what they stand for, I don't want any impurities in the white race or in my children."

Nazi's stage protest at McG headquarters

A swastika-bearing demonstration for white supremacy in America was held in front of McGovern campaign headquarters Sunday.

Thirteen brown-shirted members of the National Socialist White Peoples Party marched in a circle downtown, carrying signs reading "White Power" and handing out pamphlets condemning blacks, Jews and the present American system.

THE DEMONSTRATORS came from Gainesville, Tampa and Jacksonville.

"We are here to demonstrate disgust for the political system in this country which doesn't give the white man his deserved majority say so," said a swastika arm-banded marcher who refused to be identified.

The party believes this country has been sold out to the Jews who control the money and power in this country which is ruining the economy. Also to blame are the blacks who are termed by the party as chronic freeloaders who are on welfare.

FOCUSING ON Presidential aid Henry Kissinger (a Jew) as an example, party state coordinator and UF graduate Frank Huff said Nixon was a political puppet of the Jews. "Henry Kissinger is the real president of this country," stated Huff.

The party believes the Jews money controls politicians and Kissinger is making sellout deals with Russian communists such as the arms limitation treaty.

McGovern headquarters was picked as the demonstration site because the Democratic

residential candidate is considered the center of antiwhite attitude in America. "He is a racial mixer because he favors forced busing," said the unidentified marcher.

IF IT COMES to power, the party intends to "humanely eliminate" the Blacks, Jews and "traitors" in this country.

Instead of spending millions of dollars in Vietnam and on crime prevention "we should send the niggers over there to fight," said Huff.

Other proposals for eliminating problems are paying

blacks to go back to Africa from money saved from welfare, trial and imprisonment of America's supposed traitors who have sold out this country to the Communists and establishment of government by leaders who are pure whites.

"WE DON'T plan gas chambers or concentration camps," said Huff.

The organization founded in 1958 under the original name of American Nazi Party, claims to consist of 100 per cent pure Nordic blood. Because of their forefathers' heritage being one

of creative and cultural instincts, they feel that America should be run by race supremacy.

No candidate will be run for president this year because of a lack of support, but they believe their cause feasible.

"PEOPLE OF this country will be stimulated to our cause by activation," said Huff.

Arlington, Va. is the party headquarters for operation. Establishment of a Gainesville branch is not yet planned. "We are waiting to see which way the wind blows for support," said one marcher.

ST Pickets Gus Hall at Communist Meeting

On Sunday, 2 October, a contingent of Stormtroopers led by ST Bill Gould demonstrated against Communist Party presidential candidate Gus Hall.

Approximately 250 Blacks and old East European Jews attended the Red rally that was held for the Communist Party leader in a Los Angeles Unitarian Church. There were almost no Aryans present at Hall's meeting.

The ST passed out literature exposing the treasonous swine and were interviewed by some Russians making a film for Soviet consumption.

A carload of Mexicans who made a hit-and-run shooting attack on El Monte HQ on 30 Sept., just missing Comrade Paul Moon-ey, who was on guard, have been arraigned. A newspaper account of the incident is reproduced in full at right.

Hearing for 3 In Nazi Shot Case Slated

Three men arrested after shots were fired into the El Monte headquarters of the American Nazi party will be arraigned Oct. 30 in Pomona Superior Court.

Edward Arcega Morales, 18, of 11208 Redberry St., El Monte, Rudy Chacon Porras, 29, of 2662 Maxson Rd., El Monte, and Ruben Lugo Silva, 24, of 10817 Weaver St., South El Monte, were ordered to stand trial by Judge Edward Nitch following a preliminary hearing at El Monte Municipal Court.

They were held to answer charges of assault with a deadly weapon and assault with intent to commit murder.

The defendants were arrested after a Los Angeles high school student, a uniformed member of the Nazi party, was shot at after an argument with three men early in the morning Sept. 30.

Police said the shot from a .22 caliber rifle missed the head of Paul T. Mooney, 27, by about a foot, lodging in the front door of the headquarters at 4975 Peck Rd.

Mooney told police three men stopped at the two-story house and argued, demanding to know the type of handgun Mooney had

on his belt. They left, he said, asking if he wanted a "shoot-out."

Later, a car drove by, the horn honking, and a shot was fired.

Mooney told police he drew his gun and fired into the ground.

Police chased a car containing the suspects after it sped away with lights out. Morales was driving when the car was stopped, police said.

They said a .22 caliber rifle was thrown from the car on Ranchito Street.

Local Party Effort Stops Gregory Appearance

Dick Gregory, the notorious Black Marxist, has been denied the local school facilities in Chillicothe, Ohio, where he is scheduled to speak on 10 November.

The controversy about Gregory's appearance as a part of Ohio University's Kennedy Lecture Series was started when local Party activists publicized their opposition to his appearance. Phone calls were made to various city officials, letters were written, and Party materials were distributed widely.

Public opposition to Gregory's appearance in the school auditorium began to snowball. The result was reported in the town's liberal newspaper, the *Chillicothe Gazette*.

Controversy closes school to Dick Gregory appearance

Dick Gregory, the black performer who once amused local television viewers as a comedian, has apparently become too controversial for Chillicothe.

Gregory, who gave up entertaining for political activism and became an outspoken Vietnam war critic, is scheduled to speak here Nov. 10 as part of Ohio University's Kennedy Lecture Series.

The program had been scheduled for 8 p.m. in the Smith Junior High School auditorium. But Ohio University's Chillicothe branch withdrew from its contract with the City Board of Education for use of the facility Monday, and switched the location for the program to

OU-C's Bennett Hall auditorium.

Pressure from conservative elements in the community apparently was responsible for the change.

Jeremy Buck, chairman of OU-C's Cultural Events Committee, acknowledged the university had received objections to Gregory appearing in a public school building.

"But I'm not sure they deserve much publicity," he said.

He said OU-C contacted city school officials and offered to withdraw from their contract for the use of the auditorium, and the school officials agreed.

"I want to emphasize that Gregory's appearance, whether at Smith or here (at Bennett Hall), is entirely sponsored by

the university branch," Buck said. "The school just had a contract to rent us their auditorium."

Nicholas Alexander, superintendent of the city schools, said the school has received several telephone calls objecting to Gregory's appearance, but the schools did not request the university to withdraw from its contract for use of the Smith building.

"We had a moral and a legal obligation to let them use the building," Alexander said. He said several callers made comments about what their stand would be on the two city school tax issues to be voted on Nov. 7. If a city school building were used for Gregory's appearance, (Please turn to Page 2, Col. 2)

He said he had heard Gregory speak at Marshall University, and was offended by Gregory's attitudes and foul language.

Maxson added that he is supporting the school tax issues. "If I was not supporting them, I would not have taken this action," he asked.

The university's awareness of the controversy surrounding the program and of what such feelings could do to the school tax issues prompted university officials to ask to withdraw from the contract, Alexander said.

W. L. Mundell, president of the city Board of Education, said no real pressure was brought to bear on the school board.

At least two copies of a letter bearing the letterhead of the National White Socialist People's (American Nazi) Party have been received by city residents, attacking Gregory's appearance here, Mundell said.

He said he did not think the letter was a significant factor in the objections to Gregory's appearance.

"I personally object to that jackass even coming to Chillicothe; we don't need that type of person here."

Tommasi Speaks at College and Before LA Police

Lt. Joe Tommasi spoke before a class of Pepperdine University students on 3 October. He explained the ideals, goals, and organization of the Party. As he was exposing the Jewishness of Communism a Jew began yelling obscenities, but was silenced when Tommasi started to show the number of Red publications written and edited by Jews. Two Blacks also got uptight, yelled some obscenities, and then marched out of the classroom when the Party's repatriation programme was explained.

On Thursday, 26 October, Lt. Tommasi spoke before 75 Los Angeles County Sheriff cadets. While Tommasi was discussing the mechanics of a future National Socialist revolution, a Mexican interrupted and asked how he could prepare for our takeover. Tommasi replied that he'd better have a full tank of gas ready! When a nigger retorted that he didn't want to go to Africa, it was made clear to him that he had little choice in the matter.

Commander's Radio Program Reaches 250,000 New Listeners

The Commander's weekly 15-minute radio program, "The Future Calls," was carried for the first time on 24 October over station KPFK-FM, 90.1 mc. in Los Angeles. The station, with a 250,000 listening audience, requested a trial airing of Commander Koehl's hard-hitting radio message. It is the largest FM station in the country.

The station played the Commander's message on Rudolf Hess, the Prisoner of Peace who has been gaoled by the Allied Powers for over 30 years for his efforts to stop the conflict between England and National Socialist Germany in 1941.
