Rally Held at Gage Park and March Conducted Through Chicago's "Loop"

A White Power Rally was held in Chicago on 4 November at Gage Park, in support of the Whites there who are fighting the city's attempts to integrate their school. Gage Park is a White community on the South Side of Chicago that is now completely surrounded by Blacks.

White students and parents have been fighting the attempts by the federal and city authorities to destroy this proud Polish-Lithuanian-American community. There have been running battles between the courageous young White students and the arrogant Blacks being brought in by the cynical and corrupt Daley machine.

Despite the short notice, high winds, and freezing weather a large crowd of over 100 residents came out to hear Party speakers. The intemperate near-rain weather did not dampen the spirits of anyone attending. When local Party organizer Michael Szipronat began to speak and told the audience that the NSWPP stood for the White man and was proud it was racist the people went wild with approval.

The next speaker was Richard Biederman, Party organizer for Philadelphia and the Delaware Valley. Biederman explained to the people that their fight was proof of what the White man could do once he made up his mind and put his heart into it.

Lt. Robert Homan, the National Secretary, told the people that theirs was not an isolated struggle. They were not alone in the fight; each day more Whites like themselves were awakening and rallying under the banners of National Socialism in the great racial struggle which would determine the fate of our era.

The Commander addressed the increasingly enthusiastic audience amid shouts of "White Power!" and "More!" He made it clear to the people that they knew what the problem was: niggers! But they had to arrive at a solution. There was only one answer for them and for this country: National Socialism. America belonged to the White man, and he would fight as tenaciously for it as the White residents of Gage Park would for their neighborhood. At this the crowd roared back, "White Power!" The Commander replied, "We're ready when you are!"

After the rally, 20 Stormtroopers assembled in the Loop in downtown Chicago and began a two-mile march along the busy city streets to police headquarters, where a wreath would be laid at the foot of the Haymarket statue in memory of those White police officers killed by Black criminals. The march was also a demonstration against the recent Mau Mau slayings in the city.

The column of twos marched with American flags at front and a thirty-foot long banner which read, "Support White Police!" Commander Koehl led the column, with Lt. Homan carrying the special wreath at his side.

Although the Loop was predominantly Black, the niggers just stood in amazement at the sight of determined White men marching in their midst. A traffic cop at an intersection, as the Stormtroop column passed with the 30-foot banner, nodded approval and said a simple, "Thank you."

When the column arrived at Chicago police headquarters they were met by cameramen and an awaiting delegation of police officials. The Commander conferred with them and was told by a police captain that the marchers would not be allowed to enter the building and place the wreath at the foot of the Haymarket statue without a required special permit. The wreath was then laid outside the building, in view of the statue, by Lt. Homan.

Several TV news cameramen and reporters were visibly impressed at the complete support exhibited by local residents for everything said at the rally. The Channel 7 TV news program that evening ran a two-minute film report on the Gage Park meet, providing the Party with the greatest news coverage received in Chicago since Commander Rockwell organized the famous Cicero March there in the summer of 1966.

At a special meeting that evening, Commander Koehl swore in five new Stormtroopers. Comrade Cedric Syrdahl was appointed Group Leader by the Commander. Commander Speaks in Michigan

On Monday evening, 30 October, the Commander spoke at St. Clair Community College in Port Huron, Mich., before an audience of over 300 students.

The Commander was scheduled in a debate with Zoltan Ferency, a leader of the Human Rights Party. Ferency ran against and very nearly defeated George Romney in the state's 1968 gubernatorial election. A staunch liberal zealot for integration, social libertinism, and acquiescence in the face of Communist aggression and expansion, Ferency received his first lesson in National Socialism under the skillful tutelage of the Commander.

Commander Koehl seized upon Ferency's well-worn charge that "the corporations control the wealth of the country and therefore control America" and posed the logical question: "Who controls the corporations?" Within seconds it was apparent to the audience, if not to Ferency, just who that group was.

To Ferency's charge that National Socialism is a racist ideology, the Commander replied, "Quite naturally there's racism in America, because America belongs to the White man. He claimed this as his home. Before the White man came here, the Indians were just killing each other off."

"We are attacking the basic value system in America," he elaborated. "The system that acknowledges the dogmas of racial equality, negative individualism, and 18th century rationalism. These are the values that produced this sick society with its screwy modern art, decline of morals, and permissiveness. How can we expect these same values to provide a solution?"

While in Michigan the Commander also had the opportunity of meeting with many comrades and supporters of the movement. At a meeting held on 29 October, ST Arthur Beneker was promoted to the rank of Team Leader.

Los Angeles Unit Acquires Army Truck

The Los Angeles unit recently acquired a two and a half ton surplus Army truck, in excellent operating condition.

The vehicle, which has been repainted black with white swastika emblems, will be used in future Stormtroop activities. It will provide an impressive mode of transportation to Party events such as rallies, demonstrations, etc., and eliminate the problems entailed by use of private vehicles.

Lt. Joe Tommasi reports that since the unit has begun using the truck it has elicited a dramatic increase of interest in the Party wherever it has gone. So far, the vehicle has been used to transport ST men to counterdemonstrations against Red actress Jane Fonda and against a Communist peace march in Los Angeles.

Council head is sued over armband ban

A Federal Court suit asking for the lifting of a ban against members of a group wearing swastika armbands to Cleveland City Council meetings was filed today by the Cleveland Civil Liberties Union.

It also seeks \$10,000 damages from Council President Edmund Turk, who allegedly imposed the ban on armbands.

The suit was filed by Civil Liberties Union attorney Benjamin Sheerer in behalf of Kazimir Kalembe, head of the Cleveland chapter of the National Socialist White People's Party.

It asks Federal Court to prohibit Turk from ordering the arrest of members of the group, and to forbid Police Chief, Gerald Rademaker from carrying out the order if it is issued.

Cleveland Unit Contests Illegal Swastika Ban

Cleveland Party organizer GL Casimer Kalembe has initiated proceedings against the Cleveland City Council for imposing a ban on the wearing of the swastika during Council meetings.

GL Kalembe and other National Socialists have been attending the weekly meetings in full uniform. Details are given in the newspaper article reproduced at left from a Cleveland daily.

The Party is fighting a similar case in Miami Beach, where the Commander was arrested last August for wearing a swastika armband in violation of the Jewish city's anti-swastika statute. Commander Koehl was found guilty by the Jew judge and fined \$500 and sentenced to 90 days in jail. It is now being appealed to a higher court to challenge its constitutionality.

Christmas Campaign to Cheer Imprisoned Comrade

This Christmas, National Socialists all over the world will be celebrating with traditional Yuletide activities. But for Stormtrooper Donald Butler, it will be his second Christmas behind bars in California's Ontario Prison. Donald Butler was railroaded into jail in September of 1971 for daring to defend himself and the El Monte headquarters against a pair of drug-crazed Jews who attacked the building. New White Power Message in Philly; JDL Getting Hysterical

A new White Power telephone message has been put on the wires in Philadelphia, driving home the message of White solidarity with National Socialism to citizens there. The number of the new recording is (215) RE9-5624.

The Jewish Defense League has stepped up its frenetic campaign to get rid of the message, to no avail. Having found that the hose-nosed warriors of the JDL are no match for White men in the streets, the militant hebes have resorted to the one area in which the Chosen People excel: theft. On Nov. 2, someone broke into the home

of Party activist Charles Kress in Kensington and stole the WPM tapes and the tape deck used to broadcast them. Within days another unit was acquired, and the recording was back on the air. Several weeks later, the super-sheenies cut the wire after breaking into the suburb's main carrier cable, but this time the telephone company had the message back on within twenty-four hours. In addition, the JDL is now assured of a somewhat chilly reception the next time they go wailing to the phone company about the terrible "hate message"

Lately the full forces of the liberal establishment have been marshalled against the Philadelphia NSWPP. A Jew legislator named Josh Eilberg, in conjunction with the JDL, has sought to have the White Power message outlawed, and various "civic" and "Human Relations" groups have been getting together for gabfests, where they babble about how awful these "Nazi racists" are. Group Meets to Combat White Racist Activity

A report that a white-power group has resumed attempts to fan racial hatred in Kensington, and questions on what the community and school groups can do to combat it were discussed Thursday at a meeting of 32 leaders of community groups and school officials in Fishtown.

The meeting was called by the city's Commission on Human Relations.

Persons at the meeting said there is evidence that the National Socialist White Peoples Party also has branches at Sepviva and Cumberland sts., at an unspecified location on Kip st., and "in the vicinity of Stetson Junior High School."

Leaflets from the groups have been circulated in Jones and Stetson junior high schools, North Catholic High School and in St. Ann's parochial school, it was reported.

Boycott Petition

The group's bumper stickers have been seen throughout Kensington and on the door of the Hackett Elementary School, the meeting was told.

Recently officials of the Jewish Defense League have complained to the Human Relations Commission about a recorded telephone message attributed to the group that slurs blacks and Jews, a spokesman for the commission, said.

Mrs. Marion L. Steet, principal of Penn Treaty Junior High School, told the meeting that a petition was recently circulated in the school urging white pupils to boycott the racially mixed school.

The petition was unsigned, Mrs. Steet said.

'An Overreaction'

Mrs. Steet described racial relations in the school as "the best they've been in a long time, although they're not perfect."

The principal said the incident was an isolated one and attributed it "to misguided

children who were handled the way they should be handled in the school."

Mrs. Steet said she viewed the meeting "as an overreaction."

But Norman Spencer of the Board of Education's office of community affairs said he believes a recent increase in tension between black and white pupils at Jones and Stetson junior high schools "may be connected" with the resurgence of the white power group.

Tells of Fights

George H. Jones, a supervisor for the Human Relations Commission, said "I know for a fact that there have been fights between kids and not only kids, but adults stoning kids," Jones said.

Two weeks ago Jones said he was unable to get out of his car in the vicinity of Cohocksink Recreation Center "because of young men standing on the corner with baseball bats."

Jones said he was in the area to attend a meeting called to discuss racial tension in the vicinity of Auburn st. and Trenton ave.

Questioned about the effectiveness of increasing educational programs in the schools as a means of neutralizing prejudice, Mrs. Steet expressed reservations.

Mrs. Steet, who has been criticized by community residents for developing programs aimed at curbing racial animosity in the school, said she has changed her mind about their effectiveness.

Whites in Kensington, Mrs. Steet said, "face up to and deal with their problems better than white people anywhere else."

There is race hatred in the suburbs and the Northeast, Mrs. Steet said, "and they don't handle it any better."

"I think we're asking the people of the community entirely too much," she added.

Philadelphia's finest recently assembled for a communal weep-in over the nasty old Nazis. After a rousing session of hair-splitting, hand-wringing, and general lamentation they adjourned, after the fashion of such conclaves, with nothing in the way of solid action accomplished. Presumably there were coffee and doughnuts after the mass catharsis.
