## Commander Koehl Confronts Federal Judge Over Busing!

On Tuesday, 26 December, Commander Koehl led a contingent of Stormtroopers to confront the Jew instigator of the anti-White busing program in Maryland, Federal Court Judge Frank Kaufman. A member of the national executive council of the American Jewish Committee, Kaufman has decreed that over 30,000 school children are to be bused out of their neighborhoods and as far away as 20 miles, in order to achieve “racial balance.”

Despite the massive protests by White parents and the growing number of student walkouts, the kosher judge has displayed a callous, ruthless disregard for White people's rights that would do credit to a Soviet commissar.

Determined to confront the Jew judge and express his contempt for such anti-White activities, Commander Koehl marched with eight uniformed ST into the busing hearings that morning. There was an immediate flurry of commotion as security guards rushed to protect Kaufman from a supposed attempt on his life.

Court was adjourned for an hour and a half while proceedings were transferred to another room. After being searched, the Commander and the ST contingent seated themselves in the front row of the courtroom. Toward the conclusion of the proceedings, after school authorities and some faint-hearted parents called for a “peaceful transition” in the busing of the students, the Commander arose and directed a letter he had brought to Kaufman's attention.

Titled “An Open Statement of Contempt,” the letter denounced those who “for reasons of political expediency and because of an insane hatred of the Aryan race, would trample arrogantly and recklessly over the rights, the liberties, and the wishes of the White majority of this country.” It concluded with the statement that individuals like Kaufman had entered into “a sly and criminal conspiracy to exterminate the White race through the gradual process of genocide euphemistically called ‘integration’.” The statement was entered into the court record as argument against Kaufman's busing scheme.

The sensational courtroom confrontation was carried on all the radio and TV stations in the Baltimore and Washington, D.C. areas, as well as many of the local newspapers.

## Rudolf Hess Vigil Held Across From White House

A special 30-hour vigil was held for Rudolf Hess on the Ellipse at the south end of the White House. The vigil began on December 23 at noon, and was kept up until 1800 on Christmas Eve.

Comrades from as far north as Connecticut and as far south as Richmond, Va., came to participate in silent tribute to the Leader's loyal comrade, who is spending his 32nd Christmas behind bars for trying to end the bloody fratricide between the two Aryan nations of Britain and Germany.

Many "Free Rudolf Hess" leaflets were passed out to passers-by who had come to see the huge, 75-foot White House Christmas tree positioned but a few hundred feet from the large Free Rudolf Hess sign.

A special meeting was held in Arlington after the vigil on Christmas Eve. Standing before the traditional Yule tree, comrades who had participated in the vigil each lit a candle for the Heroes and the Martyrs of the Movement. A candle was also lit for the living Martyr of the Movement, Comrade Rudolf Hess.

Also at that meeting, Comrade Cliff Ward, a long time Party activist and staff worker at National Headquarters, was sworn into the Stormtroops.



## Commander Appears On TV in New York City

On 19 December the Commander appeared on a special hour-and-a-half television documentary concerning National Socialism and its growing influence in America. The documentary was made by WPIX-TV in New York City.

The Commander discussed the background of the NSWPP, its founding by Lincoln Rockwell, and its expansion into most areas of American society over the years. He explained the Party's racial program and pointed out that increasing numbers of White Americans were identifying with its goals and objectives.

Telford Taylor, the notorious American judge at the Nuremberg trials who took delight in condemning National Socialist leadership to death and life imprisonment, was also interviewed. Telford was recently in North Vietnam, where he declared his support for the Communist cause. Also interviewed was a representative of the Jewish Defense League. Meir Kahane was in Israel trying to swing an arms deal for his terrorist activities in this country and was unable to appear.

The show was seen by some 3 million viewers, and has been syndicated for nationwide cable TV.

### EXPOSING THE HATERS

It was a very unfunny joke that unfolded last month as the Anti-Defamation League of the B'nai B'rith reported that there has been "a marked increase during the past two years in the scope of American anti-Jewish activities, incidents, organizations and publications" and that "the merging dimensions of the threat to the security of American Jewry are disturbing and cannot be regarded as negligible."

Happy awakening, ADL! When the Jewish Defense League makes the same point five years earlier, who is among the first to condemn it? When Meir Kahane cites chapter and verse (without all the funds and staff of ADL) to call upon Jews to prepare for Aliya to Israel, who turns pure Jewish rage to attack this "paranoid"? When Jewish "militants" with far greater vision and far less vested interests, warn that America can be like any other anti-Jewish country and that the Jew must prepare himself to leave for his own homeland, the ADL's are besides themselves with anger and hate. There is apparently, a difference when the warning is made early and from the mouths of non-respectable militants and when it is made years later at the Waldorf-Astoria Hotel.

There is also one other difference. The JDL stated the problem and proposed two solutions, one short-range and the other long-range. It proposed that militant, tough Jewish groups be formed to physically attack the anti-Semites and that, for the long run salvation of the American Jews, an emergency Aliya campaign be pushed, funded and supported by the major Jewish groups.

The ADL came up with no solutions except for the usual liberal nonsense about "being alert to the dangers" and working with democratically-oriented groups to combat the hate propaganda. Such "remedies", needless to say, are worse than meaningless. They do not work and, at the same time, give the American Jew a false sense that there is a permanent solution to anti-Semitism.

#### White and Black Nazis

One of the curious things about anti-Semitism is the fact that groups who stand at opposing ends of the political or racial spectrum, and who hate each other bitterly, are capable of coming together on question of hating Jews.

There could be no greater enemy of the Blacks in the United States than the National Socialist White Peoples Party (NSWPP), the former American Nazi Party. Yet, it is a fact that it was precisely the late and unlamented Nazi "fuhrer", George Lincoln E. Rockwell, (whose general portrayal of Blacks was as half-a-level higher than apes) who joined with them in "sympathy" on the Jewish issue.

Not only that, but he betrayed a perception of Black anti-Semitism that was lacking in every major

Jewish group when, in March 1963—a full four years before the B'nai B'rith issued its incredible survey that revealed almost no Black anti-Semitism—he wrote:

"And in the last two or three years, the Negroes are becoming anti-Semitic by the million! (remember that this was written in 1963-ed.)

"Even more important, these Jew-wise Negroes are ALREADY

at the bottom of the economic pile and have little or nothing to lose by fighting the Jews whom they finally begin to realize are exploiting and using them!

"...the Negro anti-Jewish movement is a most deadly and immediate threat to the Jewish manipulators. In every black ghetto in America, the owners of the roach and rat-infested tenements who gyp the Negro occupants out of relatively fantastic rents are JEWS! The ruthless dealers in vice who sell the Negro liquor, dope, gambling equipment and other marks of negro degradation are MORE JEWS! The owners of the grinding sweat shops which

cruelly exploit more Negro workers are STILL MORE JEWS!"

Rockwell, the sick extremist, was totally capable of understanding the minds of the extremist blacks, something that major Jewish groups could not or would not. At a time when Jewish groups were aiding the Stokely Carmichaels, the SNCCs, the COREs and apologizing for every looting and burning of Jewish stores as the "frustration" of the Black, Rockwell understood that we were dealing with hatred of the Jew and a willingness to kill him. Naturally, the white Nazis were overjoyed since they saw in this the first

attacks upon the Jews, the weakening of their power and the ultimate precedent that would free white anti-Semites from their hesitation to act.

Rockwell also perceived something else. He noted the difference between the open Black anti-Semitism and the "latent" White kind. He realized that it was not true that whites were less anti-Semitic and that silence or absence of ACTS of anti-Semitism in no way reflected absence of FEELINGS of Jew-hatred. He understood that the open acts of Black anti-Semitism came about because, in his words, "Negroes

### Neo-Nazi Group Surfaces

MILWAUKEE, Wis., (JTA) — A neo-Nazi group, the National Socialist White People's Party, has surfaced in this city in recent months, according to a report by David M. Tushewitz, staff writer of the Wisconsin Jewish Chronicle. Racist fliers adorned with swastikas and filled with incendiary terms such as kike, nigger and Black pigs, have been placed in mailboxes in apartments houses, stuck under windshield wipers and slipped under doors.

A typical flier, has a headline that reads: "Mixing Stink who-mongers into a grinding machine." The flier also contains a list of names of Jews and their addresses.

The same article he wrote: "Our battle is not planned for today when the white man has two cars, a power lawn-mower with a little seat for his lardy bottom and all of the rest of the easy living of today's White American, but for the inevitable day when our phoney, debt-ridden, war-scarred and 'foreign-aid' economy blows sky high. When that day comes, as it must come, the White man will no longer be afraid....

"When Americans have nothing, they will have nothing to lose. The millions who are already enlightened as to the character of most American Jews and who, therefore understandably hate

most of them for their promotion of Communism, race-mixing and the moral subversion of our people, will turn on their Jewish 'friends' with a deadly vengeance the moment they are no longer shackled by the golden chains of the Jew and no longer have anything to lose."

It appears to me that Rockwell, the White American knew white Christian America better than the American Jew and a thousand times better than the Establishment Jew who—with everything to lose—refuses to consider that possibility. Certainly, the curious and rather amazing spectacle of Nazi Rockwell invited to sit on the dais of the Black Muslim convention clearly shows what happens when two groups work on the theory that "the enemy of my enemy is my friend." Both groups, who are deadly enemies of each other, look upon the Jew as the greater common enemy. Because of this they will join against him. This, in the end, is the great danger of Populism in the United States where diverse and illogical alliances of poor and disgruntled 'outs' will join together in temporary alliance to "get" the 'ins.' and, in their minds, there is no greater 'in' than the Jew.

*More and more, National Socialism is striking fear into the hearts of our racial enemies. The Jews are not stupid: they realize that their millennial struggle against the White race can still be lost, and they are growing increasingly aware of the NSWPP as the implacable enemy of Jewry's vileness.*
