City Officials Deny NS Bookstore in Baltimore Permit

On 14 March the Baltimore Board of Municipal and Zoning Appeals ruled in favour of withdrawing a permit granted to the NS bookstore located at 2112 Eastern Avenue several months ago. Because the bookstore also serves as a focal point for local National Socialists, it was charged that the building was not therefore a bookstore.

Ever since it was thwarted in its attempts to physically force the bookstore to be closed by looking the other way when local leftists attack the storefront, city officials have increasingly resorted to such extra-legal tactics to achieve their purposes.

Wolfgang Schrodt, the local organizer and operator of the bookstore, will continue to fight the arbitrary action. There is little doubt that a review of the board's decision in a court will reverse the anti-National Socialist action. The bookstore, meanwhile, is still operating.

Nazi bookstore's zoning is rescinded

In an action without precedent in the city's recent history, the Zoning Board last night withdrew its three-month-old approval for a self-admitted neo-Nazi to operate a bookstore out of his house in the 2100 block Eastern avenue.

The ruling came after a heated three-hour hearing at

which a handful of neo-Nazis and about 10 white South-east Baltimore residents and community leaders, whose loud protests against the ideological operation were rivaled only by noisy legal exchanges between lawyers for the two sides.

The board's decision was a victory for the area residents. They had been on a warpath

ever since Wolfgang Schrodt, 34, turned his residence into a center for ideological activity a year ago for the National Socialist White People's Party.

Daily, residents told the Zoning Board, they could see the red, white and black swastika flag fly in front of Mr. Schrodt's house in an area where many a resident lost his relative in Hitler's holocaust.

The Zoning Board based its decision on two grounds: (1) that a bookstore is the meaning of an ordinance does not exist at the location, (2) the existing ordinance is spreading literature whose sole purpose seems to be inciting hatred in the area.

"Regulative is not,"

A complex legal challenge of the board's ruling was presented last night by William H. Zisman, who represented Mr. Schrodt on the basis of the American Civil Liberties Union.

Mr. Zisman said he is planning to take the case to the Federal District Court of Baltimore on the basis that the board's ruling violates Mr. Schrodt's First Amendment rights.

"It is a matter of principle," the lawyer said. "Noting that he is a Jew, Mr. Zisman continued: 'His (Mr. Schrodt's) ideology is totally repulsive to me, but the question is about his rights—and mine.'"

And on Lincoln's birthday, February 12, about 300 people were on the street to invade the Nazi house because of the swastika flag, the American Legion commander said. Only the fact that the neo-Nazi voluntarily took the flag away prevented that, he said.

Mr. Schrodt, who said he came to the United States 25 years ago "from a European country," testified that he had not made any profit with his operation. He was unemployed, a truck driver, he refused to disclose whether he received any funds from outside to continue his unprofitable enterprise.

"That's none of your business," he told an inquiring board member.

Mr. Schrodt, who was wearing a black suit and tie but no insignia, readily admitted his books mostly dealt with racial matters.

"What kinds of racial matters?" inquired Kenneth O. Wilson, a black member of the board.

Thought Control in Zoning Guise

The Zoning Board's "no" to a neo-Nazi's bookstore in East Baltimore is a base corruption of the city's zoning powers to satisfy neighborhood opposition to the presence of an offensive ideology. The property in question is zoned for B-3 business uses, which included bookstores; the bookstore owner got a proper occupancy permit for a Class A bookstore, and nothing in the current zoning law so clearly states what constitutes a bookstore that the Zoning Board can now validly rule that the operation is not a bookstore.

The opposition was not to a bookstore but to the literature it disseminated. "This type of literature creates hatred," Councilman Schaefer testified, while Councilperson Mikulski put the issue even more succinctly in declaring "it is not a bookstore, it is a political party." The issue was the existence of a headquarters for decidedly unpopular, undemocratic views. And the strong-arm tactic to which the Zoning Board lent itself was to try to

zone the place away, as though the city's zoning powers were intended to be used to quash minority views or splinter parties.

Frequently criticized for leftist leanings, the American Civil Liberties Union demonstrated, and not for the first time either, its impartial and steadfast belief that the constitutional guarantee of freedom of expression applies equally to all minority viewpoints, left or right. Its defense of the Nazi-type bookstore is in the best American tradition of safeguarding free speech. If the bookstore does indeed pose a clear and present danger of inciting others to riot, that is a matter to be dealt with by the police, not the Zoning Board. Let there be no mistake about it: the ideas expressed by the National Socialist White People's Party are abhorrent to the ACLU, The Sun and, we hope, to the overwhelming majority of Americans. But if the powers of government are misused to put down minority views, all Americans become a little less free.

Nazi Headquarters Closed Following Zoning Protests

A Nazi facility in East Baltimore is being closed down by the city government, said a spokesman last night.

The move came after neighborhood residents had spent the last year in front of the facility to protest the flying of a Nazi Swastika flag above the American flag.

The Board of Municipal and Zoning Appeals, after a 2 1/2 hour hearing Tuesday, agreed to zone the property for B-3 business use, which would allow a bookstore to operate there.

The board's decision was a victory for the area residents. They had been on a warpath ever since Wolfgang Schrodt, 34, turned his residence into a center for ideological activity a year ago for the National Socialist White People's Party.

Daily, residents told the Zoning Board, they could see the red, white and black swastika flag fly in front of Mr. Schrodt's house in an area where many a resident lost his relative in Hitler's holocaust.

The Zoning Board based its decision on two grounds: (1) that a bookstore is the meaning of an ordinance does not exist at the location, (2) the existing ordinance is spreading literature whose sole purpose seems to be inciting hatred in the area.

Cincinnati National Socialists Oppose School Integration Plan

On 12 March a public meeting was held by the Cincinnati Board of Education concerning their new plan to integrate more Blacks into the school system. As things turned out, it was one of the "hottest" meetings they ever held.

A large crowd turned out. At the entrance of the Education Building to receive them was a group of National Socialists, led by organizer Steven Love, handing out "Boating Not Busing" leaflets.

When the meeting began, Steve Love and Comrade Robert Brannen walked into the large hall in full Party uniform and took their seats. The people, who had come to represent the general hostility of the community to the board's increased integration plan, went wild. A board member immediately took the floor and insisted that with the NSWPP and the anti-integration White audience present the vote should be postponed and conducted behind closed doors.

Towards the end of the meeting, Comrade Love was recognized by the school board and he went up to the microphone.

He identified himself and then declared that as a representative of the NSWPP he had "nothing but contempt for those who would send small White children into integrated jungles. *White Power!*"

Several interviews were given by Comrade Love to newspaper reporters and appeared in the newspapers the following day. Although three local TV stations filmed the entire proceedings, the National Socialist participation at the meeting was blacked out in their reports.

American Nazis Willing To Win At Ballot Box

CINCINNATI (P-O) — White power will soon triumph over Jews and blacks, Matt Koehl, president of the National Socialist White Peoples Party, told a meeting of members at the Holiday Inn between Sharonville and Glendale, Ohio, Feb. 17.

TWO CROSSES were burned in the last few days in Price Hill, a suburb of Cincinnati far from the NSWPP meeting scene and police have tentatively identified youths involved. Police believe they were not racially inspired but may have to do with relations between residents and high school students over parking.

Standing behind a swastika-draped podium, Koehl warned Americans to prepare for a decade of racial and religious confrontations as part of the white revolution of the 1970's. He said what his organization cannot accomplish through provocation it may try to do at the ballot box.

HE SPOKE TO 25 persons, some of them youths. He said that his party, described by his introducer at the American Nazi Party, "would use the swastika to promote continual confrontations with Jews and blacks until people get so fed up they will realize who their friends are — namely the worst enemies of their worst enemies."

Koehl said he did not expect his party to win at first but that people would be surprised with its strong showing as candidates enter local elections. The meeting, which was billed under the name of "NS Publications" saw a long

What You Can Do To Generate Interest in the Party

EXPOSING THE HATERS

Economic Problems

The Nazis have begun emphasizing more than ever, the economic problems troubling the nation. This is in line with their belief that only a collapse of the economy will give them an opportunity to take power. Thus, the December, 1972 issue of *White Power*, the organ of the National Socialist White People's Party (NSWPP), formerly the American Nazi Party of G.L. Rockwell, devotes its main story to "Jewish efforts to 'put the torch to the economy.'" Under the banner headline that reads "PRICES WILD," the Nazis show two pictures with the following captions:

"President's chief adviser Henry Kissinger wags thumb at Federal Reserve chief Arthur Burns as Fed Board Sherman Malsell looks on. At right Nixon chats with Council of Economic Advisors boss Herbert Stein. All except Richard Nixon are of the Jewish religion."

The Nazi's purpose is obvious and the very first paragraph of the "story" that follows the photos wastes no time in getting into the "plot." Thus:

"Prices were up again in October and more and more Americans began to see the economic mess for what it is: a bad case of Jewitis in our public life. Tricky Dick's

star-of-David-studded Council of Economic Advisers continued to dish out double-talk. Reactions of Aryan Americans contacted by WHITE POWER showed that increasing numbers are beginning to understand (sic) the essential insanity of what is happening."

And just "what is happening" according to the Nazis? They make no bones about it as they declare that "the economic havoc being wrought in the nation is a result of a plan carefully prepared by the twin Zionist imperialist architects of ruin, Henry Kissinger and Arthur Burns."

In reality, Kissinger IS the president. Nixon is a mere figurehead. And Henry takes his orders from such paramount Zionist financiers as his relatives (sic) the Sterns and Warburgs.

Burns has the same bosses and minds the store over at the Federal Reserve, (which) is owned by the big banks and controlled by a secret clique of international financiers who hold the voting stock."

And so again, we are witness to the myth of the Jewish "international bankers" who "control" the economy of the country and the world and who are responsible for the misery of the "little Aryan." The Nazis carefully follow in the successful path of

Hitler as they hit away at the following problems that are real ones for many Americans.

Unemployment The rate remained mired at 5.5% in Oct. But the worst thing was that the government's financial enforcement of pro-Black hiring guidelines "has meant the virtual exclusion of hard-working White men from many of the jobs that are available in favor of ignorant incompetent Blacks."

Taxes. The average worker already is donating in the neighborhood of three hours of each 8-hour day to the federal government alone. Yet another huge tax rise is absolutely inevitable because of policies that encourage welfareism for shiftless Negroes who do nothing but breed little Black bastards.

Interest. Those Whites who do find and keep a job can't afford to buy a house. Interest rates now levied by merciless blood-sucking credit institutions on 20 and 30-year home loans will almost triple the original purchase prices over the loan period."

Of course, the Nazis do not want any of these problems to be solved. Any resolution of them would spell finis to the Nazis who only grow in times of misery and frustration. But leaving aside the Hate rhetoric, the problems that they touch upon are real ones to many Americans and it is important for us to understand that the Nazis are not the total ignoramuses that so many liberals take them for. Sickies; but not fools. The harping on the economic problems that are very REAL ones to many Americans is successful. The blaming of Jews for these problems is also successful in the case of a frustrated mass that seeks a tangible scapegoat to blame. Not only is the blame put

Notes From National Headquarters

The ST uniform consists of brownshirt, black tie, black pants with 1 3/4 inch black leather belt, black GI combat boots, armband, and *regulation* helmet. No other garb is to be used in addition or as a substitute for the regulation ST uniform.

A number of individuals have inquired about including the Party in their wills as a meaningful way of aiding the Movement. Individuals interested in such an arrangement should contact National Headquarters directly for information and assistance. Local units are to direct all such inquiries to National Headquarters where it will be brought to the personal attention of the Commander.

(The Party is based firmly on the Leadership Principle. No one may be "elected" as a local leader.) Appointments, promotions, awards and demotions come directly from National Headquarters through the authority of the Commander.

There is a growing need at National Headquarters for qualified personnel to work in editorial and several other areas of Party operations. All inquiries should include a description of the applicants' abilities, interests, and practical work of experience. Applicants must be at least 18 years of age.

on the group of Jewish economic advisers to the President but the kashrut labels are also blamed for the high prices! The average non-Jewish American has not the slightest way of knowing that the kashrut symbol is on less than one half of one percent of all food items (if that), that it might increase the price of a can of soup by less than a penny (if that) and that the increase is a constant one and not one that escalates.

These things are not important to the average working man and he is likely to fall prey to the Nazi contention that there is a "kosher food racket" and that "the Jews have the cleverness to slyly make us pay millions of dollars in religious tribute to their rabbis."

Again, it is most important to emphasize the fact that the Nazis are anti-Capitalism as the Left is and that, just as Hitler, they attack the rich bitterly under the headline: "RICH: the most evil

ruling class ever." We will have occasion, please G-d, to write of this in future issues because it is one of the least understood aspects of the Nazi propaganda and one that can quite easily capture the minds of many youths who are today Leftists. The Nazis were also to be found in the January issue of *Playboy* magazine as numerous letters were printed there in response to the interview

October, '72) with JDL head Rabbi Meir Kahane. Predictably the majority of the Jewish letter-writers took sharp issue with the Kahane contention that the Jew in the United States faced a potential wave of anti-Jewish feeling. But the editor, wittingly or not, dramatically scored a point or two for Kahane when, after seven consecutive letters attacking the rabbi, he followed and ended the series with one that read:

"Rabbi Kahane is right when he says that there is no Jewish future in this country. America's future is White. Aryan and eventually National Socialist. Nothing can alter this fact. The rabbi would therefore be well advised to abandon his paranoid threats of violence against those Americans of Aryan background who choose

to believe in National Socialism. He would also be well advised to remember that two can play the same game—as our Arab friends proved in Munich...Hell Hitler!"

The letter was signed by Matt Koehl, "Commander" of the NSWPP.

What will happen when Rabbi Kahane's new book, *Time To Go Home* (Nash Publishing, Los Angeles) goes on the market in March is also predictable. The book which elaborates on the warning to Jews that the future is black in America and that violent or reactions from the Jewish Establishment in the United States. It should prove, certainly, to be one of the most provocative books in years and the Nazis would be the first to say that they are preparing to do exactly what the book warns about.
