ST Pickets in Chicago — 1,000 Jews Go Beserk!

The Jews always need to prop up their miserable, rotten history with endless press agency and tear-jerking stories. That is why they gather so frequently for the purpose of revamping their shop-worn lies. It keeps their hatred for the White Race at a fever pitch.

On April 8th, over a thousand Jews jammed into the plush Pick Congress Hotel in downtown Chicago to commemorate the "Jews of the Warsaw Ghetto," a Bolshevik gang that attempted to take over Warsaw in 1943 and destroy the Polish people.

While the Jews were inside the hotel celebrating their blood-spattered crimes of 1943, NSWPP Group Leader Cedric Syrdahl led an ST picket for more than two hours — to remind the Jews that the White Race will always triumph over Jew decadence and Jew domination.

The Jews went insane with rage as their crimes were brought to public attention. Remember, the enemy can easily dismiss all other types of protest — conservative teacup meetings, etc, etc. — but only NS activism can blast Jew lies to pieces!

Spurred on by JDL psychopaths, hundreds of pudgy, effete little Jews were whipped into a mass of raving animals, screeching in Yiddish their Talmudic curses of extermination for all White People! Like a backed-up sewer, the Jews streamed forward. Our ST stood their ground!

But, as Group Leader Syrdahl fought off an attacking Jew, an overly-zealous Chicago policeman — possibly a brainwashed Whiteman, possibly a System Pimp — moved in and smashed Syrdahl in the face with his nightstick, causing a skull fracture and wounds requiring many stitches. It must be pointed out that the reaction of the other police at the scene was definitely *pro-NS*, and despite the interruption, our ST was allowed to carry on for the full time allowable under their permit.

Comrade Syrdahl was later taken to the hospital, provided with superficial "rush-job" treatment, and released. At this writing, as the Bulletin goes to press, Syrdahl has been re-admitted to the hospital and now lies in Intensive Care. His wife and children are being threatened at their home by sick, filthy-mouthed Jews; and are harassed 24 hours a day. Moreover, Syrdahl faces "disorderly conduct" charges in the near future.

1,000 recall uprising in Warsaw ghetto

Outside the Pick-Congress Hotel, more than 1,000 Jews were gathered Sunday for a memorial service to the Jewish Ghetto Uprising 30 years ago.

"It was a time for us," said Richard Lipschultz, who was in the Soviet of the Great Hall looking at the blow-up photo of the dead and dying of the Warsaw ghetto and the Nazis who were bombing and shooting and herding the Jews to the concentration camps.

Richard Lipschultz, now 53 and Midwest representative of the United Jewish Appeal, smiled bitterly when he thought of the later-day Nazis on the sidewalk outside.

Lipschultz was one of the few who survived the Warsaw Uprising. The Jewish ghetto had fought back and the Nazis had sent in liquidation squads who went door to door shooting and herding men, women and children on their extermination roads.

Lipschultz pointed to a dim photo of Dr. Janina Korczak.

Fight breaks out at memorial for Warsaw Nazi victims; 4 held

Three men and a woman were arrested Sunday after a fight broke out between American Nazi Party members and Jews commemorating the Warsaw Ghetto Uprising.

Police said the fighting broke out after members of the Nazi Party began taunting persons attending the memorial services in the Pick-Congress Hotel.

Party member Cedric Syrdahl, 34, of 3017 W. Wrightwood, was arrested on a disorderly conduct charge. Police accused him of hurling threats and obscenities at the Jews. He was treated for a contusion at Mercy Hospital and released.

Alex Mordechai, 34, of 2971 Rockwood, Morton Grove, was also arrested on a disorderly charge. Police accused him of throwing an unidentified object.

"Korczak could have saved himself," said Lipschultz. "One of the German soldiers had grown up in his orphanage and offered to help him escape, but Korczak refused."

"Instead, he walked with the children to the cattle cars, telling them they would be better off when they got to Treblinka. And when they got to the loading platform, Dr. Korczak, who could have saved himself, leaped on a trolley with the children. And he was gassed at Treblinka."

Lipschultz himself had escaped the massacre, along with a few Gentiles, by crawling through the sewers of the ghetto and fleeing to the ringing partitions in the forest.

"Here is another hero," said Lipschultz, walking over to a small gray-black photo. A Party SS trooper was aiming his machinegun at a ringleader boy in their gang.

It was hard to tell whether Lipschultz meant the little boy or was using irony to describe the big SS with the machine-

Investigation aimed at local NSWPP action

University officials are attempting to downplay reports that the National Socialist White Peoples Party (NSWPP) has been active on campus. However, charges leveled by eight University students are being investigated both on and off campus to determine if actual physical danger to black students exists.

One of the students, Terry St. John, said that the group did not wish to discuss the details of their charges at this time. "We have a lot of delicate negotiations going on," said Mr. St. John. "We don't want to upset them."

Nevertheless, investigations of incidents both in the University and in local Buffalo high schools have been initiated. Representatives of the Temporary State Commission to Study the Causes of Campus Unrest (the Henderson Commission) were on campus last week to listen to the group's claims.

Additionally, officials of Buffalo schools have asked the FBI and Erie County District Attorney Michael F. Dillon to investigate the distribution of "hate literature" at Kensington High School and Emerson Vocational High School last week.

One prior incident

Campus police records show only one incident on campus involving members of NSWPP, which occurred in Norton Hall on November 11 during a session of Israeli folk dancing in the Fillmore Room.

Leon F. Griffin, assistant director of Campus Security reported then that two individuals wearing Nazi armbands and brown shirts were attempting to distribute "hate" literature when they were surrounded by participants in the Israeli folk dancing, carrying an Israeli flag.

"We suggested they go to another part of campus," said Mr. Griffin, "we said that we couldn't offer them any protection." The individuals voluntarily left campus, but later complained to the American Civil Liberties Union (ACLU) about violations of their rights. After a telephone call to Campus Security, the ACLU decided not to initiate a court

action.

Mr. Griffin also reported that it is a Class A misdemeanor in New York for any person to appear in a public place "in any uniform similar to that worn by storm troopers of Nazi Germany... or any distinctive part or parts... or to assemble with other persons similarly attired..." He quoted section 238 of the Military Law as his source for the statutory prohibition.

No arrests made

Mr. Griffin noted that campus police had not arrested the individuals involved because of the great difficulty in ascertaining what the court-defined interpretation of the statute would be. The literature collected by Campus Security was blatantly anti-Black and contained several derogatory innuendoes about Jews.

Mr. St. John met with Albert Somit, executive vice president, and Richard Sigelkow, vice president for Student Affairs on Friday "to warn us about what was going on," reported Dr. Sigelkow.

Also at the meeting were Roosevelt Rhodes, director of Minority Student Affairs, Carol Raynor, director of Norton Hall division of Sub-Board I, Inc., as well as other administration representatives.

"We were talking about something we can't really anticipate," said Dr. Sigelkow. "I was impressed with the way students at the local high schools handled the literature. Our students are even more sophisticated and aware of the problems involved," contained Dr. Sigelkow. "I am sure they will react as intelligently."

Ms. Raynor reported that Mr. St. John had warned University officials of a supposed incident which was to occur last Friday night involving members of NSWPP. The incident failed to materialize.

Mr. St. John has also met with Buffalo City Councilman George Arthur to seek Common Council action in this matter. The Council was to have discussed the problem at yesterday's session.

ST Lays Wreath "To White Policemen" in Bridgeport, Connecticut

On 18 March members of the Bridgeport, Connecticut ST placed a wreath on the lawn between the police station and city hall.

The large black funeral wreath bore the inscription "To All White Policemen Who Fell To Black Crimes" on it.

The ST members first paraded through Mclevy Hall Green and then proceeded to police headquarters where they circled the building several times. One of the signs displayed by the ST stated: "Hire only White policemen."
