Commander Arrested in Demanding Release of Rudolf Hess!

On Saturday, 12 May, Commander Koehl led two teams of Stormtroops into the nation's capital to observe the 32nd year of comrade Rudolf Hess' imprisonment and demand his immediate release. On 10 May 1941, Rudolf Hess, the deputy to Adolf Hitler, flew to Britain as the Leader's emissary in an attempt to terminate hostilities between the two great Aryan peoples and bring the British Empire into a united coalition with the rest of Europe against Communist Russia. For his gallant efforts, Hess was declared a "war criminal" at Nuremberg in 1946 and condemned to life imprisonment.

On the way to the White House, where the demonstration to demand Rudolf Hess' release was scheduled to be held, the Commander attempted to deliver a demand at the Soviet embassy (located just behind the *Washington Post* at 1706 18th St. NW). The demand stated:

On behalf of the great White majority of these United States, as well as the members of this organization, we hereby denounce the cruel and inhuman treatment being accorded Spandau peace prisoner RUDOLF HESS at the insistence of the Soviet Union; and we demand the immediate end of this notorious act of barbarism with the unconditional release of Rudolf Hess.

As the Stormtroop column approached within a few hundred feet of the Soviet embassy several members of the Executive Security Police blocked their path, informing them that no demonstrations were allowed within 500 feet of the embassy. The Commander explained that the ST were not there to demonstrate, and explained they were on their way to the White House, showing them the permit.

The special police, now numbering a dozen or more with reinforcements of regular capital police arriving, still refused to allow the Commander and the ST to walk past the Soviet embassy.

The Commander told the police captain of his intention to present the Soviet embassy with a demand for Hess' freedom. The police flatly refused to allow the Commander to go any further and ordered the National Socialists to go back the way they came. When Commander Koehl attempted to proceed to the embassy with his demand he was stopped and arrested. The National Secretary, Lt. Robert Homan, handcuffed himself to a fire hydrant in front of the Soviet embassy and began shouting: "Freedom for Rudolf Hess! Down with Soviet tyranny!" After five minutes the police succeeded in removing the handcuffs, and both Commander Koehl and Lt. Homan were arrested and taken to police headquarters where they were charged with disorderly conduct.

Meanwhile, at the White House, ST Harold Covington handcuffed himself to the gate in front of the White House with a demand to President Nixon for Rudolf Hess' release. Comrade Covington was arrested and also charged with disorderly conduct. The day's activities were carried on Channel 7 television and also reported in the local newspapers.

Commander Returns From Cross-Country Tour

The Commander returned to National Headquarters on 5 May after a five week cross-country tour in which he visited comrades in Tennessee, Arkansas, Arizona, and California.

The Commander's first major stop was in Phoenix, where a meeting was held and Phoenix was officially made a unit of the Party. Comrade Elton Hall was appointed the local organizer by the Commander for his outstanding efforts in street activities and organizational work.

Commander Koehl and the National Secretary, Robert Homan, appeared on a new television interview show, "Target," which is hosted by Jack Fisher. The Commander discussed the Party and its National Socialist philosophy, emphasizing the importance of repatriating the Blacks back to Africa. Unlike many talk-show hosts, Mr. Fisher was courteous throughout and the Commander succeeded in bringing out many good points during the half-hour interview. The series will be syndicated around the country very soon.

Upon his arrival in Los Angeles, the Commander held a meeting at El Monte headquarters on 7 April with over 80 comrades in attendance. After opening speeches by Lt. Tommasi and Lt. Homan, the Commander spoke to the audience about the growth of the Movement in America and the important role that each one of us plays in the struggle as National Socialists. Afterwards, a film of the fight with the JDL last January in downtown LA was shown, along with "Triumph of the Will."

On 19 April the Commander visited the Tracy Unit and discussed organization and plans for future Party development in the area with local organizer Paul Raymond. The Tracy Unit has been especially active in northern California and has caused much consternation among the local authorities because of its zealous political activities.

On 9 April the Commander was attacked by a member of the Jewish Defense League, as he was leaving a Los Angeles courtroom. The Commander was attending a hearing of Philip Fogarty. Comrade Fogarty was the ST originally hit in the head by a missile that precipitated the fight on the lawn of the Los Angeles County court house last January. The JDL then charged Fogarty with attacking them!!! The Commander went down to the proceedings with Lt. Tommasi and TL Bill Grimstad when it was discovered that the JDL had prevailed upon the judge to have a bench warrant sworn out for Tommasi because he was not in the courtroom. Lt. Tommasi had been reassured that his presence was not required so he did not attend. When the Jews learned of this they immediately raised a furor and prevailed upon the pro-Jewish judge to issue the warrant. The warrant was dropped with Tommasi's appearance in the courtroom.

When the JDL learned of the identity of the Commander, however, they immediately had a subpoena sworn out for him as a "witness," although he was 3,000 miles away in Arlington at the time of the incident. It was clearly a matter of harassment against the Commander. As the Commander left the courtroom a short, swarthy Jew by the name of Earl Krugel jumped at the Commander and hit him in the mouth. Police immediately intervened and the JDLer was seized, whereupon the Commander made a citizen's arrest for the assault. The Commander was not seriously hurt. In fact, the incident hurt the JDL's case. As usual, the Jews acted obnoxious throughout the day. They screamed epithets at National Socialists in the courtroom and indulged their overweening arrogance. It was rumored that the prosecuting attorney, a Jew by the name of Fleishman, was a member of the JDL. In sharp contrast, the National Socialists remained composed and displayed a dignified Aryan demeanor. After two weeks of hearings, the charges were finally dropped against Comrade Fogarty.

On 22 April, Commander Koehl promoted Lt. Joseph Tommasi to the rank of captain in the Stormtroops.

Prison Authorities Concerned About National Socialist Inroads

Prison authorities are becoming anxious over the growing popularity of the NSWPP and National Socialism among White inmates. Whites are greatly outnumbered by Blacks and other non-Whites in the penal system. Their protests against Black gang assaults, stabbings, and murders have, with few exceptions, fallen upon deaf ears by the System.

Forced to live in a situation where survival means organized defense, the Whites in many prisons across the country have formed National Socialist groups to spread the word of White Power to their fellow inmates and organize them for protection against the Blacks. In the past several months, Blacks have begun to learn that although they may outnumber the Whites numerically it's impossible to keep them down once they're united and determined to carry the fight home.

Whites revolted in a West Virginia prison last March in protest against the favoritism Blacks were receiving while Whites were beaten and exploited. To emphasize their militancy, and to make it clear to both the Blacks and their liberal and Jewish friends, the Whites beheaded a Black as a warning of what was to come if conditions didn't improve fast.

National Socialists Expose Narcotics Ring

Several weeks ago a National Socialist comrade in Wilmington, Delaware, learned of two racially mixed couples in his neighborhood who were dope pushers. Taking advantage of the government-sponsored "Heroin Hot-Line," he called the federal authorities in Washington, D.C., and reported what he knew about the ring.

Five hours later he heard over the local radio that the people he reported had been stopped and arrested in Spotsylvania, Va., while travelling from Delaware to Florida. Over \$82,000 worth of heroin was confiscated. Being their second offense, the criminals are subject to the death penalty.

When the National Socialist called the "Heroin Hot-Line" back, they reported the arrest occurred thanks to his information and congratulated him. He replied: "This has been a public service of the National Socialist White Peoples Party." At first startled, the federal agent then replied, "I don't care what your politics is. If you'll work with us against these dope rings we'll back you all the way."

Lone National Socialist Celebrates Leader's Birthday

A lone National Socialist by the name of Allan Vincent observed the birthday of Adolf Hitler in San Francisco. On 19 April he set up a large Swastika banner in front of San Francisco City Hall. He stood there for 30 minutes, in brownshirt uniform and armband, in memory of the founder of National Socialism. The following article appeared in the *San Francisco Chronicle* on 20 April 1973.

Cleveland National Socialists "Participate" in Warsaw Ghetto Commemoration

On 29 April TL Richard Biederman led eight Stormtroopers on a picket in front of Fairmont Temple Synagogue, which is situated in the predominant Jewish Cleveland suburb of Beachwood.

The Jews were beating their breasts over the "heroic" resistance of Marxist Jewish partisans who finally received their just desserts at the hands of the SS some 30 years ago. The ST carried signs declaring, "Gas All Red Jews," "Get Jews Out of U.S.A. Now," and "White Power."

Beachwood is 85% Jewish. The area is so Jewish that lunches at the public schools are all kosher. A large local police detachment of over 30 officers was present at the demonstration, supplemented by 25 Cuyahoga County Sheriffs deputies in riot gear.

From the moment the National Socialists arrived and started picketing the Jews became enraged and literally went mad with hatred. Hysterical Jews screamed about being gassed and shouted the most filthy obscenities at the Stormtroopers. Cars stopped in the street, causing a log jam, while hundreds of Jews shrieked their venomous epithets in Yiddish and Hebrew. Two Jewesses fainted, while police were scuffling with other Jews. One Jew pulled out a gun and was subdued by five policemen. A few minutes later a Jewess broke through the police lines and attacked a Stormtrooper with a club. She was yelling incoherently as the police dragged her away. After 20 minutes picketing, the police requested that the demonstration end. There were now over 2,000 screaming Jews and the police anticipated even greater numbers shortly.

The April issue of *Cleveland* magazine carried a special five-page article on the Party in Cleveland. Comrade Casey Kalembe was interviewed and pulled no punches in the hard-hitting article.

Adolf Hitler's 54th birthday brought forth a lonely celebration on the steps of City Hall here yesterday.

A small crowd of the curious gathered to watch Whitey Anderson, a representative of the National Socialist White People's party, display a banner that should have been borne by more than one Nazi.

Repeatedly pausing to pick up his flapping emblem, the 36-year-old Anderson said, yes, he knew Hitler's

birthday is actually today.

"It just worked out that way, I guess," said Anderson, who added that the party's ten other Bay Area members couldn't make it "because they are all working."

Anderson stayed 25 minutes at his lonesome vigil while the press waited for someone to punch him. But Anderson finished his racist rhetoric unscathed, packed up his banner and drove off in a battered old car.
