New Format Planned For This Year's National Socialist Gathering In Cleveland

An exciting, completely new format is being planned for the Fifth North American Congress of the World Union of National Socialists and the National Socialist White People's Party in Cleveland this year, with heavy stress to be laid on ceremonies, rallies and the general spiritual content of the event.

Also featured will be special displays and exhibits, movies, guest speakers, membership sessions and practical workshops—as well as a public ST march which will be the most spectacular National Socialist sight ever to hit any Midwest city.

Because of its more central location, this year's Congress is expected to draw a larger-than-usual turnout of delegates. Details will be forthcoming shortly on attendance and registration.

Those wishing to attend should plan now to keep this coming *Labor Day weekend* (1-3 September) open. Due to the limitations of hall seating capacity, no more than 350 delegates can be admitted.

On 9 May, National Secretary Robert Homan led a contingent of National Socialists into an Alexandria school board meeting which was considering busing. Lt. Homan got up to the microphone and denounced the school board's scheme to "pair off" White children to integrated jungles in that city.

On 14 May, GL Clifford Ward led a contingent of National Socialists to another local high school auditorium. As the liberals present were going through all their ritualistic handstands about the wonders of integration, a huge banner suddenly appeared out of nowhere with the words, "White Power". GL Ward jumped up and denounced the hypocritical race-mixers and their pompous plans for other people's children. It took a police task-force to quiet the National Socialist demonstration.

California Comrade Receives Order of Adolf Hitler

Paul Raymond of the Tracy Unit was recently awarded the Order of Adolf Hitler-Bronze.

In making the award, Commander Koehl cited Comrade Raymond for "conspicuous and outstanding valor in the face of overwhelming odds resulting in personal injury when attacked by a gang of JDL members while selling the Party newspaper in Hollywood, Calif., on 6 June 1972 YF-83." This was the first Order of Adolf Hitler award issued in over seven years.

GL Syrdahl Promoted To Lieutenant

Chicago activist Cedric Syrdahl who was severely injured during an ST demonstration on 8 April has been promoted by Commander Koehl from the rank of Group Leader to Lieutenant.

Southern California District Created

On his recent trip to the West Coast, Commander Koehl formally established a Southern California District of the Party, to include the following 10 counties: San Diego, Imperial, Orange, Riverside, Los Angeles, San Bernardino, Kern, Ventura, Santa Barbara and San Luis Obispo.

Named as District Leader was Capt. Joseph C. Tommasi, who has headed the Los Angeles Unit. Harlan Stevens of the L.A. Unit was appointed acting District Secretary.

Also created was a 5-man District Council, comprised of the following persons: Glenn Parker (foreman), Ray Wilson, Robert Schloegl, Dan Stewart and William Grimstad.

Southern California is the only organized district at the present time. For all other members, supporters and units outside that particular jurisdiction there are only two Party levels of operation: (1) *national*; and (2) *local*. NO OTHER "DIVISIONS," "DISTRICTS" OR "REGIONS" ARE VALID.

The district level affects organized operations and activities only. For *administrative* purposes, all personal matters relating to membership and supportership (such as dues, OS pledges, etc., as well as all mail-order purchases) should be handled directly with National Headquarters.

Increased Action In Buffalo Despite Uniform Ban

On 19 May three teams of ST men from the Buffalo area took part in picketing a Jew pornography shop. The signs displayed said: GAS SMUT PEDDLERS, WHITE POWER—WHITE DECENCY, PROTECT OUR YOUTH FROM THIS JEWISH TRASH, among others.

In the midst of the demonstration some Vietnam war veterans came over and joined the demonstrators.

On 21 May an arrest warrant was issued for Comrade Karl Hand for participating in the demonstration in uniform! The uniform ban presently in force in New York state makes the wearing of a "Nazi stormtrooper uniform" a violation of the state military code. Comrade Hand then wore his uniform at his court arraignment and was almost charged with contempt of court!

Before Comrade Hand returned to the courtroom on 5 June he was interviewed by Channel 4 newsmen. The interview was carried later in the day by numerous news broadcasts, and reached tens of thousands of White people in Buffalo. More news coverage is expected as Comrade Hand's case continues.

Fresno Activist Shows What Can Be Done!

After many deliberate attempts to stall, the telephone company in Fresno, California has finally installed a White Power Message unit on 22 May. Comrade Rick Cooper of Fresno relates what happened next: "There was no publicity on the message until the morning of the 25th. (Only the telephone company and business card supply store which made up the message cards knew of the message.) Until then, many calls came in at a heavy rate. Now the equipment is running constantly during the daytime hours!"

Comrade Cooper also sent the following letters to the editor of the local university newspaper. After the first letter was published a steady stream of Chicano abuse and invectives poured forth in further letters to the editor. Another letter by Comrade Cooper rebutted the long list of Chicano excuses for "biological inferiority."

'Biological inferiority'
Editor:
I was not surprised at all when I read Vicky Parker's letter regarding the Ethnic Studies department. There is a lack of understanding among the White student body, in general, as to why the educational standards are so low in the Ethnic Studies department — especially in the Black and Brown studies. The truth of the matter is that Blacks and Browns rarely have the intelligence level to fully understand anything comprehensively.
For this reason, neither of the two races have been able to, are able to nor will be able to create civilization (not to be confused with maintaining "civilization" at a much lower (sic) level as we Whites would consider civilization to be). To further support my statement, there in the hard sciences such as mathematics, physics and chemistry except at the lower levels of these courses? Few Browns or Blacks ever take these courses because of the difficulty. They always except have 1000 and 1 excuse except the one of biological inferiority. It's no wonder that our "equals" have never built skyscrapers, airplanes or televisions without a significant White influence.

Man Enters Innocent Plea In Nazi Uniform Case

A man who police said was walking downtown wearing a Nazi uniform and carrying a sign reading "Gas the Jews" was arraigned in City Court Wednesday.

Karl Hand Jr., of Walden Ave., pleaded innocent to wearing a foreign uniform in violation of the state military law before Judge John J. Honan, who released him without bail pending a June 5 trial.

Police said they arrested Hand about 2 p.m. Saturday after they spotted him allegedly wearing

the uniform and carrying the sign at Franklin and W. Chipewa. Police said he had another sign which read "White Power."

Hand was represented in court by Attorney David G. Jay of the Niagara Frontier Chapter of the New York Civil Liberties Union.

Hand and a codefendant last month won dismissals of disorderly conduct charges in connection with their alleged distribution of "hate literature" across from Kensington High School March 29.

Your newspaper refused to place a paid advertisement in your pages carrying the name of the National Socialist White People's Party (The American Nazi Party) without deleting the word "white". And now, display, free of charge, this symbol of "black power" as "art". This leaves in my mind the question of whether or not it would have been called "art" if this had been a white boy carrying the symbol of "white power", the swastika.

In going even further, I don't understand how Miss Kyta Woodruff failed to see the political and racial questions in this poster of David Butler's. I can understand the student judges being faint hearted because of current pressures, but I can not understand why an adult in our public school system would be.

The question remains: Would you have printed a picture of the swastika? Would a picture of the swastika have been permitted by the public school's art instructor Miss Kyta Woodruff? I believe that the newspaper and the instructor would be too prejudiced to permit the swastika.
