Registrations To Congress Start Rolling In!

Although registration cards for the upcoming North American Congress were mailed out little more than a week ago, the response at this early date has been astounding. If the trend continues—and there is no reason to believe that it won't—there will be a record turnout of delegates this year, very likely more than doubling attendance in previous years.

As things stand, approximately 40 U.S. states and Canadian provinces will be represented at this year's Congress. Early indication is that almost half the delegates will be taking off work the pre-Congress Friday so they can be on hand for the registration and rally and opening session on Saturday—even though it involves a good deal of sacrifice and personal hardship in some cases. But this is the kind of people you are going to find at this Congress, because it is not just another right-wing convention, but **A NATIONAL SOCIALIST EVENT!**

Not only will there be the history-making ST march and public rally in downtown Cleveland, but an exciting program is being planned for the indoor sessions with reports of local activity and dynamic speeches which will lead off with the Commander's "State of the Party" address, in which he will announce new goals for the Movement in the coming year.

There will also be important work sessions dealing with some of the practical problems National Socialists encounter in their daily activity across the country. If you have any questions in this respect, here's your opportunity to get squared away.

Needless to say, this is the one time during the whole year to meet like-minded comrades from all across the continent all together and all at the same time. This is an opportunity no National Socialist will want to miss.

Buffalo Activist Wins Uniform Case

On 26 June, Comrade Karl Hand appeared in Buffalo municipal court on charges of violating the New York state military code banning the wearing of Stormtroop uniforms in public.

This court case stems from an earlier 19 May demonstration when Comrade Hand tested the state anti-uniform law. A few days later, a Jew by the name of Glanzberg filed a warrant for his arrest. (See Bulletin No. 135)

Because of the flagrant violation of his rights, the ACLU agreed to take the case. The prosecution's only witness was Glanzberg, who because "he was a former concentration camp inmate," considered himself an expert on NS uniforms. The judge dismissed all charges, after finding that the uniform worn by Comrade Hand did not match the description given by the "expert" Glanzberg.

Although this was a great victory for the Party we will continue to fight the constitutionality of the uniform law until it is completely overturned.

Chicago Stormtroopers Hit Embattled Park, Picket Porno Theater.

On 17 June, Chicago Stormtroopers, in a White Power bus, assisted by Milwaukee comrades, who brought their own van, took the two vans, marked with "White Power" signs to Calumet Park on the southside of Chicago. The park has been the site of terrific racial fighting in the past few weeks.

After the vehicles arrived in the park a crowd of White youths began to gather around them. At the first sight of the "White Power" signs, cheers began to come from the crowd, and very soon, newspapers, leaflets and White Power buttons were being distributed.

A few minutes later, however, a squad of police cars and motorcycles pulled up. A police lieutenant, ordered the National Socialists, under threat of arrest, to leave the park to avoid provoking a confrontation with black gangs situated very near the park. Despite the police order, many new people were reached and inspired by the appearance of the National Socialists and the two vehicles.

On the same day but earlier, uniformed ST men picketed a porno movie house on Chicago's northside. All through the picket the theater received only five customers, because most were afraid to cross the ST picket line.

Judge Frees Man on Nazi Garb Rap

A man charged with wearing a Nazi uniform downtown was granted a dismissal Tuesday in City Court of a charge of violating the state military law.

Judge William J. Ostrowski granted the dismissal after ruling that the defendant, Karl Hand Jr., 22 of Walden Ave., was not wearing enough pieces of the uniform to violate the law. Hand had been arrested on the complaint of a former inmate of a German concentration camp.

Arm Band

Judge Ostrowski noted that Hand was wearing only a brown shirt and Nazi arm band and the section of the law he was charged under makes it a violation to wear a Storm Trooper uniform.

The judge noted he researched the Storm Trooper uniform and found that in addition to the arm band and brown shirt it required double lightning bolt insignia, a skull and crossbones insignia and other items to be complete.

Hand was charged on the complaint of Jules Glanzberg, a Chippewa St. businessman, who the district attorney's office identified as a former concentration camp prisoner and French resistance leader.

Asst. Dist. Atty. Samuel P. Simon said that Glanzberg's arm still bears his concentration camp number.

Glanzberg swore out the complaint and warrant after he allegedly spotted Hand wearing the uniform parts and carrying a sign reading "Gas the Jews" May 19, at Franklin and W. Chippewa.

Authorities said there were a few other people with Hand and

another sign which read "White Power" also was displayed. Hand was apparently the only person wearing the uniform parts.

CLU Lawyer

Hand was represented at the trial by attorney David G. Jay of the Niagara Frontier Chapter of the New York Civil Liberties Union.

Jay sought to have Judge

Ostrowski declare the military law unconstitutional because it was "vague" and restricted freedom of speech, but the jurist declined to rule on those issues.

Hand and a co-defendant last April won dismissals of disorderly conduct charges in connection with their alleged distribution of "hate literature" across from Kensington High School March 28.

Man Acquitted in Trial For Wearing Nazi Outfit

A trial of Karl Hand Jr., on charges of violating the state military law by illegal wearing of a Nazi uniform ended in his acquittal late Tuesday before City Judge William J. Ostrowski.

Hand was wearing a business suit for his trial but has appeared in court before in a tan shirt with swastika.

Judge Ostrowski ruled that the defendant wasn't actually attired in a storm trooper uniform as described in the law that includes a double lightning bolt insignia, a skull and crossbones insignia and other specified items to make it illegal.

The complainant was Jules Glanzberg, a Chippewa St. businessman, who filed the complaint after he said he saw Hand at Franklin and West Chippewa Sts. May 19 with a few others in a parade. Some were carrying signs which read: "White Power" and "Gas the Jews."

Asst. Dist. Atty. Samuel P. Simon said Mr. Glanzberg is a former concentration camp prisoner still bearing his concentration camp number and also was a French Resistance leader.

Hand, who had pleaded innocent, was represented by attorneys David G. Jay and Leonard J. Klaf on behalf of the American Civil Liberties Union.

Mr. Jay challenged the constitutionality of the military law during the trial as a restriction on freedom of expression.

The lawyers also had represented Hand earlier this year when they gained dismissals of disorderly conduct charges arising from alleged distribution of "hate literature" material across from Kensington High School March 29.

National Socialists Demand Hess Release During Brezhnev Visit

On 18 June, four teams of ST men appeared on the grounds of the Washington Monument to stage a demonstration on behalf of Rudolf Hess.

The demonstration coincided with the visit of Soviet Communist Party Leader Leonid Brezhnev to the White House. The Russians have always rejected the idea of releasing Hess from prison. Actually any one of the Soviet Union's allies—Britain, France and United States—could have released Hess a long time ago when their turn came up to guard him at Spandau.

Signs proclaiming, "Free Hess" and "Was Peace A Crime?" were displayed for tourists and other spectators to see.

After nearly two hours of picketing, about 10 members of the Jewish Defense League showed up and started screaming obscenities and shouting Hebraic slogans at the top of their lungs.

While this was going on, an officer of the Park Police approached GL Clifford Ward, who was in charge of the demonstration, and begged him to "let the police handle it." No incidents occurred, however.

Later on in the day a carload of JDLers caught a lone trooper walking down a side street in Arlington. As one of the Jews pointed a shotgun out of the car window, two others sneaked up from behind the ST man and kicked him, knocking him down. The cowardly attackers quickly sped away in their car.

L.A. Leader Appears On Local Radio

On 17 June, Capt. Joseph Tommasi accompanied by a dozen Stormtroopers appeared on radio station KEZY for a two-hour long call-in and answer show.

Three days earlier on 14 June, the JDL attempted to prevent Capt. Tommasi and four troopers from entering a television studio by showing up with 15 JDLers. This time however due to the show of force displayed by Capt. Tommasi and the troopers, the JDL chose to stay home.

The program reached tens of thousands of White listeners who were hearing the message of National Socialism for the first time.



Information For Comrades Attending The Congress

REGISTRATION:

Delegates are reminded that upon their arrival in Cleveland they are to go immediately to their registration site (to be announced in a later issue of the Bulletin). If your dues are paid up and have paid your \$3 registration fee you will then be officially registered and will receive your delegate's badge.

FILM:

Leni Riefenstahl's immortal film classic of the 1934 Party Congress and rallies at Nuremberg, "Triumph of the Will" will be shown Friday night, 31 August, at 8:30 p.m. The location will be announced in a future Bulletin. This will be the ONLY showing of this film during the Congress. It will not be shown during the Congress itself. If you wish to see this exciting documentary, plan to arrive early.

TRANSPORTATION:

Again, we remind all comrades who need transportation or all those who can supply a ride to contact National Headquarters as soon as possible.

INTERVIEWS:

The Commander will not be able to give any interviews between Friday, 31 August, and Monday, 3 September. Any probationary member desiring a full membership interview with the Commander immediately prior to Friday should contact National Headquarters as soon as possible. All comrades who wish to discuss organizational matters should notify National Headquarters no later than 27 August, requesting an appointment with the pertinent Party officer.

ATTENDANCE:

All unit leaders will be expected to attend. Those who cannot be present for some overriding reason, should notify National Headquarters by 15 August requesting official excuse. Unexcused absence will be considered grounds for suspension of a unit. All ST leaders with the rank of Group Leader or over will similarly be required to attend, unless headquarters duty prevents them from doing so.

ST MARCH:

All male delegates should come prepared for the ST march and rally. In accordance with this, participants should if possible come with boots, a standard ST helmet and a properly tailored shirt.

All comrades who do not have a helmet can obtain the regulation helmet through the Chicago Unit. Because of time limitations, all those needing a helmet should send \$13 and their head size to NSWPP—Box 5865—Chicago, Ill. 60680. The Chicago Unit will take all orders and deliver them in Cleveland. None will be mailed. Please note that only regulation helmets will be allowed.
