#### **Congress Less Than Three Weeks Away!**

With the Fifth North American Congress less than three weeks away, plans have been almost finalized for the largest National Socialist gathering since World War II. The indication so far is that we are in for a record turnout.

This is the one time of the year when National Socialists from two different countries-Canada and the United States-can actually stand side by side. As stated in an earlier Bulletin, indications are that there will be delegates from most states and several Canadian provinces. This is the one chance for National Socialists to meet other comrades from every part of North America!

Delegates are reminded of the importance of this Congress. - Not only will there be Commander Koehl's keynote speech on the state of the Party and various local reports from all over the continent, but there will also be helpful work sessions to provide valuable insights for those comrades who are interested in local activity.

When each delegate registers, he will be told about the location of the ST assembly and any other pertinent information that has not been answered.

#### Anti-National Socialist German Government Confronted By Army Comrade

On 30 July, Pvt Jimmy Clendennen, accompanied by Commander Koehl, appeared at the German Embassy in Washington, D.C., to demand an end to the harassment of National Socialists in Germany. The Bonn government has brought charges of illegal political activity against a number of German comrades, and has imprisoned one of them without trial.

On 21 March 1973, Clendennen, who had been stationed in Germany for 11 months, had his tour of duty summarily terminated, because of his affiliation with an outlawed National Socialist organization.

After the German ambassador refused to accept his statement, Clendennen handcuffed himself to the front entrance and demanded that the charges against the Germans be dropped immediately. Rather than answer his demands, the German representatives called the police and Secret Service. Clendennen was handed over to the military police and was interrogated by both Secret Service and military intelligence. No charges were brought against the Commander. Clendennen was released the following day on his own recognizance on condition that he immediately report back to Fort Lewis, Wash., where he is presently stationed.

### **GI Nazi vows to return to Germany**

#### As soon as he gets out of jail for AWOL -

A 23-YEAR-OLD GI, dressed in the uniform of the National Socialist White People's Party, a Neo-Nazi group, was arrested in Washington D.C. July 30 after he handcuffed himself to the fence in front of the German Embassy.

Pvt Jimmy L. Clendennen, 23. was arrested by Armed Forces police officers after it was disovered that he was AWOL from Ft Lewis, Wash. Executive Pro-tection Service police had cut him from the fence, and Secret Ser-vice agents questioned him before he was turned over to MPs for arrest.

Clendennen was in Washi ton to attempt to meet with the German Ambassador to the United States. He said he wanted charges dropped against Ger-man nationals suspected of being members of a group called the German National Socialist Battle German National Socialist Battle Group, an illegal national social-ist group in West Germany. If they were not dropped, he demanded that he be extradited to West Germany to stand trial with them because he was also a "suspected" of membership while e was stationed in Germany. He said that while in Germany

in February 1973, "I was inform-ed by US Army Military Intelligence that I was suspected of illegal activity in an illegal organiza-tion by the Federal Republic of Germany. The name of the alleg-Germany. The name of the alleg-ed illegal organization was the German National Socialist Battle Group." Those agents were with the 66th MI Group, Det. C, Stutt-gart, he stated. Twelve German nationals are also suspects and are awaiting trial in West Ger-many for their activities many for their activities.

"I then refused to make any statements and signed several forms acknowledging that I had been informed of the accusations against me," he said. Clendennen d at this time been stationed in

West Germany for 12 months and was on duty with the 3rd Bri-gade, 1st Infantry Div FWD at Cooke Barracks, Goeppingen. He said, "On March 21, 1973,

the U.S. Army summarily terthe U.S. Army summarily ter-minated my tour of duty in the Federal Republic of Germany, transported me back to the U.S. and ordered me to my present place of duty at Ft Lewis, Wash-ington." He is not now facing trial by military or West German courts for the alleged illegal acti-vity. He strend that bis tour in vity. He stated that his tour in Germany was shortened because he "had embarrassed the U.S."

Clendennen, who appeared well-rehearsed for the press briefing, was flanked by Matt Koehl, Commander of the National Socialist White People's Party, whose national headquarters are in Arlington, Va. where the press conference took place. Clenden-nen stayed at the headquarters while in Washington and Koehl was with him in front of the Ger-man Embassy. Koehl, however, was not arrested.

Kochl would not tell reporters the exact membership and total number of his supporters of his party in the United States. The official party paper White Power does state that there are 16 re-gional offices in the U.S. and Canada. Koeh' said that the NSWPP was a member of the World Union of National Socialists.

That organization, of which Clendennen is a member, has had a violent history since it was founded in 1960. Six years ago – on Aug. 25, 1967 – it's founder George Lincoln Rockwell was gunned down by a past party lieutenant in front of a laundromat in suburban Virginia. The party has in the past appeared in force at eace demonstrations, Jewish Defense League activities, and civil rights marches, and caused, or been the cause of, violent confrontation.

The National Socialist White People's Party is not listed by the Attorney General's Office as being a subversive organization.

According to Koehl, beside a nominal membership fee, the requirements for membership are strict. He did not elaborate. He said that ten percent of an unmarried member's income should be donated to the party.

Clendennen before he left Ft Lewis Saturday morning left a note saying:

"In an hour when a national body is visibly collapsing and to all appearances is exposed to the greatest oppression obedience and fulfillment of duty toward the system is pure toward the system is pure insanity."

Clendennen is 23, the young-est of three children, born and reared in Texas and has completed two years of a threeyear enlistment. He joined the Army to "go to Germany and tour Europe." He went to basic at tour Europe." He went to basic at Ft Dix, N.J., AITd at Ft Jackson (Light Infantry Weapons, Rifleman), and then went to Ger-many. He first joined the NSWPP in Texas sometime in April 1970. He does not plan to make the Army bis career and will leave when his three year hitch is up

While at Ft Lewis, Clendennen has in the past, and will in the fu-ture, recruit for the NSWPP. He said that he has recruited at least six active supporters so far. He said that he has been suspected by his commanding officer of illegal distribution of White Supremist literature but that there was insufficient evidence to take cri-minal action. He has in the past actively attempted to recruit his mily as well. He left Ft Lewis last Saturday family

on a weekend pass which lapsed 5:30 a.m. Monday. He was de-tained at the Washington Navy Yard where he was questioned by Military Intelligence agents, transferred to Ft Myer, and issued a provisional pass and tra-vel voucher to return to Ft Lewis. He said, "I will go to Germany at the time of the trial to demand

they charge me or drop the charges against the German na-tionals." When asked why he was a National Socialist, he said, "I love my race, more than myself."



#### Organizational Secretary Speaks To College Classes

On 17 July, recently appointed Organizational Secretary Richard Biederman spoke before three classes in sociology, German history and politics at New Jersey State College in Jersey City.

In his talk, Biederman emphasized the racial foundations of National Socialism. In making his point, he pointed out the window to nearby New York City just across the harbor and stated: "That is a good example of the extent of Jewish dominance over our moral, political and economic affairs in America."

Although there was the usual preponderance of Jews and Blacks in the classroom, no incidents occurred.

While in the area, Biederman met with local activists and discussed future plans for northern New Jersey. On the way back to National Headquarters, he also met with comrades in Philadelphia to discuss matters pertaining to local organization there.

#### Black Welfare Rally Picketed By Cincinnati ST

On 21 July, Cincinnati and Chillicothe comrades teamed up to picket a predominantly Black and Jewish anti-White rally at Cincinnati's downtown Fountain Square.

The rally supported by the NAACP and a group called the Neighborhood Regional Community Association was called to demand higher welfare payments. The ST contingent picketed for a full hour with signs that read, "Cut Federal Funds!" and "Race Mixing Stinks!" The Stormtroopers received no opposition other than a few catcalls from Black bystanders. As usual, the police and a good number of White people asked for Party leaflets and assured our men that they are with us.

#### **Buffalo Jews Respond To Party Activity**

In an effort to destroy National Socialism in Buffalo, the local Jewish community has combined efforts with area leftist and Communist groups. One of their favorite methods has been to put legal pressure on Party activists, resorting to good, old-fashioned Jewish terrorism when this fails. A good example of this was the two recent court cases involving an attempt to prevent our men from handing out Party literature and wearing the Party uniform in public. After winning both of these court cases, the Jews resorted to their other equally unsuccessful tactic when recently a large mob of members of "Youth Against War And Fascism" attempted to physically prevent our men from selling WHITE POWER newspapers on the streets of Buffalo. Needless to say our men held their ground, asserting that they were not about to be run off the streets.

### Buffalo Jews say reports exaggerate 'Nazi problem'

BUFFALO, N.Y. (JTA) - AJewish community spokesman has dismissed as exaggerated a local press report that Buffalo faces "a serious Nazi problem." The spokesman told reporters that while there had been "two or three cases" recently of Nazi activity, only a tiny number of people were involved and "the matter is well in the hand of Buffalo County and federal law enforcement authorities." The Buffalo Jewish Review, an English-Weekly published here, reported on June 29 that "a reliable federal government source" had informed it "that the problem of Nazi activity in the Buffalo area is more serious than the Jewish. community has beer led to believe." The paper said the source, who declined to be identified, was known to be well-informed. According to the paper, the source said the Buffalo police were not sufficiently aware of the situation because there was no public demand for them to keep up with it.

A statement minimizing the "Nazi problem" was issued by the chairmen of the Bufalo chapters of the B'nai B'rith Anti-Defamation League, the American Jewish Committee and the United Jewish Federation. They called on the community to refrain from "emotional reaction" in dealing with the problem.

the problem. Louis H. Glickman, executive director of the Upstate New York ADL, stated that there are no more than "four or five" people in Buffalo who engage in Nazi activity. He refused to name the people on grounds that publicity would only "spur them to further activity." Glickman said there were no more than three or four Nazi incidents during the last three months. In one case a group paraded with a swastika in front of a Jewish-owned supermarket and in front of a school. In other cases, persons passed out leaflets of the National Socialist White Peoples Party.

The source cited by the Jewish Review claimed that the local Nazi group "has dozens of adherents" and "has a camp in the Buffalo area." Glickman maintained that there was no such camp and that this fact "was confirmed by the police."

Party. A spokesman for the group also announced Friday they have asked Erie County Executive Edward V. Regan and Buffalo Mayor Stanley M. Makowski to take action to prohibit the Nazi Party members from distributing their literature.

The spokesman also complained because Buffalo police failed to arrest Nazi Party members after they became involved in a fight with members of Youth Against War and Fascism last Saturday.

#### **Final Notes On The Congress**

**REGISTRATION:** Congress registration will begin at noon, Friday, 31 August, in the Party White Power bus, which will be located in the 10000 block of Lorain Avenue in Cleveland. Registration will run continuously around the clock until 10 a.m., Saturday, 1 September. Any delegate who cannot register before that time should notify National Headquarters immediately. All persons planning to attend the Congress should return their registration cards by 29 August, along with any unpaid pledges or dues. All delegates must be in good standing to attend the Congress. If there are any questions on your status, please contact the Party Membership Secretary immediately.

APPEARANCE: Attending a National Socialist Congress is a privilege, not a right. That privilege requires that all delegates adhere to certain basic National Socialist standards relating to appearance and dress, as well as conduct and attitude. Accordingly, the following items are to be noted:

Hair length – All male delegates must have proper haircuts. This means that hair is to be no more than four inches on top, evenly tapered off on the sides and back, with sideburns not extending below the lower opening of the ear. Under no circumstances is the hair to touch the ear or collar.

Mustaches – Mustaches must be neatly trimmed, and are not to extend over the lip or below the corner of the mouth. All male delegates are otherwise to be clean-shaven, although an exception may be made in the case of elderly delegates with well-groomed beards.

Male dress – All delegates taking part in the public march and rally should be attired in the basic ST uniform (khaki shirt, black  $3\frac{1}{2}$ " cloth tie, black  $1\frac{3}{4}$ " belt, Swastika armband and black footwear-preferably combat boots). White crash helmets of standard ST type are desired, but not absolutely mandatory.

At the Congress site, only full Party Members, full NSYM members, and \*regular members of the ST are to wear the brown shirt. All other male delegates (including Official Supporters and Probationary Members) are to wear ordinary shirt and tie. Suit coat is optional. No levis, bellbottoms, leather jackets, sandals or freak or garish attire will be allowed for delegates. Similarly, no German military paraphernalia will be permitted to be worn.

\*A regular member of the ST is anyone who has submitted an ST application to National Headquarters and who participates regularly—on either an active or reserve basis—with a local ST unit.

Female dress – Women delegates should wear a dress or skirt and blouse in good taste. Miniskirts (anything over 3" above the knee), "hot-pants", shorts or slacks are not proper for this occasion and will not be allowed.

DUAL MEMBERSHIP: The Congress itself (not including the public march and rally) is an INTERNAL event of our Movement. Only those who are committed to it above all other movements will be admitted. So there won't be any misunderstanding later, let it be known in unmistakable terms that no one who is a member of any political party or any group claiming to represent the White man, – other than the World Union of National Socialists, the National Socialist White People's Party, the National Socialist Youth Movement and the Stormtroops—will be admitted as a delegate to this Congress. That privilege is reserved for those who give their sole loyalty to the one true Cause of Adolf Hitler and Lincoln Rockwell.
