## **Response to Appeal Is Overwhelming**

In mid-July the Party was faced with a completely unexpected "final-notice-before-seizure" demand because of taxes owed by the Party. These taxes were owed because of the actions of a certain individual who was incompetent and stole all tax records when he left the Party a few years ago.

The IRS disregarded giving the Party any preliminary notice of these due taxes and only allowed us two weeks to come up with a very large figure.

Faced with the possibility of having National Headquarters seized, Commander Koehl immediately called upon all supporters and members of the Movement in an appeal mailed out only one week before the deadline.

The response was overwhelming! The National Headquarters telephone was flooded with calls from all over North America from people pledging their support. Within days, the appeal had raised the necessary money to pay IRS off. Even after the enormous debt was paid, appeal response continued to come into National Headquarters for weeks.

Although most individuals gave 100-percent to the appeal, National Headquarters did receive one response that said: "Run the banner out of Arlington!" it was signed, "A certain individual who tried unsuccessfully to take over the Party." (!)

Not only was the Party able to take care of a completely unexpected expense but was able to raise enough funds to enable the Movement to undertake some very important new projects.

This is a good example of how National Socialist determination and will to victory can turn a potential catastrophe into an overwhelming success.

## The Army's neo-Nazi ret-duty aft GI Nazi back on duty

### GI Nazi back on duty

### AWOL stint

FT LEWIS, Wash.

THE ARMY'S vociferous neo-Nazi is back on duty following a brief two-day AWOL stint that resulted in an Article 15.

Pfc Jimmy L. Clendennen, 23, was prised loose from a fence in front of the German Embassy in Washington, D.C., last July 30, where he had had handcuffed himself to protest the arrests of several political colleagues in West Germany.

Clendennen, an active member of the National Socialist

White People's Party — a group founded by George Lincoln Rockwell and once known as the American Nazi Party — was turned over to Armed Forces police in Washington when it was discovered that he was a day overdue on a weekend pass from Ft Lewis, Wash.

Clendennen, who had been transferred out of West Germany at the request of German authorities for his association with neo-Nazi political groups which are illegal there, had demanded to see the German Am-

bassador to ask for the release of his former political comrades.

Instead, the young Texan white supremacist was cut loose from the fence and sent back to Ft Lewis, where he accepted an Article 15 for his AWOL and was sentenced to forfeiture of \$50 pay, seven days extra duty, and a suspended reduction to Pvt E-1.

Ft Lewis officials say Clendennen faces no additional disciplinary or administrative actions for his political activities there.

## Seattle National Socialists Demonstrate for Fort Lewis GI

On 3 August, nine uniformed National Socialists appeared on the grounds of Fort Lewis, Wash., to distribute White Power newspapers and other Party literature to interested bystanders and GIs.

The National Socialist contingent appeared on the post in early evening prepared to prove that the NSWPP had a right to reach American GIs with the White Power message of the Party, in defiance of Fort Lewis officials, who had earlier stated that National Socialist literature and ideas would not be allowed on base.

The contingent stayed one and a half hours and was able to flood all major parking lots with NS literature.

The highly successful demonstration was held on behalf of Army Private Jimmy Clendennen, who at that time was confined to barracks at Fort Lewis for an earlier demonstration in Washington, D.C., in which he protested the imprisonment of National Socialist comrades in Germany. ## GI Comrade Fined and Demoted for Protest Activity

On 10 August, Comrade Jimmy Clendennen, who is in the U.S. Army stationed at Fort Lewis, Wash., was fined \$50, given seven days extra duty and reduced to the rank of Private E-1. This action was taken against him after he swore that he would continue his protests until some action was taken by the West German government to release men suspected of National Socialist activity in that country. ## National Socialists Hit the Airwaves in Cleveland

On 10 August, local Cleveland Organizer Casey Kalemba, along with Party Member Douglas Flagg, appeared on a three-hour long radio, call-in program.

The program, the "Alan Hirsch Show" on Station WERE, lasted from 12 midnight to 3 a.m. In addition to the two moderators the station felt it necessary to have three Jew "advisors" on the program.

From the very beginning the completely non-Aryan opposition attempted to dominate the show with horror stories about gas-chambers, concentration camps and the mythical Six Million. Every attempt on the part of Kalemba and Flagg to steer the conversation towards the issues of the present was only met with more of the same old World War II hysteria propaganda.

That attempt on the part of the Jews to turn the Party philosophy into one big joke only backfired in the end when Kalemba and Flagg were able to point out the Jews' inability to argue point by point the racial and economic issues of the day.

## St. Louis Area Comrades Increase Activity

In recent weeks Party comrades in the St. Louis area headed by local organizer Richard Patton have greatly increased their activities. This increase has mainly taken the form of distributions of large amounts of White Power newspapers along with other Party literature to the public.

The main goal of the St. Louis unit is to get a White Power newspaper into the hands of every White person in that area. The small clipping reproduced on the right is an added dividend that can be achieved through regular literature distributions.

On 11 August, St. Louis area comrades conducted an anti-pornography picket outside of a well-known smut shop in downtown St. Louis. The ST picket-

## Nazis return

### Pass out hate leaflets, leave quickly after Chief's chat

Four uniformed American Nazis were on the corner of Main and Morrison briefly Saturday afternoon. They passed out hate literature.

On July 7, six showed up and stayed longer. The paper the four were passing out Saturday gave a Fairview Heights address as the St. Louis headquarters of their party.

They stayed only a few minutes. Police Chief Paul Cigliana was notified and talked to them. "A woman came in — she was indignant," the Chief said. "We hear about things like this pretty fast."

Cigliana said he did not exactly tell them to leave. He told the Herald he has no authority to require anyone not to distribute leaflets, despite the risk that appearance of such literature might inflame a backlash. He said as long as people are orderly and courteous he can do nothing.

He had previously told the Herald that prior to a visit here two weeks ago the group called in advance.

The literature, replete with swastikas, quoted Hitler, urged release of Rudolph Hess, boasted of gang beatings of minority races, and repeated racial slurs in many contexts.



## Advocates 'white power'

# 'Propaganda' wave hits area

Mimeographed sheets, issued by the National Socialist White People's Party, advocating deportation of blacks, hatred for Jewish people and communists and threatening violence against school administrators and Supreme Court justices, have been handed out and mailed to residents in the Libertyville-Mundelein area.

The "white supremacist" literature has been reported in a Libertyville discount store and several restaurants and grocery stores. Leaflets are also reported to have been distributed to area residents through the mail.

A number of complaints have been received by Libertyville and Mundelein police departments and by both post offices in the past six months in which the literature has reportedly been distributed. Both Libertyville and Mundelein police departments say they have no idea

what groups or individuals have been distributing the leaflets in the immediate area.

Donald Borgwardt, chairman of Libertyville's Human Relations Commission told The Independent-Register that he encouraged all people who come in contact with the extremist literature to "just throw it away and then, urge all others to do the same."

"I will be contacting all members of the Human Relations Commission and we will be studying the problem. The commission, however, really can't do any more than issue a statement stating our position concerning the literature," he concluded.

The literature bears the name of the "National Socialist White People's Party", with headquarters in Virginia. A party official, Clifford Ward, contacted by The Independent-Register in Virginia, said: "Our propaganda is designed to influence people in the strongest

possible way.

"When times become critical, and I must say that they are not yet revolutionary, our literature will inspire people to defend our race, our people and our honor unto death."

Ward said that the NSWPP was founded by "Commander George Rockwell" in 1967, when he formed the group from the American Nazi Party. "We are at present a small revolutionary party though I can tell you that we have units nationwide."

When asked for a membership figure, Ward hesitated a minute, then said deliberately and slowly, "I am indeed sorry. But we can release no such figures. We must ensure our members' safety."

The appearance of the literature has outraged several citizens.

Pat McMullan, a Mundelein resident, found

ed in full uniform for almost an hour, bringing to the attention of the public our opposition to this Jew-led filth. Though the activity was ignored in the local papers, our comrades did receive verbal support from the police who were on hand.

## Ideas on Spreading National Socialism

Instead of trying to advertise in large metropolitan papers which commonly refuse space, the Party has had success with advertisements in smaller local newspapers that are usually read by only White people. These smaller local papers usually will not turn down Party ads, and their readers are generally much more concerned about such things as keeping their neighborhoods White, than many readers of large metropolitan newspapers.

pamphlets last week bearing the name of the NSWPP inserted in the door handle of his car in a Jewel Food Store parking lot.

McMullan came to the Mundelein village board meeting where he protested the distribution of "hate" literature within the village. He then asked the board if there was an ordinance to prevent it.

Village attorney Charles Marino answered that the Supreme Court has upheld the first constitutional amendment guaranteeing freedom of speech but added that there existed ordinances prohibiting "littering" of streets. No further action was taken.

The ultra-right wing, swastika-stamped literature prompted McMullan to state emphatically, "I remember the swastika very well. We fought this rottenness in this country back in the 40s."

A sampling of NSWPP literature yields such comments as, "... should we do some killing? Should we cut off, root and branch, the satanic Jews and all their lackies who are stirring up the niggers against us?"

Another flyer reads, "There might be school buses going up in smoke all over the country. There might be shotgun blasts into the guts of 'mixmaster' principals and superintendents. There might even be hand grenades lobbed into the smelly chambers of the Supreme Court as the nine old swine go through their obscene legal hocuspocus."

Lt. Arthur Glitz of the Mundelein Police department said, "I have no idea who is handing out the circulars. I do know that a group operating under about six different names all advocate the same hatred of Jews, communists, and blacks." He indicated that the common denominator is the swastika insignia which appears on most of the literature.

Sgt. Tom Kerwin of the Libertyville Police Department indicated there has been only one complaint on the printed material. "There is really nothing we can do about it, Kerwin said." Distributors of the leaflet violated no village statute.

Mundelein Postmaster John Ryan indicated that he has received 12 complaints in the last year from residents receiving the material. He indicated that he had referred all complaints and sent accompanying material to postal inspection authorities in Chicago.

"We received a letter from the inspector saying that material inspected could not be classified in the category of pandering."

Ryan indicated that if the material had been declared "pandering," a temporary court injunction could be issued against the organization to prohibit it from mailing material.

An additional complication is that NWPP mail is generally first class, which, under the Sanctity of First Class Mail Law, cannot be inspected. "The only time that first class mail can be opened by anyone other than the addressee is by clerks in the dead letter department of the post department."

"The NSWPP people though, aren't the least bit shy about letting people know where the material came from," said Ryan. The best thing for someone to do who receives this mail is to mark it "refused" and return it to the post office, he said.

Libertyville Postmaster Wally Hanlon expressed concern over portions of the mailed material and said he thought that it might be "a little too strong."

Hanlon indicated that he was sending all such material that he had received to Chicago for review by postal authorities.

"You know, it's strange," he added, "but mail like this seems to come in waves. All of the sudden you will have a flood of material coming into an area."

Pending the unlikely eventuality of litigation against NSWPP mailing and leafleting practices, options open to an angered recipient of "white supremacist" material are: to mark envelopes bearing the return address of National Socialist White People's Party, Arlington, Virginia, "refused," and return them to the post office; to take literature which the recipient feels warrants further investigation to their postmaster and to destroy all handout material left on cars or in mail boxes.
