Los Angeles Headquarters Raided

On 23 August, the Los Angeles headquarters of the Party in the suburb of El Monte was raided by a conglomeration of so-called police known as the "Criminal Conspiracy Squad." This relatively new, federally sponsored conspiracy unit was made up of police from Los Angeles county and El Monte plus local government agencies.

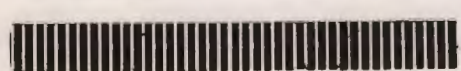
When the police gained entrance by using an arrest warrant for a local trooper who allegedly made threatening phone calls to area Jews, they completely disregarded their stated purpose and used it as an opportunity to search the headquarters. After entering they immediately placed everybody in sight under arrest, including a visitor who had stopped by to get some literature. In searching the entire building, they removed all the Party money, guns and literature they could find. Because a black jack was found on the premises, all occupants in the building were charged with the felony of having an illegal weapon. Fortunately, important Party records were kept elsewhere.

While the raid was in progress, one Party member called the local headquarters and was informed of the raid. He then called another member who lived only a few blocks away and told him to go to the headquarters and find out what was happening. After proceeding to the headquarters and finding the building completely abandoned, he entered to check it out—whereupon he was seized by police, who detained him and attempted to arrest him for burglary!

The following day, the three persons arrested were released after the Party posted several hundred dollars bond. One week later the authorities, after realizing they had no grounds for prosecution, dropped all charges. Also, all items taken in the raid were returned.

The raid shows the growing concern of System hacks and flunkies toward increased Party activity. The Party has long had good relations with the El Monte and other area police, and we are convinced that this will continue in the future. The so-called Criminal Conspiracy Squad should not be confused with the regular police, as the CCS is nothing more than a tool of the System specializing in intimidation of its political opposition.

Bridgeport WPM Upsets the System

Bridgeport Unit Leader Fred Sherwood reports that the System is very upset and concerned in New England over the recently installed White Power Message there. In an effort to get the local WPM disconnected, local System dupes have accused the Party of illegal use of the telephone lines to harass Jews and Blacks. Because of this, the local telephone co. threatened to discontinue service. Sherwood, who has contacted local lawyers has vowed that the WPM will stay on the air. Due to large distributions of WHITE POWER newspapers and other Party materials, Sherwood reports many requests for literature and information coming to the local post office box. He also reports that the WPM is running at 100 percent capacity. The two reproduced newspaper articles are indications of the continuing progress of the Movement in Connecticut. Army Private Confronts German Attorney General

In his continuing efforts to call attention to the plight of illegally harassed and imprisoned German comrades, Army Pvt. Jimmy Clendennen flew to Germany where on 21 August he confronted F.L. Bergstein, the West German state prosecutor in Duesseldorf.

Immediately upon his arrival in Duesseldorf, he went to the Ministry of Justice where he met for several hours with a detective from the criminal police division. After receiving no satisfactory reply, he then went to see the West German prosecutor, Bergstein, to demand that charges be dropped against the German National Socialists, or that charges be placed against himself. Bergstein refused to charge Clendennen but instead interrogated him for several hours concerning the case and threatened to have a judge order him to be a witness for the prosecution. Clendennen was then detained by the German police. The next day he was turned over to the military attache of the U.S. Consul in Duesseldorf. After questioning Clendennen for several hours, he was turned over to MPs who took him to Frankfurt, where he was again interrogated. After being imprisoned in Frankfurt for three days, he was flown by military police back to the United States where he vowed to continue his protest activity if the Bonn government continues its repressive policy against National Socialists.

National Socialists Give Sendoff to Seattle Race-mixer

On 29 August Seattle-area activists picketed a reception for outgoing local public school superintendent, Forbes Bottomly. Bottomly, who is known for his success in integrating public schools in Seattle, had quit his job to move to Boston to try his hand at forced integration there.

Bottomly, who arrived acting very pompous and arrogant, was shocked to see a flatbed truck pull up with two teams of National Socialists ready for action! The National Socialists then proceeded to hand out WHITE POWER newspapers and "Boating, Not Busing" leaflets to the crowd, and succeeded in getting some of the literature to Mr. Bottomly himself. Comrade Al Stone, who was leading the demonstration, was detained by Bottomly's private bodyguards, and turned over to police. Comrade Stone was immediately released and continued handing out literature.

After completely saturating the reception area plus all parking lots with literature, the contingent left. Other than a few remarks from some of the Jews and hippy types, the literature was well received. The address of the Seattle Unit is: Box 55007, Seattle, Wash. 98155.

'White People's Party' Passes Out Leaflets

Members of the National Socialist White People's party, dressed in the group's uniform of brown shirts with the swastika arm bands, equipped with helmets and carrying chemical disabling spray, distributed flyers and a newspaper put out by their organization yesterday for several hours on the green in front of McLevy Hall.

The three men, who were distributing the anti-black and anti-Jewish literature, said that no incidents occurred while they were there.

In a statement given yesterday, Stan Sherwood, the New England organizer for the national organization, said that no person associated with his group was responsible for the reported recent telephone calls to several Bridgeport blacks with unlisted numbers that told them to dial a number to find out about one of their relatives. The number they were told to call was for a recorded message from the National Socialist White People's party.

William Bush, president of the Bridgeport chapter of the National Association for the Advancement of Colored People (NAACP), said he contacted Police Supt. Joseph Walsh concerning how the unlisted numbers might have been taken from the telephone company. He also said he contacted the FBI to investi-

gate the calls, which might be termed "obscene or harassing."

Mr. Sherwood, a Bridgeport resident, suggested that the incident might be a "smear tactic" on the part of the National Association for the Advancement of Colored People (NAACP).

He added that anyone who might have taken the unlisted numbers from the telephone company was violating telephone company regulations and that his organization would never knowingly violate them.

Cops Probe Harassing Calls On Blacks' Unlisted Phones

Detectives today were investigating a complaint by William Bush, president of the Bridgeport area branch of the National Association for the Advancement of Colored People that at least four black residents with unlisted telephone numbers had been the victims of harassing telephone calls last night.

Supt. of Police Joseph A. Walsh said Mr. Bush complained that the black residents were called on their home telephones and were notified that someone in their family was "sick." They were instructed to call a number by the caller.

When they made the calls, they found the number was for a pre-recorded message from the National Socialist White People's party critical of school busing and commenting on other controversial racial issues, the police reported.

Supt. Walsh described the action of such callers who prey on innocent persons as "disgusting."

Capt. Anthony Fabrizi, Detective division commander, will meet with security officials at the Southern New England Telephone

company to determine if the company can find out how the unlisted telephone numbers were obtained.

Supt. Walsh said he will confer with John Ward, Second Circuit court chief prosecutor, on any violations of the criminal code which police uncover in the investigation.

Questions about Nazis

Tracy Press: Back in Feb. 23 of this year, there was an article discussing Nazi world plans. The information to some might seem quite convincing, but the damage could be as bad as the rest of the propaganda about the National Socialists.

But as far as the U.S. is concerned, I can more accurately answer the five questions asked better than anyone outside the organization.

The first question asked: Who pays lawyers who defend criminals? Answer: the defendant and his local chapter of the party, which pays their legal aid out of their hard-earned pay. If additional sums are needed, we rely on our legal aid fund comprised of donations from official supporters; there are no buried treasure or huge sums of post-war money. And most Nazi members accused of crimes are falsely accused, with the records to show.

Second question: Who organizes legal aid for war criminals in the USSR? Answer: To begin with, the Russian Revolution was backed, worked and controlled by Jews, who I'm sure you'll agree are not Nazis. So I don't think Nazis apply.

Third question: Who finances German publishers to specialize in neo-Nazi papers? Answer: Mostly themselves, and they're not always Germans like most would like you to think. They write neo-Nazi papers because they want to speak the truth and tell it to others and because of it are run out of business, harassed or attacked because of their beliefs by those who don't want the truth known.

Fourth question: Who finances meetings of former Nazis in Europe? Answer: None that we are aware of, for the World Union of National Socialists, which the NSWPP is an affiliate, is not aware of it, if those meetings even exist, for they are in no way in tact with us in Tracy, the U.S. or anywhere else we exist.

Fifth and final question: Who finances subversive activities of neo-Nazi groups?

Answer: No Nazi in any way is subversive (against law and order, decency, right, freedom and happiness). We stand for all these things and maybe that's why we're so supposedly hated by everyone. Our literature clearly shows our opposition to drugs, crime, etc.

If people would open their eyes, they could clearly see it. But the minute Nazi is mentioned, they close their eyes and minds and I wonder why they don't know.

Change of Command on West Coast

Effective 29 August, Marshal Clifford Ward was transferred from National Headquarters to El Monte, where he was placed in charge of the Los Angeles headquarters.

Mr. Ward succeeds Joseph Tommasi, who was relieved of command. In an unannounced visit to the El Monte headquarters, the Commander discovered flagrant violations of his orders and directives, which prompted him to take immediate action.

While recognizing Mr. Tomassi's past accomplishments on behalf of the Party, the Commander declared flatly that he will never tolerate a situation in which local leaders deliberately disregard Party policy and the command structure of the Movement. Those whom he has entrusted to give orders must themselves be able to take orders.

In further action, Mr. Tomassi's commission as Captain in the ST has been suspended and he has been placed on a two-months' leave, during which time he is to refrain from organizational activity of any kind, and at the end of which time he is to report directly to the Commander for further assignment.

In the meantime, all Southern California comrades are urged to give Marshal Ward all possible co-operation and assistance in his new responsibilities. Party Policy on the FBI

In recent months, innumerable Party comrades have been harassed and/or bribed by FBI agents in attempts to get them to become finks for the System. Some of our people have been a little confused as to how best to handle such encounters with federal NKVD operatives.

First of all, it should always be borne in mind that the National Socialist White People's Party is a completely legal and legitimate organization, and that if the Federal Bureau of Intimidation has to bother someone, it should not be us, but Communists, dope-pushers, Black terrorists as well as Republicans and Democrats who are guilty of Watergate-type conduct.

Because we are a completely legal and above-board operation, we don't have to answer to any System politician or their prostitute flunkies. It is they who will one day have to answer to us for collaborating against the White race at a time when it was fighting for its very existence on this earth.

So Party policy on the FBI is this: **DO NOT TALK TO THEM UNDER ANY CIRCUMSTANCE.** Instead, politely refer them to National Headquarters, and report any such approaches to Arlington immediately. If they have any legitimate question, they don't have to sneak around pestering our people or trying to intimidate them. They know where we're located, and they can submit their questions to us directly.

IMPORTANT: All comrades should remember that there is no law against refusing to talk to the FBI. But there is a U.S. statute making it a crime punishable by up to five years in jail and \$10,000 fine to give false, misleading or incomplete information to federal agents, whether officially, unofficially or in private conversation. If any agents decide to get you by claiming that you gave them false, misleading or incomplete information—you're in trouble! The best way to avoid such a predicament is to simply refuse to discuss anything with them—not even the time of day.

Some Guidelines as to Selling the Party Newspaper

Issue No. 44 October-'73 of WHITE POWER is off the press and in the mail to all subscribers.

Apart from the facts and information Members and supporters get from WHITE POWER, they can earn extra money and make new contacts selling the Party newspaper. Each and every National Socialist should make it his personal responsibility to sell (and not merely 'distribute' or pass out) a certain bulk quantity each month. These can be sold on weekends door-to-door, at shopping centers, and especially can be hawked on busy street corners in large quantities in a short afternoon.

Remember, WHITE POWER is an effective and complete propaganda kit in itself. It is unsurpassed in quality, and is the only effective alternative to the lie-papers put out by the rotten Communist-Capitalist system destroying America and our race. And this timely organ is put to the best possible use and advantage when sold, rather than given away, since the person who's willing to part with 25¢ to find out what we have to say is certain to be more receptive than an individual who just takes a copy to be polite. In fact, it is the responsibility of every National Socialist to make our message known to the growing multitudes of racial comrades "turned off" to the lies, treason, and genocide of the Judeo-liberal system.

In order to make the circulation of WHITE POWER wider than ever, the Party is prepared to ship Members and Official Supporters in good standing any reasonable number of newspapers on consignment for sales in their cities each month at press time. All Party comrades requesting this procedure should always pay the bulk rate and postage charges (10 percent) each month before the next shipment is made. Consignment shipping of the Party newspaper will eliminate the impasse of individuals who 'can't afford' to order bulk quantities for their communities. Those who do not have funds immediately available for large purchases can receive shipments and pay for them after they have sold the papers on the streets and door-to-door. It will also be possible for them to make a small profit for either sustaining their own expenses, making a needed contribution to the Party, or channeling their funds to meet the expanding needs of their local unit.

Of course, street sales do involve a certain amount of risk. But the same risk doesn't seem to frighten Black Panthers, who are **REQUIRED** to sell 50 copies of their newspaper **EACH WEEK** just to retain their membership. Nor is the risk too great for members of the Socialist Worker's Party, who sold **TEN THOUSAND** copies of their June 1 "Militant" on the streets. So is the risk too great for us National Socialists?

Any individual in a probationary status (Probationary Member, NSYM, ST) can't afford under any circumstances to be a slacker in this activity—nor can anyone who wishes to retain membership in the Party, NSYM or ST. Don't drag your feet! Order bulk quantities for street sales each month, starting today! Bulk order rates are: 10 copies for \$1.50, 100 copies for \$10, 500 copies for \$35, 1000 copies for \$55. On the orders of 500 copies or more there is a shipping charge on delivery.

All comrades are urged to continue their distributions of free WHITE POWER newspaper in the future as they have done in the past, though they should make a point to sell a certain number every month.
