Northern and Southern California Surge Ahead

On 6 October, over twenty-five activists from Northern California demonstrated in San Francisco. In use throughout the full day of demonstrating was the army truck owned by the Tracy unit, which was properly bedecked with White Power signs. The truck, loaded with troops, was driven to the USSR consulate and parked in front while local leader Allen Vincent attempted to present a local **consul** official with a letter demanding the release of imprisoned comrade Rudolf Hess. After reading the statement, the **Consul** General refused to accept it.

Throughout the rest of the day the truck was driven to various street corners in downtown San Francisco, where White Power newspapers were sold and distributed to interested bystanders. The troopers completed their day of activity by presenting themselves at local TV stations.

On 6 October, five teams of ST men held a double picket in Los Angeles by demonstrating against both the Communists and Capitalists. First the troopers picketed the Pacific Security Bank on Wilshire Blvd. in downtown Los Angeles, to prove to the public that we are against Big Money interests. After picketing a short while, the troopers proceeded on foot to the Progressive Bookstore located a couple of blocks away. On the way, they passed a group of about fifteen members of the JDL. As the last trooper in line passed the JDL, he was jumped—which precipitated a general melee. In the fray, masochistic JDL Westcoast Coordinator Irv Rubin was severely mauled by the troopers for the fifth time in two years. Two other Jews were so severely injured that they required hospitalization. A total of 10 Jews were arrested by police, for their attack on the National Socialists. Later two comrades, TL Thomas Knight and Trooper Mickey Wakefield were arrested on a trumped-up charge by JDL members. The only injuries suffered by the Stormtroopers in the incident were a few sore and bruised knuckles.

Later on the same day, KABC-TV carried extensive news coverage of the day's events. There was also considerable coverage on radio and in two local newspapers.



Organizational Secretary Appears on Radio Stations

On 11 October, Organizational Secretary Dick Biederman appeared for three hours on the Dennis Richards call-in program on radio station WLMD in Laurel, Md. The program was a result of several days of discussion concerning recent Boston incidents in which a number of White people were killed by Blacks. Richards, who is a super-liberal, attempted to defend the actions of these Blacks by saying that it was a result of the way White men have treated Blacks over the years. A number of callers, who were disgusted at this incredible attitude, stated their sympathies with the NSWPP. Richards then issued a challenge for a Party speaker to come on the air and debate with him concerning the pro-White stand of the Party. Richards attempted to ridicule the Party, urging that it not be taken too seriously. Biederman thoroughly thwarted this by strongly defending White interests; he stated that this is a White man's country built by Whites for Whites. Violent Clash Erupts Between Nazis, Jewish Defense League

LOS ANGELES (CNS) — Several demonstrators were taken into custody — but no charges were filed — following a violent clash Saturday between members of the Jewish Defense League and the National Socialist White People's Party.

Police said two members of the JDL were taken to Queen of Angels Hospital suffering from contusions and abrasions. They were released following treatment.

Officers at Rampart Division Police Station said 10 of the demonstrators were taken into custody following the fight. The Nazis were protesting at the Progressive Bookstore on W. 6th St.

Authorities said however, that none of the participants were being booked because neither side expressed a desire to prosecute.

Administrative reports were taken on those held, police said, in case the City Attorney's Office decides to go ahead with disturbing the peace complaints.

About 30 uniformed and helmeted members of the Nazi group marched on the book-

store, outlet for the Progressive Labor Party, carrying a Nazi and American flag.

Clifford Ward, identified as a "group leader captain," said the demonstration was being held to expose what he termed "the nature of communism, which is Jewish."

A battle between the Jewish Defense League and the National Socialist White People's Party resulted in minor injuries to two persons who were struck by sticks and placards, police said. The incident occurred when the two picketing groups met outside the Progressive Bookstore, at 1506 W. 7th St. Officers said they intend to seek disturbing the peace complaints against seven JDL members, who refused to disperse when so ordered.

Nazis, JDL Members Picket, Scuffle

LOS ANGELES (UPI) — A scuffle broke out yesterday between demonstrating members of the Jewish Defense League and the American Nazi Party while the two groups picketed one another outside a downtown bookstore.

Twenty members of the Nazi protest arrived first to picket the Progressive Labor Party bookstore and were followed, in a counter-demonstration, by a similar number of JDL members.

On 14 October, GL Biederman, along with North Carolina comrade Frank Braswell, appeared on the hour-long "Feedback" program on radio station WTOB in Winston-Salem. The program, which was heard from 9 to 10 p.m., reached a cross section of North Carolinians as many Whites and even some Blacks sympathetic to the Party's racial separation program called in. During the entire program only two anti-Party calls came in, both from self-identified Jews.

The article reproduced on the fourth page is the result of Mr. Braswell's efforts to organize in Western North Carolina.

Army Comrade Court-Martialed For National Socialist Activities

On 11 October, Army Private Jimmy Clendennen was brought before a summary court-martial in Ft. Lewis, Wash. on a charge of demonstrating in a military uniform.

This stemmed from a demonstration in front of the German Embassy last July in which Clendennen was taken into custody by the local police and turned over to the military police. (For details, see Bulletin No. 143) Commander Koehl was present for the trial to testify on behalf of Private Clendennen. He stated in his testimony that Clendennen had attempted to quietly give a statement to the German ambassador in Washington and that only after they were refused permission to see him, did Clendennen handcuff himself to the front door. Despite Commander Koehl's testimony, he was found guilty after a short three-hour trial, and was sentenced to 25 days at hard labor plus was fined \$150. After serving six days Clendennen was discharged from the service and is presently on staff at National Headquarters.

While in the area, Commander Koehl met with local Seattle-Tacoma Supporters and helped lay plans for future activities in the great Northwest.

Southern Ohio Comrades Arrested

On 2 October, Party comrades James Mason and Gregory Hurles of Chillicothe were arrested on trumped-up charges of assault on a group of Black youths. These arrests are part of an attempt by the city government of Chillicothe to stop National Socialist activity in that Southern Ohio city. Comrades Mason and Hurles recently have been distributing thousands of pieces of literature and after refusing an order by city officials to cease and desist they were arrested on these frame-up charges. The mayor earlier had been overheard saying that he would stop the National Socialists by whatever means he found necessary. Mr. Mason was released with his own funds, while Mr. Hurles appealed to National Headquarters and was bailed out the same day. Word on their trial will be forthcoming in a future issue of NS Bulletin.

October White Power Newspaper Sold Out!

For the first time in the Party's history the entire press run of the Party's newspaper "White Power" has been sold out. Within three weeks of coming off the press the entire issue had been sold, and all incoming orders were substituted with the September issue. This completely unexpected sellout is the result of a dramatic rise in subscriptions and also is largely due to the fact that bulk orders by local units has risen sharply, with most units receiving five hundred copies every month. To insure that there will be a good supply of White Power newspapers on hand the November press run will be increased by about 50% over that of October.

The L.A. unit has recently added a second unit to handle the overload of callers.

Congresswoman Chisholm gave us a political eye-opener Friday

Several years ago, a professor on the campus of Kennett Square planned to protest the lecture by Congresswoman Shirley Chisholm. James Schaefer was able to make advanced preparation to avoid or deter any counter-demonstration. No incidents were reported on Friday evening.

Four demonstrators from the National Socialist White Supremacy Party, also known as the Neo-Nazis, were on hand at the school at about 7 p.m. Involved in preventative measures were the Kennett Square police, Avondale State Police troopers and others.

Chief Schaefer was pleased with the response of the audience attending the Hadley Memorial Fund lecture commending on their restraint in the face of a provocative demonstration and their respect for the constitutional rights of others to freedom of speech.

The demonstrators showed signs with swastikas which proclaimed "White Power", "Boating not Busing" and "Free Gas and Matches all Commies".

One questioner asked her if she noticed the Nazi Party in America pickets which stood at ramrod attention at the foot of the school steps where the audience entered, holding signs insulting to the purpose of the institution where the lecture was held, as well as the intelligence of the persons attending it.

Black Congresswomen Picketed in Southeastern Pennsylvania

On 12 October, a team of local Stormtroops picketed outside of Kennett Square High School in Kennett Square, Pa. in opposition to Black Congresswomen Shirley Chisholm. The troopers stood silently at the front entrance as Chisholm and all the "respectable" liberals entered the building. In her speech Chisholm did not ignore the National Socialists, she referred to them by saying that "they should be taken seriously as people laughed at Hitler in Germany."

The event was widely reported by the local media. Kennett Square is in Chester County midway between Wilmington, Del. and Philadelphia.

Tar Heel Nazi Biding His Time

YOU DON'T think of North Carolina as harboring Nazis. The word connotes political paranoia screamed from a swastika-draped podium, black jack-boots goose-stepping, and V-2s, and grisly names like Goebbels, and grim places like Belzec.

Driving through the abundantly peaceful green of the North Carolina mountains you cannot envision any of that late-late movie fodder existing in your own back yard. After all, Hitler is history, isn't he?

Not exactly. The Fuhrer's ideals are alive and well in the minds of North Carolina's several score members of the National Socialist White People's Party. And on an obscure gravel road that winds through the quiet hills a few miles west of Spruce Pine lives their chief, the state's mini-fuhrer, an affable Navy veteran who goes to work and mows his lawn and gets along with his neighbors—his neighbors?

Just around the corner lives novelist John Ehle, who is known in some circles less for his novels than for "The Free Men," his scathing report of Chapel Hill's racial turmoil in the 1960s.

And not a mile away in the other direction is the Penland School of Crafts, where potters, glassblowers, weavers — societal exotica of all ilk and ages—gather regularly to steep themselves in creative technology. They would howl with incredulous contempt at the suggestion that "No amount of imitation and aping will instill a creative or inventive instinct into the Negro, nor will education or sympathetic aid" (Maxim 13 of the National Socialist White People's Party's argument that the Negro is an inferior ape, or that "black and

yellow skins are signs of mental and spiritual inferiority and that no tinged race can create a civilization."

But Ehle, the craftsmen and the untinged patriots all coexist in peace on the mountain. Harry Golden might say that could happen Only in America.

* * *

Except for its idyllic location far beyond the Piedmont's noise and neon, the mini-fuhrer's house is the epitome of Middle America. It is (appropriately) white. The lawn is neat, the shrubs tended. A reasonably late model sedan stands in the driveway. In fact, the house is so typically suburban that, with one crucial difference, it is the virtual twin of its neighbor 100 feet away.

The crucial difference is Frank Lee Braswell.

Frank Braswell appears wearing black boots, black trousers and a T-shirt, smiling and effusively cordial. His living room is sunny and comfortable, and on the floor is a portable phonograph, and on the turntable is an album of Charles Lindbergh's speeches, ready to be played.

On the wall opposite is a framed photograph of the Navy cable-laying ship on which Braswell served as a damage controlman, and beneath the picture are the five ribbons he earned in service.

Frank Braswell is tense. He is seldom noticed by the press, which he distrusts philosophically because the communications industry is, he believes, controlled by Jews. But he must present himself well, not only because national Nazi headquarters in Arlington, Va., will get wind of whatever is written about him, and he is trying to rise in the party's ranks; but also because he is trying

to swell those ranks in North Carolina, and good public relations is essential.

So Frank Braswell turns on his salesman's smile, which is a good one because he is a handsome, well-built man of 40 with a dark complexion and thick black eyebrows above intense brown eyes, and a virile blue swath of beard across his strong jaw.

* * *

"I used to drive a truck," says Frank Braswell, "and on these long hauls, across three countries, I found there wasn't any way a man could obey all the conflicting laws. The government is just harassing the trucking industry in order to control it. I mean, with weight limits and fuel permits and that kind of thing. There ain't no way you can obey all those laws — and the Highway Patrol, it's ridiculous. . . . Now, when a government starts to take control of communication and transportation, you know something's wrong."

Two years ago Frank Braswell went to Washington to ask questions. What he found, he says, shocked him: "This country was sold down the drain. . . . Roosevelt tried to provoke Germany into declaring war on America, only Hitler was too smart to take the bait." And it really bugs him that World War II was fought "to protect communism," now a mortal ideological enemy.

What Braswell interpreted as the avarice and callousness of high-level government bothered him profoundly; that, compounded with what he sees as the "nigger" and "Jew" problems, spurred his search for answers. He visited various right-wing organizations, among them the John Birch Society ("a joke"), and ended up with the Nazis: "All the other right-wing organizations only want to tear something down. We're the only one that's got something to

put back." (He bears an ironic childhood memory of buying war stamps in return for the privilege of shooting at Hitler's picture with a slingshot.)

The Nazis' plans for America involve deportation of American blacks to Liberia and removal of Jews from power because they represent communism — "They can work, just like you and me," says Frank Braswell, "just so they stay out of the countin' house."

When the cataclysm comes, says Braswell — that is, when the economy collapses under its own inflated weight and true famine strikes the nation — there will be widespread "shootin' and lootin'." Mayhem can be controlled only by a strong police force, which the Nazis plan to provide.

* * *

Braswell, who has given up truck-driving for a less time-consuming job in a Spruce Pine mineral processing plant, has behind him the weight of a large and innately terrifying organization.

"We don't give out figures on how large we are," says Braswell smoothly, "but I can give you the Jews' figure. They say we have about 16 million members and supporters. I'd say it might be a good deal larger than that. We're world wide and growing fast. We have members running for elected office in this country now."

Braswell will talk for two hours, apparently without tiring, about Nazism: about the sayings of that revered reactionary, "Col. Lindbergh"; and the real meaning of the "swastika," as he calls it; and his belief that the only accurate record of World War II is to be found in a book he refers to as "minecamp," a puzzling title until you suddenly realize that he is talking

about Hitler's autobiography, "Mein Kampf" (which was written in the 1920s); and the probability that although Hitler took over Germany with the loss of only 16 lives, the neo-Nazis will not capture America so painlessly. People will be killed, he says, and after the mop-up, one of the things that will happen will be nationalization of the banks, which will thenceforth loan money not for profitable interest but only for a sufficient service charge to keep operating. And the Jews won't be collecting the service charge, either.

* * *

Penland residents mention Frank Braswell with quiet amusement, possibly because his unsettling politics are camouflaged with some semblances of what the average community considers "normality": he is a Baptist and remains a registered Republican — although, he points out, voting is futile these days, since all candidates are put up by the same vested interest. Also, given its unfamiliar context, his patriotic philosophy is comfortingly familiar: "I love this country and I'm willing to die for it."

Behind him, beyond the driveway, the neighboring house is quiet in the midday sun. Its occupants are a Jewish family.

"We get along fine," says Frank Braswell with a brilliant smile. "We tolerate each other. We understand each other. They know we're out to stop them, and we know they're out to stop us. Of course, their way will take a little longer than ours."
