Commander Travels, Visits East, -West Coast

In the latter part of November, Commander Koehl was extremely busy as he traveled to the West Coast, visiting with local members and supporters and holding a record number of meetings. After arriving back at National Headquarters, he almost immediately departed on another trip - this time to Georgia and North Carolina. The Commander's itinerary went as follows:

On 16 November, the Commander started his West Coast trip by meeting with San Diego area members and supporters. In his speech, he discussed in-depth the energy crisis, its causes, and the advantages that the Party can reap from it. In concluding his address he pointed to the dire need for all Party activists to take advantage of this issue. He further stated that this is one of the first times in America's history that the public will be able to see for themselves the awesome consequences of Jewish power in

On 17 November, Commander Koehl led over two groups of Stormtroopers in a demonstration outside the Los Angeles federal building, demanding that the federal government drop all aid to the bandit state of Israel. Most of the troopers were transported to the demonstration site in the Tracy unit's army truck, where they displayed signs reading "Dump Israel," "No More Jew Wars," and "No More Troops For Israel." Only a handful of JDLers showed up. After seeing the large display of ST marching despite of a steady rain, they decided that it would be best for their health if they only watched.

Later on the same evening, the Commander addressed a packed meeting hall at the El Monte headquarters. He commended the unit on the increase in its overall activities in recent months as well as in the noticeable improvement in morale and physical appearance of the headquarters under Marshal Ward's leadership.

The Commander reminded the audience that the Party is a revolutionary political army built on dedication and discipline. He pointed out that every member of the Party should consider himself a political soldier subject to the same discipline and loyalty requirements of any army. After his formal speech he swore in a number of new troopers into the ST and issued the following awards:

TL Bruce Mathews — Wound Medal for injuries sustained on a Party paper sale on 15 Sept. 1973; TL John Ernst — Medal of Merit (posthumous) for bravery in a fight at an ST action on 6 Oct. 1973;

TL Harlan Stevens - Party Service Award for work done in his capacity as District Secretary of the Southern California District.

On 19 November, the Commander traveled to Phoenix where he met with local organizer Elton Hall. At a gathering of local Party people a film produced by the Los Angeles unit was sreeened, showing the 1973 Congress march and rally, as well as two recent demonstrations in L.A. and San Diego. After the showing Commander Koehl spoke to the group on the goals and objectives of the Party in the coming months. While in the area, he also helped lay plans with Mr. Hall for future activities in Phoenix.

The Commander was so impressed by the Los Angeles film, that it will probably be used for organizational purposes until the Party is able to produce a regular recruiting film.


On 21 November, Commander Koehl made his first Party trip to San Francisco. As in his previous stops, he met with area activists in a private meeting. He pointed out to the San Francisco unit members the opportunities that can be reaped from the oil crisis as he had mentioned to comrades in previous cities. At his meeting, the Tracy unit was also represented. Commander Koehl stated that he was very much impressed by the enthusiasm and drive displayed by the comrades from all over Northern California. Also while in the area he gave an interview for the San Francisco Chronicle.

On 27 November, the Commander was scheduled to debate a Black Panther at the University of Georgia in Athens. Because the Black did not show, the Commander unexpectedly had to change his presentation. He had originally planned to start off the debate by presenting the Panther with a boat ticket, but instead gave a short summary of the Party and then answered questions at length. The speech which was held in the university chapel drew a small (mainly due to a highly publicized Christmas parade) but very high quality audience.

On 28 November, the Commander met with National Socialist activists in the Atlanta area. At the meeting he received a report of activities on the local unit, and learned of plans to test an order by the Atlanta police department preventing the handing out of leaflets in a downtown section of the city. The Commander explained the Party's desire for good relations with local police departments, but at the same time it could not allow itself to be deprived of its fundamental rights of freedom of expression.

On 30 November, Commander Koehl traveled to Asheville, N.C., where he was interviewed on television station WLOS. The interview focused on the Party's stand in the energy crunch. For the first time thousands of White Carolinians were able to hear the Party's alternative to the fuel crisis. The Commander stated that America could be getting all the oil it needs tomorrow if it were willing to dump Israel and tell all the Zionist political prostitutes and their blackmailing Jewish masters where to go.

On 31 November, at the request of local people, Commander Koehl appeared at a White Power rally on the steps of city hall in Charlotte, N.C. In his speech he outlined the Party's overall purpose by explaining that this was a White man's country, built by Whites, and that the founding fathers expressed this when they set up a White government. Over the years, however, this power has been taken from the White majority and given to minorities. He went on to state that it was the purpose of the Party to foster a second American revolution and return the right of self-determination to the White majority.

St. Louis Comrades Appear on Campus Radio

On 19 November, Comrades Dennis Nix and Richard Patton were interviewed by radio station WSIE. Commentator Dennis Sullivan asked questions about the NSWPP and what the Party's stand was on such topics as the Mideast crisis, the race problem in America and Women's Lib. The station is on the Southern Illinois University campus. Tapes of the interviews were released to four neighboring stations.

On 27 November, St. Louis comrades set up a literature display table at Florissant Valley Community College. Many leaflets were distributed, as well as White Power newspapers and various pamphlets and booklets published by the Party. After a while the schools president demanded that the National Socialists leave "for their own safety" as Blacks were beginning to become irate at the display.

On 24 and 25 November, St. Louis comrades set up an information and NS Publications table at the nearby Edwardsville gun show. Throughout the two-day show, National Socialists sold White Power newspapers and books along with other Party materials. The display was quite well received and netted the local unit more than enough proceeds to cover its expenses.

Organizational Secretary Addresses College Students

On 14 November, Organizational Secretary Dick Biederman spoke before a special group of students at William & Mary College in Williamsburg, Va. The special group, known as "Project Plus," is a special study course designed to teach students to cope with so-called conflict and conflict resolutions.

After a preliminary discussion about the Party in small groups, the students got together in the auditorium to listen to Mr. Biederman speak on the topic of the "Total Concept of Government." After a 35-minute speech, questions were asked. Most students proved very open-minded and willing to listen to the Party's alternative to today's decadent System.

After the formal session was over, many students stayed for several hours and discussed the Party at great detail. The only incident occurred when Mr. Biederman was aptly describing the Party's concept of "community." As a majority of the students were showing their approval, a raving Jew jumped up and shouted, "Enough of this nonsense — what about the Six Million Jews?" At the same time another student stood up and yelled at the Jew to shut up and sit down.

On 16 November, Mr. Biederman traveled to Morgantown, W. Va., where he spoke before three history classes at West Virginia University. This time the topic was whether or not conditions similar to those which prevailed in Germany after World War One exist in America today. Biederman stated that though the actual conditions may be different, America is headed in the same general direction as Germany was in the '20s and early '30s. He explained that just as earlier in Europe, a situation of moral, social and racial decay prevailed in this country today and that Americans had lost the will and desire to combat Communism. Faced with this situation, he said that only National Socialism could save America. Though West Virginia University is rather liberal, Mr. Biederman was quite well received.

Tracy Unit Acquires White Power Message

On 16 November, a White Power Message was put on the air in Tracy. Local Leader Paul Raymond reported that the WPM, which is designed to serve a large portion of California's San Joaquin Valley, was running at full capacity after just two weeks of operation. The number of this new WPM is: (209) 835-3192.

Right now there are more WPM's on the air around the country than at any other time in the Party's history. This new achievement goes hand in hand with the great upsurge of Party leaflets and newspapers that are being gotten to the public, along with a great increase in Party activity in general. There is no method quite like the White Power Message for reaching the large numbers of people. In most areas of the country, the Party is at the mercy of the local media as to whether or not its message will be heard by the public. With a WPM, you have easier access to the public. Any comrades or probationary units that are interested in adding another White Power Message to the list of already existing units should write National Headquarters and request the information.

Nazi 'Hate Telephone' Held Legal

BRIDGEPORT — A Herald story about the local Nazi party which appeared last week has resulted in the Southern Telephone Company receiving several complaints.

But SNETCO says there is no way they can satisfy the complainants.

The story concerned hate messages recorded by the National Socialist White People's Party, which can be heard by anyone dialing 335-5961.

A spokesman for SNETCO said that some people have asked the telephone company to put a stop to the recordings.

"BU'T THERE is nothing we can do. The NSWPP is complying with all our regulations. As long as they don't use obscenities, they can say what they like. It's part of the 'freedom of speech' ruling.' said the spokesman.

The telephone company spokesman also pointed out that people who object to the recordings - which are two-minute long lectures on the party's viewpoint — need not listen to them.

"AFTER ALL, it's their choice whether to call the number or not. If the organization was doing the calling, then we could step in, but right now, it's all aboveboard and perfectly legal," he said.

He added that SNETCO does not screen content of messages and if the information given on the recordings is "factual" then the individual or group need not even identify themselves.

Investigation Under Way On 'Hate' Phone Messages

The chief prosecutor for Second Circuit court confirmed today that an investigation is being conducted into a complaint made by a New Haven-based Jewish civil liberties group which alleges an organization has been using a telephone recording to transmit racial hate messages.

Prosecutor John D. Ward said he has been contacted by Malcolm Webber of the B'nai B'rith Anti-Defamation league who has requested legal action against a Bridgeport organization which calls self the National Socialist White People's party.

The Bridgeport Police department, along with Public Ulities commission and Southern New England Telephone company officials are cooperating in the investigation, Mr. Ward noted.

The prosecutor said that Mr. Webber has requested action under the provisions of Section 53-37 of the state's General Statutes which reportedly prohibits the use of advertisements to ridicule or hold persons or groups up to contempt for their racial, religious or ethnic backgrounds.

Mr. Ward said that he had in hls possession transcripts of two recent messages of the material put out by the party. Mr. Webber confirmed that one message refers to "greasy Jews" and the other makes comments about "black cannibals."

Telephone company officials were unavailable this morning for comment in the matter.

AUTH ASKS BUSH RETRACT CHARGE

Accused of making a propaganda recording for a neo-Nazi group here, Drew Auth, the Socialist candidate for the Board of Education, last night demanded a public apology from William Bush, chairman of the Greater Bridgeport Chapter of the NAACP, who leveled the accusation this week.

Mr. Auth also called on the local NAACP leader to resign. "His attempt to label me a Nazl was hate mongering, the very activity in which he should never indulge," Mr. Auth said. "By this act he has done a disservice to the Negro community, the City of Bridgeport, to the NAACP and the Board of Education."

The Socialist candidate said he

The Socialist candidate said he contacted Police Supr. Joseph A, Walsh about the recording and learned the identity of the man who made it. Fift seems incomprehensible to me that Mr. Bush, in his position, does not have the same information."

Mr. Bush made the accusation during a candidate's debate at Hall-Neighborhood house Monday night, where Mr. Auth was appearing with several other School board contenders.

The NAACP head charged that Mr. Auth's voice was on a recorded telephone message paid for by the National Socialist White People's party. Mr. Auth immediately denied mailing the anti-black recording.

The candidate last hight called Mr. Bush's accusation "a scurrilous attack" adding, 'he has dealt's blow to the American political tradition of free open and rational debate."

System Opposition to Bridgeport WPM Continues

The telephone company in Bridgeport is presently been pressured by the System to stop the White Power Message recordings from being heard. In the forefront of the "complaints" against the WPM has been a Jewish civil liberties group based in New Haven and the B'nai B'rith Anti-Defamation League. The local public utilities commission and the telephone company have subtlely tried to appease the Jewish community to avoid a confrontation with them. The WPM is however still operating and getting its message over to the White com-

L.A. District Organizer Speaks at High Schools

Recently TL Martin Kerr, District Organizer for the Los Angeles area has been speaking at a number of high schools. On 15 November, Kerr spoke to a mostly Mexican and Black high school in La Puente. The White minority showed no opposition to the views put forward by Comrade Kerr.

On 19 November, Kerr spoke to 250 to 300 students at Corona Del Mar High School in that L.A. suburb. Most of the students and their parents present belong ed to a political science club. Because of the large number of Jew participants, most Whites were afraid to speak up.

On 29 November, Comrade Kerr spoke to a mostly White high school in Downey, Calif. Response was initially hostile, but gradually became favorable. On 5 December, Kerr addressed an all-White class at the same high school in Downey. This time the response was from nuetral to very favorable.

At present comrades in Los Angeles are arranging for similar appearances at other local high schools in the area.

Record Number of White Power Newspapers Again Sold Out!

In an absolutely unprecedented event, White Power newspapers sold out in December. This makes the third straight month that the Party's publication has completely sold out — this despite the fact that the December press run was 20% over that of November. Many comrades have taken advantage of the present fuel crisis by getting out more White Power newspapers which cover the subject.

All Party units and individual comrades are urged to order a large quantity of the January issue which will again cover the oil crisis and the causes behind it. The Middle East situation and the resulting oil shortage offers the Party an unprecedented opportunity to reach receptive Whites. NS Publications is increasing its press run to an adequate level, as no comrade should fear that because of the last three sellouts his order will not be filled.
