### Arlington Unit Pickets Anti-busing Reactionaries

Local Organizer Clifford Herrington led a two team picket-demonstration on the Capitol steps in Washington, D.C. on 19 March. Arriving in the Party's White Power bus, the ST and NSYM personnel disembarked and immediately ran several blocks down Constitution Avenue to get ahead of a huge anti-busing march which concluded at the Capitol. While waiting at the foot of the Cap-itol steps for the reactionary buffoons to arrive in their Revolutionary War costumes, a forty-man riot police contingent quickly formed a human wall in front of the ST/NSYM demonstrators, separating them from the cordoned-off area where the reactionary slime were to hold their rally. Local Organizer Herrington then moved the men off to an area on the Capitol steps several hundred yards away, but closer to the reactionary speaking platform. There the National Socialists picketed for half-an-hour, shouting, "WHITE POWER," the National Socialists picketed for half-an-hour, shouting, "WHITE POWI "Ban Forced Busing," and other slogans acknowledged by the reactionary speakers, who proved their spinelessness by condemning the National Socialists. Later, the ST/NSYM group moved back to its former position in front of the riot police and continued to picket and shout agitational slogans at the in-

Anti-busing demonstrators went back to Boston, Detroit, Louisville and Prince Georges County with few tangible results after more than two hours of marching and standing in the rain yesterday at the Washington

Monument and the Capitol. YESTERDAY'S demonstrators, numbering about 1,300 according to police but twice that number according to their leaders, were virtually all whites with the vast majority being from Boston.

Eight members of the National Socialist White Peoples party - formerly the American Nazi party appeared, marched in a circle and chanted "White Power." Capitol Police kept them away from the main body of demonstrators.

In this instance, Comrade Knight, who held a job at the Veterans' Hospital in San Diego, was compelled to leave with no substantiated reason as to why he was being fired. Comrade Knight later learned through acquaintances at the hospital the reason he was unexpectedly fired; he was 'guilty' of being affiliated with the NSWPP. Comrade Knight did not have the financial resources available to launch a protracted legal battle against the political discrimination and support his family for the interim as well, therefore he has disclosed plans to relocate his family and himself to Arlington, where he will join the National Headquarters Staff.

Although the outlook is dim for the Judeo-liberal system this summer, the outlook for the Party is conversely good, and all Party units throughout the Nation are now planning activities for the coming months.

One Party activity which has been consistently and profitably utilized by nearly every established Party unit has been the WHITE POWER newspaper sale.

With the return of favorable weather, more and more activists will be getting out into the streets to bring the word of National Socialism to their racial comrades through the Party's propaganda organ, WHITE POWER. Not only spreading the message of National Socialism to interested Whites, which is its primary function, this activity is the *only* self-supporting activity in which comrades can engage. Many units have discovered the real and tangible financial results regular paper sales can bring.

To utilize the outstanding potential in winning racial recruits which each issue of WHITE POWER contains, it *must* be gotten into the hands of visibly interested racial kinsmen — not randomly distributed over wide expanses of bourgeois suburbia. All ST personnel, both full and probationary, must present themselves as dedicated activists willing to stand on busy street corners *in uniform* for hours, if necessary, to sell the Party's newspaper.

Not distributing one hundred copies of WHITE POWER randomly, and forcing one or two dozen racial bretheren to part with their quarters, is more important than distributing *two* or *three* hundred copies randomly, and selling none at all. When sold in uniform on a busy street, just as many, possibly more, people will see *you* as would see several hundred randomly distributed copies, and if any of these are genuinely interested, they would take the time to buy one from you. In addition, a greater, longer lasting image is projected to the masses when introduced to the Party by seeing its smart ST in action rather than by finding a paper at their doorstep or under their windshield wipers. This applies as much to Party Members as to ST personnel and does not exclude those active Official Supporters.

This is not to discourage individual Supporters who have faithfully continued to clandestinely slip copies of WHITE POWER to friends and acquaintances, and who otherwise put out their share of WHITE POWERs. It is meant to *encourage* all means of reaching the people with the *best* revolutionary newspaper today, but reaching the most receptive people who proclaim their interest, and oftentimes concurrence with the National Socialist philosophy by walking up to you and saying, "I want one of your newspapers." Take the *IDEA* to the Racial Community!

### Los Angeles Unit Fights City Harassment

In another round in the ceaseless clashing of wills between the Los Angeles Unit and the City of El Monte, Comrades there report intensification of efforts of El Monte functionaries to oust the Party from its long held location there, resulting in this article reproduced here.

As a counterattack to the schemes of anti-Party elements who run El Monte, TL Martin Kerr, now District Organizer, lately conducted a one man WHITE POWER newspaper sale in El Monte. TL Kerr reports:

"The purpose of this action was to harass the City of El Monte by forcing them to fight a costly legal battle, which we are almost sure to win, and which will allow us to sell the Party paper in El Monte. At present, a \$20 a day vendor's permit must be purchased in order for someone to sell a newspaper here. Since WHITE POWER is a political paper, we feel this does not apply to us. We do not sell the paper to make a profit, but to spread our ideology."

The controversy revolves around a long-standing city requirement that all establish-

requirement that all establish-ments apply for a certificate of occupancy. The fee is \$10. Then, the city inspects the property for building, planning and fire code requirements. If there are violations, the city demands the building be brought un to standard brought up to standard. The city is insisting the Nazis

comply with the law and the Nazis don't like it ewart alleges that the city

is bowing to Jewish pressure. "They don't like the big swas-tika we have in front of our headquarters," he said.

Stewart said. "It would be too cumbersome to have 20 storm troopers fol-lowing me around." Stewart would not release membership figures for the E1 Monte-based Nazi unit.

"It won't take many of us to scare away all the El Moste shoppers," Stewart said.

TL Kerr was issued a citation by El Monte police for selling a newspaper without a license. He is now beginning the legal process of obtaining a public defender and setting up a jury trial.

Continuing the counterattack, District Leader Dan Stewart led a shopping tour of major El Monte department stores. Uniformed National Socialists, including ST, NSYM and NSWO, were divided into teams and sent to 'browse' through different stores. Their purpose was to cause apprehension on the part of store managers and to scare away non-White and anti-White customers, forcing Kosher merchants to put pressure on City officials to leave the Party alone.

The presence of the National Socialists in the various stores caused much consternation among store personnel who were unable to bar the activists from a public place.

EL MONTE - Police are investigating what they called a "pushing contest" between a member of the National Socialist White People's Party (Nazis) and an El Monte merchant, authorities reported Saturday.

Police said the incident involved Bruce Mathews, a Nazis member, and a merchant on the downtown mall.

Members of the Nazis reported that Mathews was attacked by a "Jewish" merchant with a lamp, but Police told The Tribune that the incident was no more than a little pushing by both men.

One Jew told a team led by TL Mathews to leave his store. When he refused, the Jew attacked TL Matthews and a fight broke out, in which 5 large creeps, armed with lamps and other furniture, battled the ST. No serious injuries resulted, although part of the Jew's store was wrecked.

These activities resulted in a large amount of publicity for the Party, including several newspaper articles and television coverage. The local TV coverage contained an interview with GL Stewart, an interview with El Monte's pro-wetback mayor, shots of the Headquarters building and scenes of the uniformed activists shopping.
