Arlington Unit Counter-Demonstrates Angela Davis

Last summer, a negress by the name of Jo Ann Little fatally stabbed a White jailer in Beaufort, N.C. in what the liberal press called a "sexual attack". Since then, she has been out on bail, touring the country drumming-up support for her defense, with the help of Communist-negress agitators like Angela Davis. On 31 May, a rally was held by these negroids in Lafayette Park across from the White House, in the hope that Jerry Ford would be intimidated into giving the homicidal negress a pardon.

The only opposition to this rally came from a contingent of ST/NSYM who demonstrated across the street from the park while the rally was in progress. The National Socialists stationed themselves in single-file formation along the sidewalk in plain view of the thousands of coons across the street. Shouting slogans "Gas Angela!", "Ship Those Niggers Back!" and "Angela - Communist Pig!" and carrying picket signs reading "Hang Jo Ann Little", "Gas Angela" and "White Power" along with a Hitler Youth Banner and a Party Banner, the contingent counter-demonstrated for over two hours. As the rally ended, the contingent marched back to their vehicles through down-town Washington, sparking violent reactions from the nigger-infested area.

As a result of the demonstration, local TV coverage included the contingent shouting slogans and marching away from the rally area.

Northern California Comrades Combine Forces

On 7 June, the combined forces of the Tracy Unit and activist elements from San Francisco met for a "Jobs Not Gooks!" demonstration in Redwood city, a predominately White suburb to the south of S.F. The 12-man strong ST group demonstrated with a huge "Jobs Not Gooks!" runner in front of the San Mateo county Hall of Justice for 90 minutes, after which they moved two blocks away to a busy intersection where they began selling WHITE POWER.

After many sales, police officers informed TL Vincent that selling the paper required a permit, whereupon TL Vincent decided simply to distribute the remainder of the papers to favorable White folk. Approximately an hour later, TL Vincent began speaking to a crowd which had gathered with a loudspeaker attached to a van used to transport unit activists. Estimating the excellent possibilities of the area, TL Vincent promised to return the following weekend. The next week, the Tracy Unit once again traveled to the S.F. area to fulfill their promise to return with the S.F. unit to Redwood City.

This time, as expected, some opposition was present, but was limited to a few brain-raped Whitemen, World War Two surplus,

who shouted at the Stormtroopers as they distributed literature, "I'll bet you never fought overseas!" to which TL Vincent replied that at least two of his men were Vietnam veterans, thus silencing the opposition. The next two hours were spent peacefully handing out literature and signing up new Supporters and subscribers.

The final combined activity of the month was an open presentation of National Socialism to students at Sacramento City College, where Party activists had arranged the use of a large SCC lecture hall. Having announced the presentation publicly beforehand, about half a dozen members of the Progressive Labor Party picketed outside the hall while comrade Rickey Cooper of Stockton and TL Vincent gave speeches on the Party to the assembled students. After about an hour and a half, the NS speakers with an ST/NSYM escort departed — with a large crowd of Marxist creeps close behind. With a campus security detachment present, however, no incidents occurred this time.

Tracy and Stockton area comrades have, in addition to the above activities, been actively engaged in promoting National Socialism in the San Joaquin valley with mass literature distributions and maintaining two White Power Message services, with an additional WPM in the planning stages for the city of Fresno. Chicago ST Visit Right-wing Rally

On 7 June, multitudes of right-wing groups led by Carl McIntire gathered in a downtown Chicago park for a traditionally uneventful right-wing "weep-in".

Under the command of Lt. Cedric Syrdahl, Stormtroopers from the city descended on the park and began selling issues of WHITE POWER to the misguided right-wingers who seemed impressed at what 'those awful Nazis' had to say.

At one point, Stormtrooper Robert Joyce attempted to give windbag McIntire a WHITE POWER paper, which he refused with a look on his face as if he had seen his own death warrant!

As McIntire tried fruitlessly to unite 'his' people (who were more interested in the National Socialists presence than hearing McIntire rattle-off "repeat after me five times: Down with communism") the Chicago Unit was busy making the people see that the only way to bring communism down is to build National Socialism up!

Out of the 1500 people present, only the ST group warranted the serious attention of the police. At least they knew who had the only *real* potential of doing anything. Throughout the entire day no incidents occurred.

National Socialist Youth Movement Activists Take To The Streets!

During the month of June, NSYM personnel throughout the nation were heavily engaged in selling the Party newspaper on the streets in full uniform and with Hitler Youth Banners.

In Arlington, NSYM under the leadership of NSYM National Secretary Jeff Palmer took to the streets of Fairfax County to sell WHITE POWER at a regularly visited target area adjacent to the largest shopping center in Virginia. On one sale, the Youth members sold over 50 copies in just over an hour! Many people were so impressed at the Youth presence that one and two dollar donations were not uncommon. NSYM personnel have returned to this area many times in recent weeks, and along with hitting other areas around the capital as well, are easily able to meet their WHITE POWER quota in street sales alone.

In Los Angeles, NSYM personnel under the leadership of NSYM Unit Leader Douglas Winkleman have continued their program of WP sales in Hollywood, West Covina and Glendale, and are planning experimental WP sales and other activities in other L.A. com-

munities. Comrade Winkleman reports a concentrated plan of activities in the making for the city of Pasadena this fall which will build a strong base of support for both the NSYM and the Southern California District Offices.

In Milwaukee, NSYM Unit Leader Rick Rumpel and the Milwaukee NSYM have been consistently participating in the Milwaukee Unit's weekly activities led by Unit Leader Tony Schmitt, and have also undertaken strictly NSYM activities on their own, such as the recent school board picket. Unit Leader Rumpel reports the NSYM there have been constructing a highly organized plan of attack for the fall in the city's junior and senior high schools.

All NSYM in their respective unit areas are hereby directed to cooperate fully with their respective unit leaders in setting up a plan of consistent — not just sporadic — Youth activities focusing on the coming re-opening of schools in the fall.

Leader of Nazi Party Gets Year's Probation

EL MONTE — The leader of the American Nazi Party's Southern California headquarters has been placed on a year's probation for maintaining improper electrical wiring leading to spotlights illuminating a huge swastika sign.

Daniel Stewart was placed on summary probation, and two other charges were dropped in connection with the "headquarters" at a two-story frame house at 4375 Peck Road.

The National Socialist White People's Party (Nazis) has been engaged in a running battle with the city over use of the residence as a meeting-place for the group's activities.

The fire department conducted an inspection March 26 and found violations of the city's building codes. A letter was sent April 1 to "Daniel Stewart, Squad Leader," informing him of violations and ordering compliance within 30 days. In the meantime, the letter warned, no meetings were to be held there.

But police who watched the house told of a meeting held soon afterwards and a misdemeanor complaint against Stewart was filed in El Monte Municipal Court's district attorney's office.

Judge Gordon McNulty dismissed two other counts — failure to obey fire department orders to stop assemblies while extreme fire hazards exist, and maintaining a place of assembly where exit doors are sealed shut.

Deputy Dist. Atty. Mike Byrne said the sentencing also stipulated that the occupants comply within 30 days to a letter from City Attorney James Nicklin which lists other corrections.

Those instructions order removing the swastika sign, ceasing to sell newspapers at the location and removing an old truck.

Byrne said the sentencing holds "severe punishment" if compliance is not met.

The charge upheld by Judge

McNulty alleged that Romex-type (non-metallic) wiring was used along the front of the building to floodlights illuminating the swastika. There were also numerous extension cords used throughout the house, the complaint said.

Although Stewart told city staff members and the City Council that the building would no longer be used for assemblies because repairs would be too expensive, police said they observed a meeting there April 5, and heard World War II-type music from the inside.

At one time, Stewart and other "storm troopers" appeared at a council meeting and promised to drive customers away from local merchants by shopping while in uniform.

There was at least one instance in which they did so, but no court action resulted from a subsequent tussle between the "storm troopers" and merchants.

politicians who came to pay their respects to, and glean votes from, the assembled jig-a-boos. Even with a Hitler Youth Banner waving defiantly under the noses of the kosher niggers, prompting many to hoot and holler at the youthful racial idealists, not a single spade had the nerve to try an attack, although some chicken bones and watermelon rinds were reported to have been seen thrown from upper floors of the hotel.

El Monte Judge Rules Against L.A. Headquarters

Due to the extreme harassment by El Monte city prosecutors of the L.A. Unit's Headquarters at 4375 North Peck Road, and the impossibility of bringing the HQ up to standards to conform to city building codes, involving the expenditure of thousands of dollars, the L.A. Unit has been forced to curtail Party functions there. Unit members and area supporters will be notified of the specific modifications in the headquarters operations, meanwhile, all are urged to render all possible assistance to Group Leader Stewart in his efforts to continue resistance against the city's oppression.

Arlington Unit Pickets NAACP National Convention

On 1 July, the Arlington Unit led by TL Thomas Knight picketed the national NAACP convention at the Washington, D.C. Sheraton Park Hotel.

There to speak to the coon convention was none other than Jerry Ford, who flew via helicopter, apparently somewhat adverse to meet the ST/NSYM demonstrators at the hotel's main entrance.

With their signs reading "SMASH NAACP" and "DUMP NAACP & FORD," the NS activists greeted the rest of the race-traitor
