#### Canadian Comrade Seized, Railroaded on Gun Charge

Comrade Armin Auerswald of Lake Wilcox, Ontario, had just returned shortly from the Sixth Party Congress in Milwaukee, which he had attended with several of his daughters. Suddenly, without warning on the evening of 8 September, a swarm of Canadian secret police and detectives burst into their home looking for weapons and "subversive" literature. Comrade Auerswald and his wife Jean, who was in her ninth month of pregnancy with their sixth child, were seized on charges of illegal possession of weapons and conspiracy. All of the family's firearms and Party material were confiscated, along with personal correspondence, leaving their neat, little home a shambles.

Showing how dangerous and vicious so-called gun control can be, it turned out that Mr. Auerswald had four pistols, two of which he hadn't had an opportunity to register. Normally, this would only bring a fine. In this instance, Comrade Auerswald has been in jail ever since and was refused bail. (Just recently a man who kidnaped a bank president's wife and held her for \$150,000 ransom was released on his own recognizance; while earlier this year a Negro youth charged with the murder of a Toronto cab driver was released on a promise to pay \$2,000! Yet, Comrade Auerswald, a responsible family man with no criminal record, who hasn't violated anyone's rights, was denied any bail whatsoever.)

Comrade Auerswald was told that unless he pled guilty, his wife would have to stand trial in her condition. To spare her the ordeal of facing trumped-up charges and to save the life of their unborn sixth child, our comrade entered a guilty plea, and was given two consecutive terms of nine months each — a total of 18 months. To add insult to injury, a hate-filled judge chose the very day Mrs. Auerswald was giving birth to sentence her husband to prison.

Those who would like to help Mrs. Auerswald and her family during this very difficult time, especially during the upcoming Christmas season, could perhaps best do so with items of clothing. ### Louisville NSYM Lead Counter-attack on Busing

One of the most recent offensives against White People is taking place in Louisville, KY, as a part of the overall plan of mix-master federal judges. Cross-district forced busing is being implemented for the first time here in an effort to force Blacks on White students. However, White people are resisting this Jewish scheme as they have in Boston and many other parts of the country. Responding to the doubly-urgent need for White unity and an alternative to reactionary and conservative anti-busing measures, the NSYM has seized the opportunity created by the busing controversy to spread National Socialism.

On 20 September NSYM Members in Louisville demonstrated against forced busing at an area shopping center. Weekend shoppers were greeted by uniformed NSYM handing out WHITE POWER newspapers and holding signs reading "Ban Busing!" and "White Power!" A local TV station dispatched a film crew to video-tape the action and to record an interview, which was shown later on in the evening news program

The days immediately following were spent by the activists distributing Party literature in uniform door-to-door in those White neighborhoods scheduled to undergo court-ordered busing, thus increasing the value of the TV coverage by reaching the people again with our message while the newscast was fresh in their minds.

The NSYM report their efforts were warmly received by Whites faced with the 'joys' of integration.

### Michigan Activists take to the Streets

A new Party unit is forming in the greater Detroit area. On 27 September, National Socialists conducted a full day of activity in the suburb of Livonia, which began early in the morning with a mass leaflet distribution door-to-door. The National Socialists then proceeded to a busy streetcorner with an oversize White Power sign, and began handing out literature to passersby. After a time there, police arrived on the scene and arrested the men, charging them with "not having a permit to

distribute materials." Local Party organizer, Rocky Suhayda, informed the officers before being booked that it was his intention to have the ACLU look into the case immediately, as a clear breach of their rights had occurred. After awhile, the police released the National Socialists and gave them back their leaflets and sign. They then proceeded to City Hall and stationed themselves near its entrance for two hours, handing out literature and talking to interested people.

Upcoming activities in the Detroit area include a "Dump Israel" demonstration and an open-air rally to be held in a suburban park, Members and Official Supporters in the greater Detroit area who wish to take part may contact Comrade Suhayda at Box Box 2173, Livonia, MI 48151.

### St. Louis Comrades Step Up Activity

The following report from St. Louis local organizer Tony Ruf describes Party activity there in recent weeks.

"In a continuing effort to squash local Marxist activity, St. Louis area activists have stepped up their program of activity. By zeroing in and concentrating our efforts against the Marxists, we are rapidly dispelling the Jew lie that 'Communism and Nazism are the same thing'.

Following is a sample of Party activities in recent weeks.

23 August - ST Michael Allen led St. Louis activists in a one-hour picket of the Socialist Workers Party HQ.

Comrade Allen reports that the size and composition of the Marxist crowd at our picket is growing and changing. Where the Reds used to have women out front, they are now beginning to bring out big burly goons. Although they still outnumber our men, they still haven't made any attacks on the ST.

6 September - ST Allen led a third picket of the SWP bookstore-headquarters. Again the Reds heavily outnumbered the ST, but there were no incidents.

Despite the continuing heckling by the Reds, local Whites are beginning to understand that the Marxist SWP represents the grossest treason in the city.

12 September - Taking advantage of a last minute announcement that visiting President Ford was to address the National Baptist Convention, ST Allen appeared at the convention site to urge Ford to dump Israel,

Completely unknown to him, the convention was an overwhelmingly Black affair. While the President was inside lauding so-called Black

# **Change Of Signals** On Rally By Nazis

What's in a name? The right to hold a rally in Kiener Plaza, for one thing, it ap-

The Greater St. Louis unit of the National Socialist White People's Party had no problem - it was assured of a permit by George M. Kinsey, Commissioner of Parks. But when a television reporter told Kinsey that the aspiring ralliers were "Nazis — World War II Nazis," Kinsey had second thoughts.

He decided that the permit should be considered by Mrs. Georgia Buckowitz, city Director of Parks, Recreation and Forestry. And Mrs. Buckowitz said no to the request by Michael Allen, party secre-

"It has been a long stand-ing policy of this department to prohibit rallies of a political nature in any city park," Mrs. Buckowitz wrote to Allen, who had announced last summer the party's intent to stamp out Communism in St. Louis. One of his goals is the passage of an ordinance to outlaw any Marxist preachings or teachings in the city.

Although Allen apparently disregards the freedom-of-speech provision of the First Amendment, he says he firmly supports its guarantee that his group or any other can assemble peaceably and petition the Government for a redress of grievances.
Mrs. Buckowitz, on the oth-

er hand, wrote Allen that an opinion from the city counselor implied that there were legal reasons for not issuing rally permits to political parties.

"We've never issued park permits to any party - Dem-ocrat or Republican - for political activities," she said.

Allen says that on Sept. 17 he telephoned Kinsey about the status of his application for a rally permit for Sept. 20. Kinsey said that the permit would be mailed the next day, with the only stipulation being a ban on distribution of political literature. But a television reporter got wind of Allen's plans and called Kinsey.

Kinsey said he had considered the permit routine and he did not connect the party's long official name "with the

Now, Allen says, he will seek a permit to use a city park for an "anti-Commu nist" rally, with no party sponsorship.

If that is not successful,

Allen, who appears at Nazi demonstrations in full Storm Trooper regalia, says he will consider applying under a front group's name. "We will use that tactic if we are forced to," he said.

'achievements,' Comrade Allen was outside in the crowd distributing WHITE POWER newspapers and urging public pressure to dump Israel.

Several Blacks, while arguing with Comrade Allen about his right to be there, acknowledged how sharp his uniform was and how much guts it took to be in a predominantly Black crowd (numbering approximately 1,500). The few White's that were there responded favorably to Mr. Allen's presence.

Two hundred WHITE POWER newspapers were distributed in less than 30 minutes while among the crowd.

17-20 September - Comrade Allen secured a valid permit to hold an anti-Communist rally in downtown St. Louis.

Late in the afternoon of the 19th, the St. Louis Board of Parks, Recreation and Forestry canceled the Party's permit to speak in defense of America's future as a White, anti-Communist nation.

Comrade Allen immediately notified the local news media and informed them that he would be at the rally site in order to present evidence of the city's double-standard in issuing rally permits. The city is known to have issued rally permits to the SWP in order to hold 'free the political prisoners' rallies.

The Park Board's statement that they had a 'long standing' position of not allowing rallies of a 'political nature' in any public park

appears to be a cover-up of submission to Jewish pressure.

Though the ACLU has indicated that we don't have a case, there is ample evidence of a double-standard. Comrade Allen is continuing to look for ways to challenge the Park Boards decision.

### Tracy Unit Activities Increase

### 'Democratic Process' Not Open to National Socialist Candidate

Wolfgang Schrodt, who operates the NS Bookstore at 2112 Eastern Ave., Baltimore, MD, has found out the true meaning of 'fair play' in a democratic system in his bid for 1st Distict Councilman. Throughout his election campaign, Party Member Schrodt has been denied the right to buy newspaper advertisements, radio spots and in fact almost all normal ways of reaching the people in an attempt to undermine and sabotage his campaign efforts. He has experienced other dirty tricks used by corrupt system bureaucrats who have tried to prevent him from getting his name on the ballot, accepting petitions, etc. But with solid determination to voice the needs of White Baltomorians in the City Council chambers he has not let these road blocks stop him from running in this election. # Nazis: Mein Kampf American style

Sometime when you're in Arlington, Virginia-just across the river from D.C.-dial 528-4361. If you do, you'll hear a recorded message that might sound somewhat like this:

"White people, unite! The Montgomery County School Board is going to integrate our schools . . . whether white people like it or not These bourgeois, fog headed liberals are ignoring the white people who do not want their children sent into integrated jungles . just to please the black nigger pigs . . . Had enough? Write to the National Socialist White People's Party, or drop into our headquarters at 2507 North Franklin Street, Arlington, Virginia.

The office of the National Socialist White People's Party-nrore familiarly known as the American Nazi Party-is easy to find. You know you're there when you arrive at a neat red brick building with a Swastika flag out front fluttering in the lazy Virginia breeze.

Press the security buzzer, wait a few seconds, and comrade Tom Knight, local unit commander, will usher you inside the small reception room. The Party it seems is extremely security conscious. They have to be. Their founder, George Lincoln Rockwell, was assassinated several years ago as he went about his rounds. Threats against his followers arrive regularly.

The room, actually more like a claustrophobic vestibule, crammed with a desk, three chairs, two literature racks, a large swastika (which the Party calls the Aryan Cross) and life size portraits, of Adolf Hitler, Rockwell and Tom Kaehl, the present Commander Supreme.

Turn yourself sideways and squeeze into a chair across from Knight, now sitting behind his desk dressed in full Nazi regalia: Brown shirt, blue trousers, thin black tie, four black bars on a stiffly starched collar and a swastika band adorning his left arm. For the final touch there is a nine millimeter Astra strapped smartly to his waist. Ask if it's loaded and he'll tell you it is as he extracts the clip from the butt to reveal a row of shiny copper and steel hullets.

Yet, as he sits below Hitler's portrait. Knight does not look particularly menacing the way a Nazi is supposed to. The martial garb and swastika, symbols of terror as presented by twenty five years of history and Hollywood, cannot disguise Knight's affable manner.

He looks no older than twenty five, is slightly chubby with a rather rotund face, and intersperses his dialogue with chuckles and grins. He could be your favorite uncle, not at all like the fanatic on the telephone recording. But Knight says it is indeed he who makes those tapes, and he smiles when you mention them.

"My father was a farmer" he explains, "and he told me that sometimes you have to take a baseball bat to a mule's head to get him to move. Those tapes are our baseball bat."

I ask whether he isn't afraid of scaring away prospective members. "No," he replies, "This way we

make the membership more exclu-

sive. We get people who aren't looking for nice words or nice solutions, because there aren't

That the NSWPP's solutions are not nice is a massive understate-

Top priority in the Party's plan for America, Knight explains, is "repatriation of all the blacks back to Africa where they belong.' (Throughout the interview, perhaps for my benefit, Knight uses the term 'blacks." But occasionally he lapses into the Party jargon of "niggers" and "black animals.")

Next on the list is formation of a National Workers Corps. This is inspired by Hitlerite Germany's National Labor Corps. All ablebodied men would have to work at projects mandated by the statesocialism at its totalitarian worst. But, unlike more orthodox brands of socialism, there would be little nationalization of private enter-

"We would not completely nationalize industry," suggested Knight, "but we would watch closely what it does. The reason governments nationalize industry is that they are afraid of what it will

After half an hour, I decide it is time for the sixty four thousand dollar question.

Jews?" I ask. "We'd repatriate them to Israel."

Nhat would you do about the

"Well, at least you wouldn't exterminate them in concentration camps the way that Hitler did." "Hitler did no such thing." The ovens, the piles of bodies, the estimates of six million dead, I am asked to believe, are all mirages born of allied propaganda-the effects of which we are all stupidly still living under.

As we talk, our conversation is constantly interrupted by a stream of phone calls, most of which last only a second or two and elicit responses from Knight such as "No I wouldn't;" "No," and a terse, "Goodbye."

I guess these are mainly crank calls, although I wonder on which end of the line exist the cranks. Knight confirms my guess, telling me that he gets several such calls each time he is on duty. Sensitive information is not exchanged over the phone anyway, he adds, because it is tapped.

#### Action in San Francisco

On 5 September, TL Allan Vincent led NSYM personnel in Sacramento in a demonstration at the appearance of Gerald Ford. As a result of the unsuccessful assassination attempt by Squeaky Fromme, their presence received little attention.

On 20 September, ST men from Northern California under the command of TL Allan Vincent held a WHITE POWER newspaper sale in Stonestown, a suburb of San Francisco. 15 ST, 1 NSYM member and I NSWO member participated in the sale. The sole incident occurred when, as one ST man reported, "... thousands of people saw us there. At one point, a hippie pulled up to a stop light at the intersection and yelled something unfriendly to us. As he did so, he ran into a pick-up camper in front of him. The pick-up had a trailer hitch which protruded about a foot behind the vehicle. This hitch was forced into the radiator of the creep's car as he velled at us. Inwardly, we all had a good laugh as the creep looked over the damage to his car!"

The really big action occurred on 27 September, when over one group of ST led by TL Vincent were engaged in a full scale riot in the scummiest section of "The Red City," San Francisco. One of the participants reports:

"On this date I was in San Francisco with members of the Tracy Unit. We had planned to take a cable car ride with comrades from San Francisco, in uniform. After we left our assembly area and marched to the place where we were to board the car we stopped and TL Vincent began to say a few words to the crowd that had gathered there. One thing led to another and I received an egg of the back of my helmet. After a few more small incidents we marched off to the pornography stores where we received more eggs, bottles, bricks and other such items. There were also a few fights. After picketing the stores we were obliged by social pressure to start the march back to the assembly area. Unfortunately the crowd which had begun as about 50 had now grown to about 200 creeps. On our way back we were again: assaulted but this time the creeps actually tore up Market St. to get bricks to throw at us. They also threw eggs, rocks, trash cans, detour signs, street warning lights, boards, paint brushes, liquor bottles and other assorted items. One member was hit and he blacked out. The police eventually barricaded the creeps behind us by blocking off the entire street. . .

"Channel 4 gave us excellent coverage. There were no anti-NS wise cracks! It stated where we stood on the issues, how disciplined we were, how orderly we were, showed the 'street people,' showed the contingent, showed some fight scenes, and then told how ugly the crowd got. It showed the worst of the creeps and explained how we left — with a rear guard and always orderly. Swastikas were everywhere in the fight scenes — what the public wants to see!

"... Channel 5's moderator was a Black. It



## Streets of San Francisco

About 20 uniformed members of the National Socialist White People's Party appeared at Market and Powell Streets in San Francisco on Saturday afternoon, Sept. 27, to bullhorn their anti-Black and anti-Semitic philosophy and distribute copies of their newspaper, White Power, to passersby. The crowd, which grew to about 300 people, eventually answered by tossing garbage and bottles. The police watched the crowd and separated the two groups before any serious violence occurred. Later the Nazis proceeded to an erotic encounter parlor on Eddy Street, where they railed against the evils of pornography.

"It was in the Washington Post and the Star a few weeks ago," he explains, "that the FBI admitted it surveys white supremacist groups. That certainly narrows the field."

He also believes the mail is monitored and that people are watched as they enter and leave the building. I immediately glance at my car parked outside, license number in full view of any lurking FBI agent, and wish I had put it somewhere else just in case. After all, you never know when you might wind up working for the government.

Hitler's followers expect to come to power by 1988. For all you Orwellians, that's just four years past 1984. And for Libertarians, wherever you are hiding, that's just thirteen years from right now. No Beer Hall Putsch though. Strictly legal says Knight. "We'll have the mandate of the people through elections."

"Right now," he says, "if we ran a candidate he would get seventeen percent of the vote. People would vote for us out of disgust, frustration, or protest." Seventeen percent, he adds, is the number achieved by a NSWPP candidate in a recent Seattle school board election.

The Nazi tells me that these are pre-revolutionary times. Despite what is going wrong, the masses are still too comfortable. But the Party is building up a leadership, they say, that will be ready when the masses open up.

Does this mean the Party is growing? How many members have they got?

Knight will not say—usually a dead giveaway of a small membership. Knight informs me the most active units are in San Francisco, Los Angeles, Milwaukee and Chicaco. He also mentions chapters in San Diego, Seattle, and Bridgeport, Maine. He does not mention New York, where he thinks there may still be anti-swastika laws prohibiting display of the Nazi emblem.

When he isn't running around in guns and swastikas, Knight is a family man. He has a wife and two children. I ask if there are any characteristics common to your basic Nazi.

Not really, he says, some come from conservative backgrounds and some, like himself, from a liberal one. Some are Vietnam veterans. Most are middle class or lower middle class.

An hour has lapsed. I am intrigued by all I see, but not shocked. I imagine I am even amused. Little girls want to be nurses. Boys aspire to be firemen. We all like a uniform. Tom Knight and company have found theirs. But that's all there is: A uniform. Their monistic philosophy is bankrupt. There is only one issue as they see it -race. Send the niggers back to Africa and we'll all be all right. Crime? Unemployment? Decadence? Blame it on the blacks and the Jews. America for the white man. Achieve that and everything else will take care of itself. (In case you are wondering why Jews are not classified as white, their non-European origin, according to Knight, disqualifies them for the honor.)

That the Nazis seriously expect to take over the nation in the name of the most despised political movement in history is ludicrous. Only in America.

Yet the smile fades as I think of Knight's children, or those of other Party members, being brought up in the NSWPP tradition. When these kids are in school, how will they react to black and white co-existing in the pages of their primers—or in the playground? How will they fit in? Martin Luther King an American hero? What a shock to their marred sensibilities. Surely, this is how new Hitlers and Robert Sheltons are formed. The children are our hope. To so violently corrupt them is venal beyond all measure.

Yet there must be a reason why Knight, contorted in his reasoning yet nonetheless grounded in normality, would join the NSWPP. Is he the personified exaggeration, albeit grossly so, of a growing cancer of middle class dissatisfaction? Laugh if you want. The Fringe, you might say. Perhaps. But The Fringe seems to be growing. Pick up your newspaper and read how the Klan, even now, is re-forming in upstate New York.

As the white middle class increasingly becomes burdened with taxes, quotas, inflation, unemployment, and the tortuous death of American Hope, will more minds snap? Are there latent legions of Knights in our midst, their fuses smoldering until at last they explode into cells of the Klan, NSWPP, Communists, Maoists, or even Devil worshippers? Perhaps there are a hundred such groups yet awaiting birth.

But these are questions for the social scientists and, God forbid, the politicians. Well aren't they?

In the meantime, just for a lark, dial 528-4361. Better be ready to try a few times though. The line's usually busy.

### Nazis Select Pasadena for Organizing, Recruiting Drive

The Southern California chapter of the American Nazi Party, a small group still festering from a shooting at its headquarters in El Monte last month, has selected Pasadena as a

month, has selected Pasadena as a target for an organizing and recruiting effort it says will be renewed this year.

The group, officially known as the National Socialist White People's Party, is considered by local authorities to have only minimal appeal. But it has become a noisy— and sometimes disruptive — force at and sometimes disruptive — force at local meetings and demonstrations.

in tones that border on the apocalyptic, party spokesmen contended that what they term Pasadena's "racial situation" offers a fertile ground for their doctrine of white supremacy.
Their swastikas and storm trooper

The Nazi leaders say that because of internal dissensions and problems they have had with El Monte authorities, they have not been active in Pasadena in recent months. But they have promised to renew their efforts the beginning of school this

"We've been singling out Pasadena for about a year now," said Martin Kerr, 23, a Southern California district organizer for the party. "It has, we feel, the proper racial make-up for our growth."

How seriously should the Nazis be taken? Are they a threat to law and order or nothing more than a group.

er or nothing more than a group of adolescents?

"I think you have to take them seriously," said Pasadena Police Chief Robert McGowan. "But when you get into the question of are they a threat, I think you have to look at the size of the organization, which is very, very small.

They certainly have the potential to bring about a state of agitation in a given situation," the police chief continued. "From that standpoint, they're threatening, but not to the degree of tremendous concern.

In both style and rhetoric, the style and rhetoric, the group owes much to its predecessor in Germany's Third Reich. Its posturing at local events is regarded by many as little more than ludicrous.

But some officials who have observed the party carefully note that it frequently seizes on popular issues such as busing or por-nography, using them to advance its own ideas of racial superiority.

"I think the average guy on the street is opposed to some of the horrible pornography," McGowan continued. "I certainly don't think the Nazis would be

very beneficial in getting pornography out of this community or out of any

The Nazis, naturally, s things differently, and like many extremist groups, they profess to see their ul-timate success in the desperation they say

afflicts the average man.

As long as the situation is moderate," said Kerr, a bespectacled, intense young man who wore a gun on his hip during a recent interview, "the people will go to moderate leaders." go to moderate leaders.

clear is that the Nazis have had a long history of confrontation, and that while their appearances in Pasadena have been lawful, they have come close to igniting racial fires.

The party figured prominently in the news last month when former chief. Joseph Tommasi, was killed at the El Monte headquarters in what of-ficials later described as a power struggle. An 18-year-old youth was subse-

quently booked on suspi-cion of murder. In 1972, 40 persons were arrested in a six-hour melee between the Nazis and the Jewish Defense League at the El Monte headquarters. Pasadena police have reported that a similar confrontation was narrowly averted this year when the Nazis made a mistake in scheduling and failed to appear at a JDL protest against an Alhambra firm with a contract to train Saudi Arabian troops.

too, there have been several incidents where authorities have reported that the Nazis have fomented tensions. In May this year, a Los Angeles judge granted an injunc-tion forbidding Nazi party members from setting foot on Pasadena public school grounds. Pasadena School Supt.
