California Comrades Spirit Strengthened by Jail

Recent developments in the case pending against Duty Officer Jerry Jones and Party Member Clyde Bingham (see August-September issue of WHITE POWER for account of allegations) include: bail for Jerry Jones was reduced from \$100,000 to \$50,000, whose case is scheduled for trial on 10 December.

Anyone who would be able to aid in raising bail for Comrade Jones on a loan basis please contact NHQ.

Pending the outcome of his trial in a few weeks, Comrade Bingham has elected to remain in jail as long as possible to stand beside Comrade Jones in that vile, nigger-infested hellhole. This attitude exhibits a profound sense of comradeship and willingness to sacrifice found only in a small number of men. These are the kind of heroes this Movement is attracting; the kind of which can be found nowhere else. By their example, they point the way to victory!

The L.A. Unit has announced the start of a "Free Jerry Jones" campaign to protest the incarceration of these comrades by the anti-White system for defending Party headquarters. Let us show we are not going to forget this man's devotion to duty and unhesitating loyalty in defending his comrades and headquarters. Los Angeles Activity Intensified

On 4 October, Southern California ST teams under the command of TL Martin Kerr conducted an encampment in L.A. County, which continued through the following day. The purpose of the encampment was threefold: (1) to expedite the training and organization of the L.A. ST; (2) to provide experience for local staff personnel in organizing and running an encampment; and (3) to stimulate morale through a disciplined, team-effort in a non-street activity.

The encampment was filmed by movie-making crew from Rio Hondo College, which recorded the ST in close order drill, physical training, boxing and self-defense techniques. Talks were given by ST leaders on subjects such as "The Tradition of the ST," "Basic Ideas Concerning the ST" and "History of the SA and ST, 1919-1975."

On 7 October, a panel of National Socialists from the Southern California District appeared on the Dick Maurice talk show at station KSHO TV in Las Vegas. District Leader Dan Stewart and District Organizer Martin Kerr represented the Party and ST, while Senior NSYM Member Doug Winkleman represented the NSYM and NSWO member Ruth Stinson represented the NSWO. All comrades were in appropriate uniforms. The talk-show host was mildly hostile, but this did not prevent the National Socialists from hammering home a number of good points of Party ideology, especially White supremacy, a refutation of the myth of the six million and the future of the Party in the coming collapse of the Jewish system.

There were no incidents, despite a brief run-in with Jew 'entertainer' Mel Torme, who was also at the station for a taping and was upset at the sight of uniformed National Socialists.

On Saturday, 11 October, TL Bruce Matthews led two teams of ST in a WHITE POWER newspaper sale on Sunset Boulevard in Hollywood. The contingent sold the Party organ for a period of two hours, during which time no incidents occurred. 85 papers were sold that day.

Chicago Unit Canvassing City

ST personnel of the Chicago Unit led by GL John Logan have been very busy in recent weeks conducting mass literature distributions throughout the Windy City, touring White neighborhoods in the Unit's White Power bus, and staging White Power marches in concentrated areas such as shopping centers and heavily-used arterials. Most Whites encountered by the ST reacted favorably, especially those living in White neighborhoods threatened with Black and Latino invasion.

BEWARE OF OPPORTUNIST FRAUD!

It has come to our attention that a book called *The White Primer* is being sold and circulated by someone calling himself "C.W. Bristol." A quick examination reveals that this so-called Primer is, in fact, an adulterated, counterfeit reproduction of Lincoln Rockwell's book, *White Power!* Not only is Commander Rockwell given absolutely no credit, but all references to National Socialism, the Swastika and the Party have been carefully removed and other symbols and organizational designations substituted.

What kind of person could it possibly be who would steal another man's work without giving him due honor and credit? How could anyone who behaves in this manner call himself a White man, let alone claim to speak for the White race? If someone does not have the courage and fundamental honesty to embrace the Swastika and National Socialism, then they have no business leeching off the memory and legacy of Lincoln Rockwell.

Adolf Hitler describes these types only too well in his book: *For as soon as a man appears who profoundly recognizes the distress of his people and then, after he has attained the ultimate clarity with regard to the nature of the disease, seriously tries to cure it, when he has set a goal and chosen the road that can lead to this goal — immediately small and petty minds take notice and begin to follow eagerly the activity of this man who has attracted the public eye. These people are just like sparrows who, apparently disinterested, but in reality most attentive, keep watching a more fortunate comrade who has found a piece of bread, in hopes of suddenly robbing him in an unguarded moment. . . If a new movement has been founded and has received its definite program, those people come and claim to be fighting for the same goal; but, rest assured, not by honestly joining the ranks of such a movement and thus recognizing its priority; no, they steal the program and base a new party of their own upon it. With all this, they are shameless enough to assure their thoughtless fellow men they had desired the same as the other movement long before, and not seldom they thus succeed in placing themselves in a favorable light, instead of winning universal contempt as they deserve. For is it not a tremendous gall to aspire to write on their own banner the task that another has written on his, to borrow his programmatical principles, and then, as though HE had created all this, to go his own ways?"* Mein Kampf, II:8

Important Legal Victory Scored in New England

On 7 October, the Movement won another important legal victory. In the state of Connecticut, three U.S. judges ruled that the Party's White Power Message service was within its First Amendment rights of freedom of speech.

The Civil Liberties Union represented the Party in the case. The true significance of this decision is that in the future, other states that attempt to silence the WPM will have little legal ground upon which to justify their anti-White actions. Thousands of White people will continue to hear the vital National Socialist message and petty system hacks will find their anti-NS antics more ineffectual than ever!

Arrested Socialists ask written complaint

Eighteen members of the Socialist Workers Party, including mayoral candidate Mary Hillery, appeared Wednesday in Hennepin County Municipal Court on charges of obstructing a sidewalk while distributing campaign literature Saturday afternoon at 7th St. and the Nicollet Mall.

According to a police report, officers called to the Mall Saturday afternoon found members of the Nazi party as well as Socialist Workers Party distributing literature. Police told the Nazis to stop their handouts, and they complied, the report said.

A Mall merchant then asked police to order the Socialist Workers to move since they were interfering with his business. The police report said that officers told the Socialist Workers to leave the area, but that they refused.

The 18 people were then arrested and taken to the Hennepin County Jail, where they were booked and released.

Court Upholds Phone Raps at Jews, Blacks

Hartford, Oct. 7 (AP) — The right of the National Socialist White People's Party to operate a telephone line in Bridgeport with messages about blacks and Jews has been upheld by a panel of three U.S. District Court judges.

Even though called the messages "scurrilous," they ruled unanimously that a 1917 state law against "hate" advertising does not apply to those who make recorded racist announcements available to the public by telephone.

The judges said that the messages preached the need to preserve the Aryan race, scoffed at the equality of blacks, and charged that Jews have taken over the communications media in the U.S.

Ruling of 1917 Law

The 1917 law prohibits advertising that ridicules any person or class of persons because of race, creed, color or nationality.

The court said the law does not apply to the Bridgeport phone line because the recorded phone announcements are available only to those who want to hear them and do not constitute advertising.

The Southern New England Telephone Co. cut off service last year on the advice of Bridgeport Police Chief Joseph

The party charged that its constitutional rights were violated.

The judges were William H. Timbers, T. Timmet Clarie and Robert C. Zampano.

about 20 minutes, police arrived on the scene and cited an ordinance against the use of a public address system without a permit to the Reds. Both the National Socialists and the SWPers continued to distribute to passersby until about 10 minutes later when the police requested the National Socialists to leave the mall area because merchants were complaining. They complied with the request and took up positions nearby. The police then demanded that the SWPers leave with their table, but they decided to challenge the order which resulted in 18 of them ending up in jail.

The incident received coverage in the news media and projected the discipline and sense of cooperation with the police which the Party exhibits on all of its street activities.
