1975 Fall Building Fund Announced; Major New Plan Starts

All National Socialists should have received by now direct word from the Commander concerning the Party's new three-year-plan to bring the Party to the attention of hundreds of thousands of new people and to make it an American political force. The success of this plan will lay the basis for a mass-movement phase by 1978 – the third of a four-phase blueprint for gaining National Socialist power in America.

Commander Koehl emphasized that the first priority of the Party in readying itself for this immense "tooling-up" operation would be the securing of qualified personnel, and especially married individuals whom the Party has up till now been financially unable to hire. This is the crucial problem that must be solved before all others, he said. In addition, a number of local electoral campaigns and special ST operations in different cities are to be launched.

To accomplish these aims, it is essential that we raise at least \$88,888. The quota of the 1975 Fall Building Campaign – which ends 24 December – is just \$11,111. The attainment of that goal will represent one-eighth of the total three-year amount sought. There should be no real difficulty in reaching the \$11,111 goal (several thousand less than the 1974 Fall Building Fund goal), provided all National Socialists pitch in.

All comrades are asked to do their best, and unit leaders are asked to make every effort to ensure the success of this campaign. The performance of each unit will be shown in the coming NS Bulletins. As Commander Koehl said, "The important thing is that you do all you possibly can to make this drive an overwhelming success."

University of West Virginia Hosts National Secretary

On 21 October, National Secretary Cliff Ward spoke at the University of West Virginia at Morgantown. The great NS film, *Triumph of the Will*, was shown. Many students were attracted to the movie and stayed to hear the National Secretary explain the National Socialist movement. During the engagement, several new subscribers to WHITE POWER were signed up as Official Supporters, and several other students took out subscriptions.

L.A. Unit Draws Wrath of Reds & System

On 16 October, TL Martin Kerr attempted to speak to an audience of 350-400 students (mostly Black), at the invitation of the Student Government at the Los Angeles Harbor College.

The speaking engagement had received considerable advance publicity, allowing anti-Party opposition time to organize. Prior to TL Kerr's arrival on campus, a Red group named the Communist Labor Party had been agitating Black and Jewish students, and passing out leaflets calling for "oppressed peoples" and "workers" to "smash the Nazi Party."

After considerable hesitation, Comrade Kerr and ST Hummer were allowed on stage. Despite the immediate howls and chanting from the niggers and the Reds, Comrade Kerr attempted to speak for nearly a half-hour. By that time, the opposition had worked up their courage and began to push past the campus security force and onto the stage. At this point, TL Kerr and ST Hummer were hustled off stage and off campus.

Later that day, Comrade Bruce Mathews spoke to a predominantly Mexican audience at East L.A. College. A standard talk on the history of the Movement, as well as its aims and goals, was given, followed by a lengthy question and answer period.

Despite the hostility of a few Black and Mexican students, the speaking engagement was otherwise uneventful, and most of the

New faces, never before seen on campus were the loudest voices in the crowd, and with their leadership everyone who called for reason was shouted down. The audience was shouting in sporadic cadience, "F-- You!" At first just a few shouted but the number increased. As a result of the Party's activity campaign in the city of Pasadena, Police Chief Robert McGowan sent a personal letter to the L.A. Unit, stating that "You are never welcome in this city ... " along with further comments of a hostile nature. In answer to this very unusual and partisan maneuver on the part of a 'public servant,' Unit Organizer Martin Kerr led a two-team picket of the "Li'l Bit O' Heaven" pornography shop on one of the city's busiest arterials. The ST carried signs reading "Ban Pornography!" and "Race-Mixing Stinks!" while NSWO distributed leaflets.



After 20 minutes of demonstrating, members of the newly-formed Communist Labor Party and Progressive Labor Party began to shout anti-White slogans. In a futile attempt to end the picket, a Communist Jewess grabbed at NSYM Winkleman's picket sign. This brought on an attack of the Reds and resulted in the arrest of five of them.

Although the Reds were violently apprehended by the White police officers, the ST received no casualties. While the arrests were being made, a Jew was knocked to the ground and whimpered before the Stormtroopers.

The National Socialists then left the scene at the request of the police.

Los Angeles HQ Bombed

At 3:05 a.m., on 29 October, a pipe bomb was exploded in front of the L.A. HQ, Damaging a small corner of the building.

The explosion, which followed threats by local Reds, was immediately reported to the local police, who arrived shortly thereafter along with fire department personnel. Upon further investigation, pieces of bent pipe and gasoline containers were discovered on the yard around the HQ. No injuries were sustained from the incident, and damage to the HQ was incidental and easily repairable. District and police officials are continuing their investigation into the incident.

Sacramento NSYM Organize!

On 22 October, NSYM personnel in Sacramento received wide-spread television coverage of their activities in area high schools. Channel 13, on its evening news program, aired a feature on the "sudden increase in Sacramento schools of Nazi hate literature." It interviewed the principal of one school, who blamed the Party for "creating a chaotic situation in my school," and who read portions of Party leaflets for the benefit of the viewers. At the conclusion of the report, a camera zoomed in on the "White Power!" slogan on the reverse side of one leaflet.

Chief Advises Nazis to Stay Out of Pasadena

PASADENA-Police Chief Robert H. McGowan has advised the American Nazi Party that it never will be welcome here under any conditions.

In a letter to Martin Kerr, one of the leaders of the party's western unit in El Monte, McGowan noted that the National Socialist White People's Party (the Nazis) on several occasions over the last 18 months has "directed their attention to matters in the city of Pasadena."

McGowan said, "I am writing this letter in order that you and your associates may be personally advised that you are never welcome in this city by the Pasadena Police Department under any conditions."

McGowan's letter comes in the wake of concern in the black community over threatening letters which were received by eight community leaders, and the reported stringingup in a tree last month of a retired black minister.

McGowan did not specify what in-

cidents the Nazis have been involved in over the last 18 months. However, some Nazi members were ordered off the Pasadena High School campus several months ago. At the same time racist pamphlets were being distributed on the campus and since have been distributed in some white neighborhoods.

The Nazis have announced the intention to concentrate on the school integration issue in Pasadena.

McGowan's letter said, "Your extremely unpopular political views are of great concern to the citizens of Pasadena and inherently create the potential for disruption in our city.

"Should your organization appear in Pasadena in spite of the fact that you are not welcome here by citizens or law enforcement, you may be assured that we will insist on compliance with the law in the strictest sense and that any violations will be strictly prosecuted."

Within a couple of days after the initial publicity, two other school activists in Sacramento ordered quantities of Party literature for distribution in their schools.

ST Return to San Francisco; Picket Jew Porno Shops

On 18 October, a group of Northern California ST staged an anti-porno demonstration in the heart of San Francisco, scene of a recent riot when ST men conducted a similar demonstration there on 27 September.

The uniformed contingent proceeded in the Tracy Unit's personnel carrier to the downtown staging area. The contingent disembarked and began picketing in front of one porno store. After awhile, a crazed Jew lunged at the contingent's banner. Two ST men quickly pinned him up against a wall while a third contained his filthy remarks by grabbing his throat. A policeman then jumped into the action and hauled the Jew away. This was the only incident throughout the demonstration, which attracted great numbers of onlookers and received objective treatment on TV channels 4, 5 and 7.

Milwaukee Jews Frustrated by Party's Right to Free Speech

Recently local Jews met to try to find ways to deny the Party its First Amendment rights, resulting in the following publicity.

In an effort to find a constitutional way to stop Nazis from passing out hate literature, the Milwaukee Jewish Council has proposed an addition to the city's disorderly conduct ordinance.

Sol Sorrin, the council's executive director, said in a letter released Tuesday by City Atty. James B. Brennan that the Milwaukee Jewish Council Board would support an ordi-nance opposing Nazis that it feels has a better chance of being held constitutional than an ordinance suggested by Brennan.

A group of Jewish attorneys proposed the following amendment to the city's disorderly conduct ordinance:

"Abusive conduct includes, but is not limited to, the expression by any means of contempt, ridicule, or derision of a race, color, religion, national origin or ancestry of any person, group, organization or members thereof."

The city attorney's office has been unsuccessful in prosecuting Nazis distributing literature in schools under the present disorderly conduct ordinance. Under that law, a person faces a \$200 fine for engaging in violent, abusive, indecent, profane, boisterous, unreasonably loud or otherwise disorderly conduct under circumstances in which the conduct tends to provoke a disturbance.

After failing to convict the Nazis under that ordinance, Brennan's office suggested an ordinance that would prohibit

distributing items exposing any race, color, creed or religion to contempt or derision that could lead to a breach of peace or riots. An attorney for the League of Wisconsin Municipalities has called that ordinance unconstitutional. Sorrin's group agrees.

The Jewish Council's proposal would authorize police to arrest Nazis when violence was threatened, whereas Brennan's proposed ordinance requires actual violence before an arrest. Sorrin's letter said.

Brennan's ordinance has not yet been scheduled for a hearing before the Common Council's Judiciary and Legislation Committee.

Brennan said the Jewish community here had been split on whether discussion of a proposed ordinance would do

more harm than good by publi-cizing Nazism. He said S o rrin's letter indicated that the Jewish community here wanted a hearing on proposals to curb Nazi conduct.

Nazi Charged

The city attorney's office Tuesday charged Dale Enders. 21, of 3049 W. Lisbon Ave., a member of the Nazi Party, with battery as a result of a street confrontation Oct. 18 in the new Mitchell St. mall.

Enders was accused of striking William Neufeld, 4108 N. 97th St., in the face with his tists and kicking him in the leg with his military boots.

Witnesses said Nazis were passing out literature and taunting members of the Concerned Jewish Citizens and some Polish war veterans when a struggle broke out

Notes From NS Publications
