## Milwaukee Unit Triumphs Over Jew-backed Literature Ban!

The Milwaukee Unit has again demonstrated the successfulness of National Socialist will and determination by standing their ground and winning against a veritable flood of anti-Party propaganda aimed at the banning of "hate" literature there. A Jew-inspired campaign in the Milwaukee press and amongst the city's Common Council members for the suppression of First Amendment rights fell flat on its face before tens of millions of Americans who saw NBC-TV's national news story of a recent council meeting attended by a large number of Party activists.

Most of the councilmen left the council chambers in frustration as a Party spokesman began to blast away at the Jews behind the whole scheme.

The reprinted articles here give a detailed account of the Jew's plan which miscarried so badly, giving the Party national publicity in the process.

## IN MY OPINION No Constitutional Basis for Proposed Ordinance

REGARDING the opinion column by Burton B. Polansky of the Coalition of Organizations Against Nazism, a few observations.

Polansky alleges 80 fist-fights broke out at a few unnamed schools as a result of distribution of "hate literature" at these schools. Yes, and we also beat students at

You can't blame that on us, Mr. Polansky.

Rather this terrifying school violence that has driven whites to the suburbs is, in our opinion, a byproduct of forcing two incompatible races together in the schools. "Hate literature" has nothing to do with it.

Polansky cites the case of *Beauharnais vs. Illinois* in 1952 as a precedent-setting case for banning all so-called "hate literature." He (Polansky) wrote, "Brennan's proposed ordinance has passed constitutional muster. It is the supreme law of the land and it has withstood the test of time."

Thomas Edison Junior High with chains, or so it was reported.

However, assuming there were such fights, what was the factor behind the hundreds of assaults upon teachers and on students recorded in 1974 or in the years before our party had a unit established here? Or in the 77,000 assaults upon teachers recorded by the National Education Association in 1974?

### Minnesota Statute Was Held Invalid

Well, let us see. In the case of *Near vs. Minnesota* in 1931, the US Supreme Court ruled against a Minnesota statute that sought to prevent the publication of "scandalous, scandalous and defamatory newspapers." The de-

cision was in support of the Saturday Press of Minneapolis, a newspaper severely critical of Jews.

In 1952, the case of *Burstyn vs. Wilson*, the US Supreme Court ruled against the State of New York for its refusal to grant a film license to Joseph Burstyn, a New York City theater operator.

The Catholic clergy of New York claimed Burstyn's Paris Theater seemed to specialize in showing "blasphemous

and sacrilegious films." In upholding the right of Burstyn, a Jew, to show films objected to by Catholics, Supreme Court Justice Tom Clark wrote: "It is not the business of government in our nation to suppress real or imagined attacks upon a particular religious doctrine whether they appear in publications, speeches or motion pictures." We agree.

As for "group libel" per se, that strange concept since 1948 has been consistently rejected by the United States Senate in its refusal to ratify, much to the dismay of liberals and in particular Jewish pressure groups, the United Nations Convention in Genocide.

Article Two of the Genocide treaty defines genocide as including "inflicting mental harm" upon any racial, religious, ethnic or national group. Both the US Senate and the American Bar Association, along with the American Legion and other concerned citizen organizations, rightfully rejected the "mental harm" concept as being too broad, vague and therefore dangerous to American civil liberties.

### It Amounts to Group Libel

The international term "mental harm" is nothing more than the "group libel"

term in the *Beauharnais* case.

Thus from such foreign concepts as "mental harm," renamed "group libel," an attack upon the Constitution has been launched that must be stopped. City Atty. James Brennan and his Jewish allies seek to redraw and to redefine the First Amendment freedoms for all Americans. We deny they have the right, the power or the constitutional basis to do so.

## Ordinance Curbing Nazis Postponed

A hearing on a city ordinance to ban Nazi literature was postponed Monday, but 15 members of the local Nazi Party attended a Common Council committee meeting and protested the item's being taken off the agenda.

Over the weekend City Atty. James B. Brennan and members of local Jewish groups agreed that the proposed ordinance needed reworking and

asked Ald. Robert P. Kordus, chairman of the Judiciary and Legislation Committee, to postpone the hearing.

The Nazis arrived at City Hall in dress uniform in the hope that the hearing would be rescheduled Monday.

The committee adjourned before the scheduled 11 a.m. hearing and committee members walked out. Arthur Jones, a Nazi spokesman, said he was disgusted with the action but "we expected it."

## La Follette Advises Fair Board on Bias

Madison, Wis. — Organizations leasing space at the Wisconsin State Fair should be required to file nondiscrimination pledges, Atty. Gen. Bronson C. La Follette told the State Fair Park Board Tuesday.

Such a requirement would alleviate problems such as those created when the National Socialist White People's (Nazis) Party leased a booth at the fair this summer, La Follette said.

The attorney general recommended that organizations applying for exhibit space be required to file statements that they did not discriminate on the basis of race, color, creed or national origin.

"Failure to execute such a statement would then constitute legal grounds for refusing to rent space to that group or organization and would fulfill your obligation to insure that state facilities are not available for use by organizations which individually discriminate on the basis of race or creed," La Follette said in a letter to James Erickson, fair board chairman.

## Board Meetings Should Be Open

MILWAUKEE — The Anti-Defamation League of B'nai B'rith and the Milwaukee Jewish Council, the city's two civic defense agencies, were challenged by the Milwaukee Jewish Chronicle for barring reporters from their meetings.

The challenge was based on the issue splitting the community of how to deal with the local Nazi group.

"Both the ADL and the MJC are pursuing vigorous policies on the Nazi issue and other issues that affect the community. But both must open the doors to their board rooms or risk the continuing loss of community support and understanding."

## Anti-Nazi Proposal Opposed

The 25th Assembly District Democratic unit Monday night urged the Common Council to reject a proposed ordinance aimed at banning the distribution of Nazi literature in the city.

The resolution adopted by the unit, which is on Milwaukee's East Side, said the ordinance was of "doubtful constitutionality and even more doubtful effectiveness." It asked the Common Council to "abide by First Amendment principles and reject the proposed ordinance."

David Luce, an associate professor of philosophy at the University of Wisconsin—Milwaukee and chairman of the unit's resolutions committee, said about 30 attended the meeting at Machos Hall, 926 E. Center St. The resolution passed unanimously, Luce said.

## Nazi Curb Gets Backing

The Democratic County Council voted Wednesday night to back City Atty. James B. Brennan's proposed ordinance to ban the distribution of Nazi literature here.

The council adopted a resolution endorsing Brennan's proposal, which is pending before a Common Council committee, by a 27-11 vote.

By an identical vote, the party rejected a resolution by the 25th Assembly District unit urging that the proposed ordinance be defeated. That resolution contended that the proposal would violate free speech guarantees.

The ordinance, if passed, would make it illegal to distribute material that portrays "depravity, criminality, unchastity or a lack of virtue among a class of people."

# Maier Said to Doubt OK of Nazi Law

Mayor Maier has told Jewish leaders here that the Common Council will not approve a proposed ordinance aimed at stopping distribution of Nazi literature.

The mayor's remarks were reported in this week's Wisconsin Jewish Chronicle.

The Chronicle said Maier "strongly indicated that organized labor opposed the proposal." It quoted him as saying that with some changes, the ordinance could pass, but that leaders of the Common Council had told him that the ordinance as now written would not be approved.

The ordinance has been criticized as being unconstitutional. Its critics have said it amounts to suppression of free speech.

## Not Confirmed

The ordinance, proposed by City Atty. James B. Brennan, would make it illegal to distribute material that exposes citizens of any race, color, creed or religion to contempt, derision or condemnation and material that also tends to cause a disturbance.

A spokesman for the mayor said Friday that he could not confirm the report. The spokesman, Robert J. Welch, said no members of the may

or's staff attended a meeting Monday night at the Beth-Am Center, 5418 W. Burleigh St.

The Chronicle reported that the meeting, at which the mayor and Police Chief Harold A. Breier spoke, was called by the Milwaukee Jewish Council.

## Hearing Postponed

According to the paper, those attending included representatives of the Jewish Council, the B'nai B'rith Anti-Defamation League, the Coalition of Organizations Against Nazism, the concerned Jewish Citizens and members of West Side synagogues and other community groups and agencies.

Earlier Monday, a Common Council committee hearing on the proposed ordinance was postponed over the protest of about 15 members of the local Nazi Party.

Officials said the postponement was requested by Brennan after a series of meetings over the weekend involving local Jewish groups.

Welch said the Monday night meeting called by the Jewish Council had been scheduled for at least two weeks and that it was not related to the postponement of the hearing.

cized daily newspaper coverage of Nazi activities. According to the paper, Maier said publicity only served to strengthen the Nazis' cause.

Maier also urged those attending the meeting to exercise restraint in their reactions

to the Nazis, the Chronicle reported.

## Proposal Endorsed

The board of the Coalition of Organizations Against Nazism has endorsed the proposed Brennan ordinance. The endorsement by the board followed a joint meeting Sunday of the coalition's legal commit-

tee and the legal grievance committee of the Milwaukee branch of the NAACP.

Atty. Ronald Polan, chairman of the coalition's legal committee, said committee members agreed that a 1952 US Supreme Court ruling, *Beauharnais v. Illinois*, supported the wording of the Brennan draft.

## WHITE POWER Distributions Continue Despite Pasadena No-sell Law

On 22 November, Los Angeles ST conducted a White Power march and literature distribution in the city of Pasadena. The ST started off the activity by marching one-half mile up Colorado Boulevard through the heart of town in formation. As they passed a pornography shop that was the scene of a recent NS anti-porno action, the troops chanted "White Power!"

Because a city ordinance prohibits the selling of the newspapers, they distributed it for free. Within a half-hour all the papers had been eagerly snapped up by Whites, and a few complimentary copies were given out to shocked Blacks and Jews.

The National Socialists marched back down the boulevard and returned to the Party's local headquarters without incident.

Just two days after this action, the LA Unit again took to the streets for a full day of ST action. Beginning at 1130, one team conducted a WHITE POWER newspaper sale in downtown Los Angeles, selling the papers to members of the business community, secretaries, executives and others during the lunch hour. This sale continued until 1300. Later in the day the contingent proceeded to their usual location in Hollywood to sell newspapers to rush-hour traffic. They remained for 90 minutes. No incidents were reported and the combined total of newspapers sold was about 80. In between sales, the ST took time to visit jailed comrade Jerry Jones.

In the wake of mounting anti-Party protests by Negroes and Communists, and publicity centered around the trumped-up 'lynching' of a Pasadena Black, the El Monte headquarters of the Party has suffered several fire-bomb and pipe-bomb attacks. The most recent attempt to destroy the Party building occurred on 27 November. This time the arsonists hurled a fire-bomb at the building in the early morning hours which burst against a fence in a neighbor's yard. The Party HQ sustained no damage. Fire Department investigators were called to the scene.

To counter the stepped-up onslaught, Party security officers are instituting special preventive measures. New procedures are in force which will aid in the identification and capture of any individuals committing attacks.

The following Sunday, the LA Unit ST gathered at the El Monte HQ for the unit's monthly ST meeting and training session.

Acting as ST training officer was a Party supporter who is presently a Marine NCO at Camp Pendleton. The ST were given thorough introduction in basic PT, hand-to-hand combat and boxing. Lectures and ceremonies concluded the meeting.

On Wednesday, 10 December, the LA ST conducted a Free Rudolf Hess demonstration. Under the overall command of TL Martin Kerr, three teams of ST proceeded to the

Two picket lines demonstrated at the Federal Building in downtown Los Angeles at noon Wednesday with a police buffer between them.

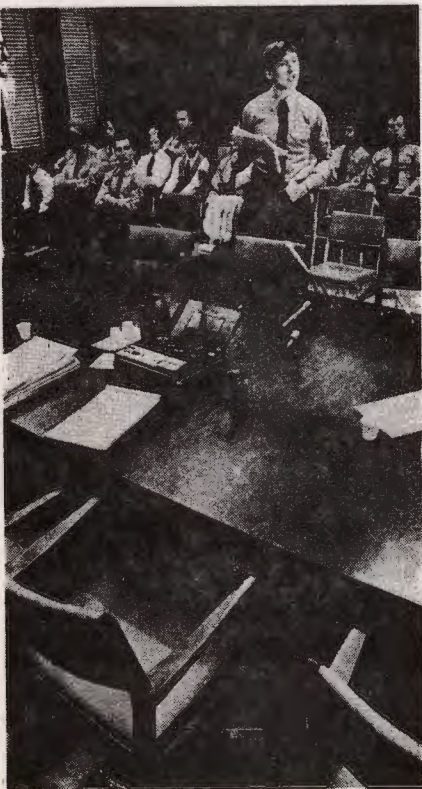
More than 50 participated in an American Zionist Organization protest against the failure of the United States to veto a U.N. Security Council resolution permitting the Palestine Liberation Organization to participate in an upcoming Middle East debate.

A few steps away, 11 members of the National Socialist White People's Party (better known as the American Nazis)—three of them women—picketed for the release from prison of Rudolf Hess, once Adolf Hitler's deputy.

Spokesmen for both groups said neither knew the other was going to be there and they ignored each other.

The Zionists also were protesting State Department policy toward Israel, under which they contend Israel was forced to sign the Sinai accords to its own detriment.

Hess, 81, is the only remaining inmate in the 600-cell Spandau war crimes prison in Berlin. The National Socialist spokesman said to keep him there is "a travesty."



Even though members of the Judiciary and Legislation Committee of the Common Council had walked from the room Monday, Arthur J. Jones, director of public relations for the National Socialist White People's (Nazi) Party, continued talking in the committee room. The group of Nazis expressed anger because a proposed ordinance aimed at stopping distribution of their literature was dropped from the committee agenda. Jones had asked for an opportunity to speak anyway.

French, British and West German consulates in Los Angeles. They presented the respective foreign dignitaries with their demand for the immediate release of Hess. A camera crew from Channel 13 was waiting to film the National Socialists handing over to the West German officials a letter demanding the immediate release of Comrade Hess.

After the ST team had visited the various consulates, the ST reformed at the Los Angeles Federal Building, only to find that a pro-Israel demonstration was going on! The ST proceeded to demonstrate for Hess' freedom despite the presence of 100 Zionist Jews at the location.

During the activity, the ST chanted for Hess' release from Spandau, while NSWO comrades sold WHITE POWER newspapers to the crowd.

### California Comrade's Case Concluded

The case pending against Party Security Officer Jerry Jones was concluded earlier this month. Jones was accused of first-degree murder for shooting and killing a deranged psychopath who was attempting to storm the El Monte HQ last August. Even though he was standing *inside* the building and protecting the life of a bystander from the homicidal maniac, a verdict of second-degree murder was brought against him. Jones, who remains in good spirits, is scheduled for sentencing 13 January.

### 'Disorderly Conduct' Charge Dropped Against Commander in Boston

The charges pending against the Commander in the racially-tense city of Boston were finally dropped recently. The Commander was arrested on 25 October while attempting to confront Judge Arthur Garrity at the Boston Courthouse. The Commander and an ST escort arrived at the Courthouse to personally deliver a letter of contempt to the mix-master judge. They were met at the Courthouse entrance by a cordon of police and U.S. marshals. When the Commander attempted to enter the public building he was immediately placed under arrest for "interfering with the operations of a government building." He was released later that day on \$1,000 bond.

All charges pending against the Commander stemming from his organizational trip in Boston have now been dropped.

### Auerswald Holiday's Brighter

The generous response of a number of self-sacrificing members and supporters to the plight of the Auerswald family (see NS Bulletin no. 190 as well as the November issue of WHITE POWER for details) contributed greatly to a brighter Yuletide season for that family than had been anticipated. Best of all, Armin Auerswald was released on bail to join his family for the holidays. For all the thoughtful gifts they received from National Socialist comrades, the Auerswalds wish to express their deepest appreciation.

### Louisville National Socialist Interviewed

Following a well-received speech on behalf of Louisville citizens opposed to busing at a public hearing on "alternatives to busing," in the community of Fairdale, NS comrade Irvin Halbleib, Jr., was interviewed by a reporter from the Louisville Courier-Journal, which is reproduced here.

## Portrait

### *A Louisville man talks about Hitler, blacks, Jews — and why he's a Nazi*

The front door of the old white house in south Louisville opened, and there he was, standing in the morning sunshine, a slightly plump, drowsy, 23-year-old Nazi.

"You wanted Irvin Halbleib?" he said, grinning as he tried to blink away the sleep. "I'm Irvin Halbleib."

It was 8:30 on a Thursday morning. Irvin Halbleib Jr. had worked at a factory until midnight, and now he had just awakened.

He padded barefoot down the hallway leading the way to his apartment, and inside the curtained door was the bed he had just left, its red and white cover tossed to the side.

It was a small, dark room. On the table lay a revolver, a dull silver revolver right next to the bed.

There were some books on the fireplace mantel. White Power. Mein Kampf. Something by or about Karl Marx. A long row of books.

Irvin Halbleib, whose appearance in

his Nazi uniform caused something of a ruckus at 2 busing-alternatives hearings last month, said he would like very much to talk. But not just then. "Could you come back at 11?" he said.

Things were different at 11. The bed was made. The revolver was gone. And Irvin Halbleib was dressed in a brown shirt, black tie, black pants and dark shoes.

His hair was combed over his forehead and to the side, in a way slightly reminiscent of caricatures of Adolf Hitler.

Halbleib wouldn't talk in detail about his private life. But he did say he is a "Dutch-German" Louisville native, a part-time college student, a worker at General Electric, a union member, a Catholic and a member of a group that still thinks much of Adolf Hitler.

He is a member of the National Socialist White People's Party, formerly the American Nazi Party. He said he has been a member for two months, but that he has been associated with it for about a year.

In November, Halbleib spoke at one of Jefferson County Judge Todd Hollen-

bach's hearings on court-ordered busing for purposes of school desegregation. It was in Fairdale. He wore his uniform and an arm band with a swastika on it.

He said that, as he remembered it, somebody pulled his arm band as he walked toward the podium, and that he took the arm band off because it got torn.

"Somebody grabbed it. I don't know who, but it was torn to pieces afterward," he said. "They thought I was a Communist. And, actually, we're new here. We are controversial. And we are misunderstood."

Halbleib opposes busing. He said he thinks it is "just one aspect of the Jewish conspiracy to destroy Western civilization. Their ultimate goal is the destruction of Western man."

One of the things you have to understand about the National Socialist White People's Party is that Jews and blacks are not highly regarded by it. Halbleib made this quite evident as he spoke. He was asked what the party would do in America if it came to power.

"We advocate an all-white America. We

would limit citizenship to whites only. We think America is a western cultural entity and should remain so. No nonwhites. Blacks and Jews would be repatriated."

The Jews, Halbleib said, at least the ones not convicted of "treason," would be sent someplace, perhaps some islands in the South Pacific. The blacks would be sent to Africa.

If any of them didn't want to go, "they would be expelled."

"As far as gazing Jews, we would not gas any Jews unless they are proven Communist traitors," Halbleib said.

Later, he said, "I don't hate Negroes. See A PORTRAIT. Back page, col. 1, this section

I'm simply for the preservation of my race and my civilization. I really regard him as an inferior species of humanity."

He was asked why race is so important to him. "I see the basic end of the state as to preserve the race . . . I think that race is the basic foundation of life."

And Hitler. What about Hitler? "I think he was the most dynamic personality since Christ. He has been misportrayed on a massive scale. Hitler fought the Alamo of the white race. He showed the way for the preservation of our civilization in the future, just as Davy Crockett showed the way for the preservation of Texas."

But Halbleib said he was no Hitler, just a man serving his party, a man willing to "accept the unconditional authority of the commander, Commander Matt Koehl," head of National Socialists.

Halbleib said he grew up in a politically conservative, Catholic family that lived in south Louisville. He said he attended Catholic schools and didn't care much about academics or politics until he was a senior in high school.

Then he started getting involved in "various right-wing groups. And I naturally evolved to the National Socialist viewpoint, through my own study, through intellectual conviction."

He applied, and became a party member. Now, he writes monthly reports to party headquarters in Arlington, Va. He said the reports cover his activities, such as his speech in Fairdale.

The party, he said, never asks its members to do anything illegal. He figures that it will really start becoming popular in the 1980s, and he said that the Louisville area, with all its antibus sentiment, is a "fertile field."

But he wouldn't say how many party members there are in the area. "We don't disclose numbers. We're going to save that for a very pleasant surprise in the future."

He said there is no formal "unit" of the party here yet, but that there will be one, "very soon."

It was a wide-ranging discussion in the dark little room that Thursday, but always it came back to politics and to the conspiracy Halbleib says he believes is overtaking the world.

He managed to avoid talking very much about his family, saying he had received some threats and didn't want them subjected to any more of them.

He said he has friends. "Some of them do not agree with conservatives, let alone National Socialists. I'm tolerant of other views and feelings."

He said he smokes a pipe, has an occasional drink but doesn't like beer, is studying German, has a girl friend, likes some movies but not "pornography trash, which is essentially Jewish," and reads a lot.

He reads Marx "because I think it is good to know one's enemy, to understand him."

## Rex J. Estelle

National Headquarters has received word that Party Supporter Rex J. Estelle passed away at his home in St. Petersburg, Fla., this past month. Comrade Estelle had been with the Movement since the mid-'60s, and had known Commander Rockwell back in his home state of Michigan. Mr. Estelle was told he was going to die just one week before the fact, when his doctor discovered he had developed terminal cancer. National Socialists will remember Comrade Estelle as they continue the struggle for a new world order.

### A Realistic Look at the Inevitable

One subject no one seems very fond of discussing — but one which faces all of us inevitably — is the subject of death. None of us will ever get out of this life alive. The important thing, of course, is that we strive to make our lives as worthwhile as possible in the relatively short span of time allotted to us on this earth.

And no more worthwhile purpose exists than unselfish service in the Cause of that higher Race which was placed in this world as a blessing to the entire earth. Today there is *only one* Movement completely, thoroughly, uncompromisingly — *fanatically* — committed devoted to the interests of Aryan mankind: the National Socialist movement, represented in America by the National Socialist White Peoples Party. As members and supporters you recognize this. This is the basis for your devotion and support.

But getting back to the inevitable, there is no reason why your role with this Movement need stop with your physical death. There is a very tangible way, in fact, in which you can continue to help the Cause after you have left this life. That way is through a bequest — either in the form of a will or life estate — to the Party.

Many persons reading this are in a position to remember the Party in their wills. Unfortunately, there is a tendency to put off a matter like this until it is too late. For those who would like to remember the Party, however — especially those over 40 — this is something that should be given very deliberate attention.

In the past, a number of individuals indicated they planned to leave their estates to the Party, but somehow they never quite got around to doing so before they died. In one instance, an outstanding patriot told Commander Rockwell that he intended to leave a seven-figure amount to the Party. Think what this Movement could accomplish with over a million dollars! The benefit would be incalculable. But the person in question died before he had an opportunity to complete his will properly, and so his estate went to some obscure playboy relative (for whom he had nothing but utter contempt) and his Jew lawyers! With just a little foresight and planning, similar situations can be avoided in the future.

If you would like to help perpetuate the work of this Movement and leave a living legacy to future generations, you may do so by making out a bequest to the Party's official corporation, *NEW WORLD ORDER, Inc.*, specifying exactly what you wish to leave to the Movement. (Bear in mind that a bonafide bequest must be made out to a person or corporation. Consequently, any bequest should NOT name the Party itself — which is unincorporated — as beneficiary, but rather its incorporated adjunct, New World Order, Inc.)

After your bequest has been drawn up, you should provide National Headquarters with written notice of your decision, so that your wishes will be carried out without complications or interference.

Some may wish to consider the possibility of a *life estate* to the Movement, which has the advantage of avoiding probate, to which all wills are subject. Local Organizer Mike Rumble reports no fewer than three fights (one involving a female supporter) broke out during the demonstration in St. Paul.

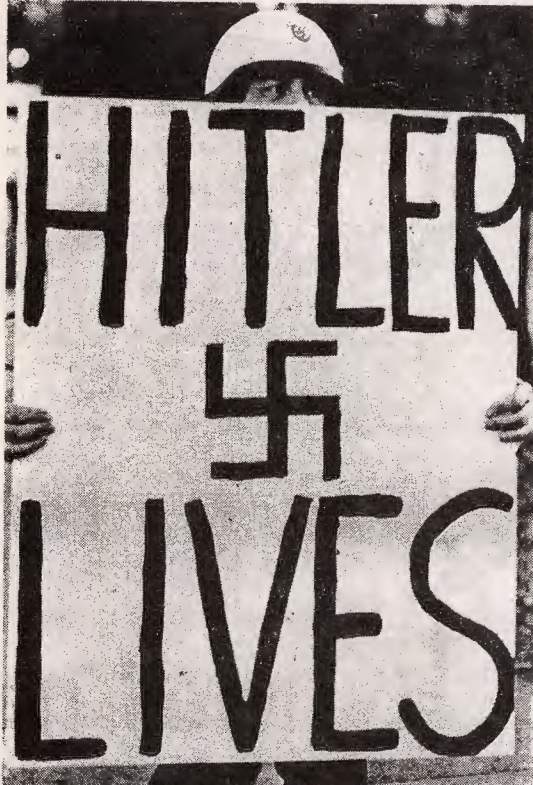

The demonstration was effective in drawing the attention of the Zionist rally speakers, including Hubert Horatio Humphrey, to the National Socialist presence in America. During his speech, the Miraculous Magpie lashed out at those "who did not know what it was like to live under Hitler," and made other anti-NS remarks.

The ST contingent left the scene chanting "Hitler Lives!"

## WANTED: Qualified Candidates

The Party is looking for persons who can qualify as National Socialist candidates for local public office. To be eligible, a person must:

- (1) Be a full or probationary Party Member;
- (2) Belong to a local unit;
- (3) Notify National Headquarters at least (3) months\* in advance of the election, giving all pertinent details (including type of office, election date, filing deadline, signatures required, etc.);
- (4) Secure NHQ approval of candidacy and campaign organization.

\*For any election before 15 April 1976, two-months' minimum notice will be allowed.

All approved Party candidates will be entitled to national Party election funds.

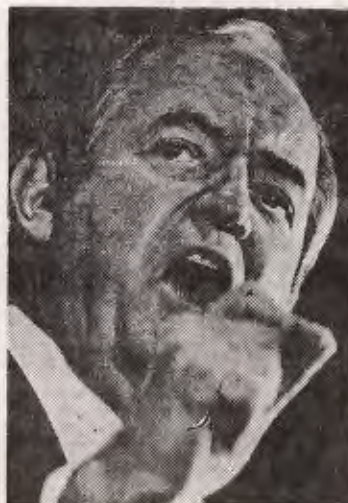

"It is nothing more or less than ugly, anti-Semitism with white gloves," Humphrey said.

Sen. Hubert Humphrey addressed the pro-Zionism rally Sunday.

He pointed out that the nations that voted against the resolution are democracies whereas the nations that voted for it have totalitarian leaders.

Before the 5 p.m. rally, five men wearing swastika armbands, white helmets, tan shirts, black neckties, black trousers and black boots carried anti-Jewish picket signs along the sidewalk on Cretin Av.

They obviously angered most of the Jews who saw them. One middle-aged man tried to attack them and was restrained by friends. "Did you ever live under Hitler?" he shouted at them.

Several young men stood and watched them while St. Paul police officers kept a wary eye out. Suddenly, a man ran up to the pickets and kicked a sign away from one man. Several small scuffles broke out as about a dozen young men charged into the pickets. The police quickly broke up the scuffles.

But the pickets' signs were broken and they became disorganized. Amid shouting and a few more quickly-broken-up scuffles, they were escorted by the police to a black and white truck and left.

As they left, a man threw a bottle at their truck. The police took the name of the man who threw the bottle, but no arrests were made.



## What's YOUR Question?

*This is a new feature which will deal with pertinent questions about Party operations and procedures. If you have a question, let us hear from you.*

### **Q. How should checks or money orders to the Party be made out?**

A. On dues and contributions, all checks or money orders should be made out to: *National Socialist White People's Party*, or *NSWPP* for short. Checks and money orders for all other purposes, such as orders, subscriptions, etc., should be made out to *NS Publications*.

### **Q. I have been an Official Supporter for almost a year, and I would like to ask you a question: Why are my monthly orders for WHITE POWER newspapers always one or two weeks late in arriving? This has happened more than once, even though I always include payment along with my OS pledge and activity report.**

A. You've practically answered your own question. In combining your WHITE POWER order with your pledge and activity report, you're trebling the processing time. Each of the three items must wait its turn to be taken care of, instead of being handled separately by three different persons at the same time. You can solve the problem and assure speedier service by separating each item according to the Party's departmental structure: Editorial (news clippings, etc.); Organizational (unit activity); Membership (dues and contributions, activity reports); and NS Publications (orders and subscriptions). Should you order an item from NS Publications and submit your pledge at the same time, remember to make out separate checks or money orders for each. This helps us and helps you too.

### **Q. Who may start a Party Unit?**

Anyone who is a full or probationary Party Member may, with permission of the National Secretary's office, form a probationary unit in those areas where no authorized unit exists. A unit consists of at least four persons who are either Party Members or Official Supporters.

Where an authorized unit already exists, a new probationary unit may be formed by anyone who: (a) is a full Party Member in good standing; (b) has served faithfully with the existing local unit for at least six months; and (c) secures the necessary approval from the National Secretary's office.

## **Note From National Secretary**

We are in the process of gathering evidence having to do with an ongoing dirty-tricks campaign by the FBI to harass legitimate political expression by National Socialists. Anyone who at any time has received hate letters — anonymous or otherwise — against the Party or persons in it are asked to forward the correspondence in question, or a photocopy, to National Headquarters.

Those who might be found to be persistently spreading rumors, lies, fictitious or slanderous charges, illegal or provocative suggestions, are likely to be a part of this disruptive attempt and are to be ruthlessly exposed and ostracized by Party personnel.

We reaffirm our unaltered policy of 100% legality and compliance with the law. We are an open and above-board *political* Party, and will not tolerate any subversion from elements of the above-named agency. We ask your cooperation in eliminating these destructive people from our ranks.

## **Notes From the Membership Secretary**

1. New Official Supporter cards for 1976 will be issued shortly. Supporters are reminded that their OS status will continue after their '75 card expiration date as long as their obligations are met. Supporters should submit three-month's pledges or \$30, whichever is less, to receive a new card for the coming year. Those who have remitted this amount in pledges already will be issued a card.

2. Effective immediately, the application fee for Party Membership becomes \$20.

## **Notes From NS Publications**

1. Due to rising postal costs, all NS publications orders after 1 January must include 10% for shipping and handling.

2. Effective 1 January, the subscription price of WHITE POWER becomes: one-year (\$4); two-years (\$7); three-years (\$10); and a lifetime subscription (\$65). Bulk rates are: 10 copies (\$3), 100 copies (\$20), 500 copies (\$50)\*, 1,000 copies (\$65)\*. \*You pay shipping charges on delivery.

3. Effective 1 January, the special membership rate for 50 WHITE POWERS will be \$5. This applies to Party Members only, and includes postage and handling.
