Those desiring accommodations should let us know as soon as possible, specifying double or single as well as particular nights desired, and remitting a \$20 deposit to hold a room.

Fall Building Campaign Just Misses the Mark!

The final total for the 1975 Fall Building Campaign is now in, showing that the drive missed its goal by the slimmest imaginable margin — by under \$10!

The grand total for the Campaign came to \$11,104.51 — just \$6.49 short of the \$11,111 objective! This astounding result shows that every single contribution — no matter how large or how small — is what is needed for an effort of this kind to succeed.

The 1975 Fall Building Campaign marked the start of a Three-year Plan to prepare the Party for an inevitable *mass-movement phase* by the late '70s. Although we fell short of our initial goal by a ridiculously small sum, it is no big disaster if every National Socialist is determined to make up for this shortcoming in the rest of the drive to raise a minimum of \$88,888.

All the great help of those dedicated members and supporters who sacrificed for the Fall Building Campaign is deeply appreciated. A significant portion of the monies raised so far have gone toward the current election battle in Milwaukee, in which Party Comrade Art Jones is running for mayor. The more help we get, the more we can do — whether it means purchasing newspaper space or radio and television time.

Occasionally a small handful will complain about the sacrifices this Cause asks of its members and supporters. To any who may be reluctant to make the necessary sacrifice for a National Socialist victory, we can only remind them of the relentless, fanatical determination of their Communist adversaries. Right now, as you are reading this, the Communist Party USA is busy raising a quarter million dollars for the publication of its newspaper alone — *and it expects to reach its goal, not in two or three years, but in FOUR MONTHS!* While some of our people give idle excuses, that is what our enemy is doing. Do those who complain and make excuses really want to see a National Socialist victory? *Or would they prefer a Communist victory??*

That which we have proven *can* be accomplished over and over in the past, *will* be accomplished if everyone continues to do their part throughout the coming months.

Again, to those National Socialists who contributed toward the 1975 Fall Building Campaign, we extend our warmest and deepest thanks.

National Socialist on the Ballot For Mayor of Milwaukee!

Thanks to the hard work of the Milwaukee Unit under the leadership of Anthony Schmitt, a National Socialist will be on the ballot in the 17 February primary for mayor. The candidate is Arthur J. Jones, Secretary of the local unit. The campaign began with the gathering of nearly 3,000 signatures — nearly twice the required number — by Milwaukee National Socialists. Jones is one of several candidates running against the incumbent mayor.

ST Greet Ghastly Golda

On 10 December, ST men from Stockton-Tracy and San Francisco massed at the Fairmount Hotel in San Francisco for a "Dump Israel" demonstration. The occasion was an Israeli fund-raising dinner featuring the former Israeli prime minister — Madame Gargoyle herself — "Ghastly Golda" Meir.

While the bulbous-nosed panhandler for the Bandit State wringed what had once been goy money from her fellow parasites, an ST column stood in front of the Stockton-Tracy Unit troop transport outside. Street traffic in both directions in front of the hotel halted at the 'unbelievable' sight of uniformed National Socialists chanting "Dump Israel," "No Troops for Israel," and "Smash Zionist Gangsters!" For 90 minutes the troopers remained the center of attention, rallying against the kind of opulent, power-wielding Jews inside who have for too long determined the course of American Middle East policy.

Stockton-Tracy Unit Secretary Rick Cooper reported no incidents besides the expected obscenities and spitting by Blacks, Jews

and Progressive Labor Party types who abound in the scummy downtown section of San Francisco.

The demonstration received coverage on all three local Bay Area TV stations, as well as two others in the San Joaquin Valley.

WUNS Member Arrested in Protest of Nuremberg-style Kangaroo Court

On 9 December, WUNS Member Jimmy Clendennen made worldwide headlines by his solo protest against one of the never-ending 'war crimes' trials of former National Socialists in Duesseldorf, Germany. Clendennen, wearing a Swastika armband and "White Power" button, walked up to the entrance of the Duesseldorf courthouse and handcuffed himself to the door. Inside, Hermine Ryan, an American until recently stripped of her citizenship and extradited to Germany, was defending herself as were 14 others against 'war crimes' charges trumped up in the great Nazi-baiting tradition of the infamous Nuremberg trials.

After arriving on the scene about 10 minutes later, police removed Clendennen's armband. His chants of "Freedom For National Socialists" in German had attracted a crowd of onlookers from the sidewalk and from inside the courthouse. Police soon were able to cut the cuffs and led Clendennen away to jail. Meanwhile, his lone effort had disrupted the proceedings of the court to the point where the judge asked Mrs. Ryan about her possible association with the National Socialist!

His exploit was immediately picked up by news services across Europe. Most German newspapers and radio stations mentioned the incident, some in great detail, as did the Armed Forces Network and many American newspapers, as shown by the accompanying reprinted articles.

Within a week after his arrest, Clendennen was set up before a kangaroo court of his own! Without knowing what the specific charges against him were, with no understanding of the proceedings and little of the language used, without being informed of his rights or of the plea his court-appointed counsel was to enter for him, before he knew what happened he was pronounced guilty of the odious crime of "glorification of National Socialist symbols," and disorderly conduct. He was sentenced to four weeks confinement.

Clendennen is expected to be deported to the United States at the end of his sentence.

American protests trial of 15 Nazis

DUESSELDORF, West Germany (AP) — A 25-year-old American, wearing a red swastika armband and a white power button, was taken into custody by police Tuesday after handcuffing himself to the door of a courthouse where 15 Nazi death camp wardens are on trial for mass murder.

"Freedom for National Socialism," he shouted repeatedly to court visitors before police sliced open the handcuffs with metal-cutting shears and led him away.

Police identified him only as Jimmy C., apparently a former U.S. soldier from Texas who has lived in West Germany for the last two years.

He reportedly told police he was a member of the World Union of National Socialists. No charges were filed immediately, but he is to be brought before an examining magistrate Wednesday.

U.S. housewife a defendant
Among those being tried by the court for war crimes is Hermine Braunsteiner Ryan, 55, a former concentration camp guard who became a New York City housewife.

Her husband, Russel Ryan, an electrical technician from Queens, was in the courtroom Tuesday for the first time since the trial began on Nov. 23. Presiding Judge Guenther Bogen asked Mrs. Ryan whether her husband had any connection with the demonstrator.

"You can ask my husband himself, she replied from the dock. He's sitting back there."

DUESSELDORF, Germany — A 25-year-old Texan who demonstrated outside a Duesseldorf court to protest a mass murder trial of former Nazi concentration camp guards was given a four-week jail sentence Tuesday for publicly disseminating National Socialist [Nazi] philosophies. Jimmy Lynn Clendennen, whose hometown was given as Houston, handcuffed himself to an iron fence outside the court building on Dec. 9, repeatedly shouting "Freedom for all National Socialists" to court visitors. On trial were 15 camp wardens charged with murdering inmates of Majdanek concentration camp in Poland, where at least 250,000 Jews and others died in World War II.

Germany Jails Pro-Nazi Yank

Duesseldorf, West Germany, Dec. 16 (AP) — A 25-year-old Texan who demonstrated outside a Duesseldorf court to protest a mass murder trial of former Nazi concentration camp guards was sentenced today to four weeks in jail for publicly disseminating National Socialist (Nazi) philosophies. Jimmy Lynn Clendennen of Houston handcuffed himself to an iron fence outside the court Dec. 9.

Cut Handcuffs
Clendennen shouted "Freedom for all National Socialists," to court visitors before police cut open the handcuffs and led him away.

On trial were 15 camp wardens charged with murdering 250,000 Jews and other inmates of Majdanek concentration camp in Poland during World War II.

Among the accused is Austrian-born Mrs. Hermine Braunsteiner-Ryan, 55, of Queens, N.Y., who was stripped of her U.S. citizenship and extradited for the trial.

trial began on Nov. 23. Presiding Judge Guenther Bogen asked Mrs. Ryan whether her husband had any connection with the demonstrator.

Husband Present
"You can ask my husband himself," she replied from the dock.

Northern California Activist Speaks to Classes

On 18 December, Stockton-Tracy Unit Secretary Rick Cooper spoke upon invitation before political science classes at Lincoln High in Stockton. Comrade Cooper addressed a total of 180 students in two sessions. His presentations included a general outline defining the aims and objectives of the Party, where the Party stands on the major issues of the day and on Party operations and publications. His only problem occurred when "I mentioned that the White race is the most industrious and productive race on earth and comparatively speaking, the Blacks and Mexicans tended to be lazy. One Mexican guy looked like he was having a hernia when he heard that and a Mexican gal blurted out that 15 percent of welfare recipients were White, that Blacks did all the hard work in the fields when they first came to America and that most all the farm labor today is done by Mexicans. I stated that the Negro slaves were well paid back for what little work they actually did and the reason why Whites are not working in the fields is because wetbacks had driven White labor off the land. That blew up the little grease-ball! I told her she was out of order and called upon another raised hand . . ."

Comrade Cooper reports many White students were very eager to receive some sample copies of WHITE POWER after the speaking concluded.
