## 'Hiding Place' Suffers From Slow Pacing

While members of the National Socialist White People's Party picketed and shouted anti-Semitic slogans outside, the sounds of sniffing prevailed inside a packed Tosa Theater where "The Hiding Place" opened Friday.

The protest by local Nazis apparently was provoked by the picture's theme of a Christian family helping Jews flee Nazi persecution in The Netherlands during World War II.

The nose blowing within was prompted by the tearful (PG rated) re-creation of the agony two courageously religious sisters suffered in German concentration camps as a result of their compassionate activities.

It is, indeed, a moving picture — emotionally, that is. The same cannot be said for its pace. For in 2½ hours, we are subjected to quite a few slow spots and more sermonizing

Corrie. Eileen Heckart brightens each scene she is in, and is responsible for much of the film's humorous relief. As the crusty Katje, bent on survival and eventual revenge, she practically steals the picture from the leads.

Arthur O'Connell is endearing as the inspirational papa, but the rest of the characters tend to blur, and in the confusion their relationships are hard to sort out.

At the end, the real Corrie ten Boom makes a testimonial, though somewhat anticlimactic, appearance. There is something unsettling after being overpowered by her earlier victimization, to last see her placidly doing needlepoint.

"The Hiding Place" is based on her memoirs set down in a book of the same title. Copies were being sold in the lobby, along with her "Prison Letters" and some of Billy Graham's texts. The movie was made by World Wide Produc-

## Mayor Candidate Cites Bias Ruling

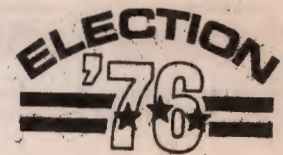

Arthur J. Jones certainly doesn't agree with the Federal Court order to desegregate Milwaukee schools, but feels it will boost his campaign as National Socialist White People's Party (Nazi) candidate for mayor.

Jones, 28, is secretary and director of public relations for the local party.

In an interview, Jones discussed his personal background, the party's national platform and his answers to some of the issues in the spring mayoral primary.

"I have nothing but contempt for anyone who would order the transport of defense-



want welfare."

Paging through a notebook containing notations on the city budget, Jones said that he could definitely cut the property tax.

He said that city funds for the Inner City Arts Council, Summerfest, the South Shore Water Frolics, the Northwest Festival, the International Ethnic Band and other "frivolous" activities should be knocked out of the budget.

Jones said that the city needed more beat policemen and also said that he would encourage more active citizen participation in crime fighting.

"It would be naive to discount the possibility that organized crime has not taken root in Milwaukee, if not City Hall," he added.

### Education Called Farce

Jones said that public education had become "a farce," concentrating on "sex education, black history and the holocaust."

His use of the term "holocaust" refers to what he said was the myth sustained by the "international Jewish conspiracy" that millions of Jews had been exterminated by the Hitler Nazi regime.

Jones, presently employed as a waiter, said that he would not give his present address because of threats against him and the firebombing of the home of a friend where he had lived from time to time.

A native of Beloit, Jones said that he graduated from Beloit Memorial High School in 1967.

Jones said that he had studied for three years at the University of Wisconsin — Whitewater.

He said that he was active in publication of the Warhawk World, a campus newspaper, while studying journalism and political science.

His past affiliations include the John Birch Society, the Young Republicans and the American Party, Jones said.

The Nazi activist said that he was honorably discharged from the Army, after serving a year in Vietnam, fighting in the central highlands and participating in the Cambodian invasion.

"Maier won't stop it," Jones said. "He's trying to spread it (integration) into the suburbs."

Jones said that he had sent a letter to Federal Judge John Reynolds and John A. Gronowski, the special master appointed to oversee the desegregation planning, expressing "contempt to all antiwhite cowards."

He said that he began the letter, "Dear Curs."

Jones said that if elected mayor, he would call on parents to boycott the public schools.

"I'm optimistic that white people will put the welfare of their children above a lot of Jewish nonsense," he added.

### Backs Housing Funds

Jones said that he favored more federal funds for housing and perhaps freeways, but not for rat control or welfare.

If elected, Jones said he would appoint a special investigative unit to "remove every undeserving welfareite from the welfare roles."

He said that he did favor local aid for the handicapped, who he said were "for the most part, decent, hard-working citizens who don't

## Florida's \$10,199 paves way in opening of 1976 DW drive

NEW YORK, Jan. 14 — More than \$22,000 have been turned in for the 1976 Daily World fund drive as the campaign entered its second week.

Dorothy Robinson, DW general manager, reported that over the past weekend, Florida press builders came through with a \$10,199 contribution. Thus Florida readers lead the way, having achieved 63 percent of their goal.

Ms. Robinson noted that the two conferences, convened by the Communist Party, held in New York and Chicago last weekend, gave a tremendous boost to the fund drive as well as the circulation drive. A total of \$225,000 must be raised by May Day. New York readers have already contributed \$4,169.

In the Midwest, Michigan is off to a good start. At the Chicago conference, press builders from the auto state turned over \$2,032 (20 percent).

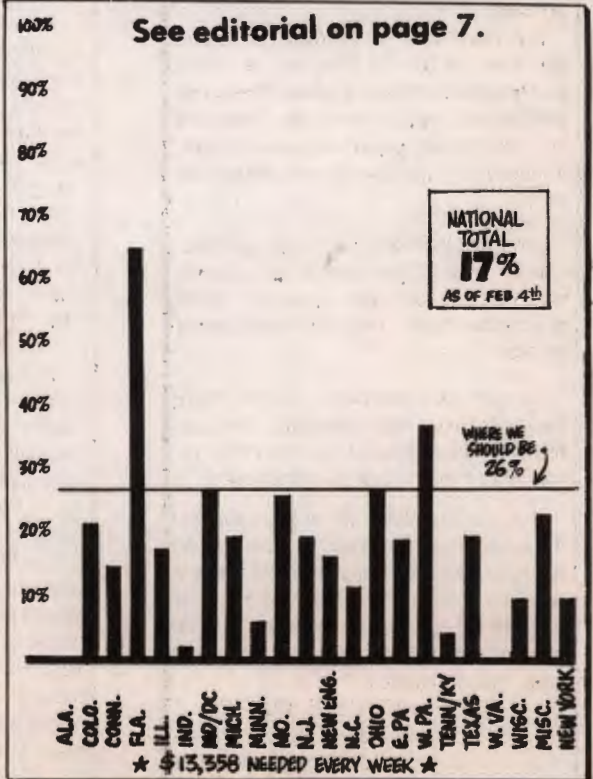
Other areas who have made significant progress in the launching of the fund drive include:

#### Israel Is Racist

Editor: Unlike America and Western Europe, where all races and religions are tolerated, although sometimes not very well, Judaism is the official religion of the state of Israel, and Jews are the official race. I challenge anybody to deny the following facts:

All Jews of the world are looked upon as the diaspora which is an integral body of Israel. Any Jew who immigrates to Israel becomes a citizen as soon as he arrives.

It is impossible for an Arab, for example, who was born in Palestine, to return and become a citizen of Israel. Those few gentiles who remain since the Jews took over are treated as second class citizens, if indeed they are able to gain citizenship at all.

Jews are forbidden to marry gentiles. More than 97 per cent of all government workers are Jews. Jews are given preference in jobs, promotions and social services.

Gentiles are restricted as to where they can live, what property they can buy and discriminated against in the social life of every Jewish community.

You say that Jews are only a religion? Then why is it that most of them can be identified by their appearance? Does a person's religion determine his race, or is it the other way around? Let Dr. Michael Heiman (letter, Dec. 16) call these facts "horse exhaust."

## Louisville National Socialist Continues to Stir Controversy

As a result of the *Courier-Journal* interview of Louisville Comrade Irvin Halbleib last December, which has drawn strongly hostile Jewish reaction, that newspaper's competitor, the *Louisville Times*, printed an article which amounts to an attack against the *Courier-Journal's* publisher, Barry Bingham, for allowing the interview to be published in the first place. This article is reprinted below.

# Some perils of one-dimensional reporting

More than a month after their publication in The *Courier-Journal*, interviews with a Louisville Nazi continue to draw reader protest.

And Barry Bingham Jr., editor-publisher of The *Courier-Journal* and The *Louisville Times*, has continued to defend the stories, which bespoke racial separatism and the brands of hatred against which World War II was fought.

Last week, a Louisville physician was the latest of many people to register dismay about the story on the Nazi.

To uncritically convey the "bigoted, intolerant and dangerous views" held by the young Nazi, the doctor wrote, was a disservice to the community.

In answer, the newspapers' ombudsman, quoting Bingham, said:

"... The greatest indictment that could ever be brought against a newspaper editor would be that a vicious organiza-

tion such as the Nazi party had sprung up in his community without the fact being publicized in his newspaper."

But such comments beg the main question.

Publication of the interview (and even the generous space devoted to it) is not the question. The issue is: Why were separatism and hatred allowed to parade unburdened by the record of history? Bingham is in the position of defending reporter Dick Kaukas' story on the Nazi—a story that did only half the job.

But the absence of any historical framework made the word "portrait" of the Nazi the more serious transgression.

The justification for the interview was that the man had caused a ruckus by appearing at bus-ing-alternatives meetings in his Nazi uniform and swastika armband. Perhaps the man discredited himself by being permitted to ramble on

about gassing "commie Jews" and sending blacks to Africa.

But reporter Kaukas says that was not his intention. The result: The man was allowed to say without challenge that the National Socialist White People's party, successor to the American Nazi party, "never asks its members to do anything illegal."

In the interview, statements by the Nazi linking most Jews and blacks with communism were allowed to go unchallenged.

But 25 years ago, the result of reporters setting down all they were told by Sen. Joseph McCarthy, without checking the record or asking enough questions, lives and reputations were unjustly ruined.

Publisher Bingham has missed the point that the same still holds true for one-dimensional reporting.

Michael Allen, a candidate in the April 6 election for village trustees and a member of the St. Louis Nazi Party, made the request Monday. He requested permission to conduct the rally as part of his political campaign.

## Breckenridge Hills Hikes Merchants License Fees

**BRECKENRIDGE HILLS**—The Board of Trustees discussed in great detail Monday night a new merchants license ordinance for the village and approved it by a vote of 7 to 1.

All businesses must apply for licenses during the period of Jan. 1 to Feb. 15. Fees are payable by Feb. 15 each year.

Under the new ordinance, a merchant who sells goods and services would be required to pay two dollars for every \$1000 of gross sales. The min-

imum fee for this category would be \$25.

Prior ordinances set the fee at one dollar per \$1000 of sales with a \$15 minimum.

Budget Director Bernard Korinhizer reported that revenue from merchants licenses for the first eight months of the village's fiscal year has been \$922.

**CITY CLERK HOLSTON BLACK** added that many businesses in the village in the past have been subject only to the minimum license fee.

**MICHAEL ALLEN** again visited the

A member of the National Socialist White People's Party, Allen presented the trustees with a letter requesting permission to hold a White Power rally in conjunction with his campaign rally for the Breckenridge Hills Board of Trustees.

The board agreed to review his letter and give its decision on the request at the next board meeting.

## WUNS Demonstrator Deported

WUNS member Jimmy Clendennen was deported by West German authorities earlier this month to the United States. After serving his four-week sentence in the Duesseldorf jail, Clendennen was brusquely rushed to a near-by airport and hustled aboard an American-bound jet. He arrived safely in Philadelphia and visited Na-



tional Headquarters in Arlington to make a full report on his world-wide NS activities. Clendennen now rejoins the National Socialist struggle in the U.S. and was welcomed home by many comrades who helped him celebrate.

### **German National Socialists Go On Trial**

On 21 January, a trial against 10 men opened in Duesseldorf, West Germany. The charges against the 10 centers on their involvement in the founding of the National Socialist Combat Group (Nationalsozialistische Kampfgruppe) founded in April of 1972. They are being accused of "criminal association" in attempting to establish the outlawed NS organization, the goal of which is "to resurrect National Socialism in Germany." Most of the 10 defendants were born *after* the war and include three non-commissioned officers of the German Army.

This trial parallels that of Hermine Ryan and other alleged "war criminals" being currently held in Duesseldorf, Germany. That trial was protested by a courageous lone WUNS member in December of 1975 (see NS BULLETIN No. 194 for details).

We encourage local units and activists to organize demonstrations against German consulates where they exist or at the offices of the German government-sponsored airline, Lufthansa, as a sign of international NS solidarity.

### **Arlington Unit Pickets Jew Leader**

On 28 January Yitzhak Rabin, the Prime Minister of Israel, arrived in Washington, DC. In response to the presence of this Zionist gangster, ST of the Arlington Unit held a picket the same day.

Beginning at 12 noon, the ST marched in front of the White House along Pennsylvania Avenue. The anti-Zionist picket signs and Swastika banner carried by the column stood in sharp contrast to the Israeli flags that were flying from government buildings for Rabin's visit.

The presence of the ST men infuriated the numerous Jewish passersby. Several minor incidents occurred when Jews purposely blocked the path of the column and were shoved out of the way by the ST. Despite this the Jews never worked up enough courage to attack the column.

After an hour-and-a-half of picketing, the ST were attacked by a gang of long-haired Marxist creeps. The Reds were dispersed by the ST in less than a minute, but not before one of them was knocked on his back and stomped in the face. Two of the fleeing Marxists were arrested and hauled away by the police.

The ST received no injuries in the fight, and the picket concluded without further incident.

### **Note on Jailed California Comrades**

L.A. Unit security officer Jerry Jones has been given a 300-day sentence to be served in the L.A. County jail, to be followed by five-years' probation.

Comrade Clyde F. Bingham, accused of "assault with a deadly weapon" is scheduled to come up for trial on 4 March, unless there is a further continuance.
