# 'FREE AMERICA!'

## Seventh Congress Only a Few Weeks Away!

National Socialists from all across the U.S. and Canada are getting ready for the greatest Party event of the year — the Seventh Continental of the National Socialist White People's Party. Present indications are that this will be one of the best attended Congresses ever held. If you haven't already done so, there is still time (until 25 June) to register. If you lost or misplaced your form, you can still sign up by writing in to National Headquarters and listing the required information — your name and address, when you'll be arriving and how long you plan to stay in the area. Be sure to include the registration fee — which is \$5 if you can only attend one day, \$10 if you can attend the Saturday and Sunday sessions and \$15 if you wish to attend the Monday session in addition to the weekend events. If you cannot afford the registration fee right now, you can pay at the door. All fees include the cost of the meal which will be served each day.

Don't miss the chance to be a part of this historic occasion. We look forward to seeing you there.

### TRANSPORTATION:

Several comrades from across the country are offering rides to the Congress. If you are in need of transportation, check the last *NS BULLETIN* to see if you live near or on the way from the areas listed where rides can be set up. If so, contact National Headquarters to work out the arrangements.

Those who plan to fly to Washington are reminded of the reduced rate when reserving their seat seven to fourteen days in advance.

### Registration:

All comrades should try to register as early as possible, so they don't miss the first events beginning on Saturday around 10a.m. Registration times at National Headquarters will be from 4-12p.m. on Friday, 2 July, and from 8-12a.m. and 4-6p.m. on Saturday. To reach National Headquarters go to the 2500 block of Wilson Blvd. in Arlington. We're located right at the corner on Franklin Road. If you have any problems, just call the Headquarters phone number, (703) 524-2175, for directions. In case you forget this number, remember it is listed in the phone book in bold letters in the white pages.

### INTERVIEWS:

Because of a very tight schedule, those persons wishing a private audience with the Commander or some other Party officer should contact NHQ no later than 30 June to make an appointment. No membership interviews will be held between 2 and 4 July. However, such interviews can be arranged before or after that time. Eligible persons should notify NHQ by 30 June.

### AUDIO-VISUAL:

The Party is looking for several qualified amateur or professional photographers to take movies and still shots of the Congress. Interested persons should get in touch with National Headquarters immediately.

Volunteers are being sought to tape the Congress sessions. Interested persons should contact NHQ as soon as possible, describing their equipment. (No cassettes please!)

No unauthorized photography or recordings at the indoor Congress sessions will be allowed.



## FILMS:

The classic documentary film of the 1934 Congress in Nuremberg, *Triumph of the Will*, as well as a shorter Party film is scheduled to be shown in the evening of Friday, 2 July for persons arriving early for the Congress. Those who wish to see the films should be at National Headquarters no later than 8p.m. for the shorter film, and no later than 9p.m. for *Triumph of the Will*.

## RESERVATIONS:

Arrangements have been made to allow those attendees with reservations to proceed directly to their rooms upon arrival in the area. If you have made a reservation but not sent in the \$20 deposit, be sure to do so as soon as possible. If the deposit is not received at least one day before arrival, NHQ will have no choice but to assign the room to some other comrade(s).

## ST MARCH AND RALLY:

All qualified male participants should come prepared for an ST parade and rally. Participants should come with regulation uniform, consisting of combat boots, black straight-cut trousers (flared-leg trousers are permissible only if they are bloused over combat boots), silver buckle garrison belt, black socks, tailored khaki shirt, black tie (width 3½"), Swastika armband and regulation ST helmet. (The last item will be available at the Congress site.) Everyone should try to participate in these exciting street demonstrations.

## APPEARANCE:

Attending a National Socialist Congress is a *privilege*, not a right. That privilege requires that all attendees adhere to certain basic National Socialist standards relating to appearance and dress, as well as conduct and attitude. Accordingly, the following items are to be noted:

*Hair length* — All male attendees must have proper haircuts. This means that hair is to be no more than four inches on top, evenly tapered off on the sides and back, with sideburns not extending below the opening of the ear. Under no circumstances is the hair to touch the ear or collar.

*Mustaches* — Mustaches must be neatly trimmed, and are not to extend over the lip or below the corner of the mouth. All male attendees are otherwise to be clean-shaven. An exception will be made in the case of persons with well-groomed beards who are not taking part in ST activity.

*Male dress* — All male attendees participating with the ST in the public march and rally should wear the basic ST uniform, with the exception of NSYM personnel who should wear the NSYM uniform.

At the indoor sessions delegates should be prepared to wear civilian dress with suit coat and tie. Sessions requiring uniforms will be announced at the Congress.

No levis, bellbottoms, leather jackets, sandals or freak or garish attire will be allowed for attendees. Similarly, no German military paraphernalia will be permitted to be worn.

*Female Dress* — Women delegates should wear a dress or skirt and blouse in good taste. Miniskirts (anything over 3" above the knee), "hot-pants," shorts or slacks are not proper for the occasion.

NSWO members should wear proper NSWO dress at those sessions announced at the Congress.

*Armbands* — No armbands are to be worn off the Congress site premises.

## DUAL MEMBERSHIP:

The Congress itself (not including the public march and rally) is an INTERNAL event of the National Socialist White People's Party and its auxiliary formations. Only those who are committed to it above all other movements will be admitted, except for a few individuals who will be officially admitted as special observers. Admission to the Congress is a privilege that is reserved for those who give their sole loyalty to the one true Cause of Adolf Hitler and Lincoln Rockwell as represented by the Commander of our Party.

## Attention Unit Leaders

Congress attendance for all unit leaders and local organizers is mandatory; unless officially excused. Personnel under their jurisdiction must be given all possible encouragement to attend. Unit leaders and local organizers will be held responsible for attendance from their locales.

## Arlington ST Demonstrates in Nation's Capital

On 24 April ST men took part in an anti-busing rally on the Capitol steps in Washington. As the National Socialists marched through the assembled crowd, they chanted "White Power," "Who needs niggers?" and "Ship those niggers back!" This was just what the racially aware Whites attending the rally wanted to hear. They swarmed around the Party activists to tell them how glad they were to see somebody standing up for the White race. The ST passed out anti-busing literature, and within a few minutes large quantities of leaflets and copies of the February-April issue of WHITE POWER were given away. Although donations were not solicited, many Whites there gave contributions to the Party.

A "Free Rudolf Hess" demonstration was conducted in front of the White House on 8 May, in commemoration of that National Socialist's attempt to stop the bloodshed between brother Aryan nations in World War II. Two teams of ST, picketed for over two hours along the busy sidewalk. They carried signs, (see photos) and chanted "Free Rudolf Hess" while the operations officer passed out Hess leaflets to passersby, the majority of whom were White tourists. Their response to the plight of the Leader's former Deputy was largely favorable. Of course, there was the usual spitting and cursing from Jews, and a few scummy-looking members of the "Youth against War and Fascism" shouted obscenities at the squared-away ST. This only put the National Socialists in an even more favorable light by visibly showing to the Whites how disgusting our enemies actually are.

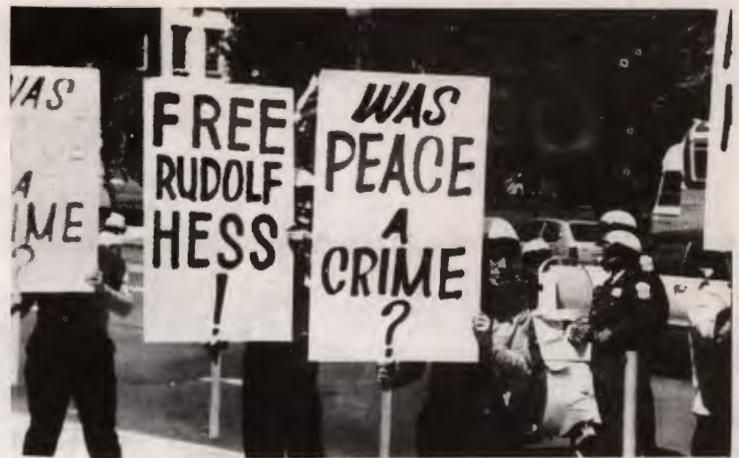
Due to the fact that the Party was first to obtain a permit for the White House sidewalk, the Reds were unable to hold an anti-White demonstration as they had planned. This infuriated the Marxists considerably.



On 12 May two teams of ST picketed the Washington Hilton, where a meeting of "the survivors of the Holocaust" was being held. The ST held picket signs with the slogans: "Hitler was Right" and "The Holocaust - Six Million Lies" and chanted the same. Shocked expressions of disbelief came to the faces of the hooked-nosed "survivors" as they arrived at the plush hotel in their big limousines.

A fight broke out when the rear of the column was attacked. The National Socialists suffered no injuries, but one Jew was sent away whining with blood streaming down his face. The picket concluded without further interruptions.

## Motion of Dismissal Entered in Trial of LA Security Officer

On 13 May Duty Officer Clyde Bingham appeared in court to face charges of "brandishing a weapon not in defense of persons or property." The case arose out of his involvement in a shooting incident on 15 August 1975, in which a deranged psychopath attacked the Los Angeles Party headquarters. Since that time, Comrade Bingham has been facing 9 months of legal harassment, including the charges of assault with a deadly weapon which were dropped in March.

At his latest court appearance, ST Bingham's court appointed attorney entered a motion for dismissal claiming that (a) his client's right to a speedy trial was being violated; (b) the prosecution lacked evidence; and (c) that the brandishing charge was encompassed by the earlier charge of assault. The El Monte court judge will decide whether to grant the motion on 7 June.

## Milwaukee Comrades Sentenced

Unit Leader Tony Schmitt and ST Dale Enders have been sentenced to 10 days in jail and two year's probation stemming from their conviction of phony charges concocted by local Jews. (See NS BULLETIN No. 201 for details.)

The Milwaukee Unit is determined that its activities will not be hindered by this latest kosher harassment. In fact, our comrades have been encouraged by this latest incident, because they are even more convinced that their courses of action in that city have been correct ones. For as Commander Rockwell said, one knows he is hurting the enemy when they retaliate in force.

## 2 Nazis to Serve 10 Days in Jail

Anthony Schmitt, leader of Milwaukee's Nazi Party, and Dale Enders, one of his self-described "storm troopers," were sentenced Friday to 10-day jail terms under the Huber Law and placed on probation for two years.

Schmitt, 23, and Enders, 22, were convicted by a jury March 31 of criminal damage to property and disorderly conduct.

They were found guilty of smashing the windshield of a car driven by a Jew, who said he was on patrol to watch for Nazi activity and to protect synagogues from vandalism.

County Judge Patrick J. Madden ordered, as a condition of probation, that they stay away from any block where a Jewish school or

synagog was located.

Madden said he was constitutionally prohibited from giving them a court order involving their political activities, but he added: "I would advise you to conduct yourselves so as not to become involved in any public disturbances."

Madden said, "Any philosophy such as a Nazi philosophy is a cancer."

Schmitt and Enders each had faced maximum fines of \$400 and jail terms of nine months.

The charges against them were brought after Milton Kleinberg, leader of the Concerned Jewish Citizens, told police that the two men had ambushed his car last Sept. 20 at 32nd and Lisbon.

### Nazis Deny All

Recently, the National Socialist White People's Party (also known as the American Nazi Party) has been accused of conducting a campaign of harassment and terrorism against the black community in Pasadena.

The most recent accusation made against the party is that it sent a letter bomb to the Rev. Harrison Bailey. We have also been accused in the past few weeks of shooting up the Pasadena headquarters of the Communist Socialist Workers Party.

The White People's Party denies having committed these or any similar acts.

The White People's Party does not advocate or practice the use of illegal violence or terrorism. The party, now, as in the past, advocates working within the system to effect change.

We see many things wrong with society today — unemployment, inflation, rising crime, rising drug abuse, illegal aliens, to name a few — but we feel that the electoral process is still workable. We seek political power through elections, not by random acts of violence.

Our slogan is "Ballots, not Bullets!" The party fully concurs with Pasadena Police Chief Robert McGowan that the accusations made against us and the police are the work of a conspiracy seeking to discredit the Pasadena Police Department and the White People's Party.

## Trotskyites Launch Smear Campaign Against LA Unit

Due to increased activism by the Party in the racially troubled city of Pasadena, race-mixing Reds of the Socialist Workers Party have attacked the LA Unit with the usual brand of lies.

Recently, ST Gregg Hummer was charged with battery by a SWP member in connection with an incident that arose at a picket of the SWP bookstore. During the Party demonstration, Comrade Hummer defended himself from an attack by a Trotskyite spic. In typical Communist fashion, the Red twisted the facts and claimed he was attacked by the National Socialist. Comrade Hummer will appear in court on 27 May to fight this false charge.

In a separate but related incident, a Black SWP supporter (who claims to be a "Reverend"), pulled another stunt like the one he tried last November, in which a phony "lynching" was staged. (see NS BULLETIN No. 191 for details.) This time he told the Pasadena Police Department that the Party sent him a "letter bomb" which exploded in his hands. As evidence of this, he showed them some minor, self-inflicted burns on his hands and a partially scorched envelope. Even though the police have not even bothered to investigate this ridiculous accusation the Jewish and Red press reported the accusation as though it were a proven fact. Some of the coverage devoted to this incident is reproduced below and to the left.

## Pasadena Blacks target of death threats

PASADENA, Calif.—"Blood will flow in the streets if you trouble-making niggers continue to mess with our schools and board of education with this force [sic] busing stink."

Racist opposition to Pasadena's school desegregation plans continues. On April 8, twelve death threats, addressed by name to Black community leaders, Black clergy, and probing activists, were issued by the Nazis.

The letters were mailed to Rev. Harrison Bailey, a Black minister who has been vocally in favor of school desegregation here.

This is not Reverend Bailey's first encounter with the local fascists.

Last year, members of the Nazi party abducted Bailey, dragged him, and took him to a nearby park. There

they "strung him up" in a tree by the shoulders, as a mock lynching.

The death message recently sent to Bailey states, "The next bomb under your house will be set to go off pronto. This may be your last warning."

All the messages were signed "Unit Seven, N.S."

"N.S." stands for "Nazi Sympathizers," the "underground" section of the Nazi party. The same group sent a series of threats last year to Pasadena Black leaders.

The threats come on the heels of an NAACP assembly March 28 backing Pasadena's desegregation plan, and two weeks before a planned April 24 rally here in support of school desegregation.

Several NAACP members and or-

ganizers of the April 24 action are targeted in the messages sent to Reverend Bailey.

The Nazi thugs recently directed their violence against Pasadena socialists, too. On February 25, the evening of the new Socialist Workers campaign headquarters open house, men later identified by police as Nazis were spotted taking down license plate numbers of cars parked nearby for the program.

The next night, rifle bullets were shot through the headquarters windows.

Then on March 13, the Nazi party staged a picket line in front of the campaign office and attacked Manuel Barrera, a socialist campaign supporter.

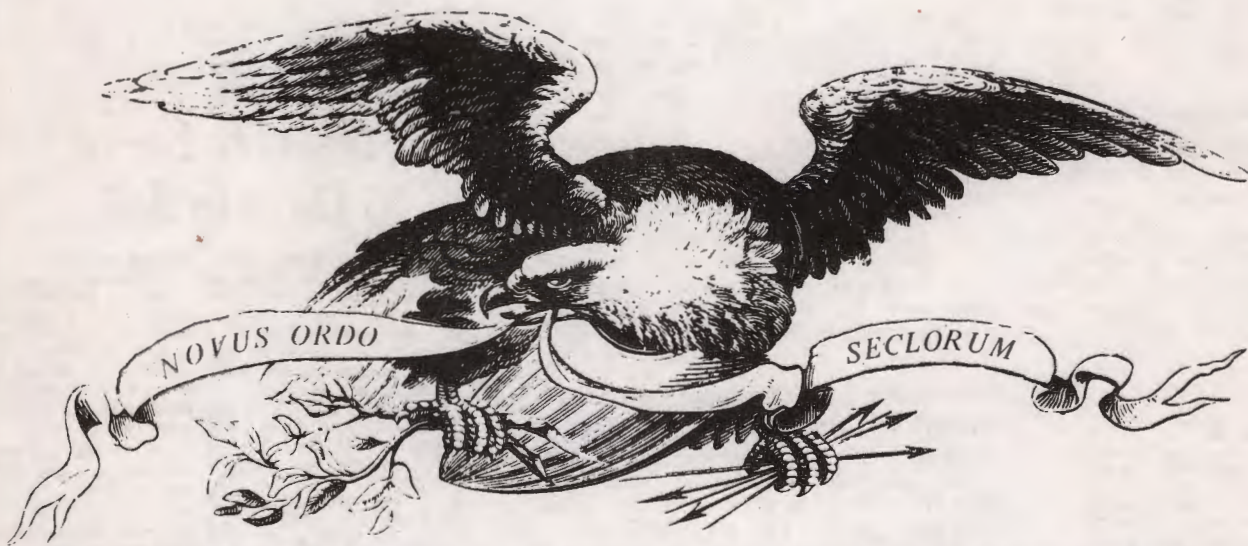
