SAN FRANCISCO COMRADE ENTERS BOARD OF EDUCATION RACE

Party Comrade Richard Johanson is running for a position on the Board of Education of San Francisco in the 2 November election. Johanson, a former teacher and secretary of the Bay-area unit, is conducting a campaign for neighborhood schools, no-nonsense education and racial pride. Although he is running in a crowded field of 17 candidates and doesn't have the large amounts of campaign money that some of his well-heeled opponents have, local National Socialists feel that the Party's campaign will afford new opportunities to gain increased public support for the Movement in the Bay area.

Developments and results of the campaign will be reported in the future *Bulletins*.

You May Be Eligible to Run For Public Office

In order to demonstrate the extent of National Socialist support and strength in the White community, the Party needs more Members and Supporters to volunteer to run for public office in their local areas. You just might be qualified! It is not terribly difficult to run in an election — every candidate the Party has run has reported that it was much easier than they thought to get on a ballot and run a campaign. Most National Socialists would be surprised that they too may have the talents to conduct a professional and effective election bid. Party personnel are encouraged to find out information on the appropriate elective offices that they might run for. Check with National Headquarters with that information and secure the necessary approval for any election plans. Most *representative* positions such as member of a school board, board of trustees and city council doesn't require any special governmental skills. *Executive* positions, however, such as mayor, sheriff, district attorney or treasurer usually require certain talents or experience suited for the position sought. Please try to notify NHQ at least six months before the date of the election you plan to enter.

Remember, it is immaterial whether you win or lose in elections at this time. The important thing is *to get involved!* In the process you will be able to attract and develop the latent NS support that exists in your community — and get the largest possible number of votes for National Socialism.

Houston-Galveston Activists Picket Pornographic Theater

On 10 July, uniformed ST and NSYM of the Houston-Galveston probationary unit picketed the pornographic "Academy Adult Theater" in Houston. The National Socialists carried signs reading "WHITE POWER," "BAN JEW SMUT" and "STOP JEW PORNO" and "Race Mixing Stinks" leaflets were passed out. During the picket, the theater manager came outside and threatened the activists, but retreated when the ST confronted him. Except for some heckling from certain scum elements present there were no incidents and many passing

Whites expressed support of the National Socialist's anti-pornographic stand.

On 24 July, the contingent returned to the same theater to picket the anti-NS film, "Three the Hard Way." The ST carried an American flag and picket signs and chanted, "What Do We Want — White Power!" and Ban Jew Smut", over and over as they marched. Several minutes after the beginning of the demonstration, police arrived and consulted with the Jewish owner. The two officers tried to tell the demonstrators they were trespassing on private property, which was not true. The National Socialists were at all times in a single file on a public sidewalk. When the column continued to picket, the police again consulted the Jew owner, who agitated them for several minutes. The police then arrested the ST, claiming falsely that they had interfered with a business, harassed customers, etc. The National Socialists were booked on charges of "disorderly conduct." The following day they were bailed out and had a court appearance set..

Local Organizer Jimmy Clendennen summed up the whole incident: "This whole thing only makes us more determined, and it shows how much the System considers us here. We expect to have the phony charges thrown out of court."

'Outlaw Nazis'

To The Sentinel:

Any extraordinary combination to commit crime and foment domestic strife requires extraordinary legislation for its suppression. What that legislation should be imposes a grave responsibility upon any lawmaking body.

A fundamental principle of law is that while a citizen owes allegiance to the government he has a right to expect protection for life, person and property. Many times government officials are in cahoots with the criminals in a conspiracy to oppress and harass the people.

The Constitution contains an express grant of power coupled with an imperative injunction for the exercise to protect citizens. The first section of the 14th Amendment provides that no state shall deny to any person within

its jurisdiction the equal protection of the laws."

If the National White People's Socialist Party cares to pattern its behavior after the degrading philosophy of one of the greatest archenemies known to mankind, after a mind responsible for millions of murders in Hitler's Germany, then full force should be given to laws already on our books to outlaw the American Nazi Party. In the amendment declaring equal rights, the fifth section states: "Congress shall have power to enforce by appropriate legislation the provisions of this article." The "provisions" being equal rights for all inhabitants. This authority is subject to no restrictions or limitations.

By whose authority does this National White People's Party dare to tell me what rights I can enjoy and what rights are denied me? Why do

any think they can deny me any of the rights they enjoy as citizens of the United States?

It is clear that Congress does have the power to investigate subversive activities. There's no use in fooling around with local authorities in combating this Nazi venom polluting our national social system. They present all sorts of excuses as to why we should not outlaw these saboteurs of domestic peace.

I know that the wisdom of enlightened statesmanship can prescribe a remedy for any abuse which the ingenuity of bad people can invent. I know that failure on the part of our lawmaking bodies to curtail the shameful acts of our national hoodlums will be an admission that our criminal law is a mockery and our government a failure. 'Not Subversive'

To The Sentinel:

A recent letter by James Cameron has a few errors pertaining to the National Socialist White People's Party (NSWPP) that warrant correction.

First, Cameron attempts to allege that the government is "in cahoots" with the NSWPP; in the past, we have had enough visits by FBI agents to disclaim what Cameron attempts to prove — whether or not he would care to believe it.

Then, he invokes the Constitution in an attempt to have the NSWPP banned. But the Constitution also states: "But when a long train of abuses and usurpations, pursuing invariably the same object evinces a design to reduce them under absolute despotism, it is their right, it is their duty, to throw off such government, and to provide new guards for their future security." This is what the NSWPP plans on doing: fulfilling our right and our duty in an effort to heave off the yoke of "absolute despotism" in the United States.

Cameron then goes on to ask "by whose authority" can we tell him what and what not he can do? I have yet to know of someone with the NSWPP telling a non-National Socialist what he may or may not do. If the NSWPP would come to power in these United States tomorrow and it was not found to Mr. Cameron's liking to live under such a government, he would then have every right to move to a nation with a political atmosphere more to his liking.

I would like to point out that the National Socialist White People's Party is not subversive — as claimed by Cameron. We are registered in Wisconsin (and many other states as well) as a legal political party. We are not legally known as the "American Nazi Party" or the "National White People's Socialist Party" as Cameron so claimed. But rather, the National Socialist White People's Party. Believe me, there's a helluva difference. If Cameron cannot even get our name stated correctly, I wonder if he can form an objective point of view — which is needed to form an opinion if one is to involve himself in politics or whatever.

Nazi Party Would Give Blacks \$10,000 To Return to Africa

"We're sick and tired of Blacks getting special treatment," Jeff Palmer corresponding secretary of U. National Socialist White Peoples Party, said recently. Party propaganda distributed in Washington, D.C. advocates giving each Blackperson in the United States \$10,000 to return to Africa.

The group, formerly known as the American Nazi Party, considers Milwaukee one of its national strongholds, according to an article in the Wisconsin Jewish Chronicle, a weekly tabloid.

The "strong" showing by a Nazi candidate in Milwaukee's

spring mayoral race proves that the party "has a great deal of support in the city," according to Jerry McGee.

McGee is a 60-hour-a-week "professional duty officer" in the Arlington, Virginia national headquarters of the Nazi party. McGee made claims of growing support for his party in Wisconsin, especially in local police departments. He was, however, unable to substantiate most of the claims.

McGee, 24, stressed the vote-getting ability of Arthur J. Jones, the mayoral aspirant, may influence the party to run additional candidates in Wisconsin.

According to party records here, Jones' 4,765 votes comprised 5.5 percent of the votes cast in the primary.

"It's not quite our time yet, but we did well anyway," said McGee. He claimed that support for Jones would have been greater had voter turnout not been curtailed by bad weather. had suburban residents been allowed to vote in the primary, Jones would have received several additional votes, according to McGee.

Party officials believe that the Milwaukee Police Department "sympathizes and agrees" with the Nazi Party platform.

McGee claims that Milwaukee police officers admire the way in which Nazis "patrol the streets of the city and overwhelm such Communists groups as the Youth Against War and Facism."

McGee and other party spokesman blame Jews for what they call the "ills" in Milwaukee and other US cities — "like Communism, race-mixing, and pornography."

For such crimes, McGee declares, all Jews should be tried and punished, while those found innocent should be sent to a remote island.

St. Louis Unit Demonstrates in Support of Local Police

In the aftermath of incidents in which St. Louis Police shot Black criminals, local Marxist and liberal groups have been screaming for limitations on police use of firearms. On 26 July a "coalition" of Red organizations picketed the St. Louis city hall in support of their demands. Counter-picketing them were ST men from the local unit, who were present to demonstrate the White community's support for the police in curbing ever-increasing Black crime in the city and to expose the Reds' actions as nothing but another anti-White move. Publicity received included the two articles reproduced below.

Mayor Against Restrictions On Police Use Of Firearms

Mayor John H. Poelker says he opposes restrictions on the use of firearms by police.

Poelker said at his weekly press conference yesterday that the issue of firing a weapon often involved a split-second decision by a policeman.

In general, the city policy follows a state law allowing policemen to shoot at fleeing persons suspected of having committed felonies.

Shortly after the press conference, a coalition of groups demonstrated at City Hall against what they called "excessive force and brutality on the part of policemen."

"There has been no reason for police

to shoot when some of the suspects haven't even had weapons," said Coraminita Mahr, co-chairman of a group called Citizens Against Police Brutality.

Meanwhile, three members of the St. Louis branch of the National Socialist White People's Party marched in a counter demonstration in support of the police. The two groups marched side by side, without incident.

Michael Allen, a unit-leader for the white people's group, said his group would march in protest every time the anti-brutality group marched. "We believe that policemen have acted in a local manner," Allen said.

Group to oversee police urged

About a dozen persons marched in front of City Hall Monday with demands that a citizen review board be established to oversee police activities.

Mrs. Coraminita E. Mahr, a spokesman for a coalition of five social action groups that took part in the noon march, said monthly demonstrations will be held at City Hall until the review board is established.

"There have been a lot of recent incidents in which police are jumping on citizens, particularly blacks. What we would like to see is representatives of the

community sitting on this review board," she said.

The marchers represented Citizens Against Police Brutality, the St. Louis Alliance Against Racism and Political Repression, the Task Force on Police Crime, the Justice Committee for Johnson and Lamplsey and the St. Louis Moratorium Committee.

At the same time, a counterprotest was staged by three members of the American Nazi Party who demonstrated in behalf of the police department.

Organizational Changes in Southern California
