SPECIAL APPEAL INCHING AHEAD

The special Spring appeal for the Three-Year Plan inched ahead during the month of May with \$2,864.94. This is over \$900 less than we raised in April. Our new total for the Plan as of 31 May is \$50,547.64.

It is our goal to raise a total of \$14,000 during the 88 days between 20 April (the Leader's birthday) and 14 July this year. As of 31 May, we have raised \$5,695.37. This means we must raise over \$8,000 between now and the middle of July if we are to meet this deadline.

Overall, we have reached 57% of the Three-Year Plan goal of \$88,888. By this time, however, we should be at the 64% mark, and have \$56,888. There are only 11 months left until our final target date of 20 April 1978. In order to get the Plan back on schedule, we must meet our special appeal deadline by 14 July of \$14,000.

Remember, those who contribute \$88 or more during this special appeal will receive a special, large, glossy photograph of the Leader, suitable for framing and display.

National Headquarters staff wishes to thank everyone who contributed to the Three-Year Plan during May. Some comrades have really come through in a marvelous fashion and can be proud of the dedication to this Cause that they have shown. During May, donations were received from 29 states and 3 foreign countries. The contributors initials are shown on page 2 of the BULLETIN.

National Socialists Demonstrate for Release of Rudolf Hess

On 14 May, members of Arlington/Baltimore ST Group One under the personal leadership of the Commander, demonstrated in front of the White House in Washington, D.C., demanding the release of Rudolf Hess. While the Stormtroopers picketed and chanted "FREE RUDOLF HESS!", other comrades handed out "Free Rudolf Hess" leaflets. The demonstration lasted two hours, and was seen by thousands of weekend tourists visiting the nations capital.

After reloading in the open stake-bed truck they arrived in, the ST group drove back to National Headquarters. During their return trip, they passed through the Georgetown section of Washington, which is known for its high concentration of Jews, Reds, politicians and other similar riff-raff. Large numbers of Jews and creeps were seen foaming at the mouth because of the Stormtrooper vehicle and Swastika banner flying in their territory.

Later on, a special meeting was conducted at NHQ, at which the Commander spoke on the sacrifice being made by Rudolf Hess for the Cause.

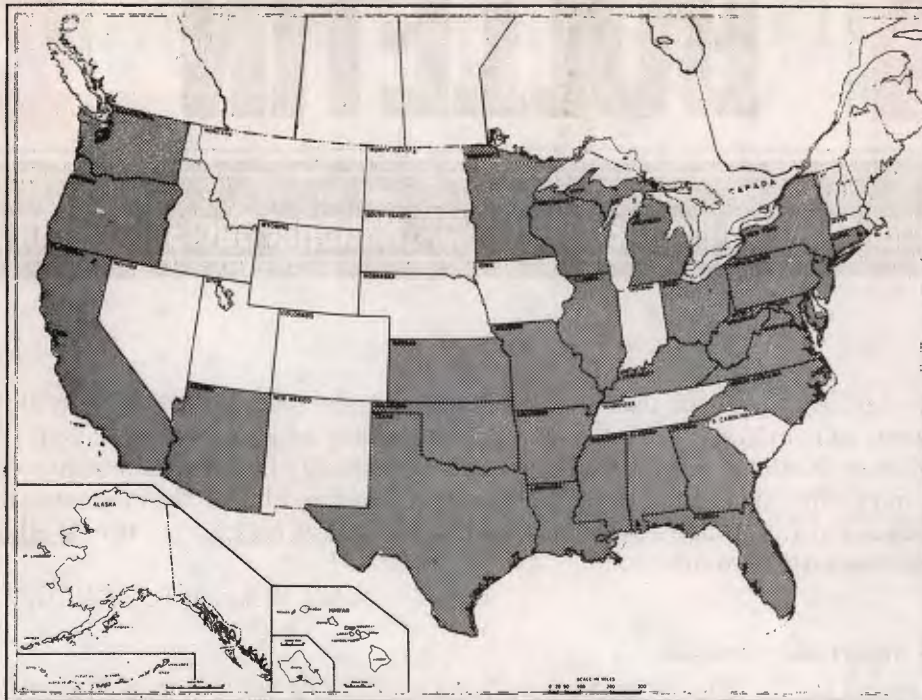

Stormtroops and Creeps Clash

On 28 May, two teams of Stormtroopers from Arlington/Baltimore ST Group One, under the command of Acting Team Leader Frederick Verduin, clashed with communists, creeps, and miscellaneous White trash elements at an anti-South African "African Liberation Day" rally in Washington, D.C.

After being driven to a point near the rally site, the ST formed up into a column of twos, and accompanied by support personnel in civilian clothing, marched towards the niggers and their Marxist friends. The troops were initially blocked from entering the park where the rally was taking place by 20 long-haired White creeps. A/TL Verduin then simply led his men around the creeps and marched them into the mob of Blacks chanting "White Power!" and "Who Needs Niggers?" Soon afterwards a fight broke out when the same White trash creeps again attempted to block the Stormtroops advance. After a brief, but violent skirmish, the ST reformed, and were ordered by the police to leave the area.

As they were leaving, they were stopped by reporters seeking interviews. As a result of this action, publicity was received in the *Washington Post* as well as on Channel 4 and Channel 7 news, and various radio stations.

All of the uniformed troops and support personnel have received the Medal of Merit for their bravery during the activity, and PT Richard Janos was additionally awarded the ST Wound Medal, for a head wound he sustained during the encounter which required 20 stitches and several hours hospitalization.

The African Liberation Support Committee marched from the White House up toward Meridian Hill Park yesterday, denouncing the imperialist superpowers and the All African People's Revolutionary Party.

The African Liberation Day Coalition marched from Kalorama Park to Lafayette Park, denouncing the All African People's Revolutionary Party and the African Liberation Support Committee, barely missing the fur hats and snare drums of the United House of Prayer Daddy Grace Memorial Parade, passing the Carl McIntire Honor America marchers, and trailing the Sons of the Desert Mecca Temple No. 10.

It was a good day, all in all, to march.

As it turned out, nobody tangled up anyone else's parade. However, six members of the National Socialist White People's Party were bloodied when they walked into the African Liberation Day Coalition's parade, shouting, "We hate nig-

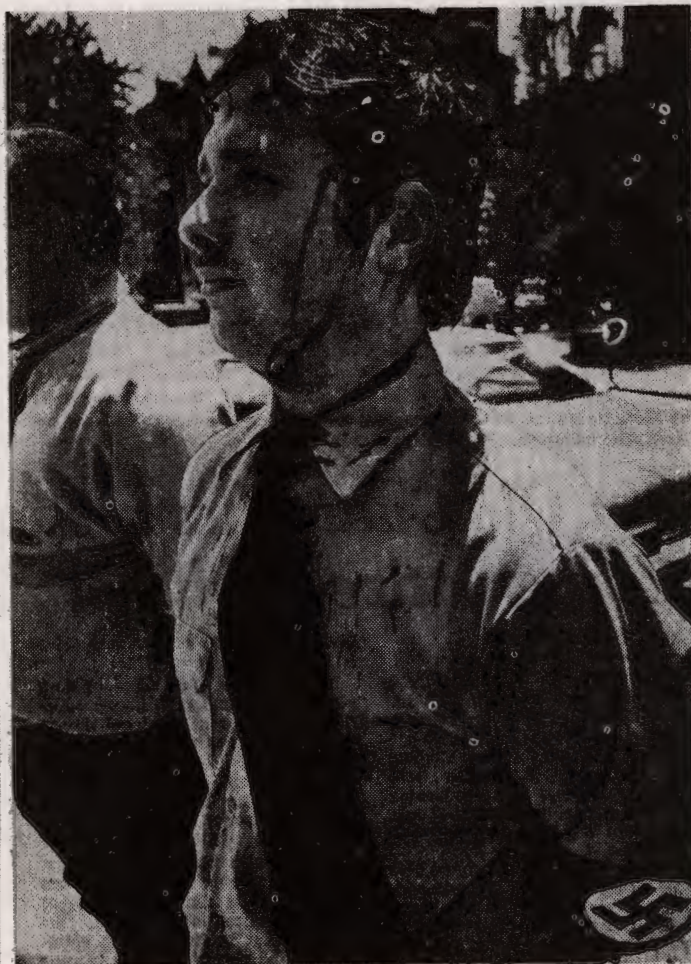

Tactics of anti-nazi struggle debated at Brandeis U. forum

WALTHAM, Mass., April 8—Two different approaches by the Jewish community to fighting neo-nazism were presented at a recent panel discussion here sponsored by the Brandeis University Hillel.

Dr. Martin Goldman, education director for the New England Anti-Defamation League (ADL), defended his organization's policy of "monitoring" the actions of nazis, while at the same time not actively working to stop them.

Dr. Jack Porter, a sociologist and Cheryl Polansky, a Brandeis student, spoke of the importance of grass-roots organizing in opposition to neo-nazism. Both Porter and Polansky have been involved with the Coalition of Organizations Against Nazism (COAN) in Milwaukee, Wisconsin.

Dr. Goldman began the discussion by presenting an overview of the principal neo-nazi organizations in the country.

Dr. Porter and Ms. Polansky centered their remarks on the activities of one of these groups, the National Socialist White People's Party (NSWPP), in Milwaukee, and the emergence of an anti-nazi movement there. A city which historically has had both a strong pro-nazi movement and a deep socialist tradition, Milwaukee was chosen by the NSWPP several years ago as a testing ground for their increased public activity. Beginning in 1975, the actions of the nazis included public demonstrations, acts of vandalism, physical attacks and distribution of literature consisting of violently anti-Semitic and racist statements.

In the fall of 1975, COAN was formed, a broad coalition of community organizations. The purposes of the group, according to Ms. Polansky, are to "sensitize people as to what nazism is," and to "stop them while they are still small, before they gain a legal base."

COAN followed the NSWPP around the city; each time nazi literature was distributed or that there was a public nazi demonstration, anti-nazi literature would also be distributed and there would be a counter-demonstration.

Dr. Porter warned those present that the Nazi Party is changing tactics. "They are moving into electoral politics," he said. This is a shift Porter feels is dangerous as it "gives them legitimacy."

One focus of COAN's work was support for an anti-nazi ordinance introduced in the Milwaukee City Council. The ordinance was not passed, partially the result, Porter and Polansky claimed, of a campaign against it by the ADL.

Dr. Goldman was the subject of much criticism in the course of the discussion. It was charged that the ADL has had a consistent position of non-action in regard to the growth of the neo-nazi movement.

At one point Dr. Goldman admitted that the ADL spends "very little" time on neo-nazism.

Dr. Porter and Ms. Polansky emphasized the role of grass-roots organizations such as COAN. Asserting that the ADL had attempted to curtail the activities of COAN, Porter posed the question "Who speaks for the Jewish community?" In reference to the ADL's practice of "monitoring" the actions of neo-nazi organizations, Polansky stated that there are "more things you can do than just monitoring."

The students attending the discussion appeared to agree, that, as stated by Ms. Polansky, "every means possible to stop this group (the nazis)" must be utilized.

Chicago ST Picket Reds

On Saturday, 28 May, troopers from the Chicago Unit picketted the 30th National Convention of the Socialist Labor Party (Marxist-Leninist), which was being held at the very plush, unproletarian, Mid-Land Hotel in downtown Chicago. The communists were furious at the presence of the uniformed National Socialists. For the most part, they contented themselves at raging impotently (and safely) from a distance. The only incident that took place occurred when one Jew tried to break through the picket line. The Jew was promptly ejected and booted in the rear-end, which may have been what he wanted all along, as only a masochist would

single-handedly try to interfere with an ST picket!

Reds React to Party Growth

The Communist Party, U.S.A., (CPUSA) newspaper, the "Daily World" recently printed the article reproduced here on the left entitled "Tactics of anti-nazi struggle." The CPUSA, (who, incidentally, get their instructions straight from Moscow) at least, has no doubt that the NSWPP is their worst and most dangerous enemy in the years of struggle which lie ahead.

L.A. Comrades Convicted in Paper Sale Case

In a clear violation of the First Amendment of the Constitution guaranteeing freedom of speech, assembly, and the press, two Los Angeles comrades were convicted of selling WHITE POWER without a license. Comrades Martin Kerr and Gregg Hummer were convicted of a charge of conducting a business without a license by a Pasadena, Cal., municipal court on 4 May. They were found innocent of a second charge of "misdemeanor begging."

The case stems from an activity held in Pasadena on 15 December, 1976, in which comrade Hummer intentionally allowed himself to be cited for distributing the Party paper in exchange for a voluntary donation from passersby. Comrade Kerr accompanied TL Hummer, but did not take part in the distribution. Both men were subsequently cited for violation of local ordinances requiring licenses for conducting a business and begging.

Two Nazis convicted of illegal newspaper sale

Two members of the National Socialist White People's (Nazi) party have been convicted in Pasadena Municipal Court of selling newspapers without a license on the steps of Pasadena's City Hall.

The two Nazis, Martin Kerr and Gregg Hummer, were fined \$250 apiece by Municipal Court Judge Mortimer G. Franciscus. A jury found them not guilty of a charge of begging.

Kerr, who acted as his own lawyer, promised to appeal the conviction. "This is what we expected all along," he said of the jury's verdict.

The youthful, bespectacled Nazi said he

appealed a similar conviction recently in El Monte and won a reversal in Los Angeles Superior Court.

Testifying on behalf of the prosecution was Pasadena Police Agent Bruce Linsenmayer, who said he bought copies of the party's newspaper, "White Power," from Kerr and Hummer last December.

The two Nazis have contended that the Pasadena city ordinance that requires a license for newspaper vendors is an unconstitutional violation of free speech.

Kerr is the Southern California district party leader, and Hummer is treasurer of the party's Los Angeles unit.

Upon their conviction, Comrades Kerr and Hummer were given fines of \$250.00 each. This is an unusually heavy fine, roughly *ten times* that which would normally accompany the offense for which they were convicted. All this can be seen as being a further extension of the campaign vowed by the local city government to drive the Party from Pasadena "by any means necessary."

A Letter From Franz Pfeiffer

He requested that the following letter be printed in the "NS Bulletin," to help clear up any misunderstandings that may have arisen recently as the result of charges made by certain anti-Party splinter groups and individuals who have claimed that Comrade Pfeiffer is no longer associated with WUNS.)

Dear Comrades,

25th May 1977

I have been in touch for some months with several groups in the United States and have written articles for their publications. This has caused some people to believe that I am either a hired staff-member of those publications, a supporter or even an official of some of these groups. This has never been the case.

My loyalty has always been with the only rightful National Socialist organization, founded by Commander George Lincoln Rockwell almost 20 years ago: the National Socialist White People's Party and its leader, Commander Matt Koehl.

This position has never changed, as all those who have written or called me by phone have always been told.

Many honest National Socialists who have contacted me have often expressed worries about the future of the NSWPP and the World Union of National Socialists. It is my belief that it would be wiser to pitch in and help solve any problems, instead of merely complaining.

My personal thanks go out to all those who have understood this and have been brave, for instance, to stand up as NSWPP candidates, like those wonderful ladies, the Milwaukee comrades, and the San Francisco comrades.

I want also to point out that I have never been in contact with Mr. Collin (Cohen) who is misleading fine people to make them kosher. A certain Mr. Jim Mason, now widely known as a de-ranged psychopath posing as a "Nazi" already got an answer from me a long time ago.
