Spring Appeal Lagging Behind

With only two weeks left until the end of the Spring Appeal for the Three-Year Plan, over \$6,600 still remains to be raised. It is the goal of the Spring Appeal to raise \$14,000 during the 88-day period between 20 April and 14 July.

During the month of June, only \$1,697.98 was raised. This makes the total for the Spring Appeal \$7,393.35. and means that \$6,618.65 must be raised by 14 July for the Appeal to be met and the Three-Year Plan put back on schedule.

Overall, we have raised \$52,245.62, which means that \$36,642.38 must be raised during the remaining 10 months to reach our final goal of \$88,888 by our target date of 20 April, 1978. As of 30 June, 68% of the time for the Plan has elapsed, while only 59% of the total has been raised.

During June, comrades from 22 states and the District of Columbia, as well as three foreign countries donated money to the Plan.

The Party wishes to extend its special thanks to those who gave \$88 or more, and especially to the Alabama comrade who gave \$500 to the Plan. Those giving \$88 or more during the Special Appeal will receive a large, glossy photograph of the Leader as a token of the Party's appreciation.

Those who can afford to give large sums are urged to do so, but those who can afford to give only a few dollars are reminded that their help is needed too! Those comrades whose state or province has not appeared on the map on page 2 in recent months should make a special effort to make a contribution to the Plan, so that it may appear on next months map.

The final results of the Spring Appeal will be announced in the August NS BULLETIN.

Milwaukee Comrades in Court Battles

Party comrades from Milwaukee have been undergoing much legal harassment in recent weeks. Much of this stems from court cases brought against various comrades by Milwaukee Jews who are terrified at the rapid, steady growth of National Socialism in the Milwaukee area. One tactic the Jews have been employing against

the comrades there consists of accusing individual ST men of "assaulting" poor, helpless Jews on the street, without provocation. In reality, it is the Jews who start the fights.

Reproduced here are two clippings from the *Milwaukee Journal* which tell of the effects this Jewish agitation is having.

Activity Reports

Both local units and individual activists should send complete reports of their activities to National Headquarters on a regular basis. Besides monthly reports summarizing all of the activities undertaken during that month, separate activity reports should also be filed for individual activities of a significant nature.

Here are some things that should be included in each activity report:

1. Type of activity — Paper sale, march, speaking engagement, picket, etc.
2. Date
3. Length of time activity lasted
4. List of participants (include Party or ST rank of each)
5. Were uniforms worn?
6. Description — Include wording of signs or banners, number of papers sold and money collected, audience or spectator reaction, etc. Also include details of fights or confrontations.
7. Media coverage — include any clippings from newspapers or magazines. List any television or radio coverage.

Be sure to make all reports as accurate as possible. Do not exaggerate or falsify information or incidents in

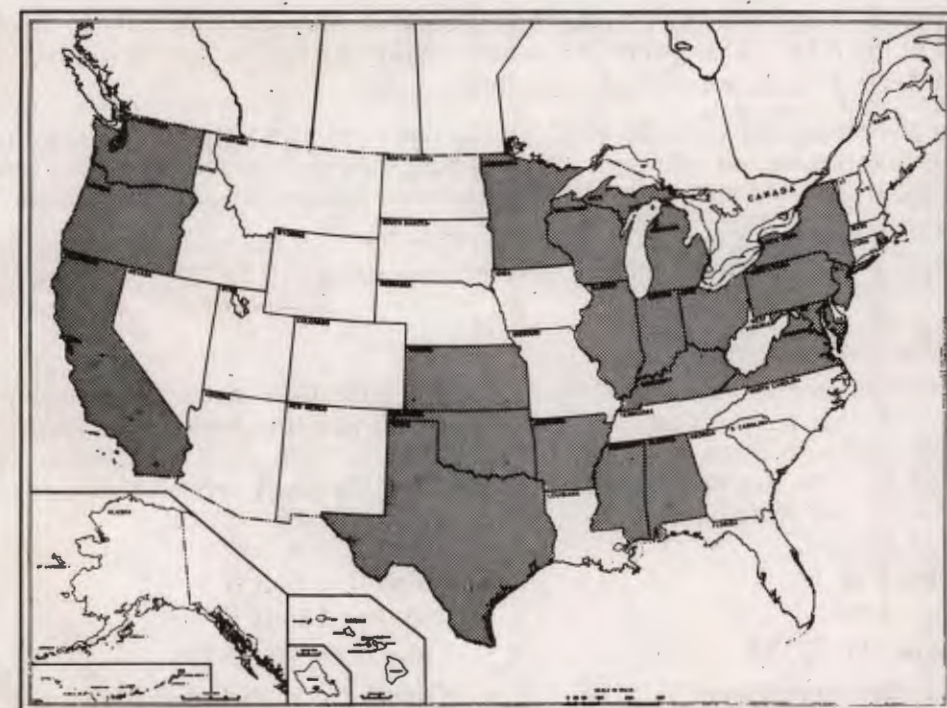

Scuffle With Nazis Described in Court

Persons affiliated with the Concerned Jewish Citizens and the National Socialist White People's (Nazi) Party blamed each other in court Thursday for a 1976 street scuffle on Mitchell St.

They testified in the opening day of a trial of seven Nazi Party members on disorderly conduct charges resulting from a fight between members of the two groups on Oct. 9, 1976, in the 1000 block of W. Mitchell St.

Members of the Jewish group claimed they had been assaulted, and the Nazis denied it.

According to testimony before Municipal Judge Ted E. Wedemeyer Jr., the Jewish group frequently counterdemonstrates when the Nazis are demonstrating.

Greeted by Shouts

Marion Sadoff, 26, of 6991 W. Glenbrook Rd., a CJC member, said that when she and her husband, Jon, drove up to the site of the fracas, they were greeted by shouts from some of the Nazis that, "The damned Jews are here."

She testified that some CJC signs were leaning against a building and that she saw Jeffery Enders, 19, of 3047 W. Lisbon Ave., one of the defendants, run and pick up one of the signs and throw it at her legs.

"I ran into the store (Gimbels) and then I saw five men attacking my husband who was on the ground . . .," she said.

Another defendant, Arthur J. Jones, 28, of 3014 N. 62nd St., testified he was across the street when he saw a former member of the Nazis being attacked by some CJC members and came across to help the youth. Jones, who said he was the Nazi public relations director, was in charge of the Nazi leaflet distribution that day.

"On the Ground"

"I wasn't fighting. I was on the ground with three

Jews on top of me," Jones said. He described himself as a model storm trooper and party member. He responded, "Yes sir," when asked by David R. Mogilka, an assistant city attorney, whether he was a citizen.

No arrests were made at the scene. A policeman testified that the Nazis were gone when police arrived and that CJC members identified the defendants from pictures at police headquarters.

CJC members filed the complaint.

Wedemeyer adjourned the trial until 8:30 a.m. July 15.

Nazi Loses His Uniform as Penalty

Anthony C. Schmitt, leader of Milwaukee's small but active Nazi Party, was stripped of his uniform Friday.

The State Bureau of Probation and Parole added a condition to probation terms set down for Schmitt last year by County Judge Patrick J. Madden.

The new condition is that Schmitt not wear his Nazi regalia in public, according to Lawrence Sneezy, assistant regional probation chief. However, Sneezy said, he will look into the rule to see whether it is an appropriate condition or a violation of Schmitt's rights.

Earlier this week Schmitt and another Nazi Party member, Sheldon Enders, 19, of 2047 W. Lisbon Ave., were charged in the District Attorney's Office with disorderly conduct in connection with a scuffle the two had with a Sheboygan man in the middle of Wisconsin Ave. Downtown.
