# National Socialists Mark Anniversary of Commander Rockwell's Death

On 25-August, National Socialists around the world paused to mark the 10th anniversary of the martyrdom of Commander Rockwell. In Arlington, special ceremonies were held to commemorate the tragedy.

At 12:00 noon, Commander Koehl, accompanied by national Party officers and a detachment from the Arlington/Baltimore ST group, laid a wreath at the exact location where Commander Rockwell fell. A Stormtroop honor guard held a silent vigil at the location after the Commander and the other troops had left.







That evening, special memorial ceremonies were held at National Headquarters in honor of Commander Rockwell. In his address, Commander Koehl emphasized the significance of Lincoln Rockwell and his sacrifice.

Speaking to the comrades who had gathered for the service, the Commander said "In years to come, historians will recognize three important pillars supporting Lincoln Rockwell's claim to greatness. He was the first man after 1945 to fully recognize the timeless genius of Adolf Hitler and the significance of his mighty Cause.

"At the same time," continued the Commander, "he was the first man with the courage to pick up and raise the banner of National Socialism out of the ashes of defeat and despair of World War II against a hostile world.

"Lastly," the Commander concluded, "he built a Movement around that banner."

A special armed ST honor guard stood watch over the urn containing Commander Rockwell's remains, which was positioned on the altar in front of the Party banner during the ceremonies.

# Nazis Mark Ten Years Since Rockwell's Death

ARLINGTON American Nazi party members, reportedly coming from across the country, gathered at a small shopping center here yesterday to observe the tenth anniversary of the death of their former leader, George Lincoln

In a subdued ceremony, party members, led by the organization's current commander, Matt Koehl. laid a wreath near the spot where Rockwell fell dead after being shot by an exparty member in 1967. Two "storm troopers"

ş

held a vigil at the wreath in the shopping center, located in the 6000 block of Wilson Boulevard, for most of the afternoon.

A swastika, painted on the pavement in the parking lot, marked the exact location where the American "Fuebrer" died from two bullet wounds in the chest.

Members of the party. now known as the National Socialist White People's Party, said a private ceremony was to have held last night for the fallen commande

Rockwell, who founded the party in the late 1950s, was killed by a sniper while leaving the parking lot of the shopping center, where he had apparently gone to do his laundry.

1967 According to ublished reports, Rockwell was returning home to retrieve a bottle of bleach he had forgotten when the sniper fired the two shots that killed the party head Ex-party member and former marine John Patler, who had reportedly been drummed out of the party for leaning towards Marxism, was arrested the same day and charged with

the slaying.

# **Chicago White Power Message Called Illegal**

On 9 August, Illinois Attorney General William Scott filed suit against the Chicago Unit of the Party and the Illinois Bell Telephone Company. The suit charged that the Party's Chicago White Power Message was unlawful, as it presented "a clear and present danger" to the public.

The Message in question, which had been taken off the air well before the suit was filed, offered a reward of \$200 to any White man or woman who killed a non-White while defending his or her life or property.

On 11 August. Midwest Party leader Cedric Syrdahl was served with a summons ordering him to appear in court the next day.

Once in court, he explained that the White Power message that was being objected to had already been changed. This did not stop the Jewish assistant attorney general in charge of the case from demanding that the injunction be granted anyway. The judge quickly agreed.

As a result of the suit, the Party received national news coverage. Media coverage, including television interviews with Capt. Syrdahl, was especially extensive in the Chicago area. A fraction of the news articles received by NHQ are reproduced here.

# Nazis given warning: Don't use party line!

A Chicago judge last week ordered the National Socialist White People's Party, a Cicero-based organization, to stop using the phone lines for offering a bounty in the killing of "black criminals."

Circuit Court Judge Raymond Berg acted after At-torney General William Scott received complaints about one of the phoned messages which offered a \$200 reward "to the first white man or woman who will...blow one of these black criminals away" while "exercising their right "to protest life and property."

Cedric N. Syrdahl, self-proclaimed "Captain of Storm Troopers," of the latter-day Nazis, agreed to change the language of the messages and said the party never meant to incite racial killings.

THIS WAS after Berg told him, "I recognize your right to free speech, but you must recognize the rights of others, and in my opinion you are presenting a clear and present danger to society." Under the court order, Illinois Bell can disconnect the party's phone if the messages continue.

The NSWPP considers itself a "purist" National Socialist group and disavows any connection with the National Socialist (Nazi) Party of America headed in Chicago by Frank Collin, it has been said. It has been located in Cicero for some time but, axcept for a few brown-shirted young men going and coming, it has maintained a low profile. Scott halled Berg's ruling for making a clear distinc-

## Milwaukee Anti-Busing Rally Rattles Reds, Jews

On 27 August, Milwaukee Unit I, assisted by Milwaukee Unit II and comrades from the Chicago Unit, held a public anti-busing rally in Humboldt Park, Milwaukee.

The National Socialists arrived early at the location to set up a speakers platform and a powerful sound system, which blared forth American marches before the rally started. The first speaker was Mrs. Sandra Osvatic, former Party candidate for school board. She spoke on the need for a sensible education program in today's schools. She was followed by Comrade Art Jones, who verbally attacked the anti-White busing schemes now being forced on Milwaukee. Unit leaders Tony Schmitt and Rick Prohaska were the hast two speakers.

Besides 300 Whites who came to hear the National Socialist speakers, a motley crew of "counter-protestors," 600 strong, including communists, Jews, homosexuals, drug addicts, and street scum of every imaginable description showed up. Despite the fact that they outnumbered the ST and NSWO by 30 to 1, they could not muster the courage to do more than shout insults and throw some eggs until the troops were getting ready to leave.

An attempt to block the National Socialists from departing peacefully proved unsuccessful when a 17 year old bystander was injured by the creeps, and the police moved in to crack some wooly heads and make a few arrests. # **Three-Year Plan Progresses**

Three-Year Plan donations in August totaled \$1,710.57. This makes the total for the Three-Year Plan as of 1 September \$57,322.90. While this is a very strong showing, it does not bring the Plan back on schedule.

At this point, with 74% of the time allotted for the Plan having past, we have raised only 65% of our total. We now stand \$8,454.22 *behind* where we should be.

This means that all loyal National Socialists will have to redouble their efforts in the upcoming months to make the Plan a success. As badly outnumbered as we National Socialists are today, each and every one of us must do as much for our Cause as 100 of our enemies do for theirs. Nothing less than total commitment, absolute dedication and a willingness to sacrifice will bring victory to this Movement.

Comrades from 28 states and four foreign countries contributed to the Plan during August. Individual contributions ranged from as little as fifty cents to as much as \$200. # **Bill to Outlaw Party Introduced in Wisconsin**

A bill which would prevent the Party from appearing on election ballots has been introduced in the Wisconsin Assembly. The alleged purpose of the bill is to prevent any political party which advocates force, violation of the law, or incites imminent lawless action from appearing on the ballot. The bill's sponsor, Republican John Gower, however, told reporters of the true purpose of the bill. It will exclude from the elective process any group whose members "are not prepared to live by the system we have,"" he said.

Since all National Socialists are unalterably opposed to the System that governs the U.S. today, that certainly includes us!



It is not known yet whether the bill will be passed or not, but the Milwaukee units have lost no time in denouncing this latest attempt of democratic repression of pro-White political power. A newsclipping on the Party's denunciation of the bill is reproduced here.

Jones, 28, sald his party at one time had a youth group and conceded that some of its members "did commit a few minor acts of vandalism from time to time."

"As a mass movement, we cannot be expected to be responsible for the personal conduct of every member of this party 24 hours a day, any more than all Republicans are responsible for Watergate or all Democrats for the current Korean payoff scandal,"
