National Socialists Mark Anniversary of Commander Rockwell's Death

On 25-August, National Socialists around the world paused to mark the 10th anniversary of the martyrdom of Commander Rockwell. In Arlington, special ceremonies were held to commemorate the tragedy.

At 12:00 noon, Commander Koehl, accompanied by national Party officers and a detachment from the Arlington/Baltimore ST group, laid a wreath at the exact location where Commander Rockwell fell. A Stormtroop honor guard held a silent vigil at the location after the Commander and the other troops had left.



That evening, special memorial ceremonies were held at National Headquarters in honor of Commander Rockwell. In his address, Commander Koehl emphasized the significance of Lincoln Rockwell and his sacrifice.

Speaking to the comrades who had gathered for the service, the Commander said “In years to come, historians will recognize three important pillars supporting Lincoln Rockwell's claim to greatness. He was the first man after 1945 to fully recognize the timeless genius of Adolf Hitler and the significance of his mighty Cause.

“At the same time,” continued the Commander, “he was the first man with the courage to pick up and raise the banner of National Socialism out of the ashes of defeat and despair of World War II against a hostile world.

“Lastly,” the Commander concluded, “he built a Movement around that banner.”

A special armed ST honor guard stood watch over the urn containing Commander Rockwell's remains, which was positioned on the altar in front of the Party banner during the ceremonies.

Patler was convicted by an Arlington jury and sentenced to 20 years in jail.

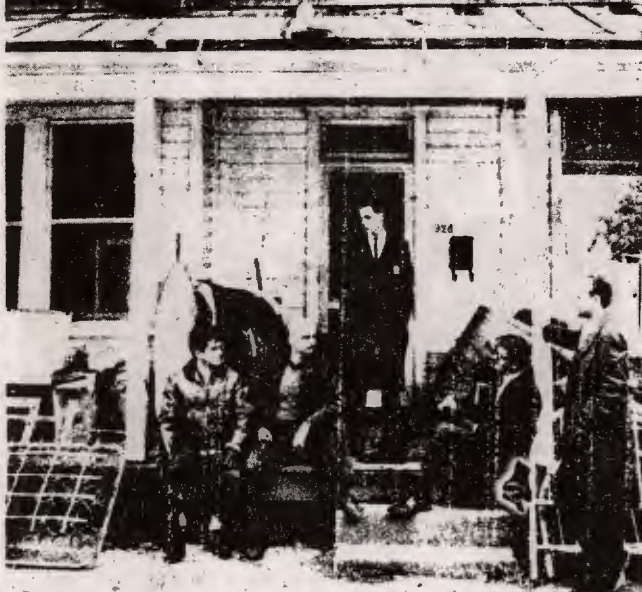

Chicago White Power Message Called Illegal

On 9 August, Illinois Attorney General William Scott filed suit against the Chicago Unit of the Party and the Illinois Bell Telephone Company. The suit charged that the Party's Chicago White Power Message was unlawful, as it presented "a clear and present danger" to the public.

The Message in question, which had been taken off the air well before the suit was filed, offered a reward of \$200 to any White man or woman who killed a non-White while defending his or her life or property.

On 11 August, Midwest Party leader Cedric Syrdahl was served with a summons ordering him to appear in court the next day.

Once in court, he explained that the White Power message that was being objected to had already been changed. This did not stop the Jewish assistant attorney general in charge of the case from demanding that the injunction be granted anyway. The judge quickly agreed.

As a result of the suit, the Party received national news coverage. Media coverage, including television interviews with Capt. Syrdahl, was especially extensive in the Chicago area. A fraction of the news articles received by NHQ are reproduced here.

Suit seeks halt to white group's hate messages

ILLINOIS ATT'Y. GEN. William Scott filed Thursday seeking an injunction against a N. type organization called the National Socialist White Peoples Party, with headquarters at 24 S. Central Av., Cicero.

The suit, filed in Circuit Court, charges that the organization has been broadcasting hate messages over the telephone against black people. For the last week, the suit says, one of the messages has offered a \$200 cash bounty "to the first white man or woman who will exercise his right to protect his life and property and blow one of these black criminals away."

ILLINOIS ATT'Y. GEN. William Scott filed suit Thursday seeking an injunction against a Nazi-type organization called the National Socialist White Peoples Party, with headquarters at 2442 S. Central Av., Cicero.

The suit, filed in Circuit Court, charges that the organization has been broadcasting hate messages over the telephone against black people. For the last week, the suit says, one of the messages has offered a \$200 cash bounty "to the first white man or woman who will exercise his right to protect his life and property and blow one of these black criminals away."

STOP NAZI 'KILL' MESSAGE

The National Socialist White People's party in Illinois has been ordered to cease using a recorded racist telephone message in which people are urged to kill Blacks. Cook County Circuit Court Judge Raymond K. Berg has ruled that the message constitutes a "clear and present danger" to society. The recording was used for a week before the court order. It was heard when the telephone number of the Nazi headquarters was dialed. The message started out with "Wanted: Dead looters!" referring to events in New York City during the 25 hour disruption of power, the racist message offered \$200 to "the first white man or woman who will exercise his right to protect his life and property and blow one of these Black criminals away."

Scott filed the suit after his office received a complaint about the message.

CAPLAN SAID THE organization has had the telephone number since June 5, 1976, at the Cicero address and that Illinois Bell Telephone Co., which is also listed as a defendant, will not cut off the telephone number.

The suit charges that the message violates the Illinois Constitution, which prohibits communications that incite violence or hatred against a person because of religious, racial, ethnic, national, or regional affiliation.

Caplan described the speaker of the message as being a "professional and speaking in a rousing, eerie, emotional tone."

A hearing on the suit is to be held at 11 a.m. Friday before Judge Berg of Circuit Court.

Whites told to halt hate messages

A TEMPORARY RESTRAINING order was issued Friday to bar the National Socialist White Peoples Party, 2442 S. Central Av., Cicero, from continuing to use recorded telephone messages offering bounty for killing blacks.

The order, issued by Circuit Judge Raymond Berg, was requested by Illinois Atty. Gen. William Scott following one of the messages, which offered a cash bounty "to the first white man or woman who will exercise his right to protect his life and property and blow one of these black criminals away."

A party representative, who described himself as a member of the Storm Troop, recognized "your right to have to recognize us, and in my opinion, a clear and present danger."

The party has agreed to stop using and said the party would not use racial killings.

Judge Bars Nazi Telephone Recording

CHICAGO — The American Nazi party no longer can play recorded telephone messages that urge people to kill, Cook County Judge Raymond K. Berg has ruled.

A taped message that began "Wanted: Dead looters!" constituted a "clear and present danger" to society, Berg ruled. He said the National Socialist White People's party cannot play that recording or any similar message.

The tape, which played for a week when persons dialed a Nazi headquarters telephone number, referred to the looting during New York City's black-out. It then offered \$200 to "the first white man or woman who will exercise his right to protect his life and property and blow one of these black criminals away."

Berg told a party official, Cedric N. Syrdahl, but you must balance that right with the right of other people have.

Nazis given warning: Don't use party line!

A Chicago judge last week ordered the National Socialist White People's Party, a Cicero-based organization, to stop using the phone lines for offering a bounty in the killing of "black criminals."

Circuit Court Judge Raymond Berg acted after Attorney General William Scott received complaints about one of the phoned messages which offered a \$200 reward "to the first white man or woman who will... blow one of these black criminals away" while "exercising their right 'to protect life and property.'"

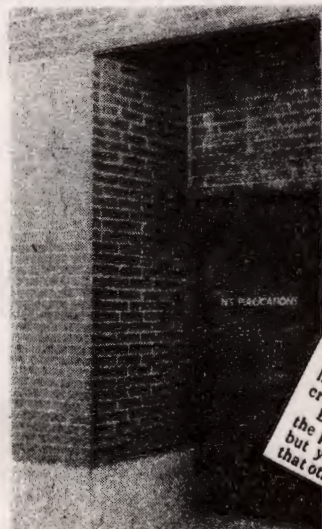
Cedric N. Syrdahl, self-proclaimed "Captain of Storm Troopers," of the latter-day Nazis, agreed to change the language of the messages and said the party never meant to incite racial killings.

THIS WAS after Berg told him, "I recognize your right to free speech, but you must recognize the rights of others, and in my opinion you are presenting a clear and present danger to society."

Under the court order, Illinois Bell can disconnect the party's phone if the messages continue.

The NSWPP considers itself a "purist" National Socialist group and disavows any connection with the National Socialist (Nazi) Party of America headed in Chicago by Frank Collin, it has been said. It has been located in Cicero for some time but, except for a few brown-shirted young men going and coming, it has maintained a low profile.

Scott hailed Berg's ruling for making a clear distinction between unlawful conduct designed to incite a breach of the peace and legitimate expression of controversial ideas.

Milwaukee Anti-Busing Rally Rattles Reds, Jews

On 27 August, Milwaukee Unit I, assisted by Milwaukee Unit II and comrades from the Chicago Unit, held a public anti-busing rally in Humboldt Park, Milwaukee.

The National Socialists arrived early at the location to set up a speakers platform and a powerful sound system, which blared forth American marches before the rally started. The first speaker was Mrs. Sandra Osvatic, former Party candidate for school board. She spoke on the need for a sensible education program in today's schools. She was followed by Comrade Art Jones, who verbally attacked the anti-White busing schemes now being forced on Milwaukee. Unit leaders Tony Schmitt and Rick Prohaska were the last two speakers.

Besides 300 Whites who came to hear the National Socialist speakers, a motley crew of "counter-protestors," 600 strong, including communists, Jews, homosexuals, drug addicts, and street scum of every imaginable description showed up. Despite the fact that they outnumbered the ST and NSWOP by 30 to 1, they could not muster the courage to do more than shout insults and throw some eggs until the troops were getting ready to leave.

An attempt to block the National Socialists from departing peacefully proved unsuccessful when a 17 year old bystander was injured by the creeps, and the police moved in to crack some wooly heads and make a few arrests. Reproduced on the following pages is a portion of the mountain of publicity received as a result of the rally, as well as the Red's reaction to the event.

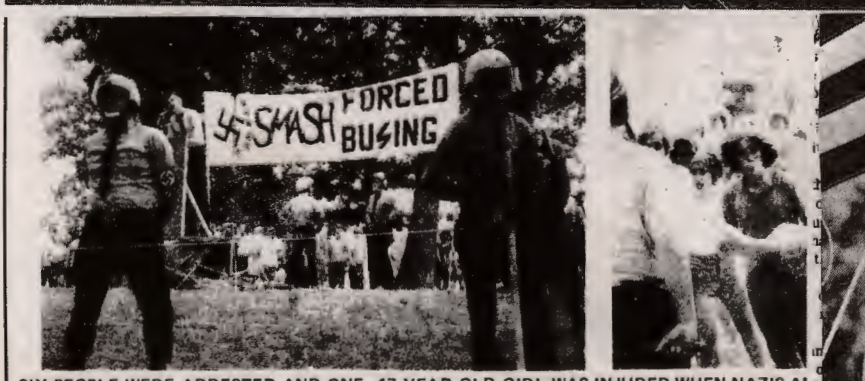

Three-Year Plan Progresses

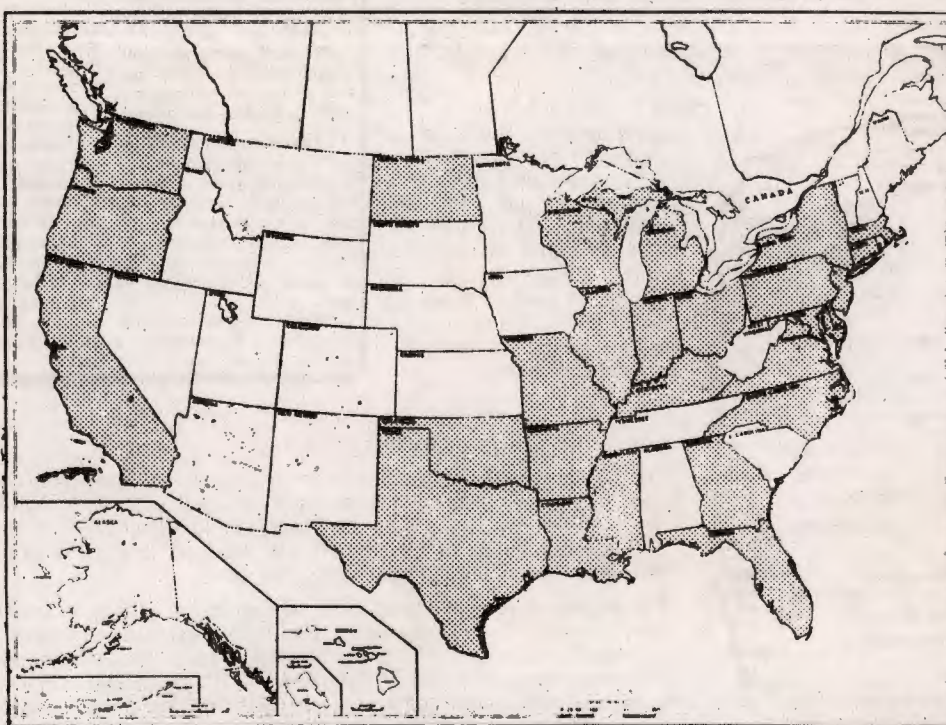

Activity of the Month

Those comrades who are members of a local unit are only a small minority of Party membership nationwide.

In order for the Party to grow more rapidly, every National Socialist must become an active fighter for White Power. While it is true that not every comrade lives near a local unit, and while not every comrade can be a stormtrooper, there are still many activities that each comrade can perform alone.

Beginning with this issue, the NS BULLY TIN will be listing an "activity of the month." These activities will be of the type that every comrade will be able to undertake by himself or herself, even if the comrade is not a member of a local unit.

This month's activity is a simple and inexpensive one: putting up Swastika stickers. Stickers should be placed in a public area where they can be easily seen by as many White people as possible. Avoid placing them on private property of privately owned vehicles, as this will only create bad feelings towards the Party by the "victims" in such cases. Likewise, do not post stickers in restrooms or on garbage cans because of the negative connotations involved. Other than these few restrictions, let your imagination run free!
