### **FALL BUILDING CAMPAIGN BEGINS!**

The start of the 1977 Fall Building Campaign was announced by the Commander in Arlington on 9 November. The goal of the campaign is to raise \$12,000 between now and Christmas, to be applied towards the Party's Three-Year Plan.

The theme of this year's drive is "GET READY!" As revolutionary times draw closer and closer, it is the duty of every National Socialist to help make the Party battle-ready for the hard days ahead. In order to do this, the Party vitally needs the funds being raised in the Three-Year Plan.

Unfortunately, the Plan has drifted behind over the last year, and now a special effort is needed to ensure that the goal of \$88,888 is met by the closing date of 20 April, 1978. The first step in closing the gap is raising the \$12,000 called for in the Fall Building Campaign.

## Bombing Attempt on Nazi Fails

A crude bomb was found Tuesday morning under the car of Anthony C. Schmitt, leader of Milwaukee's Nazi Party.

Police said the dynamite bomb would have blown Schmitt to pieces, if not for a clothespin triggering device that failed.

Authorities gave this account:

Schmitt, 24, heard something dragging underneath his car about 1:15 a.m. Tuesday as he drove from a woman friend's home on N. 60th St.

At 58th and Nash, Schmitt stopped the car and discovered part of the bomb dragging on the roadway. The bomb consisted of five dynamite sticks wired to a dry cell battery.

The bomb was to have

been detonated by a switch made with a clothespin. At the end of each prong of the clothespin, a metal contact had been attached. The clothespin was propped open but was to have somehow slammed shut to close the bomb circuit when Schmitt's car began moving.

However, police said, when the clothespin snapped shut, the ends of the prongs missed each other and failed to make electrical contact.

Police said that when Schmitt found the bomb, he returned to the home of the friend, where he called police. Police officers disarmed the bomb.

A detective said Schmitt told them he had no idea who might have planted the bomb. Schmitt was quoted as saying that he had not received any threats recently.

The Commander is making a special appeal for all comrades to give just \$1 a day for the 44 days between 9 November and Christmas Eve, 24 December. Some may be able to give more or less during this period. The important thing is for every comrade to give as much as he can afford.

The appeal is late in getting started this year, because the Party has focused much of its energies on getting its publications back on schedule. Due to this, any donations made to the Plan in October and the first days of November will be counted with the appeal total.

The amount raised in October was moderate. Exactly \$1,002.22 was received in contributions from comrades in 25 states and two foreign countries.

With only six months left until the Plan ends, we have raised \$63,521.24, or 71 percent of our goal. This means that we are \$7,500 behind, as we should have raised \$71,000 or 81 percent of our goal by this point.

Those who donated in October are to be thanked for their dedication and generosity. The initials of those who contributed, as well as their states, are listed on page two.



go off. Comrade Schmitt was driving home at approximately 1:15 a.m., when he heard something dragging under his car. He stopped to investigate, and discovered a bomb attached loosely to the bottom of the car. The bomb, which consisted of five sticks of dynatmite wired to a dry cell battery, was to have been triggered by a clothespin snapping shut, completing an electrical circuit. Fortunately, when the clothespin closed, the ends of the prongs failed to make contact.

The only effect the murder attempt has had on Unit Leader Schmitt and the other Milwaukee comrades has been to strengthen their resolve and dedication to the Movement and to the Commander.

It is unknown at this time who was responsible for the attempt on Comrade Schmitt's life, but the Party and the police are both investigating several leads.

### Commander Leads "Dump Israel" Picket

On 15 October, the Arlington/Baltimore ST group, under the personal direction of the Commander, picketed the White House, demanding that Carter "Dump Israel" as an ally of the United States. Thousands and thousands of weekend tourists to the nation's capital saw the National Socialist demonstration, which featured a giant DUMP ISRAEL banner, as well as pickets signs reading DUMP ISRAEL and NO MORE JEW WARS. In addition to the many White people who saw the action, a number of Jews were treated to the sight of an openly "anti-Semitic" demonstration in front of the White House. As usual several of the Chosen Ones went absolutely insane at the sight of White men waring the Aryan Cross armband and chanting anti-Jewish slogans.







These insane, berserk Jews provided quite a sideshow for the numerous spectators who gathered, as they went through their hilarious kosher antics.

Also present on the scene were several hundred "anti-neutron bomb" demonstrators from various Communist organizations. As could be expected, most of them were Jewish also, and were predictably upset by the Commander and the Stormtroopers.

The only incidents occurred when a few hose-nosers attempted to harass the NS column as it was leaving the site of the picket. There were no ST casualties.

### Second Party Comrade Convicted in Frameup

A second Party comrade, TL Frederick Verduin, has been convicted of assaulting an off-duty Black policeman and his White wife, in an incident which occurred in Arlington during the time of the Eighth Party Congress (see NS BULLETINS 229 and 230). Comrade Verduin has decided to appeal the case, as has the other trooper convicted, TL Robert Bukowy. Lawyers for both men say the outlook for the convictions being reversed looks very good at this time.

TL Verduin, who is a member of the U.S. Army on active duty with the elite 3rd Infantry Regiment, has caused quite a stir in the press. Up until several months ago, he was a member of the presidential guard, and took part in numerous White House ceremonies and functions. Rumor has it that Jimmy Carter himself ordered Comrade Verduin's transfer to a "less sensitive" post when he learned of his Party affiliation.

Reproduced on page four are some of the news clippings in which the media show their dismay and outrage at the discovery that a presidential bodyguard was a horrible "Nazi."

### California Comrades Clash with Creeps

On 8 October, a group of ST men under the command of GL Dan Stewart clashed with a mob of anti-White creeps at an "anti-Bakke" rally in Oakland, California. There were no incidents, outside of routine police and press contact as the troopers advanced towards the demonstration site. About half a block from where the Reds were rallying, a bunch of Jews, Mexicans and White trash street scum attempted to block the ST column. One trooper gives this account of what followed:

"We marched down the sidewalk until the creeps — many creeps — tried to block our way. The two of us in front had to punch a hole in the creep mob. I only got to smash three or four creeps in the ribs and stomach myself. As soon as we started swinging, the creeps nearest to us went down and the others went running. I did not have enough Jews and spics to punch, and the other comrades complained later of the same problem."

After the police moved in to save the anti-Party scum and normalize the situation, numerous newspaper, radio and television reporters swarmed in to get statements from the Party spokesman. Massive publicity, some of which is reproduced on page five, was received as a result of this activity

### Elite Guard Admits Nazi Affiliation

### Demoted 8 Months Ago, GI Is Guilty of **Beating Policeman**

A former member of the U.S. Army's elite presidential guard, who was convicted yesterday of beating a black off-duty D.C. nolice officer, testified at his trial that he is a member of the Ameri-

can Nazi party.

Frederick T. Verduin, a member of the 3d United States Infantry at Ft. the 30 United States infantry at Ft. Wyer in Arlington, was a member of the honor guard until about eight months ago when Army officials discovered Verduin was a member of the National Socialist White Peoples Party, formerly known as the American Nazi party.

Party, formerly known as the American Narl party.

Verduin was demoted from the 180-member guard, which performs at parades and ceremonies, such as at white House functions, at the Tomb of the Unknown Soldier and at Arnington National Cemetery funerals.

"It is an embarrasaing thing as far as the Army is concerned," an Army spokesman said. The spokesman said he didn't know of any other Nazis in the Army and that Verduin's party membership "has not interfered with his military duties." He now is an historian at the Ft. Myer museum.

It is not against Army regulations


it is not against Army regulations to be a Nazi as, long as the organization is not attempting to violently overthrow the government, the spokesman said.

It could, not be immediately determined yesterday whether Verduin was ever at White House ceremonies, but the spokesman said that once it was discovered Verduin was a Nazi, his white House clearance as a member of the honor guard was taken away.

Servicemen may wear other uni-forms, the spokesman said, as long as it is not during on-duty hours. Ver-duin testified yesterday that when the assault incident octurred on Sept. 3 he was wearing black boots, black trousers, a beige poplin military-style shirt and a red armhand with a swas-

The detective, who has worked two years as a detective with the 2d district theft squad, began pumping gas for his car.

Both Threats said a brown Chevrolet Caprice with two men in it wearing Nazi uniforms pulled up next to their car.

The driver of the Nazis' car got out and bought a soda from the vending machine, Mrs. Threat testified, "and gave it to a passenger in the car. Mrs. Threat said she then went to the machine to get a soda for thefuldren and as she passed the Nazis' car one of the occupants said to her: "More power to the white people, you nigger-loving bitch." On her way back to the car with the soda, the man repeated the same comment and then threw a soft drink on her, Mrs. Threat testified. "Please leave me alone. I don't want

"Please leave me alone. I don't want to have anything to do with you," Mrs. Threat testified she told the man. Threat then ran to the car and said: "You leave my wife alone."

A fight enswed and Verduin testified he ran over to the Naxis' car and started beating Threat because he said Threat was hitting a man who was pinned inside the car.

During the fistlight, which lasted between five and seven minutes, as

tween five and seven minutes, as many as 35 uniformed Nazis, armed with riot gear and billy clubs, came from their headquarters across the street to the gas station, Threat testi-

woman or something like that?"
Threat said the Nazis shouted at him as three men were slugging him on his face with their fist. Why are you beating on these white people?
Threat said the Nazis yelled at him.
Threat said he then yelled that he was a police officer and waved his badge to the crowd. By that time Arlington County police had arrived, Threat said.

Judge Richard Corman found Verduin guilty of assault and battery against Threat and destruction of Threat's eyeglasses. For each count, Verduin was sentenced to serve 10 days in the county jail and pay a \$100 fine. Verduin said he will appeal the case to the Arlington Circuit Court.

The Army has not decided what action, if any, to take against Verduin, but the Army spokesman said his 20 day jail term will be counted as unexcused time.

A Chicago man, Robert F. Bukowy,

A Chicago man, Robert F. Bukowy was convicted Sept. 9 of assault and battery on Threat and Threat's wife and destruction of Threat's eyeglasses. Threat's wife testified that when she tried to pull one of the men off her husband, Bukowy kicked her in the

husband, Bukowy kicked her in the back and on the arm. He was sentenced to a total of 12 months and five days in jail, with all but six months suspended.

A third man, Sean McQuire of Pasadena, Tex., is at large and Arlington police have filed an assault warrant for his arrest in the incident, according to Assirthat Arlington Commonwealth's Attorney William Nunn.

## Trial Set for 'Nazi' On Assault Count

A soldier in the U. S. Army's elite presidential honor guard, who is a self-proclaimed Nazi, is scheduled to ap-pear in Arlington General District Court Monday to answer charges that he assaulted an off-duty black District policeman last month

PFC Frederick T. Verduin, assigned to the 3rd United States Infantry (The Old Guard) at Ft. Myer, is charged, along with iwo other men, with assaulting Metropolitan Police Officer Edward L. Threat and his wife Sept. 3. Also charged in the case are Robert F. Bukowy of Chicago, whose Sept. 9 conviction on the charges are under appeal, and Sean McQuire of Pasadena, Tex. McQuire has been arrested, and Arlington-police spokesman said its unlikely that extradition papers would be filed because only a misdemeanor charge is involved.

According to an Arlington County police report, Verduin and the two other Nazi party sympathizers assaulted the police officer and his wife at agas station at 2520 Wilson Blvd., about a block from the headquarters of the National Socialist White People's

A Nazi party spokesman conceded that the party member made "obscene remarks for the police officer's wife. In the police report, it is alleged that McQuire then got out of his car, started hitting first Threat and was joined by Bukowy and then by Verduin in the attack.

When Arlington police arrived there was a "large gathering of Nazi members" attempting to aid Verduin and Bukowy, although McQuire had left

Threat swore out warrants against Verduin, Bukowy and McQuire for assault and battery and destruction at his eyeglasses His wife also swore out a warrant for assault and hattery against Bukowy.

Bukowy was held in lieu of \$500 hag, and Verduin released to military abthorities on his promise to appear in court, police said.

Bukowy was sentenced Sept. 9 in General District Court to sky months in jail on the first count of assault and battery, six months suspended jail sentence on the second count and five days suspended sentence for destruction of property. He appealed his conviction in Arlington Circt Court and is scheduled to appear for a jury trial scheduled to appear for a jury trial Dec. 13.

Army officials at Ft. Myer refused to comment on Verduin's case. Capt. Daniel C. Cullinan, public affairs officer, did say that "if Verduin is found guilty by civil authorities, the army will dispose of his case according to army regulations, just like any other soldier in the same situation."

"This is a matter between myself, the other party involved and the state of Virginia," said Verduin.
Bukowy could not be reached for comment. Threat declined to comment.

Harold Mantius, NSWPP director of public relations, said the party is providing Bukowy with legal advice but Verduin "elected to provide his own counsel."
Mantius said Verduin is a party member while McQuire and Bukowy are listed as party "supporters."
"There is no doubt in my mind these men are not guilty," said Mantius.

## Nazi Clash At Bakke Protest

Ten uniformed Nazis interrupted a rally by about 2,000 persons who want the Bakke court decisibili överturned, and the confrontation led to a fist-fight Saturday.

The Nazis, dressed in brown shirts, boots and helmets, and wearing swastika insignia and armbands, were shouting "White Power Now" and carrying "Bakke Equals White Power" signs.

The rally in Oakland's San Antonio Park was protesting the California Supreme Court's decision in the Allan Bakke "reverse discrimination" case, which will be heard by the U.S. Supreme Court Wednesday.

"We came to voice our support for the Bakke decision," said Dan Stewart, 37, a member of the National Socialist White People's Party from Los Angeles.

"We are out to march in a peaceful demonstration just like the people in the park and make our point," he said.

His Nazi group was met at a corner of the park by rally monitors, supporters and Oakland police.

After the free-swinging fistfight, police arrested Robert Haake, described by Stewart as

a Nazi group leader in San Francisco. Haake was later released without charge and was only taken away from the area "for his own protection," according to police.

There were no further incidents as 30 Oakland police patrolled the area.

"The Oakland rally was part of a national day of gatherings to demonstrate support against the Bakke case. Rally spokesman Bob Wing said thousands of people were expected to turn out in Los Angeles, Sacramento, Seattle, New-York, Washington, D.C., Philadelphia, Chicago and other major cities.

Various speakers told the crowd they were gathered to demand an end to racism in this country.

"We, the people of this nation, come not to praise the Bakke decision, but to bury it. So long as there are slums for people to live in, people in want of decent homes and jobs, we must fight decisions like Bakke," Alameda County Supervisor John George told the crowd.

George added the Board of Supervisors and the Oakland City Council had declared the day a "day of concern" over the Bakke case.

Rep. Edward R. Roybal, D-Los Angeles, and member of the Hispanic Congressional Caucus, said, "The Bakke case must be seen not from the 16 minority slots but from the entire pitture"

Five places have been reported to have been reserved by the dean of admissions, he said. "It is the dean who denied Bakke admission, not the minority students. The court's decision must make it fair to minorities to get

into professional schools and colleges as a whole," Roybal added.

Since the high court is made up of Nixon appointees, Roybal expressed hope their decision would be tempered with common sense.
"If the decision is adverse to

"If the decision is adverse to minorities, then Congress will have to take the next step," Roybal warned.


During a press conference, Melinda Paras, of the Union of Democratic Filipinos, said the Bakke decision was more than a case involving "reverse discrimination."

"It is an attempt to blame the economic and unemployment crises and other problems faced by the country on minorities," she said.

picket was conducted by the ST men from the Chicago unit on 9 October, at the Federal Building in downtown Chicago. Two teams of troopers, under the command of Capt. Cedric Syrdahl, picketed for one hour carrying signs which read "FREE BOB MILES!" and "WHITE POWER!" There were no incidents. (See photo at right.)

A record-setting WHITE POWER T-shirt and paper sale was held in the Marquette Park area of Chicago on 1 October. A total of \$195.43 was collected by eight uniformed troopers during a three-hour period, despite intermittent rain and 50-degree temperature. TL Steve Lynch, who led the activity,



reports that the majority of comments from passersby were favorable.

Another "pro-Bakke" demonstration was held in San Francisco on 15 October, a week after the Oakland demonstration. This time the ST men were intercepted by an anti-NS police sergeant who told the troopers that their Constitutional rights were being "waived" by him, and that they would not be allowed to demonstrate as they had planned. Undaunted, the Stormtroopers picketed as near as they could to an anti-Bakke rally being held by local Reds and non-Whites. Despite the attempt by the police to prevent the action, some media coverage was received.

Milwaukee Unit I reports that a full schedule of low-key activities was undertaken during the month of October, in the wake of the tremendous publicity from the two successful anti-busing rallies held in August and September. Three uniformed WHITE POWER sales were held during the month, as well as two door-to-door distributions, in which thousands of papers were passed out.

A so-called "group libel" ordinance was repealed by the Milwaukee County Board on 11 October. The ordinance was admittedly aimed at silencing the Party in Milwaukee. Under its provisions, criticism of any group (such as Jews or Blacks) which led to violence would have been punished by heavy fines and jail sentences. The ordinance was repealed because the Board felt it to be unconstitutional in that it abridged freedom of speech—and also because they felt that the Party would actually benefit from controversy the ordinance was causing.

Unit Organizer Gregg Hummer reports that the Los Angeles Unit comrades had a full day of activity on 22 October. On their way to a routine paper sale in Ontario, California, the troopers heard on the radio that President Carter would be in West Los Angeles that afternoon, and that various "radical" groups would be demonstrating there. The troops held the paper sale in Ontario as planned, and then drove to West L.A. where Carter was appearing. Upon arriving at the site, the troopers, still in uniform, held an impromptu demonstration of their own, which upset the local Reds and JDL-ers, who as usual contented themselves with spitting and cursing at the National Socialists. Television and radio coverage was received as a result of the activity.

### Commander Rockwell's Dog Dies-
