## **COMBAT WITH THE RED FRONT!**

During the month of December militant Communists launched assaults against Party National Headquarters in Arlington, at a Party meeting place in Milwaukee, and at an ST demonstration in Minneapolis. These attacks reflect a new policy on the part of the most radical of the Red groups to "smash the Nazis before they get any stronger." Needless to say, the Party emerged victorious in all three encounters – but this is just the beginning!

All Party comrades are urged to steel themselves both psychologically and physically for the bloody struggles ahead.

The details on the three December actions are as follows:

### **Stormtroops Repulse Attack on National Headquarters!**

On 9 December, NHQ was notified by friendly residents of the NHQ area that leaflets has been placed in mailboxes and on car windshields reading "Death to the Nazis" and announcing that an anti-NS demonstration was to be held in front of NHQ at 11:30 on the morning of 10 December. Because only about 24 hours remained before the scheduled demonstration, we were able to muster only 13 ST men.

Later on the 9th, the Arlington County Police Department contacted us, asking to allow them to place a man inside NHQ during the demonstration, and informing us of the precautions they were taking to avoid violence.

On the morning of the 10th, as the troops were receiving their briefing instructions at the Headquarters, a gang of 30-40 Communists from the Progressive Labor Party and a front group it controls called the Committee Against Racism attacked the front of the building, hurling rocks, bricks, etc. Because the Reds arrived at 10:45 instead of 11:30 as they had announced, both the ST and the police were caught off-guard.

TL Fred Verduin led a team of stormtroopers armed with axe-handles into the attacking mob – and the fight was on! For several minutes the troopers, outnumbered eight-to-one, battled with the Red vermin, and had actually succeeded in driving them off of Party property and into the street when the police began to arrive and the Reds dispersed.



Three troopers were treated for injuries by para-medics, including one who had a fractured arm. Other than that there were no serious injuries among the ST. It was a different story for the Reds, however. Approximately 10 Communists were hospitalized for various injuries, both in Arlington and in Washington, D.C. hospitals. One Red who had been smashed in the face with an axe-handle reportedly was paralyzed temporarily and missed a week of work.

Although the police arrived too late to make any arrests, they all congratulated the ST men on their gallant performance, and expressed disappointment that they didn't have the opportunity to crack some Communist skulls themselves.

Although the Reds vowed that this is just the beginning, no further contact with them has occurred since the attack.

### Minneapolis Troopers Stomp Red Creep!

Three ST men and one NSYM member of the newly formed Minneapolis Probationary Unit picketed a meeting sponsored by the Red "Socialist Workers' Party" at the University of Minnesota. The ST carried signs reading WHITE POWER and CLOSE THE BORDER!, in honor of the guest speaker at the meeting, a non-White mongrel named Pedro Vasquez. The men chanted "What do we want? DEAD REDS!" as they picketed.

About halfway through the demonstration, a leftist creep attempted to sneak up behind the ST men and assault the last trooper in the column. As soon as the creep was discovered, he was seized by the ST men and thoroughly beaten. The rest of the Communists cowered inside the building, watching the beating from behind locked doors, and refused to come outside to aid their "comrade."

After the ST were sure that the creep had learned his lesson, they resumed the picket, and the Red scurried away to safety. Approximately ten minutes later the police arrived, and took the four National Socialists into custody. The three ST men were charged with simple assault, and the youth was released into the custody of his parents.

The hysterical over-reaction of the Reds to the incident can be seen in some of the news clippings reproduced here.

### Milwaukee ST Confront Local Reds

Recently, a Communist newspaper published in Milwaukee called *The Worker* has been boasting that the NSWPP had been driven from the streets of Milwaukee by the Reds. *The Worker* is published by the Revolutionary Communist Party.

To show that this was not the case, Milwaukee Stormtroopers conducted a picket in front of *The Worker's* offices on 10 December. The Reds contented themselves with frowning at the ST men from behind locked doors during the demonstration. Unlike the two White Power rallies held in August and September, there were no police present to protect the Reds. After slipping and sliding on the RCP's unshoveled sidewalk in subfreezing weather for 30 minutes, the troopers left.

Later on in the afternoon as the ST were warming up for some paper sales, 15 members of the RCP came by the house of a Party activist where the ST had gathered. In a heroic display of Communist courage, they scurried up onto the front porch of the building and attempted to kick in the screen door.

Instantly the stormtroopers, armed with baseball bats and accompanied by a snarling German Shepherd, charged out of the house. The 10 troopers then surrounded the Reds at a nearby gas station, which the creeps had retreated to, and held them at bay until the police arrived. Although they outnumbered the ST, the Communists managed to restrain their fury until the arrival of the police, thus saving their lives and keeping the ST out of jail for homicide.

The gallant vanguard fighters of the proletariat revolution then demanded that the authorities arrest the ST men for the earlier (completely legal) picket of their newspaper.

Both the ST and the police had a good laugh at the whole episode, and the Reds returned to their rat-holes to devise new tactics to advance the workers' revolution.

## FALL BUILDING CAMPAIGN EXCEEDS GOAL BY \$2,000!

The Fall Building Campaign for the Three-Year Plan exceeded its \$12,000 goal by nearly \$2,000! The Campaign, which was extended from Christmas Eve to New Year's Eve, raised a total of \$13,959.36.

We are now within *one percent* of where we should be to be on schedule. With 87 percent of the time elapsed, 86 percent of the goal has been raised. We must now raise the final \$12,400 in the four months which remain between now and 20 April.

Everyone who gave will be receiving their copies of Commander Koehl's *Laws of Revolutionary Development* as soon as it comes back from the printer. Those comrades who gave \$88, \$176 or \$888 or more will be receiving their gifts in the near future also.

Let every comrade resolve to give as much as he or she possibly can in the upcoming months, so that we not only equal our final goal of \$88,888 but exceed it!

### No Response to Commander's Offer to Amnesty International

On 1 December the Commander sent a letter to Amnesty International, asking that organization's assistance in securing the release of Rudolf Hess. At the same time, he sent communications to the leaders of the United States, Great Britain, the Soviet Union and France, expressing his willingness to exchange places with Hess in Spandau Prison, and serve out the remainder of his sentence there.

As of 31 December, no response had been received from Amnesty International or from the various heads of state.

Amnesty International is an organization dedicated to helping to free political prisoners wherever they are held in the world – at least in theory. In reality, it is only interested in helping secure the release of imprisoned Communists and pro-Communists. The Commander's offer thus not only brings Comrade Hess' plight to the attention of the public, but also exposes the Amnesty International phonies for what they are.

# Sticks And Stones

Now we don't know who started it or even why it all started, but the behavior by a group of anti-racists this weekend was nothing less than gross misbehavior and violation of the rights of others.

The group, which calls itself the Committee Against Racism, held a demonstration outside of the national headquarters of the National Socialist White People's Party, formerly known as the American Nazi Party, which is located on North Franklin Road in Arlington.

According to police, the committee had received a permit to demonstrate in front of the Nazi headquarters and was well within its rights to be there. However, the hurling of rocks and eggs and the scuffling with Nazi party members goes beyond the rights allowed by that permit.

Apparently, according to a police spokesman, the committee came there with the intention of not holding a peaceful demonstration but of doing as much damage to private property as could be done before the law showed up.

While people may not like the NSWPP for what it stands for and/or its philosophy, they seem to forget that the Nazis have a right to exist, to practice their beliefs and to locate in Arlington.

Since the death of George Lincoln Rockwell, the founder of the American Nazi movement, 10 years ago, the NSWPP here has been relatively quiet and has not caused any major disturbances. They have conducted themselves well by not provoking brawls, although they still raise the eyebrows of people who believe everyone should believe in the same things they do.

While we don't condone or believe in the philosophies of the NSWPP, we firmly contend that they have the right to their beliefs. We also believe that anti-Nazis have the right to demonstrate against those beliefs — but only if they do so peacefully.

The stone-throwing by the anti-racism group Saturday only reinforces the need for stringent enforcement of the laws that prohibit one person from infringing upon the rights of another. We are disappointed that enough police weren't on hand at the beginning of the brawl to slap a few of the demonstrators behind iron bars to teach them a lesson about what the U.S. Constitution means when it ensures freedom of speech and belief to all people.

The committee's pamphlet entitled "Death to Nazis" is another matter. A section of that pamphlet says, "We ... believe that what the Nazis need is not free speech, but free 2x4s to have their heads smashed in with; free rope to be hanged on; and the freely flying fists of thousands of outraged anti-Nazis and anti-racists."

That section leads us to believe that some of the anti-racists are not much better than some of the racists.

## Anti-Racists, Nazis Clash

ARLINGTON—In what was described by police at the scene as a "hit and run" operation, 30 to 40 anti-racists descended upon the Arlington headquarters of the National Socialist White People's Party (NSWPP) Saturday, hurling rocks and eggs and scuffling with members of the pro-Nazi group.

"They didn't come here to discuss anything," said police Lt. David Reiten. "They came here to chuck rocks."

Calling itself the Committee Against Racism (CAR), the group had announced its intention of holding a demonstration outside the NSWPP headquarters at 11:30 a.m.,

but arrived before 11 a.m. and were shortly engaged in a brawl with NSWPP "storm troopers."

One CAR demonstrator, identified by police as Paulette Chiklar, 30, of 1613 Harvard St., Washington D. C., was treated for a head injury and released.

Three NSWPP members, Arthur Mitchell and Richard Jones, of 2507 North Franklin Road and Kenneth Badders of 4606 Frankford Road, Baltimore, were also treated and released. No arrests were made, police said.

Surprised by the early arrival of the CAR demonstrators, Lt. Reiten was the only police officer at the scene when the scuffle broke out.

He ordered the group to disperse and when that failed, turned on his siren and stepped out of his unmarked police car, shotgun in hand.

The demonstrators ran off up Wilson Boulevard from North Franklin Road, where the NSWPP office is located. Within minutes, more than a dozen police cruisers and 30 officers were at the scene.

According to Louis Griffin, membership secretary of the NSWPP, the demonstrators took little time to start pelting the building with rocks and eggs.

"They were chanting and screaming," said Griffin. "The chant I remember best was 'Hitler rose, Hitler fell, racist Nazis go

to hell.' A simple phrase from people with simple minds," Griffin added.

Griffin said that "six or seven of our 'storm troopers' responded," including one armed with a ball and chain. The CAR demonstrators were armed with sticks and canes.

In a leaflet titled "Death to Nazis," the CAR group said that the purpose of the demonstration was to fight the Nazis before they gained large-scale support.

"We in CAR believe that what the Nazis need is not free speech, but free 2x4s to have their heads smashed in with; free rope to be hanged on; and the freely flying fists of thousands of outraged anti-Nazis and anti-racists," it said.

The Committee Against

Racism also claims responsibility for besieging the American University radio station last month while it was conducting an interview with George Mantius, director of the NSWPP.

They also entered the Washington Post newsroom recently to protest an editorial. They were issued a permit for Saturday's demonstration. Once known as the American Nazi Party, the group changed its name shortly after its former leader, George Lincoln Rockwell, was murdered in an Arlington shopping center 10 years ago. A party spokesman would not give a figure for the number of members presently in the group.

## Anti-Racists, Nazis Clash in Arlington

Arlington police in riot gear broke up a demonstration Saturday involving members of the National Socialist White Peoples Party and the Committee Against Racism after the groups clashed with ax handles and picket signs.

The Committee Against Racism had been issued a permit for a demonstration in front of the White Peoples Party headquarters off Wilson Boulevard in Clarendon.

But what was planned as a peaceful demonstration became a wild melee after the headquarters building was

pelted with rocks and eggs.

Members of the White Peoples Party, clad in brown shirts and Nazi armbands, poured out of the two-story building and waded into the protesters, swinging ax handles.

One of the demonstrators—Paulette Chiklar of the District—was treated at Arlington Hospital for head injuries. Three members of the White Peoples Party were also treated for injuries.

Lt. Roxy Crack said police had established a detail near the headquarters shortly before the demonstration was to begin, but the protesters arrived earlier than expected and launched a sudden attack on the building.

Last month the Committee Against Racism staged a protest at American University's radio station during a radio interview with a White Peoples Party member. After The Washington Post published an editorial critical of that action, the group staged a protest in the paper's newsroom. Spokesmen for the White Peoples Party, formerly known as the American Nazi Party, said party members were in an upstairs room when the attack took place.

Police estimated that about 40 demonstrators took part in the confrontation. About 15 members of the White Peoples Party were in the building at the time, according to a party spokesman.

## Nazis in Arlington Battle 40 Attacking Protesters

A group of about 40 club-wielding young demonstrators, who call themselves the Committee Against Racism clashed with uniformed members of the local American Nazi Party at its Arlington headquarters, injuring four people, police said.

According to police, the chanting demonstrators at the Nazi headquarters off Wilson Boulevard in Clarendon threw eggs and rocks, smashing several windows.

About seven Nazis, one of whom carried a ball and chain, then emerged from the building, on which hangs a large "White Power" sign. The Nazis began battling the demonstrators, who were themselves armed with clubs and ax handles, police said.

A few minutes later, when more than 30 police cruisers arrived, the demonstrators fled on foot up Wilson

Boulevard and surrounding streets. No arrests were made.

One demonstrator, identified by police as Paulette Chiklar, 30, of 1613 Harvard St. NW in the District was treated at Arlington Hospital and released.

Also treated and released were Nazi Party members Arthur Mitchell and Richard Janos of 2507 N. Franklin Rd., Arlington, and Kenneth Badders of 4606 Frankford Rd., Baltimore.

A leaflet distributed by the demonstrators stated, "What the Nazis need is not free speech but free 2x4s to have their heads smashed in with."

Last month, young people calling themselves the Committee Against Racism invaded the American University radio station while it was conducting a telephone interview with a Nazi Party member. After The Washington Post published an editorial critical of the committee's action the group briefly entered the Post newsroom to protest.

## Nazi Storm Troopers Beaten Back

WASHINGTON, D.C., Dec. 10—Over 50 members and friends of PLP and Committee Against Racism beat members of the Nazi Party early this morning at their Arlington, Va. headquarters. Chanting "Death, death, death to the Nazis," our multi-racial force of workers and students armed with canes and picket signs, but

especially with the revolutionary communist ideas of PLP and the anti-racist determination of CAR, beat back an attack (with axhandles and bats) by 10 of these racist scum, sending at least 3 of them to the hospital.

IN A WELL-PLANNED AND ORGANIZED action, we were able to smash these racists

and retreat before their friends, the cops, were able to attack or arrest any of our people (the cops began to come at us to protect the beaten Nazis).

We held a rally before leaving the Nazi headquarters, at which PLP and CAR people spoke of why it is important to stop these Nazis now.

# DEATH TO NAZIS!!

Once again the Nazis are being defended openly by the liberal press and by the cops. The Nov. 20 New York Times Book Review asked "whether Hitler is not absent ally [of the U.S. bosses] in the hour of need." The liberal ACLU falls all over itself to defend Nazis from anti-racists who would like to smear Nazis all over the street. The American University radio station (WAMU) put a Nazi on the air and then called the cops on a group of enraged anti-racists who forced their way into the station protesting this free publicity being given to these mass murderers. The Washington Post then wrote an editorial condemning CAR (Committee Against Racism), which organized the protest at WAMU; the Post called for free speech for Nazis. But a few nights later, the very same bosses at the Post called the cops on a group of CAR members who entered the Post newsroom to demand that their side of the story be printed. Also: after a big build-up on Channel 4 news, the National Archives recently showed a notorious Nazi propaganda film, and then called the cops on a group of CAR members who loudly protested that this sort of racist filth should not be shown.

Let us remember what the Nazis did before and during World War II. They caused the death by starvation, shooting, gassing, disease, live burial, torture, burning and bombing of nearly one hundred million people all over the world. Starting off with leftists, anti-racists, communists and Jews, they went on to massacre, sterilize, exploit and enslave tens of millions of Gypsies, Poles, Russians, Czechs, Magyars, Greeks, Italians, French, Chinese, Koreans, etc. etc: workers, students, soldiers, men women and children. The racist, expansionist ideas of the Nazis were exactly the "thing" needed by the German ruling class in its attempt to conquer the world and organize millions of Germans into a deadly war machine. The Nazis could easily have been smashed in the 1920's before they got big and before the German ruling class started bankrolling them in a big way. But apparently no one saw them as much of a threat, and nobody tried to wipe them out, until it was too late.

Today we are in a similar situation. The Nazis (and similar groups) are still small, but the US ruling class sees itself on the way down because of international competition. It needs to split the US working class (and students) along racial lines so that it can extract more profits from all of us and so that it can organize us into a genocidal, racist, expansionist war machine once again. And that's where groups like the Nazis fit in: that is exactly their stated aim.

We in CAR say that this cannot be allowed to happen. We must unite black, white, latin, asian and white working people, students, unemployed, etc. against the following: all forms of racism and exploitation; cutbacks in social services; tuition hikes and scholarship cutbacks; attacks on the wages and working conditions of all workers; and racist gangs like the Nazis BEFORE they get too big.

We in CAR believe that what Nazis need is not free speech, but free 2x4's to have their heads smashed in with; free rope to be hanged on; and the freely flying fists of thousands of outraged anti-Nazis and anti-racists. Without the police and the court protection the Nazis get, these miserable thugs wouldn't dare come up for air.

# Nazi violence crosses over racial lines

Violence on the part of the American Nazi Party is not limited to ethnic minorities and a young white man learned that lesson the hard way last Friday.

Richard Hillman, an employee of the University of Minnesota Hospitals, was crossing the U campus on December 2, when he ran into a picket line thrown up by the Nazi Party.

The Nazis were protesting the meeting of the Young Socialist Alliance taking place inside Coffman Union.

The main speaker at the meeting was Pedro Vasquez, a Chicano socialist and a leader in the movement to stop deportation of Mexicans from the United States. Members of the American Nazi Party, wearing leather jackets and swastika armbands, carried signs reading, "White Power," and "Close the Borders."

Hillman had nothing to do with the meeting but as he passed the protestors he made it clear he did not approve of their actions by making an obscene gesture. At this point four men broke the picket line ranks and at-

tacked the 27-year-old hospital worker. Hillman suffered multiple cuts and bruises and was taken to the U hospital for emergency treatment.

The four Nazis, three adults and one juvenile, were ticketed and charged with assault by University police and were scheduled to appear in court on Tuesday afternoon.

The day after the assault, Saturday, December 3, a news briefing was held to protest the Nazi violence. Norm Overby, civil rights

activist, Pedro Vasques, the speaker at the campus meeting, Manuel Guzman, a member of the Minneapolis Chicano community and Jim Carson, Socialist Workers Party mayoral candidate and witness to the arrest and injuries that occurred, united to denounce the terrorist tactics of the Nazis.

Carson stated at the briefing that "this physical attack is an attack on the freedom of speech and freedom of association and we are here today to protest it." Carson said that this was not the first time the Nazis had used physical intima-

tion against socialists and members of the minority community in Minneapolis but pointed out that "for the first time the Nazis were caught in the act." He called upon the Minneapolis city authorities to prosecute the offenders to the full extent of the law.

Norm Overby, who works with the Minneapolis Urban League, addressed some of his remarks to the white community. "From their statements," he said, "you would think the American Nazi Party is pro-white,

# Young Nazis plead innocent to assault

Three members of the National Socialist White Peoples (Nazi) Party pleaded innocent today to assault charges after a man at the University of Minnesota was beaten Dec. 2.

The three suspects identified themselves to police as Steven P. Martinson, 23, 2646 Oakland Av. S.; Micheal L. Rumble, 21, 5805 North Pearson Dr., Brooklyn Center, and Donald J. Shafranski, 20, address unknown. A 16-year-old boy also was arrested and has been referred to Hennepin County juvenile authorities. The three Nazis appeared today

without attorneys in Hennepin Municipal Court. Their cases were continued to Jan. 11.

The Nazis were picketing in front of Coffman Memorial Union as a chicano socialist spokesman from San Antonio, Tex., was inside, speaking against deportation of Mexicans.

Richard Hillman, 1813 S. 5th St., who reportedly had no part in the socialist meeting, passed the pickets and was cut and bruised after he made the obscene gesture, police said.

Hillman was treated at the university hospitals and released.

# Kick Nazis Off U. of Minn.!

MINNEAPOLIS, MINN., Dec. 12—Four uniformed nazis held a picket line on the Univ. of Minnesota campus on Dec. 2nd opposing a Trotskyite Socialist Workers Party forum on immigration. They carried racist signs attacking undocumented immigrants (with slogans like "close the borders"). When a hospital worker walked by on his supper break and gave the nazi scum the finger, they jumped him and beat him up. Meanwhile, the pacifist, cowardly SWP members watched from a building and didn't even try to help the worker.

THE COPS TOOK THE NAZIS IN BUT IMMEDIATELY released them. They also left the nazis in the same room with a witness who was going to sign a deposition against them. The fascists told her that if she testified they'd find out her address and come beat her up, and maybe kill her. This intimidation scared her so much that she didn't testify. Other individuals and groups have also expressed virtual terror that the nazis might fire-bomb their buildings, etc., if they do anything against them. We in PLP stress that a large, coordinated organization can defeat fascism, both ideologically and in the streets.

After PLP and Committee Against Racism found out about the incident we held a demonstration on Monday, Dec. 5, calling for the multi-racial unity of students and workers to stop the Nazi stooges. An organizing meeting followed.

The PLP in Minneapolis is self-critical in the fact that a few weeks ago we held a demonstration against the nazi propoganda film Triumph of the Will. Some nazis we recognized showed up to see the film and all we did was expose who they were to the crowd. We did not have a contingency plan. We should have introduced them to the sidewalk.

# Nazi Party Attack Sparks Unity Meeting

Four members of the American Nazi Party attacked and beat up a young man at the University of Minnesota on Friday night. The four men were arrested and charged with a misdemeanor assault by the University police.

A group of five or six Nazis were picketing a meeting sponsored by the Young Socialist Alliance inside Coffman U Memorial Union. The main speaker at the meeting was Pedro Vasquez, a Chicano socialist and a leader in the movement to stop deportations of Mexicans from the United States. The Nazis carried signs saying 'White Power' and 'Close the Borders.'

The victim, Richard Hillman, a 27-year-old University Hospital worker said he was attacked by the four men as he was entering Coffman Union at 8 p.m. Friday night. He had nothing to do with the meeting that was going on inside but was at-

tacked because he made it clear that he did not like what the Nazis stood for. He was taken to University Hospitals for treatment of facial cuts and bruises.

The day after the assault, Saturday, December 3rd, a news briefing was held to protest the Nazi attack. Norm Overby, a black civil rights activist; Pedro Vasquez, the speaker at the campus meeting; Manuel Guzman, a member of the Minneapolis Chicano community; and Jim Carson, Socialist Workers Party mayoral candidate and witness to the arrest and injuries that occurred, united to denounce the terrorist tactics of the Nazis.

Jim Carson, Socialist Workers Party mayoral candidate, stated at the news briefing: "This physical attack is an attack on freedom of speech and freedom of association and we are here today to protest it." Carson said that this was not the

first time the Nazis had used physical intimidation against socialists and members of the minority community in Minneapolis but pointed out that "For the first time the Nazis were caught in the act," and called upon the Minneapolis city authorities to prosecute the offenders to the full extent of the law."

Norm Overby, who works with the Minneapolis Urban League, addressed some of his remarks to the white community: "From their statements you would think the American Nazi Party is pro-white. However, this incident [the young man who was attacked was white] demonstrates that if you're white and your ideas conflict with theirs, your color is not going to protect you. So it means that if you have any attitudes against assault and violence, racism, sexism or what-have-you, you automatically, whether you choose to or not, make yourself an adversary of this party."

## 4 Nazi Party members tagged in scuffle at 'U'

Four members of the American Nazi Party were tagged for misdemeanor assault Friday night after they allegedly broke ranks to pummel a man while picketing in front of Coffman Memorial Union at the University of Minnesota.

The victim of the pummeling was identified by university police as Richard Hillman, 27, 1813 S. 5th St.

Hillman had no part in the event being picketed by the Nazis, according to Jim Carson, a member of the Socialist Workers Party and a 1977 candidate for mayor of Minneapolis. Carson identified Hillman, who could not be reached for comment, as an employee of University of Minnesota Hospitals.

The Nazis were picketing a meeting sponsored by the Young Socialist Alliance inside the union, Carson said. A speaker at the meeting was Pedro Vasquez, San Antonio, Texas, described by Car-

son as "a Chicano Socialist and leader in the movement to stop deportations" of Mexicans from the United States.

The police report said Hillman passed the pickets and made "what used to be considered an obscene gesture toward them," in the words of a police sergeant.

After the gesture, Hillman was set upon — allegedly by the pickets — and was cut and bruised about the head. He was treated at University of Minnesota Hospitals emergency room.

Police tagged three adults and one juvenile on the basis of Hillman's complaint. The three adults must appear in Hennepin County Municipal Court on Monday to face charges of simple assault, the police said.

Under most circumstances in Minneapolis, people accused of misdemeanors are identified by the police, given a citation like a traffic ticket and ordered to report to court at a certain time.

They were tagged for assault Dec. 3 for allegedly beating Richard Hillman, 27, 1813 S. 5th St.

## Rudolph Hess

The men who ruled Nazi Germany were not merely misguided patriots. They were pretty thoroughly deranged, and it is both overly cynical and downright ignorant to contend their only War Crime was to lose.

Hermann Hess rendered himself a bizarre footnote in the otherwise enormously more bizarre tale of the Nazi Reich when he flew to Scotland in 1941 to "make peace" with the British.

Hess' mission has been revealed by postwar study to be pretty much what it first appeared to be, a deranged one-man attempt to make peace on the basis of what he saw as the shared interests of the German and British governments.

But how shameful it is to be declared deranged, when one's standards of "normalcy" have been such figures as Hitler, Goebbels, and Goering, we aren't sure.

The fact remains that Hess is still imprisoned, at age 83, while Albeert Speer (who ran the Nazi war production machine with its ever-growing reliance on slave labor in the closing year of the war) has been at large, raking it in with his See How A Good Boy Went Wrong number, since long before John Ehrlichman and company ever thought of it.

We find it hard to align ourselves with Matt Koehl and his National Socialists on anything. We certainly do not agree with them when they say Hess was convicted by "the farcical Nuremberg Trials ... in a cynical travesty of justice."

In fact, it is thoroughly ironic that a plea to re-examine the Hess case comes from the Nazis at all. As a martyr, he may at least serve them some Machiavellian use. And if Hess had been judged an enemy of a Nazi victor in 1946, his remains would now have spent 31 years in some lime pit.

Whether Hess is still dangerous can only be determined by the kind of review Koehl calls for. Frankly, we suspect the only reason Hess is still held is at the insistence of the Russians, who have not always revealed the humanitarian nature America once hoped to find in her allies against Nazism.

Koehl and company probably cannot see that such a review is a refutation of all their invective against this society. They will claim anyone who answers their call is seeing the truth of their beliefs.

That is an inanity with which we will have to bear.

The case of Rudolph Hess should be reviewed.

## Nazis Seek Aid For Rudolph Hess

ARLINGTON — The leader of the Arlington-based World Union of National Socialists, a neo-Nazi organization, has asked Amnesty International for assistance in securing the release of imprisoned Nazi war criminal Rudolf Hess.

Matt Koehl, commander of the group, said that he

"is asking for the help of Amnesty International, a left-wing, anti-Nazi organization, because all other efforts to effect Hess' release have been unsuccessful." Amnesty International was recently awarded a Nobel Peace Prize for its efforts on behalf of political prisoners.

Hess, 83, was the one-time deputy to Adolf Hitler and has been imprisoned

under the joint control of the U.S., the U.S.S.R., Great Britain, and France at Spandau prison in Germany since being convicted at the 1946 Nuremberg war crimes trials.

Koehl, who is also the leader of the National Socialist White People's Party (formerly the American Nazi Party), offered to take Hess' place in prison in exchange for his release.

In his letter to the amnesty group, Koehl charged that Hess, who was considered second in rank only to Hitler in the German government, and who has been imprisoned since he flew to England in 1941 in a single-handed effort to negotiate an end to World War II, is "in virtual solitary confinement," and "denied proper medical treatment."

Calling Hess the "longest-held political prisoner of modern times," Koehl asked, "Must Rudolf Hess, a living martyr to the idea of peace, die in jail for crimes he never committed? Was peace a crime during World War II?"

sentenced to life imprisonment.

Today, 36 years after his heroic effort to end the Second World War singlehandedly, Hess is still in jail. He has become the longest-held political prisoner of modern times.

Must Rudolf Hess, a living martyr to the idea of peace, die in jail for crimes he never committed? Was peace a crime during World War II?

I appeal to you to use every means at your disposal to help secure the release of Rudolf Hess' from this unjust and inhumane imprisonment.

For my part, I hereby state that I am willing to take Hess' place in prison immediately in exchange for his release.

# Release Rudolf Hess

### Editor's note:

The following is a letter sent to Amnesty International in New York by Matt Koehl, current commander of the national socialist party, which is located in Arlington. Koehl's letter was the subject of a story and editorial in the Tuesday edition of the Sun.

### Dear Sirs:

I understand that your organization is concerned with the plight of political prisoners throughout the world. I would like to ask your assistance in securing the release of one such prisoner presently being held jointly by the United States, the Soviet Union, Great Britain and France.

He is in virtual solitary confinement, unable to communicate with his family and friends and denied proper medical treatment. His

living conditions and mental state are such that he has attempted suicide at least twice in the past year.

The political prisoner I am speaking of is Rudolf Hess.

You may already be familiar with Hess' case. In the event you are not, let me give you some background information.

In May, 1941, Rudolf Hess — then the number two man in the German government — flew to Great Britain in an effort to arrange a peace settlement between that country and his own, which were then at war.


Instead of being treated as the envoy of peace, which he was, Hess was thrown into jail by the British and kept there until the end of the war. Then, in 1946, in a cynical travesty of justice, he was convicted of "crimes against peace" at the farcical Nuremberg Trials and

## Commander Addresses Chicago Meeting

As part of an organizational tour of the Midwest, Commander Koehl stopped off in the Chicago area in early December, and visited the Midwest Regional Headquarters the Party maintains there.

Speaking to a meeting of Party members and supporters on 3 December, the Commander summarized the danger the White race is in at the present, and explained the only way out of this danger.

Underneath the false prosperity of a plastic world, the Commander explained, lies rot and corruption. The healthy values of a natural Aryan society have been inverted, so that now we are told that black is white, that ugliness is beauty, that sickness is health, *that bad is good*. It would be incorrect to place all of the blame for this situation on our racial enemies, however. As dangerous and evil as they are, they could never by themselves do the damage which has been done to our people and our culture.

No, the Commander said, a lot of the blame for the perilous state our Race is in must fall on the White man himself. He got himself into this mess, and only he can get himself out of it.

It is the duty of the Party to show the White man the way — and that way is *National Socialism*.

The Commander remained in the Chicago area for another week before returning to National Headquarters in Arlington.

## Commander Offers Aid to Persecuted Polish-American

As was noted in the last NS BULLETIN, Polish-American Frank Walus, of Chicago, has been the recent target of a Jewish witch hunt. The Jews and their lackies in the government have decided to persecute Walus for so-called war crimes, which they are quite aware Mr. Walus never committed.

Commander Koehl learned of the plight of this law-abiding, upstanding American citizen on his recent Midwest tour. The Commander decided that Walus could be helped in two ways:

First of all he needs money to help conduct his legal defense. If this defense fails, due to lack of funds or any other reason, it will probably cost Walus his life. He will be deported to Communist Poland, where a kangaroo court and a firing squad almost certainly await him.

To assist Walus financially, the Commander offered him Party funds, and ordered that the address of his legal defense fund be printed in the Party paper and bulletin so that he may also benefit from the generosity of other NS comrades.

Secondly, the Commander decided to bring the Walus situation to the attention of the public. The newsmedia had been giving the case only the slightest amount of coverage, all of which was heavily biased against him.

To remedy this, the Commander went to the court where Walus is having a citizenship hearing, along with four stormtroopers. All the National Socialists were in full uniform. After listening to the hearing for a while, they went outside the building and picketed.

The result was that the Chicago newsmedia went wild and gave the mini-demonstration and the Commander's offer of help the full treatment. Because of this publicity, Walus received a great outpouring of public support from people who were completely unaware of his situation before.

To be honest, all of this might not save Frank Walus in the long run – but it will certainly improve his odds, and make it that much harder for the Jews and the government to railroad him!

## ACTIVITIES IN BRIEF

● Comrade Steve Martinson reports that the Minneapolis Probationary Unit distributed 1,817 copies of the Party paper and 490 Eric Thompson comics during the month of December. The flood of NS literature throughout the city is worrying the local Jewish population. Proof of this is the clipping reproduced here from the *Minneapolis Star*.

● A dozen Party activists from National Headquarters staff and Northern Virginia held a rush-hour demonstration on the morning of 5 December. The National Socialists stood on Memorial Bridge, which links Arlington and Washington, D.C., and displayed signs and banners urging that the U.S. dump Israel. This is the second such activity the Party has held in recent weeks.

● Comrades from National Headquarters, Northern Virginia and Baltimore held their annual *Freedom for Rudolf Hess* vigil across from the White House on 23 December. The vigil, which began before dawn and lasted well into the night, was seen by thousands of holiday tourists.

● As well as battling and harassing the local Reds, the comrades of Milwaukee Unit I found time for conducting three WHITE POWER distributions door-to-door during the month, according to Unit Secretary Scott Mosby.

● The Los Angeles Unit held two paper sales in Hollywood during December. A total of 200 papers were distributed, and approximately \$50 was collected in donations.

● Rickey Cooper, Unit Leader of the Tracy/Stockton Unit in northern California, reports that the Party has become very popular among the White students of Franklin High School in Stockton. The school experienced severe racial violence recently between White and "Chicano" students. As a side result of subsequent Party organizational efforts, a "White Students Organization" was formed by the youngsters there.

# Nazis offer to aid defense in atrocity trial

A NEO-NAZI GROUP in Monday offered to help pay the legal expenses of a Chicagoan accused in federal court of helping Adolf Hitler's troops commit

atrocities, including the murder of children, during World War II.

But the defendant, Frank Walus, said he knows nothing about the National Socialist White People's Party, which made the offer.

Walus, 55, who lives on the Southwest Side, appeared at the Dirksen Federal Building Monday to hear Senior Judge Julius J. Hoffman turn reject a bid by Walus to dismiss a civil suit filed against him by the federal government. Hoffman set the trial for next Monday.

The year-old suit seeks to revoke Walus' citizenship on grounds he participated in war crimes in Poland and illegally failed to disclose information about his


wartime activities when he applied for United States citizenship.

MATT KOEHL, national commander of the Virginia-based Nazi group, sat in the rear of Hoffman's courtroom with four other party members, all of them wearing Nazi uniforms.

Outside the courtroom, Koehl said the group was supporting Walus because his anti-Communist beliefs have made him a victim of "a Jewish witch hunt and mockery of justice."

"We've extended an offer to help him in any way he might request, including hiring a lawyer for him and even monetary help. And there will be absolutely no strings attached," Koehl said.

But Walus, confronted by reporters as

he ever had been a member of Hitler's he ever had been a member of Hitler's Gestapo or SS Troops and said he had been working on a farm far from where the atrocities allegedly occurred.

Walus says he has his own witnesses and documents to support his plea of innocence.

The suit accuses Walus of aiding Hitler's troops in Poland from 1939 to 1943 by separating children from their parents and then helping to execute the children.

# Man accused of atrocities spurns Nazi offer of money

A neo-Nazi group has offered to help pay the legal expenses of South Side man accused of committing atrocities as a Nazi henchman during World War II. But the man, Frank Walus, 55, says he doesn't want their help.

The government is seeking to revoke Walus' citizenship on the ground that he obtained it illegally by failing to disclose his alleged role in atrocities when he received his naturalization papers in 1970.

Senior U. S. District Court Judge Julius J. Hoffman set next Monday for the trial.

As Walus sat in court Monday, five uniformed members of the National Socialist White People's Party sat rigidly two rows behind him, wearing brown uniforms adorned with swastika arm-bands.

The group was led by Matt Koehl, national commander of the Virginia-based Nazi party which wants to help Walus "with no strings attached," Koehl said.

The government has charged that Walus shot a Jewish woman in the neck in 1942 in Czesochowa, Poland, after she refused to disrobe, and that he participated in the slaying of two of the woman's daughters, who were with her.

The government also alleged that he and other members of the Gestapo shot a Polish man who had attempted to escape from a cemetery execution site in 1943. Walus, the government has alleged, also helped German SS troops separate children from their parents. The parents later were shot.

The Daily News first disclosed the allegations made against Walus in a series of stories last January.

Walus, of 5141 S. Kilbourn, denies all charges against him. He says he was doing forced labor on several farms in southern Germany at the time of the alleged atrocities.

Asst. U.S. Atty. John L. Gubbins said the government has 13 witnesses—most of them from Israel—to the atrocities Walus allegedly participated in, and four witnesses from the Chicago area who claim Walus boasted to them of anti-Jewish activities during the war.

# Nazi unit offers Gestapo suspect aid

A Nazi organization Monday offered legal or financial aid to a suspected Gestapo terrorist whose citizenship is under challenge in federal court. The accused man said he wanted no Nazi aid.

Matt Koehl, national commander of the Arlington (Va.) based National Socialist White Peoples Party, appeared in a brown-shirt uniform with four uniformed followers in the courtroom of U.S. District Judge Julius J. Hoffman Monday to offer support for Frank

Walus.

Walus, 55, who lives on the Southwest Side, was accused last January in a civil suit by the U.S. Attorney's office of committing atrocities while aiding Hitler's Nazi forces in Poland during World War II.

The suit charges that Walus lied on his citizenship application and seeks to strip Walus of his naturalized citizenship as a first step toward possible deportation.

Hoffman, Monday postponed start of the Walus trial for one week because he is presiding

over another trial and also because Walus fired his attorney Monday.

Outside the courtroom, Nazi leader Koehl told reporters the government's citizenship suit is "a Jewish witch hunt."

"The government of this country is going after eastern Europeans with manufactured evidence and perjured testimony," he said, "while millions of illegal aliens are pouring into this country taking jobs away from citizens."

Koehl said Walus is being "hounded for his anti-Communist

beliefs. This is a big frame-up. We've extended an open offer to help him in any way he might request including hiring a lawyer for him and even monetary help . . . with no strings attached."

He said he fired his lawyer because the case was going too slowly. "I'm a retired man and I've had five heart attacks and all I want is to live quietly. If you want to know the truth of this case, come to court and I will bring my witnesses and my documents," Walus said.

"The Nazis took me to Germany and I was a slave worker. I was never a member of the German Army and I was never a member of the SS (Hitler's elite guard)," he said.

Assistant U.S. Atty. John L. Gubbins said the government expects to present 13 witnesses who will testify they saw Walus commit atrocities, including murder.

# RICHARD BIEDERMAN

JUNE 19, 1951 - DECEMBER 5, 1977

It was with great sorrow that the Party learned of the death of Comrade Richard Biederman. Comrade Biederman, a member of both the Party and the World Union of National Socialists, was serving with the Rhodesian Army at the time of his death. He was killed while on a combat mission inside Mozambique on 5 December, and was buried in Rhodesia on 16 December.

A native of Minnesota, Comrade Biederman first got in touch with the Party after seeing Commander Koehl on a Minneapolis talk show in 1968. He joined the Party as an Official Supporter a year later. He subsequently joined NHQ staff, and later served as the Party organizer for first Philadelphia and later Cleveland. He took part in countless demonstrations, and served as the Commander's personal aide on many occasions.

In early 1974 he left staff to join the Rhodesian Army, to help in the life and death struggle our racial brothers and sisters are waging there. He originally enlisted in the Rhodesian Light Infantry, and later on volunteered for the elite Special Air Service.

Taking a much-deserved leave from his dangerous combat duties, he returned to the United States to visit with relatives and comrades during August and September of 1977.

He participated in the Eighth Party Congress, and spoke at the Congress' outdoor rally on the racial struggle being waged in Rhodesia.

Upon his return to that country, he was promoted to the rank of sergeant, a rare honor for a foreign-born soldier with no previous military experience.

Comrade Biederman was winding up his last year of service with the Rhodesian Army; he planned to return to the U.S. in May, and to resume an active role in the Party. While overseas he had been working on making important WUNS contacts.

Comrade Biederman will be greatly missed by those who knew him. He was fiercely loyal to the Commander and the NSWPP, and had nothing but contempt for so-called National Socialists who have abandoned the Commander and the Party to pursue their own ego trips.

Every National Socialist should let Richard Biederman's life serve as a shining example, as one who valued the welfare of his Race over his own personal existence.

## Party Comrade Loses Appeal

As was reported in previous NS BULLETINS, TL Robert Bukowy was convicted of assaulting a Black race-mixer and his White wife, in an incident which took place in Arlington over the Eighth Party Congress. Comrade Bukowy appealed the conviction, and was accorded a jury trial in Arlington County Court on 13 December.

Once again he was found guilty, thanks to the perjured testimony of the Black, Edward Threat of Washington, D.C., and his wife. The prosecuting attorney also was viciously anti-National Socialist and spared no trick in the book to make sure that Comrade Bukowy would be convicted.

Although he had an absolutely spotless criminal record, with no previous arrests or convictions, he was sentenced to 20 days in jail and a \$500 fine. Such a severe sentence for a fist fight is almost unheard of, especially when it is the individual's first offense, and it becomes all the more outrageous when the fact is considered that Comrade Bukowy wasn't even guilty!

## Write to Bob Miles

As every Party member and Official Supporter should know, the Party has been giving moral, financial and political support to Reverend Robert ("Bob") Miles since he was first incarcerated.

For those who are new to the Party, Bob Miles has been falsely convicted of plotting to blow up school buses that were to be used to integrate the school system of Pontiac, Michigan. Bob Miles was framed, convicted and then sent away to the Federal prison at Marion, IL, where he has consistently been denied parole, despite the fact that even the prison authorities admit he is a model prisoner.

This month's activity is to drop Rev. Miles a postcard or letter, letting him know that he is not forgotten. Tell him of the racial situation in your area, and any NS activities which have taken place there. Be sure you mention you are with the NSWPP. What you say is not as important as letting Bob Miles know *we care*.

Don't let Bob Miles down. Write him a note *today*. He is one of the finest leaders the White race has, and must not be forgotten!

## Notes from the NSYM National Secretary

1. All probationary and full NSYM members should send their 1978 dues of \$5 to NHQ along with two recent passport-type photographs of themselves, so that they may receive their 1978 membership cards.
2. Starting this year, the NSYM will concentrate all of its activities on organizing in high schools. This has been shown to be one of the most effective recruiting areas for the Party.

An NSYM comrade from California writes:

"I started passing out Party leaflets at school in December. After two weeks, kids were coming to me for leaflets and information, and I made contact with an underground NS group on campus that had never heard of the Party before."

This is just one example of the appeal National Socialism has for those who have not yet been brainwashed by the System. NSYM members will be receiving more detailed instructions individually.

## NS Pilgrimage Tours

As of 31 December, the response to the proposed Party-sponsored tours of German and Austrian NS sites has not been great enough to warrant a trip in 1978. The tour would cost \$888 per person, which would include all transportation and hotel expenses (although most lunches and dinners would be extra). A multi-lingual NS comrade would personally conduct the tour of such places as Nuremberg, Munich, Branau, Linz, etc.

If there are any comrades still interested in a 1978 tour who have not contacted National Headquarters yet, they should write to World Union of National Socialists Secretary H.A. Koehler in Arlington within the next few weeks; otherwise, this year's tour will be cancelled.

Anyone interested in the 1979 tour should also notify NHQ of this at this time.

## Correspondence Slowdown

Comrade Doug Winkleman has finished his six-month tour of duty on National Headquarters staff, and has returned to his home state of California, where he will resume leadership of the Los Angeles Unit. Comrade Winkleman had been serving as corresponding secretary. Until the new corresponding secretary arrives, various staff members will be handling routine correspondence as their schedules permit. This means that routine acknowledgement of donations, pledges and dues will be delayed. Answers to letters seeking information will also be delayed. All comrades will receive the proper acknowledgement for their contributions and answers to their questions at the earliest possible moment. Until then, NHQ asks that everyone keep their correspondence with Headquarters down to a minimum.

## Party Publications Behind Schedule

Both WHITE POWER and the NS BULLETIN for January and February will be issued later than usual because of a mechanical breakdown in the Editorial Department. The Party's IBM composer, on which the paper and bulletin are typed, has worn out after nearly 10 years of continuous use. A new composer costing the Party \$8,900 has been purchased, but will not be delivered until March. Until that time, we are having the paper produced elsewhere, which will take longer than when we do it ourselves. We are continuing to produce the NS BULLETIN ourselves, using the old half-broken machine.

We hope all comrades will bear with us through these delays. Contributions to help pay the cost of the new composer should be sent to National Headquarters, in care of the Three-Year Plan, as Plan funds will be used to pay for the new machine.
