A Message From The Editor

GET IN SHAPE!

The following is an excerpt from a taped telephone message recorded by the Jewish Defense League in New York City:

"... We are calling for Jews to unite in an all-out war against Nazis and any other Jew-haters. We are beginning our battle by offering \$500 for every Nazi lawfully killed during an attack on a Jew. We are also advocating mass executions of Nazis in order to make their stay in this country an unhealthy one. JDL is presently recruiting people to go and fight Nazis wherever they may march..."

Party activities this coming spring and summer promise to be some of the bloodiest and most violent in Party history. Thousands of radical Communists, as well as militant Jews, have made public their intention to "stop the Nazis before they get any stronger." At this very moment, paramilitary communist and Jew groups are training in armed and unarmed hand-to-hand combat for the opportunity to confront the Party with violence on its public demonstrations. Besides being armed, our enemies also have the weight of numbers on their side. We must expect to be outnumbered from anywhere from five-to-one to 100-to-1.

Of course, this is primarily of concern to the Stormtroops — but not entirely. Eventually, every National Socialist faces the possibility of violence at his home, school or place or work, as our enemies escalate their assaults against us.

If we are to survive and be victorious in these encounters, every Party comrade will have to get himself or herself into topnotch physical shape. There isn't a moment to lose!

To be honest about it, there are some comrades — including ST personnel — who are in *disgraceful* physical shape. They are overweight; they smoke too much; they get little or no physical exercise. In such condition, they lower their effectiveness to the Party significantly.

For instance, every comrade should be able to run (not jog) a full mile, unless they have a bad heart, a broken leg or some other medical disability. How many of you can do it? Age and sex are not important factors here — everyone should be in good physical shape.

Stormtroopers, in particular, should be combat ready in their physical condition at all times.

It is important to be tough psychologically, and I know that most Party members and supporters are. But unless your body as well as your brain is in good shape, you are endangering yourself and the comrades who are depending on you.

Every National Socialist who is not now engaged in some sort of regular physical fitness program should look into one today. Do NOT rush into such a program without knowing what you are doing. Reproduced here are some physical fitness

TL Verduin Loses Appeal

TL Fred Verduin, who was involved in a scuffle with an interracial couple near Party National Headquarters over the Eighth Party Congress, has lost the appeal he filed in Arlington Superior Court on a conviction resulting from that incident. Comrade Verduin had rushed to the aid of another comrade, TL Robert Bukowy, who was being assaulted by an off-duty Black policeman, Edward Threat of Washington, D.C., and his White wife. Both comrades were arrested after the fight when Threat gave a false account of the altercation to the Arlington County police.

Threat stated that he had been assaulted without provocation by the "Nazis." In the ensuing court battles, Threat, his wife and another witness perjured themselves on the witness stand. That, along with a clear anti-National Socialist bias held by the court, was sufficient for both comrades to be convicted. Both appealed, and both lost their appeals (see NS BULLETINS Nos. 229, 230, 231 and 233).

Verduin, a member of the elite Third Infantry regiment and former member of the presidential honor guard, lost his appeal on 4 Jan. He was sentenced on 13 Jan. to a \$700 fine and eight months probation. (Accompanying news reports which state otherwise are in error.)

Los Angeles Units Planning Public Meeting

As part of their campaign to bring National Socialism to the White people of Los Angeles, Los Angeles Units I and II are planning to hold an indoor meeting which will be open to the public. Initially, the L.A. comrades had planned on renting a private meeting hall in the Pomona area. However, because of the great difficulty and expense in obtaining such a hall for Party use, the units have applied for the use of public school facilities.

In the past, public schools have tried to deny the Party use of such facilities because the Party "discriminates" on the basis of race. All such restrictions have long been declared unconstitutional, however, and there is nothing that local authorities can do to deny us these buildings for public meetings. As long as the comrades of a local unit are determined to fight for their constitutional rights, they will be victorious in the end.

Further developments concerning the efforts of L.A. Units I and II to obtain public facilities for their meetings will be covered in subsequent NS BULLETINS.

6 Tips for Exercising

If you are thinking about getting in shape, here are some basic rules recommended by the American Heart Association:

- Check with your doctor; an exercise-tolerance test may be required first.
- 2. Pick activities that are rhythmic, repetitive and challenging at an intensity appropriate for you.
- 3. Choose exercises that you enjoy, that are suited to needs, and that can be done year-round.
- 4. Wear comfortable clothing appropriate for the exercise to guard against becoming overheated.
- Remember to warm up and cool down gradually, so your body can make adjustments.
- 6. Follow your exercise program regularly, at least three times a week and preferably not on consecutive days.

ACTIVITIES IN BRIEF=

The controversy over the Party's attempt to obtain facilities for a public meeting in Los Angeles has not been the only local activity to receive media attention. The Party was also mentioned in the press as a result of the NAACP's futile attempts to have the White Power Message operated by L.A. Unit II disconnected. Said the local head of the NAACP: "I've tried everything I can think of to get the phone company to disconnect their service, but with no success." The phone company says it regrets that many Jews, Blacks and Mexicans find the recordings "offensive," but that the WPM is protected by the First Amendment, which guarantees freedom of speech.

And when legal means fail, our enemies try to silence us in other ways. The security and intelligence officer for L.A. Unit I reports that an unsuccessful attempt was made to destroy the building in which the unit has its offices by fire. There was no serious damage.

The Chicago Unit distributed thousands of WHITE POWERs along with copies of a specially produced leaflet entitled "A Warning to Cicero" during the first half of January. Cicero is the city in which the Midwest Regional Headquarters is located. The leaflet warns that the all-White suburb of Cicero may become a multiracial jungle if the White people there don't wake up to the "impending Black invasion."

Other units and areas which report WHITE POWER and leaflet distributions during the first half of January include: Arlington, Baltimore, Minneapolis, Milwaukee Unit I and the Milwaukee NSWO unit.

Unit Leader Rickey Cooper (Tracy-Stockton Unit) and Unit Organizer Robert Haake (San Francisco Unit) spoke to a political science class at Los Medanos Junior College on the Party and its beliefs on 11 Jan. The two comrades addressed the class and answered their questions for over an hour and a half, and then stayed nearly another two hours to speak with interested students. There were no incidents.

Soldier Member of Nazi Party Convicted Again in Assault

A former member of the U.S. Army's elite residential honor guard who is also a professed Nazi was convicted yesterday of as-saulting a black off-duty D.C. police officer at an Arlington gasoline station where the policeman had stopped with his white wife.

Frederick T. Verduin. 22, a member of the.
3d U.S. Infantry at Pt. Myer, testified during
the two-day trial before an Arlington Circuit
Court jury about his "disgust" with interracial
marriages and dating.
Verduin said that he became disgruntled with
the Army's special treatment of blacks and was
guided into membership in the National Socialsit White Peoples' Party (formerly the American Nazi Party) by "a sergeant in the honor

goard with connections in the White People's Party."

The presidential honor guard is a crack 18-member unit that performs at parades and ceremonies such as White House functions, at the Tomb of the Unknown Soldier and at Arlington National Cemetery funerals. Verduin was quickly removed from the guard when someone told Army officials of his Nazi affiliation and his security clearance was revoked, an tion and his security clearance was revoked, an Army official testified at the trial.

Army official testified at the trial.

Verduin was convicted by Arlington General
District Court Judge Richard Corman in October of assault and battery on Officer Edward
L. Threat, and breaking the police officer's eyeglasses. He was sentenced to 20 days in jail and
a \$200 fine.

Verduin appealed Corman's decision to the
Circuit Court. The five-member jury yesterday

unvicted Verduin of assault and battery and entenced him to a \$1,000 fine. Earlier in the day, Judge Charles Duff dis-

Earlier in the day, Judge Charles Duff dis-missed charges of breaking Threat's eyelasses because he said there was not enough evidence to show the glasses were broken by Verduin or one of the other two Nazis in the fight, Duff, who has the power to reduce a sentence, said he will impose sentence on Verduin on Jan. 13.

he will impose sentence on Verduin on Jan. 13.

As a result of his party affiliation and the first conviction, Verduin said he has been demoted twice, from E-4, which is a privatt.

Verduin is also under investigation by Secretary of the Army Clifford Alexander, an Army officer testified, sithough it is not against Army regulations to be a Nasi. Only membership in organizations attempting to overthrow the government violently is prohibited.

Verduin testified that he became disgrun-tied with the Army because, he claimed, black soldiers; were disciplined less often than whites, allowed to wear hair longer and were deficient in "general upholding of standards." He then joined the white supremeater party on the advice of a sergeant, he said.

"I always considered myself to be patriotic,"
testified Verduin, who wore his dress blue
Army uniform. "And the National Socialist
White People's Farty was the only patriotic
organization."

Verduin suggested under cross-examination that the country "revert to laws we had

WASHINGTON—A young soldier, filled with idealism and dedicated to achieving what, in his view, is a better America, is the latest to learn that the profound pronouncements that this society is a "free market place of ideas" are hollow

are nonew.

Because of his political views he was busted from "specialist" ranks (analogous to corporal) to private. Also because his political views—and not a hint of a security problem—he has been drummed out of the elite guard unit that patrols the Tomb of the Unknown Soldier and the President.

His penalty for having his own thoughts about what's good for America is so severe that the secretary of the Army is personally trying to banish the young

Frederick T. Verduin's strong sense of duty and patriotism, and his unblemished life-long record eliminate any issue of "security risk."

It's just that in this 'nonpolitical Army' commanded, under the Consti-tution, by a civilian President and com-mander-in-chief and by a civilian secretary of defense and Army secretary, the politics must be conventional or they'll punish you.

You see, Verduin is a "Nazi"—a member of the National Socialist White People's Party based in the Washington suburb of Arlington, Va,

He's bright, clean-cut and articulate— denving the stereotype of the alack-jawed, beady-eyed, slobbery, bear-bellied rabble-rouser so carefully nur-tured by so-called "liberals" who prattle about freedom of thought and speech— so long as it is liberal thought and liberal

eech. If a "Nazi" is what classic history defines as a "Nazi," then Verduin is no Nazi. So, what is a "Nazi?" The herd of accepted World War II historians give you



this nutshell 'definition of a "Nazi" One who helped gas "eix million Jews," who is a "socialist" and who had to be whipped in World War II or Adolf Hitler would have conquered the world.

The above description is precisely what young Verduin says he is met, while maintaining that Nazism holds the hope of the future. So Verduin's mitshell definition of himself and all Nazis from Hitler's time to the present:

One who did not, and neyer entertained the notion, of gassing any Jews ("The Hoax of the 20th Century" by Dr. Arthur Butz of Northwestern University and two previous books, suppresed in this country, are cited by Verduin). Nor did the Nazis ever threaten, in any way, war with England, much less the United States. (He cited the peace mission of the imprisoned Rudolf Hess and Hitler's confirmed orders

ot to wipe out 50,000 British at Dunkirk but stand by as they were rescued across the channel in pleasure boats. He also mentioned numerous statements He also mentioned numerous statements and actions by Hitler, some of which are surprisingly, found in the latest and accepted biography by John Toland and David Irving). The war between France and Germany, he says, had been an off-and-on affair for a century and would have ended there if England had not declared war on Germany.

Nazi socialism? Don't compare it with Nazi socialism? Don't compare it with Marxist-Soviet control of your personal life. Hitlerian socialism, which Verduin calls "ethical socialism," champions private enterprise and is "socialist" only in its determination to stamp out international monopolistic super-capitalism. Commercial competion and human initiative blossom better, he says, because the "socialism part" restrains the multinational financiers who actually restrict competition through monopoly.

ompetition through monopoly.

Verduin was asked to reconcile this view of national socialism with a speech made some years ago by the late commander of the American Nazi Party, George Lincoln Rockwell, on the Mall in Washington.

In that speech, Rockwell advocated a free vacation of two weeks, at any point on earth and by any mode of transportation, for every American at public ex-

That was never part of format party doctrine, said Verduin, but intended to demonstrate what could easily be ac-complished in a free society where re-

sources are kept at home instead of squandered on "foreign aid." "A free-enterprise society always over-produces." Verduin said. "So there is

"A rece-enterprise society always over-produces," Verduin said. "So there is no reason why the elderly should not have a good living and good health care." The nation could easily afford the paid vacations, for example, if industry and commerce were less drained by govern-ment interference and taxes, and foreign

aid ended, he said.

So, during an in depth interview, Verduin emerges not as a monster but a young man who is convinced that his group has a better idea for America—a country he deeply loves, for which he is an unabashed "flag-waver" when his contemporaries find it no longer chic, and for which he would offer his life if threatduring an in depth interview,

This society is so tolerant that a Jane
Fonda remains socially acceptable despite aid and comfort given to Communist
North Vietnam when her own nation was
at war. And avowedly Marxist college
instructors are protected and even cherished on grounds of "academic freedom." Why then, is a "Naxi" not tolerated?

Information on party numbers is secret, but there is no pretance that its ranks are swollen. This is of no concern, Verduin said.

"We are a revolutionary party in pre-revolution times," he said.

When the great mass of discontented Americans stir themselves, the leadership will be ready; it is already established.

How far into the future is such a revolution projected?

"I can't see it being more than 10

reart see it being more than it years," said Verduin.

The young soldier's ideas are all his own and nothing in his typical, middle-class background in a small California town pointed him toward national socialism. His father was a member of the American Civil. Liberties Union and his

Aside from economics, Verduin's ex-planation of National Socialism is very interesting—and a far cry from what one reads in the national media. The Nazis are bitterly opposed to attempts to weaken the family unit, which they see as the besic unit of any healthy society. Hence, they oppose pornography, homo-sexuality and even an economic system sexualty and even an economic system which forces the wife to work. They endorse subsidies for farmers, believing that a strong rural population, is the foundation of a nation, and they oppose the idea of free trade which forces American with low-paid forceirs. sne mea of free trade which forces Americans to compete with low-paid foreign workers to survive. Hitler, he says, is the most misunderstood man in history although in his writings in "Mein Kampf" and elsewhere he clearly laid out his views and the principles of the party he founded.

founded.

Verduin says the Nazis see race as the major social problem. His solution originated with Abraham Lincohn: send the blacks to Africa and establish a "Jewish state." Here, he reminds you that Hitler had a program of Jewish em-

igration from 1933 to 1938 when-unlike the displaced Palestinians when larnel was established—they could liquidate their assets and take their money. The emi-gration program continued after 1938 but Germany was being economically bled so white that the property had to

remain.

Will the radical change he projects

Will the radical change he projects come peacefully?

"No great change ever came about peacefully." Verduin responded. "The people in power cannot be voted out because they were never really voted in." Verduin said internationalists control both major political parties and, thus, the government. So the masses confuse a vote with a choice.

The Army's vendetta with Verduin came when it learned of his Nazi views. It was later that a potty police incident occurred which was exploited and spread across the newspapers after-the-fact in an attempt to justify punishing Venderic.

Verduin.

It happened after a Nazi rally when party members were in uniform. (The newspaper stories implied the Nazis had dreased for the occasion and went hunting for trouble). A black man and his white wife stopped at a gas station where the Nazis had paused a moment before.

Verduin acknowledges that probably a colleague had something unflattering to say about the interracial couple. In any event, Verduin observed the black man hitting a Nazi who was still easted in

his car. Venduin leaped to his friend's

The black man was yelling that he was a police officer, said Verduin, but when they asked for his identification he refused to give it. Arlington police arrived, learned that the black man was a Washington policeman and brought charges against Verduin. But, Verduin said, police refused to let the Nazis give their own account of the incident.

This black-eye incident was widely reported in a town where murder and rape are so frequent that they are often unreported or rate a bare mention deep inside the newspapers.

It came just in time for the Army, which had started to wonder about how it would explain its harassment of Ver-

U.S. Nazi in Army Loses Appeal In Attack on Black D.C. Detective

Pvt. Frederick T. Verduin, once a member of the Army's elite presidential guard, was convicted by an Ar-lington General District Court judge of assault and battery and destruction of property (a pair of eyeglasses) in connection with a fracas Sept. 3 involving two other men and a D.C. police detective and the detective's wife.

According to testimony at the Oct. 24 trial, a fight followed at a gasoline station after racial comments were made to the detective's wife, who is

An Arlington Circuit Court jury Verduin, who testified he was a upheld the assault and battery member of the American Nazi party, was sentenced in District Court to 20 days in jail and fined \$200. He appealed to Arlington Circuit Court.

> A jury deliberated about five hours yesterday before affirming Verduin's conviction for assault and battery and fining him \$1,000. A judge earlier had dismissed the destruction of property conviction when it could not be determined at what time during the fight the eyeglasses were broken.

Verduin also testified he had two black roommates in the Army and had no problems with them.

Verduin's conviction stemmed from an incident Sept. 3 at the Redhead Gasoline Station, 2520 Wilson Blvd. in Arlington, across the street from the national headquarters of the White People's Party,

According to Threat, he and his wife, Karin, and their two children stopped in the station to get fuel after a shopping trip. Mrs. Threat walked past another car in the station, in which two Nazis were sitting to get a soda from a vending machine.

As she passed the car one of the occupants yelled at her, "More power to the white people, you nigger-loving bitch," Mrs. Threat testified. She said she ignored the remark. On the way back to her car one of the Nazis repeated the remark and Mrs. Threat replied, "Shut up," and that she didn't want to have anything to do with

them. One of the men then threw a soda on Mrs. Threat, she said.

At this point, Threat, who had been pumping gas into his car, ran to his wife's side and told the men to leave her alone, he said. The two men jumped from the car and started beating Threat and Verduin soon joined them, both Threats testified.

But Verduin testified he had merel warked across the street to the station to get a soft drink after having been to the Nazi rally earlier. He said he heard a woman scream, "You racist bastard," as he was getting the soda and then he saw the fight.

Verduin ran to the fracas and then pushed Threat away from the men to stop the fight, he testified. The half dozen times he hit Threat were in self defense, he testified.

Verduin maintained his innocence after the trial and said he doesn't know how he will pay the fine from his monthly Army salary of about

Arlington Judge Fines Soldier-Nazi

Frederick T. Verduin, 22, a former member of the Army's elite presidential guard and professed Nazi, was ordered yesterday to pay a \$1,000 fine by Arlington County Circuit Court

Judge Charles H. Duff.

A five-member jury convicted Verduin of assault and battery against a black off-duty D.C. police officer, Edward Threat on Jan. 4. That conviction, which followed an earlier one in Arlington General District Court, stems from an incident that occurred Sept. 3 when Threat and his wife, who is white, stopped at a gas station near Nazi party headquarters on Wilson Boulevard.

Yesterday Judge Duff denied Verduin's motion for a new trial. Verduin, who has been demoted twice since September, had said he didn't know how he would pay the fine from his \$300-a-month Army salary. He was ordered to file a financial statement within five days and to appear in

court Feb. 20.
