Three-Year Plan Moving Ahead on Schedule

The Three-Year Plan made a very strong showing in January, despite the fact that the Fall Building Campaign had just wound up with a tremendous response. Over \$1,500 was raised in January, and the Three-Year Plan is still within two percentage points of where it should be.

As of 31 January, the Three-Year Plan has raised \$78,015.52, or 88 percent of our goal. However, 90 percent of the time has elapsed. In the remaining two months and 20 days, we must raise another \$10,872.48 if we are to meet our goal of \$88,888 by the Leader's birthday.

The Party received contributions in January totaling \$1,557.14 from 21 states and three foreign countries. Our sincerest thanks to everyone who has donated to the Plan.

If the Three-Year Plan is to be a success, all of our comrades will have to search their hearts and consider how important an NS victory is to our Race. Isn't it worth at least the price of a six-pack, or of a current movie? If everyone — not just a few hardcore supporters, but *everyone* — supports the Three-Year Plan, we can easily finish this campaign *over the top!*

Chicago, Milwaukee Stormtroops Picket Red Meeting

On 29 Jan. ST men from Chicago and Milwaukee picketed a meeting held by the Communist Party, U.S.A., which featured the leader of the party, Gus Hall. The Reds were holding their rally in the plush "Gold Room" of the Pick-Congress Hotel in Chicago. Over 800 Communists turned out for the event, all of whom had to pass by the ST picket line. There were no incidents.

The meeting was covered by a film crew from WMAQ-TV. Their coverage of the meeting began smoothly enough, but when they started to pan the faces of the audience, which included many wealthy local Jewish businessmen, the Reds got upset. They had a nigger goon squad rough up the newsmen, and then eject them forcibly from the hall. Outraged at such treatment, the newsmen seized at the opportunity afforded them by the Party picket line to blast the Reds while giving the Party some impartial news coverage which it so rarely receives.

Part of their broadcast news story included the following statement: "... These are the Nazis. No, not the rag-tag band you've seen from Marquette Park; these are men from the National Socialist White People's Party in Cicero. And they have a message to deliver for the Communist Party members inside the warm hotel room. And this is their message: 'What do we want? Dead Reds!'"

Many favorable calls were later received at the Midwest Regional Headquarters from interested Whites who had seen the story on the news.

Minneapolis Comrades Convicted

The three Minneapolis ST men who were arrested after badly stomping a Red creep who had attacked them during the picket of a Socialist Workers Party meeting (see NS BULLETIN No. 233) were convicted in January of disorderly conduct and sentenced to 30 days in jail. The sentence was stayed for one year, which means that if they are convicted of no further charges during this period, they will not have to serve the jail time. Initially they had been charged with simple assault, but the charge was reduced by the city attorney in exchange for the guilty plea.

Local Organizer Steve Martinson says that the conviction will absolutely not have its intended effect of hindering Party operations and growth in the Minneapolis area.



Three Nazis fined for disorderly conduct

Three members of the American Nazi Party were fined \$50 Friday after they pleaded guilty in Hennepin County Municipal Court to disorderly conduct while picketing a meeting at the University of Minnesota Dec 2.

They had been charged with simple assault for allegedly beating a man who made an obscene gesture toward them, but they negotiated a plea for the lesser charge.

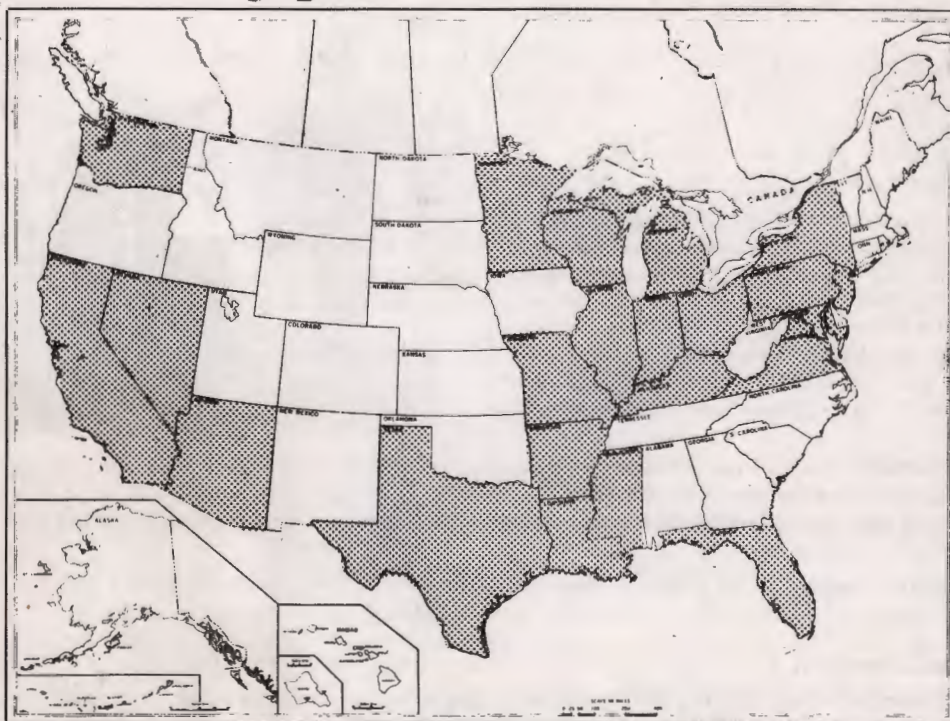
Three members of the American Nazi Party were fined \$50 Friday after they pled guilty to disorderly conduct.

Party Members Should Arm Themselves!

In the last NS BULLETIN we explained the pressing need for all Party comrades – regardless of age, sex or Party status – to get themselves in top physical condition. Certainly this should take high priority in every comrade's life. We explained that in the bloody struggles which lie ahead, every National Socialist will need to be healthy and strong, if for no other reason than to protect himself or herself.

There is another matter concerning self-protection which we would like to discuss here: the matter of firearms.

Every National Socialist – and especially full Party members – should own at least one working legal firearm. All comrades should additionally have a good supply of ammunition (*not* reloads) to go with the weapon. They should also be proficient in the use of this weapon.

Under no circumstances should any Party comrade obtain or keep an *illegal* firearm, no matter of what sort.

Owning a firearm – whether it be a rifle, a shotgun or a pistol – is simply a matter of survival. As our enemies intensify their assaults against us, we must expect attacks by opponents armed not just with clubs and rocks, but with bombs and guns. Unless all Party comrades are prepared to meet such attacks with firepower of their own, they may find themselves in BIG trouble.

On the other hand, if our enemies know that they are going to be facing armed National Socialists, with instructions to shoot to kill if their lives are endangered, they may think twice before causing any trouble.

Just so there is no misunderstanding, let us repeat this once more: we are urging all National Socialists to buy at least one LEGAL firearm, solely for the purpose of defending themselves and their families. Under no conditions should any National Socialist obtain an ILLEGAL firearm, nor should they use a legal firearm for illegal purposes.

(If you have any questions about the legality of firearms in your state, consult your local police. But do not mention that you are a National Socialist, as that may unduly alarm them, and cause them to give you incorrect information.)

Physical fitness should still be the first goal of all Party comrades, but in addition to that *all Party comrades should arm themselves.*

ACTIVITIES IN BRIEF

● As was reported in the last NS BULLETIN, comrades from Los Angeles Units I and II are attempting to obtain use of public school facilities in which to hold a public meeting in Pomona. Public school systems are required to let private groups use their facilities under the Freedom of Access act. Despite this, the Pomona board of education has refused to grant the Party the right to use its buildings. Local Party leaders are appealing the decision. Some newspaper clippings on the case are reproduced here.

● An otherwise typical paper sale held by the Chicago Unit on 21 Jan. was given an unexpected – but most welcome – assist. ST Charles Johnson, one of the five troopers taking part in the sale, was called over by the driver of a car who wished to purchase a paper. Instead of just giving the 35 cents which the paper cost, the individual emptied his entire wallet into ST Johnson's hands – a total of \$62.00! Altogether, the ST men collected \$95.00 during the sale, in donations, paper sales and sales of White Power T-shirts.

● Hundreds of WHITE POWER newspapers, Eric Thompson comics and assorted leaflets were distributed by the Minneapolis Unit during the last half of January. Numerous fights between White and Black students were reported in some high schools which were the targets of WHITE POWER paper and sticker raids by unknown National Socialists. As usual, the incidents were hushed up in the press.

● Numerous individual comrades throughout the nation, not associated with any local Party unit, report undertaking their own literature distributions in the second half of January. Local units which report organized distributions included Milwaukee Unit I and the Milwaukee NSWU unit.

Nazi group's rally plan Pomona board defeats

An application by the National Socialist White People's Party (NSWP), an offshoot of the American Nazi Party, to use the Pomona school district's education center for a rally was turned down by the school board Tuesday night.

A spokesman for the district said the board believed the rally "would lead to or provoke violence."

The NSWP had applied for building use permits with the school

district and with the Pomona Parks and Recreation Department to stage a rally Feb. 4.

That date was later changed to Feb. 18.

Prior to the turn-down by the school board, a district spokesman said previous to the meeting that the rally would take place unless the district could come up with legal reasons to deny the permit.

However, school district officials,

police and recreation department spokesmen are reluctant to talk about the issue and areas of conflict seem to exist between the public agencies.

Initially, Orwin Zuiderweg, who lists himself as secretary of the NSWP, applied for use of the Palomares Center, 250 W. Artesia Ave. on Dec. 21 for use of the facility Feb. 4.

On the application Zuiderweg

listed his address as a motel in Ontario.

Jack Hoxsey, park and recreation director, confirmed that Zuiderweg had requested use of the center, but said he hadn't heard from the man since Dec. 21.

School district officials say Zuiderweg applied for use of the education center at 800 S. Garey Ave., first for the Feb. 4 date and more recently for Feb. 18.

NSWP appeals for use of school

The National Socialist White People's Party (NSWP) will meet with an attorney for the Pomona Unified School District Monday for a ruling on whether it will be allowed to use the district's education center for a rally.

The NSWP was formerly known as the American Nazi Party, according to Greg Hummer, Los Angeles unit organizer for the group.

Hummer met with Kenneth Cooper, assistant superintendent for business in the school district, Friday after the group's request to use the building was denied earlier in the week by the school board.

Hummer said he will meet with the district's attorney and try to work out possible problems in using the facility.

The education center is located at 800 S. Garey Ave.

The main problem seems to be the legality in using the school facility.

Hummer said. "The school board hasn't actually refused us the use of the building because they can't make that decision."

School officials, however, say the application for use of the school facility on Feb. 18 definitely was turned down by trustees Tuesday night.

Hummer said that during the Friday meeting with Cooper, the superintendent suggested that perhaps the NSWP could rent a private facility in Pomona to use instead of a city or school district-owned building.

Hummer said his group may consider alternatives, such as the Fox Theater at 114 W. Third St., but he also said the NSWP chapter may take the matter to the American Civil Liberties Union.

White People's Party member to talk to ACLU on rally denial

A member of the National Socialist White People's Party (NSWP), angered by Pomona school officials' denial of his request for a rally at the district's education center, has vowed to take the matter to the American Civil Liberties Union.

Greg Hummer, Los Angeles unit organizer for the party, said he has a Friday appointment with Kenneth Cooper, assistant superintendent of business for the Pomona Unified School District, to go over the matter.

The application by the NSWP, formerly connected with the American Nazi Party, was made with the district for a rally at the center, 800 S. Garey Ave. for Feb. 4.

The date was later changed to Feb. 18.

Hummer said after the turn down, which occurred at Tuesday's school board meeting, that he had requested and received an appointment with Cooper for 11 a.m. Friday to "see why they canceled the meeting."

"If those talks don't prove beneficial then I'll go to the ACLU because the district has no right to turn down a political or religious meeting."

"Actually," Hummer said, "we plan to have a public meeting where anybody can come to for free."

"We're just going to talk about how we feel about the country and not going to promote any violence."

Hummer said the organization had already contacted the Pomona police, offering to cooperate with them.

He said it was the police who initially suggested the use of the school education center.

Prior to the application for the center, Orwin Zuiderweg, who lists himself as secretary of the NSWP, had applied for use of the Palomares Center, 250 W. Artesia Ave., for the rally Feb. 4.

Park and recreation officials, as well as police spokesmen, said they encouraged Zuiderweg to select a different location since the Palomares Center is located in a minority neighborhood.

Hummer said the rally is part of "Stage 2" in the overall plans of the NSWP to come to power in the country.

He said the first stage has already taken place under the direction of the late George Lincoln Rockwell who established the group under the name of the American Nazi Party.

He said Rockwell chose the Nazi party name to get the attention of the American public. Rockwell was assassinated in 1967.

"But once we got their attention, which was stage 1, he (Rockwell) changed the name to what it is today," Hummer said.

"Stage 2 consists of building leadership for when the masses of white people in the country turn to us when things get bad for them," he added.

According to Hummer, stage 3 will consist of massive rallies and parades as their party comes to power and stage 4 will be when they take over the country — "through election."

Hummer said his organization was responsible for a rally in San Francisco last October, organized to protest the refused admittance of Alan Bakke to the University of California, David because of previous minorities admissions.

Hummer said a fight ensued because "Communists got involved and then the police were called out."

"Fifteen of our storm troopers marched in that rally," Hummer said.

Hummer said that nationally the party claims a membership of 5,000.

Activity of the Month

To be honest, the results of most of the "Activities of the Month" so far have been disappointing. Too many comrades are taking the attitude of "let someone else do it."

Well, someone else isn't going to do it — *you* have to do it yourself! This is a small Party with little influence at this time. If it is ever to become a large Party with a lot of influence, every single Party supporter and member is going to have to be an activist in some capacity or another.

This month's activity is to approach the proprietor of a news stand where many different publications are sold, give him a sample copy of WHITE POWER, and ask him (or her) if he would be interested in stocking it along with the rest of the magazines and newspapers he sells.

Many dealers, being Jewish, will respond negatively (and probably obscenely). Some will be interested in selling WHITE POWER, however, and even if only half a dozen or a dozen news stands across the country agree to sell the paper, it will be a big step in the right direction.

Party Rank Chart

There has been some confusion recently with regard to the rank structure of the Party and its self-defense arm, the Stormtroops. Below is a chart which shows how the various Party ranks and positions compare with each other and with ST ranks.

The first column shows *Staff ranks*. These ranks are assigned only to personnel working for the Party full-time, either at a Party headquarters or elsewhere. The second column consists of *Local Organizational ranks*. The third column shows the rank order of the *Stormtroops*.

Ranks which are on the same line are roughly equivalent. Normally, a comrade with a given rank has authority only within his given sphere of operations. For example, a chief assistant at National Headquarters has a higher rank than a treasurer in some local unit, but he does not have authority over him under normal conditions. Likewise, a district leader from California has no authority over a unit secretary in Milwaukee. It should further be noted that wherever a conflict arises, Party rank takes precedence over ST rank.

Any questions on this chart should be directed to the Organizational Secretary at National Headquarters.

Jews Ready 'Six Million' Lies

Local NBC-TV affiliates will be airing a so-called docudrama entitled "Holocaust" beginning on 16 April and continuing nightly through 19 April. The show will deal with the alleged "extermination" of European Jewry by National Socialists during World War Two. Many local units will be protesting this effort to resurrect the tired old six million myth, either by picketing their local NBC affiliate or by other means.

Those units that picket should do so on the first day of the mini-series, which is Sunday, 16 April. They should give the press plenty of advance notice. Picket signs should carry short messages in big, thick, easy-to-read lettering. Some slogans that should be considered include:

- The '6 Million' Rule America!
- Six Million Lies!
- End WW II Hate Propaganda!
- NBC Pushes Jew Lies!
- _____ Pushes Jew Lies!

Instead of having as many different signs as possible, it is much more effective to have one or two — three at the most — signs with the same slogans repeated over and over.
