### National Socialists Honor Birth of Lincoln Rockwell

On 4 March dozens of National Socialists accompanied Commander Koehl on a special march and wreath laying ceremony in Bloomington, Illinois, the birthplace of Lincoln Rockwell. ST men, NSYM members and NSWO members from Chicago, Milwaukee, Minneapolis, Detroit, Kansas, and Missouri joined together with the Commander to commemorate the 60th anniversary of the birth of the Party's founder and first Commander.

Prior to laying a wreath at the hospital where Commander Rockwell was born, the National Socialists staged a dramatic march through downtown Bloomington, which was well covered by the local media.

Following the march and wreath laying ceremony, the National Socialists gathered at the Party's Midwest Regional Headquarters in Chicago. Prior to that, however, a special White Power march was held by the troops through the Marquette Park area, which has been the scene of stiff White resistance to forced integration. There were no incidents.

Afterwards, a general Party meeting was held at the Midwest HQ. The Commander spoke on the need to recruit real racial idealists into the Party's ranks. It is not enough, the Commander said, to merely recruit those who are against the Jews, who are against the Blacks, who are against the

communists. Rather, we must seek out White people of an idealistic nature, who are not merely against all of these things, but who are for the positive side of our program.

The meeting concluded with special ST ceremonies.

### Los Angeles Unit Members Aid Mudslide Victims

On 4 March members of the Los Angeles Unit, under the leadership of Unit Leader Douglas Winkleman took part in a clean-up program in the Sunland-Tujunga area of Los Angeles County. The area had been devastated by mudslides which were caused by the heavy winter rains.

Under the direction of UL Winkleman and Unit Organizer Gregg Hummer, the National Socialist work crew aided in traffic control, sandbagging, earth-moving and light equipment operation.

## Nazi activity at Southwest High leads to investigation of threats

At least two students at Southwest High School are being investigated for allegedly passing out Nazi literature and printing anti-Jewish and antiblack slogans on school property, school officials said Thursday.

In addition, a student at the school said he and other students received threatening telephone calls this week as a result of their opposition to the two alleged "Nazi" students.

None of the students was identified by officials.

Southwest Principal Byron Schneider said last night that he has recovered no more than "a dozen" pieces of professionally printed inflammatory literature. He did not have any of the pamphlets with him when called at home, but he said he believed an address in the state of Virginia was printed on the bottom.

He said the problem was brought to his attention yesterday. He has contacted the parents of the two

students believed involved, he said, and he plans to talk with them today.

Southwest, located at 3414 W. 47th St., is not facing any ordered changes in its racial or ethnic makeup in the next school year.

A student said last night that earlier this week he received a telephone call. The voice at the other end, he believed it was a man's voice, said: "We heard that you have been harassing one of our

members. If this does not stop, we will have to take action against you. White Power." Then the caller hung up, he said.

His girlfriend, he said, got an anonymous telephone threat in which the caller said he would shoot her and blow up her house. That night on her way home from her part-time job, he said, she twice saw a green pickup truck with a swastika flag on its aerial.

He said "68" has been written on restroom walls in the school. The double-eight stands for "Heil Hitler," he said, H being the eighth letter of the alphabet.

Also written on the walls, he said, were "Jews Beware" and "Hitler had the right idea." Also, he said, "Send the blacks back to Africa."

One of the suspected students, he said, once wrote an article on Nazism for the junior high newspaper, The Quiver Calliope. The article was rejected, he said.

The student, who asked not to be identified, said he and other students opposed the "Nazis" and, in fact, physically attacked them on several occasions. He said all the students involved were ninth-graders.

Counselor Robert Rundorff said he did not know of the attacks but did know of student opposition to the alleged "Nazis."

## Nazi literature prompts probe at Southwest High

Officials at Southwest High School today continued their investigation of Nazi activity—swastikas and anti-Jewish and anti-black statements written on lavatory walls and distribution of racist literature—by a couple of 9th-grade students.

Among the slogans written on toilet walls in pencil and rubbed on in soap were "Jews beware," "Hitler had the idea" and "Send the blacks back to Africa."

Byron Schneider, the principal, said he learned of the problem yesterday, and that he has met with several parents and students on the issue. He said he planned to meet with the parents of one of the students involved today and with the other early next week.

HE WOULD describe the students involved only as "loners." "The dramatic thing out here is the total rejection of this by our

student body," Schneider said. He said other students in the school have rejected the Nazi approaches, and in a couple of instances there have been minor pushing and shoving incidents.

Schneider said the two students apparently had distributed about a dozen pieces of Nazi literature, produced by the National Socialist White People's Party, also known as the American Nazi Party.

He said school policy prohibits handing out materials that advocate racial and religious bigotry. He pledged to investigate the question, while respecting the students' right to due process, and to "discipline harshly those who are found guilty."

He wouldn't speculate what the punishment might be.

## ACTIVITIES IN BRIEF

● Commander Koehl spoke on WDCB-FM radio on 10 March, as a guest of the station's "Sound Off!" program. The Commander began by demolishing the tired, old World War II hate propaganda that is still being forced on the American people, which defames their German racial brothers and sisters. After this, he went on to tell why National Socialism is the only Movement which offers salvation to the White people of the world. There has been much favorable reaction to the Commander's talk.

● A dozen ST men from the National Headquarters area picketed an abortion clinic in Fairfax, Virginia, on 11 March, demanding an end to the murder of unborn White babies there. The clinic has been the target of

publicity is counterproductive and should be avoided. We must aim for quality publicity, and keep our public image in mind at all times.

Once again, the L.A. Unit is to be commended for its mudslide cleanup participation, and all other comrades are strongly urged to undertake similar actions in their localities.

### Commander Blasts "Skokie March"

At a special press conference held in the Party's Midwest Headquarters on 9 March, Commander Koehl blasted the proposed march through Skokie, Ill., by a Jew-led splinter "Nazi party."

Addressing the newsmen present, the Commander said that the march through the heavily Jewish town was "nothing but cheap Jew-baiting."

"We want to dissociate ourselves from this march completely," the Commander said.

Elaborating further, the Commander noted that the march would accomplish nothing constructive. The publicity the whole affair has received has been mostly negative, and does nothing but stir up sympathy for Skokie's 7,000 concentration camp "survivors."

The leader of the little group planning the March is Frank Cohn (alias "Collin"). WHITE POWER readers will remember his cheery kosher face from the reward poster issued by the Party, offering \$10,000 to anyone — including Cohn/Collin — who can prove that the Hebrew phony is NOT Jewish. So far, there have been no takers on the offer — not even from Frank Collin/Cohn himself.

Some of the publicity concerning the Party and Collin/Cohn's Jewish ancestry is reproduced here.

### Commander Visits Minneapolis Unit

As part of a general Midwest organizational tour, the Commander visited Minneapolis during mid-March, for the first time in 10 years. During his stay, he had the opportunity to meet with many Party comrades and other individuals interested in furthering the Movement.

At a unit meeting held on 12 March the Commander spoke on the importance of winning over our White racial brothers and sisters to the Cause, rather than wasting time antagonizing our racial enemies. The Commander also pointed out that small groups of dedicated activists can be just as effective — if not more so — than larger groups of less fanatic individuals.

Local comrades report that they were very pleased and thankful for this instructive and morale-boosting visit.

### Minneapolis NSYM Comrades Active

Authorities in the Minneapolis school system are becoming increasingly paranoid over the

rising tide of National Socialism in their schools. A flood of student-oriented literature distributed by campus activists has brought much favorable response from the student bodies at various high schools.

One principal — Bryon Schneider — stated publicly that his students had "totally and dramatically" rejected National Socialism. He did not comment on why he found it necessary to institute emergency courses on "Nazism" and the "Holocaust," however.

One NSYM member has been expelled from one high school by a Jewish principal, as a result of his NS activism. He has continued his efforts for the Party along with other NSYM comrades at his new school.

These comrades are to be highly commended on their persistent and determined efforts to bring White Power and National Socialism to their school system.

Reproduced here is some publicity gained as a result of NSYM organizational efforts in Minneapolis.

### Nasty Nazis needle Collin

NAZIS ARE NASTY, even when they're fighting among themselves. Latest evidence of this comes in the offer of a \$10,000 "reward" by the National Socialist White Peoples Party to anyone who can prove that Chicago Nazi leader Frank Collin is NOT Jewish. In announcing the offer, the NSWPP said, "For eight years this phony has been attempting to fool decent white people into believing that he is not of Jewish descent." The NSWPP members, who formerly called themselves the American Nazi Party, have regarded Collin as a traitor ever since OutFrontor Art Petacque disclosed in 1970 that Collin's Jewish father had been a prisoner at Dachau, the infamous Nazi concentration camp. But Collin has continued to deny his own father's assertion of his Jewishness. Hence the needling reward offer by the zantes who booted Collin out of their hate group.

### 2 Spurn Skokie March

Chicago, Ill. —UPI— The head of the former American Nazi Party says he will not participate in a planned march by Nazis through the predominantly Jewish village of Skokie, and Gov. James R. Thompson says he will take no part in a planned counter-demonstration if it threatens to become a confrontation.

"We regard this march as nothing but cheap Jew baiting," said Matt Koehl, commander of the National Socialist White Peoples Party (formerly called the American Nazi Party).

[Koehl is a Milwaukee native. He graduated from Washington High School in 1952.]

Thompson said Thursday that he would not participate in a counter-demonstration if the two marches were held at the same place. He had urged Jewish leaders to conduct a rally of their own, and they have announced that it will be in Skokie the same day as the Nazi march, tentatively set for April 20.

### Ex-Nazi group chief won't march

CHICAGO (UPI) — The head of the former American Nazi Party says he will not participate in a planned march by Nazis through the predominantly Jewish village of Skokie and Gov. James R. Thompson says he will take no part in a planned counter-demonstration if it threatens to become a confrontation.

not Jewish. Collin then formed the rival Nazi group on Chicago's Southwest Side.

Thompson said Thursday he will not participate in a counter-demonstration to the planned Nazi rally in Skokie if the two demonstrations are held at the same location.

Thompson had urged Chicago area Jewish leaders to conduct a counter-demonstration to the Nazi rally. They since have announced plans for a counter demonstration to be held in Skokie the same day as the Nazi march.

The governor told an impromptu news conference he will "participate in any counter-demonstration that serves a useful purpose." But he said he will not parade in the counter demonstration if it is in the same area as the Nazi march.

He said such a rally, if held in the same area as the Nazi march, would just provoke violence.

### Nazi group blasts Skokie march

The planned Nazi march in a heavily Jewish Skokie was strongly criticized Thursday by a rival group sharing Nazi beliefs.

"We regard this as nothing but cheap Jew-baiting," said Matt Koehl, commander of the National Socialist White Peoples Party.

"We want to dissociate ourselves from this march completely."

Koehl, of Arlington, Va., has headed the former American Nazi Party since the assassination of its founder, George Lincoln Rockwell, in 1967.

The controversial march in Skokie is planned by the Chicago chapter of the National Socialist Party of America, headed by Frank Collin. It is tentatively scheduled for April 20, Adolf Hitler's birthday, if all legal barriers are removed. Jewish leaders are planning a

massive counter-rally the same day.

Koehl held a press conference Thursday in his "white power" party's Midwest headquarters in Cicero to announce that it would not join Collin's march.

Meanwhile, Gov. Thompson Thursday reaffirmed his readiness to join in a counter-demonstration to the Nazi march in Skokie but only if it is held in a different place. Thompson said that staging

the counter-demonstration in the same location as the Nazi march inevitably would bring violence. "The governor is sworn to uphold law and order in the state," he added.

Koehl said that Collin was ejected from the "white power" party in 1970 after failing to produce proof that his father was not Jewish. Collin then formed the rival Nazi group on Chicago's Southwest Side.

A "We Are Back." sticker somehow found its way onto the door of a business owned by one Abraham Landau, one of the many, many concentration camp "survivors" that have been surfacing lately. Landau reportedly nearly blacked out "with anger and revulsion" when he saw the sticker. ## Swastika incident irks local Jews

Abe Landau found a swastika on the door of his tailor shop on Pleasant Street yesterday.

The spectre of Nazi horror still follows Landau and his wife even though it has been 33 years since they were liberated from the concentration camp at Bergen-Belsen . . . after six years of existing in Nazi hell-holes.

Gerald A. Kleinman, executive director of the Jewish Federation of Greater New Bedford, said posting of the Nazi symbol has alarmed the local Jewish community.

"It is ironic they picked his (Landau's) place to put it up," said Kleinman, who sees the incident as a symptom of a growing trend toward Nazism and anti-Semitism in America. Kleinman said a resurgence of Nazism seems to have been spawned by the march planned by the American Nazi

Party through predominantly-Jewish Skokie, Ill. Many of Skokie's residents are survivors of the Nazi holocaust.

Landau said he almost blacked out with anger and revulsion when he found the paper symbol and the warning, "We are back," stuck on the door. Memories of his and his wife's animal-like existence for those six long years will never die.

They had both hoped that Nazism and anti-Semitism had died.

"My first reaction was one of shock. I couldn't believe it," says Landau. "I was just talking with a friend last night and he was saying how that was something you didn't have to worry about in New Bedford. I've been here 28 years."

Landau and his wife, Freda, do not seem to show the effects of living under the constant shadow of death. But there

are blue numbers tattooed on their arms. The Landaus were numbers, not names.

Freda says she lets people believe the numbers are her Social Security number. She will not relive her horrors for the merely curious.

But neither of them can watch shows about the Nazis and neither of them likes to talk about their experience. But Abe does talk about it so that people won't forget. They should never forget, he says.

"Even a swastika on TV . . . It gets me right here," Freda says, jabbing a finger at her heart.

"Lately everything has been coming back," Abe says sadly.

They are weary of the Nazi hatred that still shows its ugly face in modern American life. But they will fight, if they have to, Abe says.

## New National Headquarters Staff Members

# THE FUNDAMENTALS OF SUCCESSFUL PROPAGANDA – Part 3

In the last issue of the Bulletin we explained what should be done *before* actually beginning propaganda activities. We said that the first things that must be done are to select an area and decide what issues the Party takes a strong stand on should be pushed in this area.

Let us suppose our tiny band of activists have decided to concentrate on the issue of Black crime. They have selected a White, middle-class neighborhood that borders on a Black ghetto. The residents of this neighborhood are frequently the victims of Black crime. This is especially true of elderly Whites, who cannot adequately protect themselves, and White youngsters, who are terrorized daily in their integrated schools by Black gangs.

The first thing our activists must do is to get a post office box to use as a mailing address. If they are to recruit interested Whites into the Party, there must be a way for these Whites to get in touch with them. Using the home address of one of the activists is both dangerous and foolish. A post office box is more professional and safer. (In the same manner, local activists should have their phone numbers either unlisted, or listed by name alone with no address.)

Now they are ready to begin their propaganda offensive. They should start out by ordering bulk issues of WHITE POWER from NS Publications. As they are going to be concentrating on Black crime as the main issue in their target area, they should order quantities of back issues which deal with this problem. Likewise, they should order leaflets, stickers, and so forth, all dealing in some manner with the problem on hand – *and not something else.*

All leaflets, papers, etc. should be stamped with the local post office box address. The quickest and easiest way to get started is by distributing papers and leaflets door-to-door throughout the entire tar-

get area. Simply go up to a house or apartment and leave a copy of the paper on the doorstep, and then move on to the next house.

Do not expect fantastic results from this at first. After distributing 1,000 papers, you may get zero responses in your local box. Do not get discouraged, this is a hard job, and it takes much time, effort and expense before it will pay off. Cover your entire target area not just once, but three or four times in rapid succession.

At the same time as you are distributing literature, you should be putting up stickers everywhere (well, everywhere but on White owned businesses, personal vehicles, garbage cans or in rest rooms).

Another effective activity, in conjunction with all of this, is writing letters to the local newspapers giving the Party's stand on the problem of Black crime.

After a few weeks or a few months you will begin to attract more and more interested Whites into the Party. Most will merely subscribe to the Party paper. A few will become Official Supporters. Of these, a tiny handful will become activists..

At this point, you should consider holding public meetings, as well as applying for official recognition by National Headquarters as a local Party unit.

Yet, the local activists job is far from over. In fact, it is just the beginning! You have criticized the existing state of affairs. You have recruited people to help you out, and made hundreds more – maybe thousands – aware of the problem. Now comes the hard part: you will have to show that the Party can do more than criticize; you will have to offer practical solutions to the problems at hand, you will have to do something about the problems.

## Note From the Membership Secretary

As of 1 June 1978, full Party Members and Probationary Party Members dues will be raised from \$20 per month to \$25 per month.

The requirement of receiving and distributing 20 WHITE POWERS per month will be dropped, effective the same date.

Those members or probationary members who wish to continue to receive 50 WHITE POWERS each month may do so. No orders will be accepted by NS Publications unless accompanied by payment of \$3 for the papers.

(Note: Local units are still required to purchase a minimum of 50 WHITE POWERS a month for each unit member they have.)

All Party Members and Pro-

bationary Members who have not yet paid for papers received in the past should make arrangements for payment at the earliest possible moment. Failure to do this could result in the forfeiture of membership.

Any Member or Probationary Member who is unsure about how much they owe should contact the Membership Secretary in Arlington.
