Party Endorses California Anti-Homosexual Proposition

The Party has officially endorsed a measure which will be appearing on the November ballot in California. The measure, known as Proposition 6, would prevent homosexual teachers from foisting their sick perversion in public school systems.

The proposition would require dismissal of school teachers and administrators “for advocating, soliciting, imposing, encouraging or promoting private or public sexual acts . . . between persons of the same sex in a manner likely to come to the attention of other employees or students; or publicly or indiscretely engaging in such acts.”

The initiative is supported by the vast majority of California Whites, and opposed by the usual coalition of liberals, Communists, degenerates and non-Whites. It is expected to pass by a wide margin.

The Party’s official endorsement is reproduced here. All California comrades are urged to work for its passage in every way possible!

OFFICIAL ENDORSEMENT

Proposition 6—California

The NATIONAL SOCIALIST WHITE PEOPLE’S PARTY officially endorses the initiative on the November ballot in the State of California known as *Proposition 6*.

This measure, designed to prevent sexually degenerate public school teachers from infecting their students with their own perverted sexual and moral value system, is in keeping with the code of values upon which American society is based.

At a time when the family unit, the traditional wellspring of moral instruction, is being eroded by the diseased materialism of our age, it is necessary that our public school systems do not become the breeding grounds for further immorality.

Furthermore, we feel that homosexuality is clearly in opposition to the values of decency and wholesomeness upon which the National Socialist worldview is based.

It is for these reasons that the NATIONAL SOCIALIST WHITE PEOPLE’S PARTY endorses Proposition 6.

It should be noted however, that our support for this measure is qualified. Although it is a step in the right direction, we by no means feel that it is far-reaching enough in scope. Ultimately, we favor stronger, more determined anti-homosexual legislation to protect the youth of this country.

Commander on Indianapolis Radio

Commander Koehl gave a two hour interview on WNDE-Radio on the morning of 24 July. After giving a summary of what the Party believes in and how it plans to implement its beliefs, the Commander answered questions phoned in by the listening audience.

The Commander called for the complete geographical separation of the races as a prerequisite to solving any of the many problems that afflict the United States today. Nothing else can be accomplished until this is done, he explained. The Commander cited such sources as the Constitution and the words of several U.S. presidents, showing that this idea is as American as apple pie.

In answering another call, the Commander told the listeners that the Jews are not part of the White race. Rather, he said, they constitute a distinct racial group, whose actions and very presence within our borders pose a threat to America as a White people's country. The Commander went on to cite the Jewish infiltration and undermining of the federal government, the economy and the news media as proof of the dangerous nature of the Jew.

In subsequent calls, the Commander voiced the Party's concern on such problems facing America's White population as inflation, taxes, the farmer's strike, housing, medical care, social security, drug abuse, crime, pornography and the decline of the family unit. In each case, the Commander explained the National Socialist solution to these problems.

Last—and certainly least—the Commander was asked about the “holocaust.” He blasted the whole fairy tale of Six Million barbecued Jews as a “complete fabrication” and a lie. It is time, the Commander said, to put aside the worn, tired out anti-NS propaganda left over from World War II, and get on with facing and solving the problems which confront us today.

On a whole, the show was a total success for the Party, and greatly strengthened support for the Party in the Indianapolis area.

Chicago Comrades Continue Paper Sales, Battle Jews

Four paper sales were held by the Chicago Unit during the month of July, netting the Unit \$264.34. As usual, the sales were extremely successful, and the support shown the Party by area Whites was most heartening.

The only major trouble occurred during the sale being held on the northside of Chicago on 15 July. After selling the paper for a little over an hour, the National Socialists were assaulted by a group of Jews which outnumbered them three-to-one. The Jews drove their vehicles straight at the ST men, forcing them to break ranks to avoid being run over. Although outnumbered, the National Socialists attempted to stand their ground. Eventually, the Jews tried to drag TL Robert Bukowy—who had been cut off from the rest of the troops—out into the street where he was to be run over by a waiting car.

TL Bukowy managed to fight his way back to the sidewalk, where he went down under a wave of screaming, cursing Jews. Shortly afterwards, the Jews disperse.

The very next day, a larger detachment of ST returned to the very spot where the Jew attack had occurred, in open defiance of the Jews who had arrogantly “ordered” that we “never return again or else.” Although some Jews shouted insults at the troopers from their cars while driving past at high speeds, there were no physical confrontations. A number of neighborhood men and youths who had bought Party literature the day before and who had witnessed the fight joined ranks with the ST that day, and vowed to help the Party drive the Jews from the area if they were ever stupid enough to return again.

Charges were eventually filed against one of the attackers, but were thrown out by a Jewish judge because the troopers had reported the attackers were in their twenties and thirties—and this particular Jew was in his forties.

California National Socialists Support White Prisoners

In addition to numerous paper sales and literature distributions, the Orange County (California) Unit of the Party held a demonstration in support of White prisoners on 15 July. Two teams of National Socialists, under the command of ST Jerry Weston, picketed outside of the Youth Training School in Ontario.

Word of the demonstration quickly spread to the prisoners inside the facility, who began shouting “White Power!” and other pro-White slogans. The only incident occurred when a lone Black attempted to assault the ST men. He was restrained by the police before reaching the National Socialists, thus preventing him from being seriously injured.

Also during the month of July, the Orange County Unit assisted in the organization of two meetings in the San Diego area, to help encourage the growth of the Party in that city.

Assault on Nazi causes clash with Minneapolis police

About 30 members of two leftist groups clashed with Minneapolis police Friday night after the protesters assaulted a Nazi in an effort to stop him from entering a

downtown radio station to appear on a talk show.

One protester's glasses were smashed during the melee, although no serious injuries were reported. About eight of the protesters were arrested, but charges

had not been filed last night.

About 12 policemen spraying Mace and using clubs brought the disturbance, which began at 10:15 p.m., under control in about five minutes.

The confrontation began taking shape at 8 p.m. when members of the Progressive Labor Party and the International Committee Against Racism set up a picket line outside WWTC-News Radio station at 609 Second Av. S.

The groups were trying to block the appearance of Steven P. Martinson, 23, a member of the National Socialist White People's (Nazi) Party on “Bob Allard's TC Talk Line.”

However, a spokeswoman for the protesters, who asked not to be identified because she said she receives many threats, said the groups were also trying to get publicity. She contended that re-

cent news media attention on the Nazis has heightened racism.

At 10:10 p.m., as three squad cars stood by, the protesters said they heard that Martinson would not show and they claimed victory.

“We have shown that we can prevent the fascists from showing their faces in downtown Minneapolis,” one shouted over a bullhorn.

Moments later Martinson, accompanied by an unidentified man, walked behind the picket line to enter the front door. Several protesters blocked him and punches were exchanged. A scuffle ensued, which most of the protesters joined.

Police parked in squad cars across the street ran to break up the scuffle and a melee began in which several of the protesters and policemen fought. The police were joined minutes later by about five squad cars. The reinforcements

used Mace to move the protesters away from the building and Martinson entered the station and appeared on the talk show.

Before the fight, the mostly young protesters appeared to be in a hostile mood, carrying signs reading “Death to the Nazis” and chanting “Cops and Nazis, you better start shaking. Workers' revolution is in the making.” The spokeswoman told a reporter before the incident that the groups intended to use force to bar Martinson.

“It's a perversion to call this a free-speech issue,” the spokeswoman said. However, the talk show's producer, David Hellerman, said before the clash occurred that he disagreed.

“I'm your Jewish producer, so I think that makes the antisemitism charge against the station seem ridiculous. The fastest way to defuse racism is to give full exposure to the racists' viewpoint.”

7 arrested as Nazis, protesters fight in city

Minneapolis police arrested seven people Friday night when about 30 members of two leftist groups clashed with police as the protesters tried to stop a Nazi from appearing on a radio talk show.

Members of the Progressive Labor Party and the International Committee Against Racism set up a picket line outside WWTC-News Radio station at 609 Second Av. S. When Steven P. Martinson, 23, of Minneapolis, a member of the National Socialist White People's (Nazi) Party, attempted to enter the station at 10:15 p.m. to appear on a talk show, a scuffle ensued between the protesters and the five people accompanying Martinson.

Police, spraying Mace and using clubs, broke up the disturbance and arrested the seven, including one juvenile who said he was a Nazi.

Arrested were: Nathan B. Viste, 22, 3212 Clinton Av. S., charged with disorderly conduct; Scott J. Yamauchi, 24, 2545 Dupont Av. S. and Margaret R. Beegle, 26, no address known, both charged with interfering with lawful arrest; Gregory C. Nelson, 31, 4505 Oakland Av., and Harry V. McCallister, 21, 1201 E Building, Cedar Square West, both charged with simple assault and disorderly conduct.

In addition, a 17-year-old boy was arrested when police said they saw him spray the demonstrators with a can of Mace. He later told them that he was a member of the Nazi Party, police said.

A 28-year-old woman was being held Saturday for probable cause to riot. Her name is being withheld until the County Attorney's office decides whether to charge her with a felony or misdemeanor.

All but the 28-year-old woman have been released on bond and are scheduled to appear in Hennepin County Municipal Court on Monday morning.

● In addition to beating up Communists in their city, the comrades of the Minneapolis Unit found time to conduct three literature distributions during July. Nearly 1,000 leaflets and copies of WHITE POWER were distributed in White neighborhoods. Also, Comrade Martinson had letters-to-the-editor published in two newspapers. In his letters (reproduced here) Comrade Martinson attempted to undo some of the damage to the National Socialist movement caused by the antics of Jewish "Nazi" Frank Collin.

City woman faces charge of rioting at radio station

A Minneapolis woman was charged Thursday with rioting following a clash between police and protesters outside a downtown radio station last Friday night. The charge was brought in Hennepin County District Court.

Alida Bakuzis, 28, who gave her address as 2022 4th Av. S., allegedly spoke over a megaphone while two leftist groups were protesting the planned appearance of a member of the National Socialist White People's (Nazi) Party on a WWTC radio talk show.

When the Nazi member, Steven P. Martinson, arrived at the station, he and some companions fought with protesters. Police at the scene also became involved, and police reinforcements used Mace to bring the disturbance under control.

Anti-Nazi Protesters Dispersed

MINNEAPOLIS — A dozen policemen used tear gas to disperse about 30 protesters trying to stop a Nazi from appearing on a radio talk show.

No serious injuries were reported in the incident. Police said about eight of the protesters were arrested, but no charges had been filed.

Protesters said they were trying to block the appearance of Steven P. Martinson, 23, Minneapolis, an organizer for the National Socialist White People's (Nazi) Party, on a late-night talk show.

● The Milwaukee Unit of the National Socialist Women's Organization reports that it held an intensive literature distribution from 14 July through 25 July. 1,000 copies of WHITE POWER and 3,000 leaflets were distributed during this period.

So you thought Nazism ended in 1945

Local Nazi defends white superiority, suggests Blacks go to Africa

Editor's note: Nazis are in the news again. More than three decades after the United States and its allies fought a costly world war to stem the tide of Hitlerian aggression, the National Socialist movement is rearing its head in Western Europe and, to a small extent, in the United States. The heavily Jewish Chicago suburb of Skokie has been a legal battleground for the rights of a Nazi faction to march through the streets. Recently, the much-heralded television series, "Holocaust," presented an account of Nazi persecution of the Jews in the 1930s and 1940s.

While there are few active Nazis in this area, one was recently interviewed by Spectator reporter Steve Menestrina. The Nazi requested anonymity because he said he feared for the safety of himself and his family.

The Spectator, of course, does not endorse this man's views, but we present them as a reminder to those who thought Nazism died with Hitler and the defeat of Germany in 1945.

The man is the opposite of a lean arrogant movie Nazi. He is slightly overweight, has a receding hairline, and is well mannered and quiet spoken.

He is a graduate of a local high school and college, and is in his early thirties. Married with two children, he is employed in a secure, well-paid position with a government agency.

Because of a job regulation he can no longer attend Nazi Party meetings, but he is a dues-paying, official supporter. He estimates national Nazi Party active membership at under 1,000 and believes there are about ten times that many official supporters like himself.

All of his replies have been condensed without changing their meaning, as he spoke at length on most questions.

When did you first join the Nazi Party?

"It was a kind of long, slow process. At about age sixteen I read George Lincoln Rockwell's autobiography and thought it was awful the nasty things he had to say about the Negroes and Jews. I was pretty far to the left at that time. Only later did I come to understand that much of what National Socialism stands for is true. National Socialism has a complete platform, a policy for everything in government. Its stand on race relations is all that catches the media's attention. I spent some time in the service in Chicago and Washington, D.C. and saw what they said about Negroes and Jews is true. I understand now that Negroes march to a different drummer. How ever well intentioned integration is, they just can't be integrated into white society. They are different from us."

When did you actually join?

"I visited the national headquarters in Arlington, Virginia when I was in the army. I found out they weren't a bunch of nuts the press makes them out to be. They are loyal, dedicated Americans. Yes, there is a touch of fanaticism, but it's a fanaticism that comes from having a special mission. We know something the rest of the people aren't aware of. It's our mission to tell them. It's just hard to get people to listen to the truth. It was there . . . I became a National Socialist. I never have gone to meetings. Only been to one rally, in Cleveland 1973, but I'm a Nazi."

How does it feel to be allied with a group that is credited with eleven million deaths, six million of them Jews, during World War II. Aren't you booed and jeered when you march?

"In Cleveland in '73 when 300 of us marched we were booed but we were cheered too. People around here just don't understand yet. In the major cities whites are trapped. Those people are ready for our "White Power" ideas. Look, the Negroes stick together, the Jews stick together but we whites don't. We want the whites to unite, be proud of being white, don't let the blacks and Jews take over. When two strange blacks meet they flash each other the communist's salute (closed fist wave) like brothers. All Jews seem to care for all other Jews. We whites don't. We've got to stick together. A real racial confrontation is coming in the cities.

Like most radical political groups, the National Socialist White People's Party has reams of propaganda available, explaining history and current problems, according to party beliefs. The Aryan style of Nazi Germany still applies, witness the above heroic-style poster printed by the NSWPP.

The cities are armed camps. We've slowly moved into a situation like a civil war. Look, there are lots of areas in cities where whites can't go, it's not safe for whites. Blacks are armed and ready, we aren't. Whites must unite to protect themselves. We need White Power. There's all kinds of racial violence, muggings, rapes, murders that aren't recognized or reported as being racially motivated. It's there, you just got to look."

What do you want to do with the Blacks?

"We want to repatriate the Negro back to Africa where he belongs. They don't fit here, they're political pawns. Both parties use them. No one really cares about Negroes. Until FDR found out they'd vote like hell no one looked at them. Now the parties exploit them. The Jewish businessmen exploit them. They'll (Blacks) buy a stereo or color TV at five dollars a week for the rest of their lives. They're the perfect consumer. But they're a real pain in the ass for white people. Crime would drop 70 or 80 percent if the blacks were gone. We all know that."

What about the Jews?

"Why should Terre Haute Jews care about what goes on in Israel? Why don't we care about the whites in Rhodesia? Why should Jews enjoy the fruits of America when they're really loyal to Israel. They aren't loyal to America first, we whites are. If they love Israel let them go there and live."

What about the six million Jews the German Nazis killed in the concentration camps?

"There were Jews in the concentration camps but concentration camps aren't death camps. All the death camps were behind the communist lines (now East Germany). Stalin and the communists used them--not the Germans. We only have the communists' word for it. Germans are good and decent people--they wouldn't murder people just because they disagree with them. Sure, some Jews were executed . . . for being communist not Jewish. And only a few thousand at that. (He now refers to a book

"Six Million Did Not Die" and uses alleged facts and statistics from it about Jewish deaths).

"Nazis are not bloodthirsty people. They are determined, hard-nosed, but not murderers. We get things done. Germany was in a horrible depression, the Nazis changed that and made Germany prosperous. Why should we take the word of a Jew over the word of a white man? They haven't proved themselves extra truthful. There are some indications they are less truthful. Jews in Israel have stolen Arab land, have tortured Arabs for thirty years, but they deny it. Look at Begin, he's the worst terrorist in the Middle East and he's Premier. He lies to America all the time. He doesn't want a just peace. We're seeing now how reasonable an Arab, Sadat, can be. Sadat wants peace, Begin doesn't. How can you reasonably say all Israelis do good and all Nazis do wrong, it's not reasonable."

What about the ovens in the concentration camps?

"The camps were like nice small German towns. Every German town has a crematorium. It's their style for handling the dead. You don't kill people in ovens, you cremate them."

What's the purpose of the Nazi march in Skokie?

"I don't know. That Frank Collin is not a National Socialist. He and his group are just crazy, I guess. He's part Jew and was kicked out of our party. So he founded his own. Why should we harass a bunch of Jews? We don't do that. We confront groups of militant Negroes, not old retired Jews. It's a great burden to try and show the right way. The left always has some hero, like McGovern. We never get good, honest publicity for our views."

"National Socialism is the most important movement of the 20th Century. We will win, we must, we must unite whites for the future. Whites must unite!"

What do you really see as the future for Nazis in America?

"We'll either be dead by 2000 or Nazi by 2000. We can't go on like we are. The Negroes and the Jews look out for themselves, we whites must also. At least 50 percent of the whites in America believe like we do, they just don't know it yet. They're certainly racist in beliefs, just not Nazi in political affiliation . . . yet!"

When I told him his statements were incredible he said, "I know it but the truth is often incredible."

● The Cleveland Unit is continuing its steady program of activities and is meeting with good results. During July two public WHITE POWER sales were held, and one literature distribution was conducted. Additionally, two closed meetings were held during which special ideological training was conducted.

● Northern California comrades Rickey Cooper and Steve Goldman were interviewed by KCEY/KMIX radio on 22 July. The interview, one-and-a-half hours long, is scheduled to be edited down to a half-hour and aired at a later date over the twin stations, one of which is AM and one of which is FM.

● The Milwaukee Unit conducted three distributions during the month, in which they passed out over 1,500 WHITE POWERS. A paper sale was held by one team of troopers on 15 July. There were no major incidents.

Police Seeking Morristown Nazi

MORRISTOWN — Is there a local Nazi who has been distributing hate literature in town? Or is it just a sympathizer who has been plaguing residents for the last few months?

Police Chief William Pierson is seeking answers to these questions. His investigation is centered around *White Power*, a Nazi-inspired hatesheet that was found last week on the porches and front walks of homes on Early Street.

Although an official complaint was made by a woman of Polish-Jewish extraction, it soon became evident that the newspaper was distributed at random.

Patrolman Eugene Steele said he tossed his copy of *White Power*

away in disgust after a quick perusal of its contents, which included a disdainful article on the inclusion of black ministers in the Mormon Church. It has listed a full page of the names of members of President Jimmy Carter's administration who are allegedly of Jewish extraction.

Steele lives up the street from Mrs. N.L. Wenarsky, who brought her copy into headquarters

Pierson said that he has filed her complaint, "but there isn't anything illegal about the the paper."

He said distribution of the "obnoxious" material is well within

the rights protected by the First Amendment.

Pierson said that the number of incidents in Morristown is much fewer than those in other communities.

Pierson said that he is still investigating and will prosecute anyone who was responsible for painting swastikas on signs near the Rabbinical College on Sussex Avenue or for posting a similar warning note recently on the front of Morristown Hardware, whose owners are Jewish.

He said that it was two years ago that Nazis in uniform marched from the courthouse to the Green because they were being evicted from their storefront in Hackettstown.
