The Party Enters the Computer Age!

Thanks to the selfless generosity of National Socialists in the U.S., Canada and a number of foreign countries, the Movement has been able to acquire its own computer system. The system is still being programmed as this NS BULLETIN is being prepared. It should be fully operational sometime in November.

Although transferring the Movement's entire mailing list of thousands and thousands of names from our old, obsolete Addressograph plates to the new computer disks will further delay the Party's already woefully backlogged publication schedule, in the long run the new system will add to the efficiency and speed of Party mailings.

Eventually, not just Party publications but every facet of administrative and bookkeeping work will be computerized. This will allow the staff at National Headquarters to accomplish a greater amount of work with fewer people, thus helping to ease the chronic manpower shortage which has plagued NHQ for the past five years. The overall effect will be that the Party's ability to attain its goals successfully will be greatly enhanced.

All comrades are asked to be patient with the delay in receiving their copies of the NS BULLETIN, WHITE POWER and THE NATIONAL SOCIALIST. We assure you that the extra wait will be well worthwhile in view of the Movement's increased potential and capability as a result of computerization.

'Computer Age' Appeal Exceeds Goal by 35%

Despite the fact that it took longer than we had hoped for, the Party successfully concluded the fund drive to buy the computer system described above. As was announced in NS BULLETIN 279, the \$5,000 goal to "Help the Party Enter the Computer Age" was met in late July. Many comrades, however, continued to contribute to the drive throughout August and into the first part of September.

As of 8 September, the final cut-off date for the appeal, \$6,772.27 had been raised—some \$1,700 over the initial goal. The monies above and beyond the \$5,000 computer goal have been applied against various back-debts which the Party accrued in the past year.

Once again, the Commander and all the staffworkers at National Headquarters wish to offer their heart-felt thanks to those comrades whose generosity enabled the Party to undertake this important project.

Martyrdom of Lincoln Rockwell Commemorated

The 14th anniversary of the assassination of the Party's founder and first Commander, George Lincoln Rockwell, was commemorated in August.

In Arlington, the date was marked by a full day of National Socialist activism. The day's events started off with a WHITE POWER distribution in Washington, D.C., by uniformed Party Stormtroopers. The distribution passed without incident. Afterwards, the ST men visited the Capitol building, where they wished to have a group photograph of themselves taken on the front steps. Capitol police attempted to stop the photo-taking session, first by claiming that it was illegal to wear political or military uniforms on the Capitol grounds. Later the police offered to allow the ST men to go ahead with the photograph—but only if they would remove their Swastika armbands. When the comrades refused to compromise, the police finally backed down.

That afternoon a picnic was held in Lincoln Rockwell Park in Arlington. In the evening, an informal meeting commemorating Commander Rockwell was held at Party National Headquarters. A highlight of the gathering was the showing of a rare, color, 1965 home movie, featuring Commander Rockwell and early Party headquarters buildings in Arlington. The day's activities concluded with a solemn procession to the assassination site, where a ceremony for Lincoln Rockwell was held in front of a burning crucible.

Jerry Falwell Afraid to Debate Matt Koehl

Comrades who received NS BULLETIN 279 and WHITE POWER 99 should be aware that Commander Koehl has challenged Rev. Jerry Falwell, leader of the Moral Majority, to a debate on the following question: "Should the United States continue to give political, military and economic aid to the state of Israel?"

Shortly after the offer to debate was made, Calvin Thomas, M&M propaganda minister, issued a statement which called the Party a "hate group" and said that the M&Ms wouldn't engage in a debate with Matt Koehl because they "repudiate everything [the Party] stands for." It should be noted that Falwell and other M&M spokesmen have publicly debated numerous critics with whom they have significant disagreements. Clearly, Rev. Jerry is afraid to debate Matt Koehl, perhaps because his Jewish friends told him that such a debate would give too much exposure to the Party or perhaps because Falwell correctly senses that there is no way he could win such a debate.

The Commander's challenge to Falwell has generated some positive publicity for the Party. Mention of the debate was made in newspapers throughout the country, including the *Chicago Tribune*, *Houston Chronicle* and *Philadelphia Daily News*. Overseas, word of the challenge reached U.S. armed forces personnel through the widely-read service paper *Stars and Stripes*. Significantly, no mention of the controversy was made by the media in Lynchburg, Va., home base for the Moral Majority and a city where Jerry Falwell wields immense influence. Falwell obviously is anxious to avoid any publicity in this matter.

Local units everywhere have held actions designed to spread word of the Commander's challenge to the public. Most local units mailed press releases and the Commander's letter to their local news media, along with copies of WHITE POWER 99. The Chicago Unit produced two special leaflets denouncing Falwell which have been distributed by the thousands. The Cleveland Unit mailed copies of WHITE POWER 99 to dozens of fundamentalist ministers who support Falwell and the M&Ms. New Jersey Party activists cornered M&M spokesmen on radio call-in talk shows on two occasions and questioned the M&Mers on why Falwell was afraid to debate Commander Koehl.

Indianapolis Unit comrades attended an M&M meeting in their city and spoke to the local leader of the M&Ms about the proposed debate. Copies of WHITE POWER 99 were left on the windshields of the cars of those who attended the meeting. White Power messages on the Commander's challenge were broadcast in Arlington, Chicago and Cleveland. National Headquarters was especially pleased to learn that students at Falwell's Liberty Baptist College in Lynchburg were among those who kept the Arlington WPMs ringing off the hook.

Despite the fact that Jerry Falwell is eager to avoid debating Matt Koehl, the Commander is still interested in setting up such a debate if enough pressure can be put on Falwell to cause him to change his mind. The Party's response to the answer given by Cal Thomas concerning the Commander's initial letter will appear in WHITE POWER 100, which is now in production.

Richard Biederman Unit Denies Link to Theater Bombing

The Richard Biederman Unit in Minneapolis has formally denied that the Party was in any way involved in the 17 August bombing of a theater which showed Oriental movies and which catered to Orientals. A large Swastika and the words "White Power" were painted on the sidewalk in front of the theater immediately prior to the explosion, in an apparent attempt to implicate the Party in the blast.

In an official statement released to the press, local Party leader Steven P. Martinson explained that:

"It is not now, nor has it ever been, a policy of this organization to engage in terrorist activity. The National Socialist White People's Party is a *legal* political organization, dedicated to bringing about change *legally*.

"Not through acts of violence directed at human beings or property, but rather through winning the hearts and minds of White people to our Cause will we be successful. We hereby deny any involvement in the Ritz Theater bombing."

The statement was broadcast over the Minneapolis CBS-TV affiliate four days after the explosion.

Judge Dismisses Charges Against Cleveland Organizer

It was reported in NS BULLETIN 278 that Cleveland Unit Organizer Jimmy Clendennen was arrested by a drunken anti-National Socialist police officer on 27 June. Comrade Clendennen was leading a WHITE POWER street sale at the time of his arrest. The anti-NS officer, with a heavy smell of alcohol on his breath, had been harassing the Party activists who were selling the paper. When Comrade Clendennen politely asked the officer for his badge number so that a formal complaint could be filed with the Cleveland police department, the drunken patrolman arrested Clendennen and charged him with disorderly conduct!

On 15 July a municipal court judge in Cleveland dismissed the charges against Comrade Clendennen after the arresting officer failed to appear in court to testify in the case.

Falwell Snubs Nazis

Moral Majority Nixes Debate

LYNCHBURG (UPI) — The American Nazi Party challenged Moral Majority founder Jerry Falwell to a debate Friday, but a Moral Majority spokesman said the group would not dignify the Nazis by publicly arguing with them.

"They are a hate group and Dr. Jerry Falwell and Moral Majority oppose them and repudiate everything they stand for," said spokesman Cal Thomas in a terse, short statement.

Matt Koehl, commander of the National Socialist White People's Party, sent a letter to Falwell challenging him to a public debate on whether the United States should continue to give political, military and economic aid to Israel.

Koehl said he knows he and Falwell do not share similar views on Israel.

"If news media reports are to be believed, you are the most fervent and outspoken non-Jewish supporter Israel has anywhere in the world," Koehl said in his letter.

Koehl alluded to Israel Prime Minister Menachem Begin's telephone call to Falwell "to whip up support for his criminal acts after the illegal, peace-threatening raid on Iraq."

Koehl charged that U.S. support for Israel could be instrumental in triggering a "global nuclear holocaust."

"To be blunt, I do not believe that U.S. support for the Zionist entity in Palestine is in the best interest of either the American people or world peace," Koehl said.

ACTIVITIES IN BRIEF

- There was a great upsurge in the distribution of Party literature during the months of August and September. Organized WHITE POWER and leaflet distributions were reported by local units in Baltimore, Charlottesville, Chicago, Cleveland, Indianapolis, Milwaukee, Minneapolis, Northern New Jersey and New York. The distributions in the suburban New York City area received hostile coverage from the Jewish-dominated System news media.
- Among other literature distributions conducted in recent months by the Richard Biederman Unit in Minneapolis was a special mailing of sample copies of WHITE POWER to 99 Minnesota libraries. A WHITE POWER subscription blank was enclosed with each copy of the paper.
- WHITE POWER street sales were held by Chicago Unit comrades on 1 August and 19 September.
- A letter from Chicago Unit Organizer Richard Steele appeared in the *Berwyn Life* newspaper on 30 August. Comrade Steele's letter explained the differences between our Party and a Chicago-area "Nazi" splinter group which has been bringing disrepute to the Movement recently. The *Indianapolis News* printed a letter from Indianapolis Unit Organizer Clayton Roots on 6 August. Comrade Roots defended the Party from attacks made in an anonymous letter to the *News* in July.
- Cleveland Unit Organizer Jimmy Clendennen was interviewed for an article describing different pro-White groups active in the Cleveland area. The article, which reflected favorably on the Party, appeared in the *Cleveland Press* on 16 August.
- World Union of National Socialists comrades in Latin America report receiving publicity following the systematic distribution of Spanish-language NS materials throughout Panama, and especially at the University of Panama, where an NS student organization associated with WUNS is particularly active.
- National Socialist study groups were held by the Chicago, Cleveland and Milwaukee units in August and September.
- The Richard Biederman Unit held a garage sale on 19 September to raise funds for future unit activities.
- An interview with National Organizer Martin Kerr was broadcast over WQFM radio in Milwaukee on 25 September. The interview dealt exclusively with the Party's stand on the "holocaust" fairy tale.
- Chicago Unit Organizer Richard Steele and Unit Treasurer Randy Shirk spoke to an audience of 100 high school seniors in Naperville, Ill., on 24 September. Comrades Steele and Shirk explained the Party's beliefs and answered questions put to them by the students for two hours.
- Members of the Cleveland Unit attended a gathering of White racialists from the East Coast and the Midwest in Howell, Mich., on 19 September. The meeting was sponsored by Rev. Bob Miles, a longtime pro-White activist.

Canadian Party comrades joined with members of various racist organizations for a weekend of survivalist training on 29 and 30 August. The training took place on property owned by a German-Canadian National Socialist, in Western Ontario. Those who attended received instruction in self-defense and survival techniques and participated in ideological discussions.

Comrades from the Charlottesville Unit report conducting defensive marksmanship practice during August.

The Richard Biederman Unit donated \$50 in August to a home for the handicapped that had been terrorized by a gang of Black criminals. The Negro thugs had invaded the home, raping and robbing its disabled residents. The National Socialists also volunteered to help in the distribution of leaflets offering a reward for information leading to the arrest and conviction of the perpetrators of the assault.

Party Comrades Donate Monument To Murdered Wartime National Socialists

In NS BULLETIN 271 it was reported that Indianapolis Comrade Richard Sharp had discovered that the bodies of six German National Socialists murdered by the Roosevelt government in 1942 were still lying in a common pauper's grave in the Washington, D.C. city dump. The six were members of the German American Bund, and one was a U.S. citizen. They were executed as members of the German intelligence service, the *Abwehr*, after some legal irregularities.

After trying unsuccessfully to get the West German treason regime to move the bodies to a more suitable gravesite—or at least mark the location of their burial appropriately—Comrade Sharp took matters into his own hands.

A special monument to honor these fallen heroes was purchased with money raised by the Indianapolis Unit, and in September Comrades Richard Sharp and Clayton Roots, with

the help of comrades from the National Headquarters area, placed a granite monument at the location of their burial which reads:

*In Memory of
Agents of the German Abwehr
Executed August 8, 1942
Herbert Hans Haupt
Heinrich Harm Heinck
Edward John Kerling
Hermann Otto Neubauer
Richard Quirin
Werner Thiel
Donated by the NSWPP*


AMAZING PHOTOGRAPH

BLACK MAN TELLS WHY HE JOINED THE KKK

SHOCK waves are being felt through the Ku Klux Klan membership in North America.

Louis Proctor, a black construction worker, has joined the Alberta, Canada, branch of the organization, becoming the first black to be accepted as a member of the segregationist group.

"I want to stop racial violence and the Nazi movement, and one way to do that is by joining the Klan," the 40-year-old Proctor told the Examiner.



The Fruits of Anti-Hitlerism

The vileness and insanity of anti-Hitlerism knows no bounds. Reproduced here is part of a sickening news media report concerning a Ku Klux Klan group based in Alberta, Canada, which has decided to accept Blacks as members.

According to Klan leader Tearlach Mac a'Phearsoin, the new interracial Klan "will help form a united front, not only of Whites, but of people who are Black or Jewish, against the neo-Nazi movement." Louis Proctor, the first Black to be admitted to the KKK as part of this despicable racial sell-out, boasts that his desire to fight the resurgent forces of National Socialism was one of his key reasons for becoming a Klansman. "I want to stop racial violence and the Nazi movement, and one way to do that is by joining the Klan," said Proctor.

In reporting this astonishing incident we certainly do not mean to imply that all Klan organizations are willing to compromise their racial integrity in this manner. We are sure that this is an isolated case and that it does not reflect the feelings of any significant number of Klansmen. It does show, however, the great lengths to which many individuals and groups are willing to go once they adopt an anti-National Socialist stance, and it reveals the dangers involved in trying to defend the White race while rejecting the personality and teachings of Adolf Hitler.

For when all is said and done, the future of our Race is inseparable from National Socialism.
