Government Moves to Destroy Party; Commander Announces 'State of Emergency'

All readers of the NS BULLETIN should be aware of the recent attack made on the Party by the federal government. This attack came in the form of a tax bill presented to the Party in mid-November, demanding the Movement pay nearly \$40,000 in "back taxes." The Party was initially given a mere two weeks to pay this astronomical sum.

This is not just another System effort to soak the Party for taxes—it is a clear attempt to destroy the Movement. This attack must be viewed more seriously than most past attempts to kill the Party, because of its size and scope and because it comes at a time when the Party is already in a dangerously weakened condition.

In view of the above, the Commander has declared the Party to be in a "state of emergency." Accordingly, National Headquarters has given the *survival of the Party* the highest priority, and all routine operations and special projects will have to take second place to this battle for survival until the Party fights its way out of its current predicament—or is destroyed.

'Tax' Bill Update

As we mentioned in WHITE POWER 100, the bill for \$39,314.45 was initially due on 1 December. On that date the Party managed to obtain a short extension—to 17 December. On 18 December, when the bill was not paid, the IRS informed the Party that a lien would be forthcoming, order-

ing the Party to pay the sum.

If the bill is not then paid, the government will be able to take punitive measures against the Movement.

The Commander has not taken this outrageous attack lying down. In addition to trying to raise money by way of an emergency appeal to the Movement's entire mailing list, National Headquarters has been pursuing a number of other strategies. While we do not wish to reveal all of these possible maneuvers here, we can give a rough sketch of our legal defense.

We are fighting the \$40,000 bill on two grounds: In the first place, the Party is exempt—as are all political organizations—from paying taxes on monies it receives in dues and contributions. A large portion of the bill is levied against such income. That we are even being asked to pay taxes on this income is a form of blatant harassment on the part of the government.

Secondly, the Party has filed amended income tax returns for the years in question, *giving documented proof that the maximum taxes we could possibly owe—even including the exempted income mentioned above—is not more than \$22,000, considerably less than the \$40,000 the government is demanding.* (In fact, because we are exempt from paying taxes on income received as dues and contributions, the actual amount we owe is only a tiny fraction of the \$22,000 figure.)

The IRS so far has even refused to consider our fact-filled amended returns. Instead, it has levied additional penalties against us for not paying the \$39,314.45 promptly in mid-December! The new amount they claim we owe is in excess of \$40,000.

Prospects for the Immediate Future

The prospects for immediate future look bleak but not impossible. Although the government has us in a corner now, in the long run it seems likely that the Party will at the very least be accorded its legal rights: At some point, the IRS will be forced to accept our amended returns for \$22,000 (rather than the \$40,000-plus); at some point the IRS will be forced to restore tax exemption to the Party for monies received in dues and contributions. If these basic, fundamental political rights are *not* restored to the Party, it will mean that the System now considers the Movement to be outside the law, and our struggle will have entered a new phase.

One bright note to this whole affair is that the response to the Commander's appeal has been especially strong. Although there is no way that we can raise the full \$40,000 by way of the appeal, it appears that this fund-raising drive will be the most successful one in recent years.

As this issue of the NS BULLETIN is being prepared in late December, donations to the appeal are continuing to roll in. What is most gratifying is that the Commander's plea has caused many people on our mailing list who have never before contributed to the Party to give a generous donation. Also, the average size of contributions we are receiving is substantially larger than in the past.

The overwhelming show of support for the Party that the appeal has brought forth has raised the morale of everyone at National Headquarters, and given us all the hope and encouragement to see this fight through to the end.

As was expected, Party enemies are purring with satisfaction over the Movement's current hardships. Also, about a dozen faint-hearted Official Supporters have resigned from the Party because of the government's attack. Otherwise, Party members, supporters and sympathizers have stood foursquare behind the Commander during this time of extreme difficulty.

Why This Attack Hits Us So Hard

We mentioned above that one reason this assault on the Movement is so potentially lethal is that it comes at a time when the Party is in an already weakened state. To understand why this is, one must know a little bit about the history of the Party since the death of Commander Rockwell.

When Lincoln Rockwell was assassinated in August of 1967, the Party almost died along with him. Only the steadfast resolution and determination of Matt Koehl, the Movement's new leader, kept the NSWPP from disappearing entirely. Under Commander Koehl's leadership, the Party overcame the tragic and monumental loss of its founder. And not only did it survive, but in time it began to prosper and grow far beyond the level it had reached during Lincoln Rockwell's lifetime.

But even in the midst of this new prosperity and growth all was not well. Commander Rockwell had believed that the Party would one day be a mass organization, made up of millions of members, and

that it would be swept into power in an open election. Accordingly, the Party's propaganda, activities and organization were geared to being able to accommodate the huge numbers of White people whom we felt would rally around our banner in the near future.

However, the political climate of the United States in the years following Commander Rockwell's assassination changed radically. It eventually became apparent that the Party would definitely not be a mass organization in the immediate future, and that it might *never* be such an organization. This realization was not arrived at suddenly. Rather, it was something that became obvious only slowly, over a long period of time.

Thus throughout the mid- and early 1970s the Party was simply on the wrong track in this respect. Our entire outreach and all of our organizational techniques were geared to mass organizing, when in fact what was needed was the formation of a small, highly select, high trained and highly motivated National Socialist elite.

But instead of being "select," the Party opened its doors to virtually any White person who wished to join, no matter what his or her personal defects or motivations for joining might have been. And instead of aiming its propaganda at the elite of our Race, the Movement tried to appeal to the lowest common denominator. After all, this is how mass organization are supposed to operate!

So despite our ability to hold larger and larger demonstrations, to raise money and to garner publicity, the Party was on a disastrously wrong course. Solid ideological training and cadre building were ignored in favor of cheap publicity stunts. Individuals of unsound character were admitted to our ranks who chased more stable comrades away. Party propaganda was designed to appeal to "nigger-haters," not sincere Aryan racial idealists--and we got what we asked for.

By 1976, the Party's inorganic, artificial growth began to catch up with it. Qualified personnel couldn't be found to man Party headquarters; new racist organizations arose that began to siphon off the support of those who were dissatisfied with the Party's faltering approach; Party publications didn't appear on schedule; local units and street activism stagnated. The White masses whom we had been waiting for and trying to recruit since 1959 clearly wanted no part of the Party or its solutions.

Things got worse as the years went by. Although Commander Koehl recognized the problem and tried to quietly adjust the Party from a mass-strategy orientation to a revolutionary-elite orientation without causing the Movement any major disruption, the momentum of the old approach was too great to be broken without a major effort.

Finally, in 1979, the Commander was forced to make drastic changes. He announced that instead of trying to be a mass organization without the masses, the Party would regroup and reorganize as a revolutionary, National Socialist elite formation. This transformation would be brought about by way of a Two-Year Plan, which was to run from 1 January 1980 through 31 December 1981.

The Two-Year Plan

The Two-Year Plan, now nearing its completion, was vitally necessary. Nothing less could have gotten the Movement off of its wrong course and onto the right one.

In any successful radical surgery, there is always a period of recuperation when the patient is very weak. The Two-Year Plan was just such surgery. We amputated numerous mental defectives, racially marginal individuals, ideological deviationists and assorted bums, losers and creeps from our ranks. We purged the Movement of worn-out and ineffective propaganda and activities. We replaced the diseased notion of mass-strategy with a healthy one of building and training a revolutionary elite. The surgery was successful, but it substantially cut back our financial base of support, leaving us in a weakened and vulnerable state.

Why the Government Decided to Strike Now

It seems odd at first that the government should have chosen this precise moment to attack the

Party. In our present weakened condition we pose less immediate threat to the System than previously. Perhaps they are striking us now because they know we are weak and unable to defend ourselves as vigorously as we would like. *Or perhaps they are concerned that although we may be weak now, our new orientation will enhance our ability to wage war against this evil anti-White System in the future a thousand-fold.*

Conclusion

The Commander is convinced that we are aimed in the right direction at this time. In the months ahead--assuming we are still here--National Headquarters will be making some major announcements concerning the development of the Movement following the conclusion of the Two-Year Plan.

During this crucial period we ask that all comrades give the Commander and the Party their unconditional loyalty, and that they intensify the struggle for National Socialism and White Power in their areas.

ACTIVITIES IN BRIEF

- Party comrades from Cleveland, Detroit and elsewhere took part in a White racist gathering hosted by Rev. Bob Miles in Michigan in late October. Cleveland Unit Organizer Jimmy Clendennen read a statement to the audience from Commander Koehl, who was unable to attend the rally because of his heavy workload in Arlington. The Commander's statement (which is reproduced here) was enthusiastically received by the assembled White racials, much to the embarrassment and disappointment of certain anti-Party elements who also attended the gathering.

- National Organizer Martin Kerr gave a television interview to journalists from the Soviet news agency Tass on 2 October.

- NSYM comrade Sean McCarthy appeared on the New York City CBS-TV affiliate on 17 November. Comrade McCarthy was interviewed as part of a news report on the National Socialist movement in America.

- NS activist and police officer Richard Sharp of the Indianapolis Unit is once again the center of controversy. A shop owned and operated by Jews has refused to sell Sharp items for his police uniform because he is a National Socialist. This is in direct violation of civil rights legislation passed in the 1960s, and Comrade Sharp has informed National Headquarters that he intends to sue the store for violation of his constitutional rights. The Jews have threatened to extend the boycott of Comrade Sharp to all Jewish-owned stores in Indianapolis. Comrade Sharp has received much support and sympathy from fellow police officers as a result of the illegal abridgement of his rights.

- Party comrades from the National Headquarters area celebrated White Pride Day by attending a Ku Klux Klan rally and crosslighting in Preston, Maryland, on 7 November. The National Socialists were invited to participate in the gathering by local Klan leaders. National Organizer Kerr was one of a number of speakers who addressed the audience of 150 White people.

• Organized literature distributions were reported during October and November by comrades in Chicago, Indianapolis, Southern California and Westchester County (N.Y.).

• A delegation from the National Socialist Federation of Ireland participated in the annual memorial service held in Glencree on 17 November. The service honors the war dead from National Socialist Germany who are buried in Ireland.

• Classes on defensive marksmanship and firearms maintenance held by Party supporters and sympathizers in Charlottesville, Va., in recent months were attacked by the Anti-Defamation League of B'nai B'rith in November. Norman Olshansky, regional director for the ADL, called the classes "arms training" and suggested that Virginia may need special legislation to control extremist and "paramilitary" groups. (It's interesting to note that the ADL has yet to denounce weapons training undertaken by Zionist terrorist groups, such as the Jewish Defense League.) This attack on the right of National Socialists to defend themselves brought news media coverage in Charlottesville. Additionally, National Organizer Kerr gave an interview concerning the attack that was broadcast throughout the state by the Virginia Radio Network.

A Note from the Membership Secretary

Membership Secretary Rick Harp reports that there will be a delay in the issuance of 1982 Official Supporter cards. The new cards, with 1982 Swastika stamps, will be issued in early February. This unavoidable delay is the result of the state of emergency declared by the Commander, which has forced many routine tasks to be temporarily postponed.

Party Policy

Party Support for Candidates for Public Office

From time to time the Party is approached by individuals who seek our aid—either openly or not openly—for an electoral bid. It is our policy to give aid to two types of candidates:

1. Party members and supporters running as open National Socialists with the prior approval and full authorization of National Headquarters.
2. Independent White racialists not running as National Socialists who are on friendly terms with the Party and who are not running specifically as a candidate of another racist organization. Even if these qualifications are met, the Party will not give aid to such a candidate unless we have reason to believe that he has at least some remote, outside chance of winning the election.

If the Party does decide to support a candidate, there are a number of ways in which we can help his (or her) efforts, including providing financial aid, designing, producing and printing campaign literature and supplying manpower for grassroots organizing and canvassing, among other things.

Although electoral efforts are not the primary focus of the Movement at this time, they can be a valuable tool for strengthening the Party and spreading the good word of National Socialism and White Power among our racial brothers and sisters.
