North American Assembly Announced

A special North American Assembly of the World Union of National Socialists will be held in Arlington over the Fourth of July weekend (3 and 4 July) this year.

Attendance to this assembly will be restricted to a limited number of selected Party Members and Official Supporters who are active in promoting the Movement in their area, either in connection with a local unit or otherwise. A number of significant changes in the structure and orientation of the Movement in North America will be revealed at this gathering. These changes will be discussed in future issues of the NS BULLETIN.

The assembly takes the place of a regular Party congress, which had been scheduled for this summer. Those activists selected to attend the gathering as either delegates or observers will have received notification of this in the mail by this time.

Party Meets 15 April IRS Deadline

The Party was successful in raising yet another \$6,500 demanded of it by the bloodsuckers of the Internal Revenue Service in April. This sum, which was levied against the Movement as the result of a supposed technical error in the Party's 1975 income tax filing, came on the heels of an outrageous and unjustified bill for "back taxes" of over \$26,000, which was satisfied in March.

The earlier bill was paid under extreme protest by the Movement, in the face of IRS threats to seize the Party's Arlington headquarters or other assets.

Although there are no further IRS claims against the Movement at this time, National Headquarters cautions all comrades

against adopting an attitude of complacency. Every piece of available evidence indicates that the federal government is determined to destroy or at least cripple the Movement this year. Accordingly, further harassment and attacks — either financial or non-financial — are expected in the near future.

The Commander wishes to extend his personal and most sincere thanks to the many comrades in the U.S., Canada and abroad who have helped us through these recent difficulties with their generous support.

**Marc Gillet's Condition Improves;
French Police Arrest Would-be Assassin**

National Headquarters has received word that French NS activist Marc Gillet is in good condition following the assassination attempt against him in March. The 23 year-old Gillet was struck by three shots fired at him when he answered the door to his Nice apartment. Although severely wounded, he managed to slam the door shut on the assailant, thus saving his life. At the present time his right arm is completely paralyzed, although doctors say that he may be able to regain use of it in two or three years and after many operations.

Because of the publicity which has attended this and other incidents, Comrade Gillet is unable to find employment. He has also been forced to curtail his university studies because of the pain he is experiencing in the wake of the shooting. On top of this, he must still pay a fine of approximately \$3,500 which a French court levied against him for distributing an NS newsletter in his city. If he fails to pay this fine, he faces another eight months in prison.

Despite these adversities, Comrade Gillet remains completely

dedicated to the National Socialist movement and its struggle.

The French police have arrested an individual known as Raynan in connection with the attack on Marc Gillet. He is a member of the Gaullist party, P.R.P., which has close ties to the French Jewish Defense Organization, although Raynan himself is not Jewish. Movement comrades have described him as having a weak, easily-manipulated personality. The press has portrayed Raynan as being slightly deranged, and has implied that he was a well-meaning soul who was simply incapable of controlling his "understandable repugnance" at the "horrific nature" of National Socialism.

National Organizer Testifies Against Bill Aimed at Banning Party Literature in Maryland

On 19 March National Organizer Martin Kerr testified against a bill aimed at banning White racist literature in Maryland. Comrade Kerr was one of a number of people who stepped forward to give testimony on the measure before the judiciary committee of the Maryland House of Delegates.

The bill in question would make the distribution of so-called "hate literature" a criminal offense, carrying penalties of up to three years in prison and a \$5,000 fine. Although the Party was not mentioned by name in the bill, Luiz Simmons, the Jewish delegate to the Maryland Assembly who introduced the measure, had publicly specified that it was designed to halt the dissemination of NSWPP material.

Comrade Kerr opened his testimony by agreeing with a representative of the American Civil Liberties Union who spoke immediately before him. The ACLU denounced the bill as being grossly unconstitutional, in that it would flagrantly violate the First Amendment right of White racials to free speech.

Comrade Kerr went on to emphasize three other important points. First of all, he said, the characterization of Party material as "hate literature" was factually incorrect. The goal of the Party's outreach is to attract those to our ranks who are motivated by love of their own people — not by hatred of others — as well as to build White racial awareness through stressing such concepts as White pride, White unity, White self-defense and White Power.

Furthermore, Comrade Kerr noted, it was highly unlikely that the bill would be enforced in an equitable manner. Rather, it would lend itself to *selective enforcement*. Although so-called "anti-Jewish hate literature" (that is, anything that exposes or strongly criticizes the Jews) would be made illegal, literature published by the Jews which stirs up hatred against Whites and other non-Jews would probably not be outlawed.

As proof of this, Comrade Kerr proceeded to read passages from the gruesome, obscene and demented Jewish book of religious laws *The Talmud*, which is available in Jewish bookstores throughout Maryland. The excerpts read by Comrade Kerr were far more hate-filled and gory than anything the Party has produced in its 23-year history. Nonetheless, he said, it is clear to any thinking and informed person that the sale and distribution of *The Talmud* would not be restricted by the bill before the

Hate Material Debate

Md. Bill Proposes \$1,000 Fine, Jail Term For the Distribution of False Statements

ANNAPOLIS—Three members of an Arlington Nazi group read from the Talmud, the traditional Jewish body of laws, and cited various television shows in testifying last week against a bill that would outlaw the distribution of hate literature in Maryland.

"It's true that some people find what we have to say unpleasant. Well that's tough; some things in life are unpleasant . . . The fact that some people find it distasteful is a consequence of living in this wonderful democracy we have," said Martin Kerr, a spokesman for the National Socialist White People's Party, which advocates white supremacy and racial separation.

Kerr read passages from the Talmud that he said proved that it advocated violence against gentiles. Among the television shows he mentioned was "Hogan's Heroes," which he said subjected Nazis, and therefore him, to ridicule. He said neither the Talmud nor the show would be outlawed by the bill, and that this was proof that the bill would unconstitutionally single out his group.

The widely publicized bill, introduced by State Del. Luiz R. Simmons (R-Montgomery), would make the distribution of "defamatory matter" a misdemeanor, punishable on the first offense by up to a \$1,000 fine and a year's imprisonment. Subsequent offenses would be punishable by up to a \$5,000 fine and three years' imprisonment. Simmons said the bill does no more than extend to racial or religious groups the protections against libel that individuals already enjoy.

Some civil libertarians argue that the bill violates constitutional guarantees of free speech. "It's one of the more mischievous bills I've seen. I've seen six or

eight bills on the subject of terrorism and the like, but it's the only one that does not aim at action. It aims only at speech," said John Roemer, executive director of the American Civil Liberties Union of Maryland, who testified at the House Judiciary Committee hearing Friday.

State Attorney General Stephen Sachs agreed with Roemer in a preliminary opinion issued Thursday, saying it is his view that the bill violates the first amendment's guarantee of freedom of speech and is based on a 1952 opinion that would not hold up in court today. Simmons said he had amended the bill to make clear that the bill was addressed only to materials that defame a group by "false statements or representations," and said these changes would satisfy constitutional requirements.

The bill was prompted, Simmons said, by the rise in racially and religiously motivated incidents reported in Montgomery County and elsewhere. The Montgomery County Human Relations Commission reported 98 such incidents in 1981, and only 25 the year before. The Prince George's Human Relations Commissioner, testifying on another bill, said that the county had experienced a 106 percent rise in such incidents since 1978. Among those testifying in favor of Simmons' bill were representatives of the Maryland B'nai B'rith, the Women's American Organization for Rehabilitation through Training and several individuals.

Joanne Anderson, a representative of the Maryland Human Relations Commission, said she would not address the constitutional qualifications of the bill, but added: "We have 24 political jurisdictions in Maryland, and everyone of them has reported some type of literature of this kind. If this bill would relieve some of that, so be it."

Lastly, Comrade Kerr read quotations by famous American Whites that could theoretically be banned under the proposed legislation, as tending to stir up hatred or ridicule against non-Whites. Abraham Lincoln, Thomas Jefferson and Benjamin Franklin were among the individuals cited.

Membership Dues for 1982

All comrades who have signed up as Associate Members of the World Union of National Socialists over the years should send in their 1982 dues to the General Secretariat as soon as possible, if they have not already done so. The minimum dues amount to U.S. \$30, or the equivalent in any convertible currency, and should be sent in cash in a registered letter. Please use your own currency.

A special circular will be mailed to all Associate Members later this year, containing a report on the development of the organization. Depending on the income, we also plan to prepare an introductory brochure about WUNS.

It should be stressed here, however, that Associate Membership is open to just about everybody. Associate Membership in the World Union is roughly equivalent to Official Supportership in the NSWPP. It does not imply a WUNS endorsement of any activities carried out by the individual nor any right for him or her to speak on behalf of the organization. Associate Membership is a personal affair which does not affect the relationship between WUNS and other organizations. No membership cards are issued, but all Associate Members receive a receipt upon payment of their dues. Membership receipts issued for 1981 expire on 1 October 1982, and no one is considered an Associate Member who has not renewed his membership by that date. Nobody without a receipt can claim Associate Membership in the World Union — and nobody should brag about their membership, whether he has a receipt or not. It does not concern anybody else that you support the work of the World Union of National Socialists.

The WUNS application forms for Associate Membership are somewhat inadequate, as they are aimed at a closer association than WUNS can be at this time and as we realize that there is no way to enforce the pledge of unconditional loyalty given there. The forms will be used, however, until they can be replaced by new ones.

Full Membership in the World Union can only be granted by the Commander; there is no way you can apply for it.

Special Note to North American WUNS Members

Effective from January, 1982, handling of North American Associate Members has been transferred to the General Secretariat. A good many North American comrades have signed up as AM over the years, although they have never

been charged any special amount for this membership, as the fulfillment of their requirements towards the NSWPP has been considered enough. As Associate Membership has mainly a supportive function, there is little sense in this arrangement.

For this reason, we hereby cancel all Associate Memberships for comrades permanently residing in Canada and the United States of America, including Alaska and Hawaii, but excluding Puerto Rico and other American territories.

These memberships are cancelled *without prejudice*, and Members and supporters of the NSWPP who want to give *extra* support to our international work — *over and above what they are giving in the form of dues and pledges to the NSWPP* — should write to the General Secretariat and *renew* their membership, enclosing the dues for 1982, which amount to U.S. \$30 or Canadian \$37.

Special Fund-Raising Effort Launched by Irish Comrades

Our Irish comrades of the Federation of Irish National Socialists have launched a special fund-raising appeal to support the World Union of National Socialists. On top of the usual collections, a comrade got a list of people who would sponsor him in the Dublin City marathon of over 26 miles. The comrade completed the race and raised 76 Irish pounds for the Movement.

The Irish comrades have also contributed substantially to the NSWPP effort to survive a massive financial assault by the IRS.

Despite heavy pressure from the Anti-Defamation League, the National Association for the Advancement of Colored People and similar organizations of their ilk, the bill was ultimately defeated. A prime consideration in the defeat was a statement issued by the Maryland state attorney declaring that in the opinion of his office the bill was blatantly unconstitutional, and that even if it were passed, it would be overturned by the U.S. Supreme Court. (The Party had previously announced that it would challenge the bill if it were made into law, and that it was willing to fight the matter all the way to the Supreme Court, if necessary.)

A number of other bills aimed at stifling the Movement were also presented before the judiciary the day Comrade Kerr testified.

- One bill called for making the “defacement” of public or private property with a Swastika a felony. Thus, conceivably, putting up Party stickers would fall into the same criminal classification as murder, rape, kidnapping and armed robbery.
- Another bill, supposedly aimed at “ethnic terrorism,” would have automatically made any criminal act — no matter how minor — a felony, if it could be proven that it was committed with any sort of racial hostility.

These and other measures introduced throughout the country — some of which have been made into law — are part of an ongoing campaign initiated by the Jews and Judeophile gentile politicians to ban the Movement in stages. In other countries (such as Great Britain and Canada), they have been able to curtail the

operations of the racist movement nationwide in one fell swoop. However, in the U.S., because of the First Amendment, they have been forced to adopt the tactic of attempting to outlaw the Movement a little bit at a time, and limiting their efforts to specific states and cities where they can muster the most support.

We will keep the readers of the NS BULLETIN informed on the progress of this insidious campaign.

Minneapolis Comrades 'Inflict Abuse Upon the Human Race'

The Richard Biederman Unit reports that it conducted a special mailing of the leaflet “Three Jewish Contributions to Western Civilization” in March. The mailing was sent to groups professing opposition to the nuclear arms build-up.

In response to the mailing, the unit received a letter from one Arthur A. Rouner, Jr., of the Colonial Church of Edina (which frequently holds “interfaith services” with local synagogues).

Rev. Rouner told the unit that he “reacted with horror” to the anti-Jewish sentiments of the leaflet, adding that “as a Christian and a human being, I profoundly object to the abuse you inflict upon me by such a mailing, and the abuse you inflict upon the human race . . .”

Apparently the good reverend would rather run the risk of being vaporized in an atomic war than offend the sensibilities of his Jewish friends by confronting the truth of the issue.
