### 'HUMAN RIGHTS FOR RUDOLF HESS!'

East Coast comrades on 12 May demonstrated in Lafayette Park in Washington opposite the White House with a huge banner visible from Ronald Reagan's bedroom window demanding "HUMAN RIGHTS FOR RUDOLF HESS!" Although tens of thousands of persons—notably tourists—witnessed the demonstration, the media kept a tight lid of silence over the entire event.

For their part, White House officials refused to meet with representatives of the NEW ORDER to discuss the plight of the Prisoner of Peace, who turned 90 on 26 April.

Each day that Hess remains in prison, meanwhile, stands as a continuing indictment of the foul and vicious system which holds him, just as he himself remains a living symbol of loyalty and steadfastness for every National Socialist.

### COMMANDER ON OHIO RADIO

On 1 May, Commander Koehl was heard on the Stacey Taylor Show over WING Radio from Dayton, Ohio. In his remarks, the Commander described the NEW ORDER and its program for a better America and a better world. During the call-in portion of the program, the switchboard was jammed, and the Commander had an opportunity to dispose of many of the standard misperceptions concerning the National Socialist movement.

### WUNS SECRETARY INTERVIEWED ON PUBLIC RADIO

The General Secretary of the World Union of National Socialists, Povl Riis-Knudsen, was heard throughout the United States in a special interview carried by National Public Radio on 12 May. The interview, which was broadcast over affiliate stations in most major cities, was transmitted through the facilities of the BBC in England.

Earlier, on 7 April, Comrade Riis-Knudsen presided over the first national convention of National Socialists in Denmark since 1945.

### GERMAN PRISONERS ORGANIZE 'FREE RUDOLF HESS' COMMITTEE

Prisoners at the Butzbach Federal Prison in West Germany organized a Freedom for Rudolf Hess Committee in April. Comprised of 15 members—six Germans and nine foreigners—the committee demanded the immediate release of the Prisoner of Peace.

A spokesman for the group informed prison authorities about the development and requested a meeting of the signatories and a press conference. On 12 April the director of the prison turned down the request with the excuse: "Refusal of the proposed measure

# A STATEMENT

## to the National Convention of the Danish National Socialist Movement

National Socialist Comrades:

On this special occasion of your first national convention, I extend to you my personal greeting, as well as the very best wishes of every North American comrade and all comrades of the World Union.

The work you have undertaken in Denmark is a source of immeasurable encouragement and inspiration to us in our efforts here; and I trust that, in turn, an awareness of this outgoing effect of your work will serve as an inspiration to you.

Today we are living in a period of dissolution and chaos following the *Götterdämmerung* of 1945. Our race and the entire world face the most awesome dangers of all time. But we are happy in knowing that these very dangers are for idealistic and aggressive spirits a supreme challenge. For only out of the storms of adversity and danger is there an opportunity for feats of true heroism and greatness.

We are now in the process of entering the second half of human history. Our task is to build a *New Order*, a New Order foretold in the most ancient Northern legends. In this task we are buoyed by the knowledge that we represent the greatest of all causes on this earth. Our cause is not merely one of reaction or reform, but a radical, revolutionary one, with an outlook and a value system totally different from that of a decadent and dying Old Order. At the same time, it is based on a recognition

of the age-old, timeless, immutable laws of Nature—laws which were given conscious form in human affairs by the unique Personality of our age, who is also the founder of our Movement.

In our struggle, we are fortunate in possessing an invaluable asset which no other national or racial movement shares, namely, a *revolutionary tradition* which has been consecrated by the blood sacrifice of hundreds of thousands of the finest heroes and martyrs, including many from your own country—comrades who fought and died for a better world to come.

Should we ever waver, should we ever weaken, should we ever grow discouraged or despair, the undying memory of these comrades must serve to remind us anew of the future and of our duty. They must serve as examples to strengthen our resolve and our commitment. They must serve to inspire us with hope and belief in our ultimate triumph.

Therefore at this time, may an awareness of what you represent be sharpened, may your will and determination be steeled, may your National Socialist faith be deepened, and may the overall solidarity of our great, common Cause be strengthened. I salute each and every one of you in the name of the immortal Leader of our Movement.

# 'To Believe In Adolf Hitler Is to Believe In Victory!'

The other day, while browsing through the NEW ORDER bookstore, I met another White person who had bought a couple of books, and we began a conversation. The gentleman impressed me as being well-read on Race, the Jewish Question, etc. But then he proceeded to shock and amaze me by saying that he could not align himself with a racist organization, because he "abhorred violence" and "we were fighting a lost cause, anyway."

I have run across this pacifist-defeatism before, and I consider it an enemy of the Movement.

Violence, *per se*, is not something to be condoned or condemned. It is simply a part of Nature, and should be accepted as such. From the smallest molecules composing matter to the largest planets and stars; from the simplest insects to the most magnificent creatures of the oceans and jungles, Nature is in a continuous state of struggle, motion and change, frequently resulting in violent collisions and clashes.

The NEW ORDER, of course, seeks only legal means to victory. While Communist take-overs, for example, require terrorism, coercion and subjugation of people, a National Socialist revolution can only come about through the will of the people. At the same time, National Socialists are not squeamish, and we will do what

is necessary to protect the interests of our Folk.

As for "fighting a lost cause," anyone who claims to be a National Socialist (which, in fairness, the gentleman in the bookstore did not), but also claims to be fighting a "lost cause," is stating a contradiction. *To believe in Adolf Hitler is to believe in victory.* The two beliefs are synonymous. A defeatist has somehow missed a major point of the Leader's Message to us. I feel strongly on the matter: Spreading defeatism is tantamount to treason.

I would rather argue my views with a White person who is a dyed-in-the-wool Marxist-Leninist, than argue with a race-conscious defeatist. With the Marxist-Leninist, I enjoy the exhilaration of a good fight (if only verbal), and even a hope of winning him over. But the race-conscious defeatist is himself already defeated, and he will drag you down into the depths of his own gloom and cowardice if you let him. It is best to avoid him like the plague.

Let's get on with the business of fighting for a National Socialist *New Order*, and let the pacifist-defeatists and dainty dilettantes marvel at our victory!

is absolutely necessary for the maintenance of the prison's security and the prevention of serious disturbances."

He went on: "The prison has knowledge that the Freedom for Rudolf Hess Committee was started and carried in principle by one individual who is actually serving time for popular incitement and for offenses [involving use of unconstitutional symbols] and who during his imprisonment exchanges correspondence with persons of National Socialist ideology.

"Furthermore, it is known to this institution that another prisoner, who also calls himself a National Socialist . . . tries, through repeated activities, to bring his glorifying view of National Socialism to other people. He, too, belongs to the committee."

Referred to are Erwin Schonborn and Manfred Roeder, respectively. In its decision, the prison clearly admitted their status as political prisoners. As such, they have been stripped of even those rights and privileges which common criminals enjoy, and placed in *total isolation* where they are currently being subjected to spiritual torture and calculated degradation.

Another prisoner of conscience languishing in West Germany's prisons is Thies Christophersen, the dissident publisher of *Die Bauernschaft*.

Please remember these courageous men, and give them your moral support and encouragement. In writing, always bear in mind that the authorities scrutinize all incoming, as well as outgoing, mail.
