## Rockwell Near W-L High School Nazi Outfit Buys House In Arlington as Party HQ

ARLINGTON — George Lincoln Rockwell has returned to Arlington and intends to establish a headquarters for the American Nazi Party of the World Union of Free Enterprise National Societies.

Rockwell plans to establish the headquarters at 923 N. Randolph St., a three-story frame house near Washington - Lee High School.

He said last night he expected to "motivate" thousands of high school youth into his Nazi movement.

"We're going to agitate like mad," the self-styled Nazi "Commander" said.

Rockwell, 41, is a tall, rugged build Naval Reserve commander who has consciously patterned his recent career on that of the man he most admires, Adolf Hitler.

The intended headquarters is owned by Floyd Fleming of Washington, a long time Rockwell collaborator who was president of the Seaboard White Citizens Council. Fleming and his wife bought the property last Thursday from the Hall Realty Co. for \$15,500.

Mrs. Hall yesterday expressed shock at the use to which Fleming intended to put the property.

Mrs. Hall said she would see her lawyer about the possibility of revoking the sale because of a breach of trust or contract.

FLEMING and his wife Emma, paid \$1500 down on the property, designated as Lots 20 and 21, Block 6, Centre Ballston. Mrs. Hall said there were two mortgages totaling \$20,000 on the property.

Rockwell yesterday asked the county for an occupancy permit to convert the house into the political headquarters of the American Nazi Party. Until now the party has used Arlington P.O. Box 1381 as a return address on the thousands of anti-Jewish handbills with which Rockwell and his Nazi "troopers" have advertised Fleming's Washington, and the Maryland and Virginia, suburbs.

Also associated with the venture is James K. Warner, who like Morgan and Fleming was with Rockwell last spring when his "National Committee" headquarters at 6512 Williamsburg Boulevard was thriving.

The Nazi headquarters was the center of much disturbance in the Williamsburg neighborhood. Rockwell and his brown-shirted, side-arms-bearing "troopers" passed literature to hundreds of teenagers from area schools, hung out swastikas and created a display of a huge red-floodlighted Nazi banner in the living room.

Neighborhood residents complained and teenagers gathered several times, some to hurt eggs or rocks, a few to enter the Nazi den, but most to watch the spectacle.

The Williamsburg boulevard Nazi nest was scattered out after a grand jury cited Rockwell as a "public nuisance," police raided the place and confiscated most of the Nazi paraphernalia as evidence, and a former wealthy backer finally won a legal battle to oust Rockwell from the premises and regain a photo-offset printing plant in the basement.

AFTER prolonged legal skirmishes during which Rockwell roamed from one Northern Virginia locale to another, Circuit Judge William D. Medley finally concluded there was insufficient evidence for the grand jury citation and the case was dismissed.

Rockwell, a professional printer and illustrator, would not disclose where he has printed his handbills since losing the press. The new headquarters is zoned "commercial" and could house a printing operation.

Rockwell said he had found a new "fatcat," his term for a source of money, in fact he had two — "Fleming and a really big one, who doesn't want to be known."

Rockwell and Warner have already taken possession of the Randolph street house. Last night Rockwell held a "indoctrination" session there for three youths who had just finished helping him drape a huge Nazi battle flag across a wall — the swastika banner "troopers" must attend with a droplet of their blood when they join the movement.

SOME WORE swastika armbands. There were at least four guns in the pine-paneled rooms, a .32 caliber machine rifle, a shotgun, and 45 and .35 caliber automatic pistols.

Rockwell said all the weapons were registered but acknowledged he held no permit to carry a concealed weapon on the streets. One youth played dilly with a pencil made to fire tear gas cartridges.

a vacant brush-covered field "where the mobs can gather — and there'll be mobs when we get going," he said.

In the rear is a large yard where his "troopers" can drill he said.

BEST OF ALL, Rockwell pointed out, the house is two blocks from Washington-Lee High School, where he plans to recruit followers.

He said he will invite high school youths into the headquarters, distribute anti-Jewish literature, and conduct regular discussion and indoctrination sessions.

The house will also be editorial headquarters for a global Hitlerian magazine, the "International Nazi," Rockwell said. He said he has already established links with Hitlerian elements in several countries, including England, France, Sweden, and Germany.

He refused to name his German contacts but said they were the "real" Nazis behind the "neo-Nazi" German Reich's Party.

At least one German anti-semitic in touch with Rockwell's movement is known to live in Berlin. American and German authorities are now investigating his activities and his possible connection to anti-Jewish vandalism in Germany.

AS FOR recent swastika daubings in this country, Rockwell proudly took "moral responsibility."

He said his actions and literature have played a part in arousing anti-Jewish elements. "I despise the average some of them chose," he said. "I would not permit my troopers to paint swastikas on synagogues or churches."

"Some of my younger boys might — the ones I won't let join the party — but I don't approve," he said. "It's not necessary here. It is in Europe, where there's no other way."

Arlington Commonwealth's Attorney William J. Hassan, who raided Rockwell's first headquarters last night, "if there is any violation of law, he will be prosecuted."

BEFORE the county issues an occupancy permit a property must be inspected and approved by zoning officials.

## FIASCO FOR A FUEHRER

Lincoln Rockwell, suburban Hitler, had a new gimmick to sell his line of hate. But the youth of Arlington, Virginia, weren't buying...

A PASSEBY saw it first. He couldn't believe his eyes. But through the rain and the shadows of a mid-March night, he could see it clearly in the bright red beam of a floodlight. A swastika! It hung in the living room of the neat brick house fully visible through the open windows and front door. There was no mistaking the huge Nazi battle flag — the black *heckenkreuz* in the circle of white on a crimson field. Set into the center of the swastika was a bronze bas-relief of Hitler. Beneath it burned three candles — a veritable shrine to Nazism right in the middle of quiet Williamsburg Boulevard in Arlington County, Va., suburb of the nation's capital.

As the passerby stopped to stare, a tall, muscular man in a trenchcoat came to the door, saluted Nazi style and yelled: "Heil!"

The passerby ran to phone the police. The police came to take a look and, as rather cleared, people strolled drove by 6512 Williamsburg Boulevard to observe the latest shenanigans of its less popular citizens — anti-Semitic pamphlets and swastika

swastika against his slate-black roof. When the shocked and curious lingered, Rockwell and his uniformed "troopers" — about a dozen all told — appeared. They wore Nazi-style brown shirts, swastika armbands and had holstered revolvers at their belts. The revolvers were perfectly legal as long as the boys were inside the house grounds.

The curious came to see — mainly teenagers, exactly as Rockwell had planned. He invited them in, handed out packets of anti-Jewish tracts, carried on disarming "man-to-man" question and answer sessions. More came, attracted by the storm-troop regalia, the guns, the dramatic brutality of the performance put on by Rockwell and company. Rockwell was pleased with himself.

"When I was in the advertising game," he said, "we used to use nude women. Now I use the *heckenkreuz* and storm troopers. You use what brings them in."

The town authorities conceded he was "bringing them in" all right — as many as a hundred a day — and they worried about the effect on their teenagers. After one visit, a youngster said: "He's very subtle. He can

not to let them gang up and get into trouble with Rockwell's gun-boys."

Washington area newspapers understood that one of Rockwell's objectives was to attract attention and publicity. They played down the events on Williamsburg Boulevard. Rockwell, angry over the publicity denied him, telephoned newspaper editors to complain of being quarantined and to demand coverage.

Perhaps the newspaper "dim-out" itself added to the problem. Outraged citizens who were informed of Rockwell's bid for youth support and resulting disturbances feared the authorities were either unaware of the threat or were doing little about it.

## 'Nazi' Free, Lauds Court Dismissal

ARLINGTON — Public nuisance and disorderly conduct charges against self-styled Nazi leader George Lincoln Rockwell were dismissed yesterday by Circuit Court Judge William D. Medley.

## Jewish Council Urges Ban on 'Hate' Parties

CHICAGO, Jan. 11 (AP)—The Midwest Jewish Council, in the midst of widespread denunciations of Jewish synagogues, yesterday urged Federal legislation to outlaw anti-Semitic and anti-American movements.

In a resolution the council specifically urged that Congress outlaw what it termed the American Nazi Party led by George Lincoln Rockwell, a printer of anti-Semitic literature, who lives in Fairfax, Va.

The council, which represents Jewish fraternal, social and welfare organizations, also voted to seek the support of the Greater Federation of Churches, labor organizations and civic groups to fight what it called the "spreading hate campaign."

## Gentiles Fight Back

The white people of these United States are waking up. They are beginning to defend themselves from persecution from the minorities. They are fighting back! People in the North who never knew race prejudice before — are beginning to hate the Negroes and are organizing against them to save their communities and their schools. In Washington, D. C. and New York and Chicago—the various movements are snowballing.

Jews are responsible for this race-mixing project and they have brought down upon themselves the wrath of the great Anglo-Saxon peoples all over the world. Hitler could not win because he left God out, they reason, and with God on their side, they shall not lose!

Patriotic Jews are not without blame in this upcoming anti-semitic crusade. They could have helped to prevent it by scorning their devilish leaders and urging them to stop the persecution of other peoples. Many Jews have done just this, and they should be commended for it.

As swastikas fly in Washington and Germany — as well as in New York, Chicago, Jews are beginning to quiver. They should. They asked for it—and they will just have to take the consequences.

It may be too late for the Zionist Jews to repent and save their hides. We hope it isn't. In the meanwhile, it would be wise for them to cease their war on the white people in the South and drop the fight to destroy the Bible, the Christmas celebration, and Christianity itself.

We Southerners don't give a damned what the Jews worship or believe in or how they conduct their synagogues. We don't object to their demands for all Jewish communities. In fact, we'd rather they would stay on their side of the tracks, any-how. But we won't stand idly by and let them destroy, modify, limit or restrict our Christianity.

The Jews who own and control the Senators, Congressmen and Supreme Court Justices have reason to be alarmed at the growing hatred against them. These puppets themselves should also be alarmed for their end may be in sight.

## Navy Acts to Oust Nazi Reservist

WASHINGTON, Jan. 15 (AP)—The Navy disclosed today that steps had been taken to discharge George Lincoln Rockwell, self-styled Nazi, as a commander in the Naval Reserve.

Mr. Rockwell, who recently applied for a permit to open a headquarters for his American Nazi party in Arlington, Va., was a naval aviator in World War II and the Korean conflict.

The Navy said an official letter had been sent to Mr. Rockwell informing him that his "mobilization potential has been reduced to a point where he is of no further value to the Navy."

He was told that he had a month in which to appear before a special board in Washington or submit a written statement of his position. He has the alternative of resigning his commission.

## Navy Hears 'Nazi's' Plea On Discharge

WASHINGTON — The Navy is expected to announce by next week its ruling in the discharge proceedings against George Lincoln Rockwell, Arlington's self-styled Nazi "commander" who is a commander in the Naval Reserve.

Rockwell, who appeared before a board of four naval officers yesterday to challenge the discharge move, said he read a

statement to the board.

ROCKWELL said he produced two witnesses to support his protest, J. V. Kenneth Morgan, who Rockwell called his "deputy commander on the subject of Negroes," and Benjamin Friedman, of New York, a "good Jew." Friedman is known as a writer and publisher of anti-Jewish material.

The Navy declined to discuss the proceedings but said it would issue a final ruling before the middle of next week, after the decision has been reviewed.

The officers on the board were Capt. John S. Fahey, USN, Capt. E. A. Parker, USNR, Cmdr. R. T. Kiehl, USNR, and Lt. Cmdr. W. L. Mumma, USN, who was the recorder.

## 'Gas Chamber' Pamphlets Flood Capitol

WASHINGTON (PO)—Anti-Semitic propaganda threatening American Jews with the "gas chamber" continued to flood the nation's capital with Anti-Defamation League officials seemingly powerless to do anything about it.

ADL OFFICIALS termed the leaflet, "the most vicious and insulting seen in many a day."

Behind the new drive is an old anti-Semitic peddler, George Lincoln Rockwell, of nearby Arlington, Va. Rockwell called for enlistment of American Nazis to fight the Jews.

REPRESENTATIONS by Herman Edelsberg, ADL director here, to capital authorities were turned down on the basis of "free speech." Edelsberg was also rebuffed by the N.S. Navy where Rockwell holds an officer's rank in the U.S. Naval Reserve.

District ordinances technically forbid distribution of leaflets that may precipitate a breach of peace. The Nazi leaflets also requested financial contributions and such solicitation is unlawful without license. But it appeared that the District authorities would not act because of devotion to "free speech" considerations.

Every Saturday afternoon, at precisely 2 PM, we have been arrogantly appearing at the same street corners in the center of Washington, D. C., and handing out broadsides with screaming, red headlines, "WHITE MAN, ARE YOU GOING TO BE RUN OUT OF YOUR NATION'S CAPITOL WITHOUT A FIGHT?" The sheets expose the victimization of both White and Negro races by the Jew-Communist NAACP, preach understanding of the ignorant and innocent Negro tools of the vicious Jew-Communists, and brutally warn the Jewish traitors - (not ALL Jews, as the press pretends) - that we are going to throw them all in the GAS CHAMBERS.... ## The Washington Merry-Go-Round

In the Arlington, Va., phone book, Jackson 4-9831 is listed as the telephone of J. Kenneth Morgan. But if you call that number, a voice at the other end replies "Nazi headquarters."

It's a little startling. But the voice on the other end is delighted to talk about the Nazi party in America, tells you how to get Nazi pamphlets and discusses the strategy of

"Commander" George Lincoln Rockwell, self-appointed head of the Nazi party—who actually turns out to be the voice.

"Our plan," he explains, "is to have our storm troopers hand out literature right downtown in the middle of Washington."

"I told this fellow Drew Pearson," Rockwell continues, "that we're going to throw him into the gas chambers along with the Jews when we take over in 1972."

When the caller told Rock-

well that she might like to cooperate in distributing pamphlets, he called to someone else in the room: "Hey, there, a young woman who would be willing to help us. Won't that be inspiring?"

"You'd be a real inspiration," he continued to the phone caller. "We haven't any women with us."

Rockwell's eagerness to have a new recruit was a giveaway that his movement is not doing so well—which, actually is the case. His neighbors have generally ignored him.

## Rockwell Takes 'Moral' Blame for Swastikas

George Lincoln Rockwell opened a new Arlington headquarters for his American Nazi Party yesterday and announced he accepts "full moral responsibility" for the worldwide outbreak of anti-Jewish crimes.

But, he says, "moral" responsibility is not "direct" responsibility.

"We are responsible, but we haven't done it and if I catch anyone in a swastika-dabbling, I'll turn him in."

"We are going to agitate like mad, distribute literature, make speeches... I'm going to sell my program just like Richard Nixon or anyone else."

Upstairs, however, the new "political headquarters" was forming on the first floor, the Northern Virginia Mental Health Association worked away on its own campaigns.

Mr. Rockwell said he has purchased the entire building and the Mental Health group is paying rent to his American Nazi Party.

He said his new spurt of activity is being financed by an unidentified "fat-cat."

Last year, Mr. Rockwell's old headquarters at 6512 Williamsburg Blvd., now abandoned, was raided on charges of "creating a public nuisance." The charges were dropped later.

He traced moral blame to the indirect effects of the preachings of his party, dedicated to stamping out "traitors, communists and Zionists."

The tall, dark, self-styled Nazi paced up and down the half-furnished first floor of the headquarters at 929 N. Randolph st. yesterday afternoon, all of plans.

## 2 Arrested Scuffling for 'Hate' Tracts

A dispute over the distribution of anti-Jewish and anti-Negro pamphlets on a downtown street corner yesterday ended in the arrest of two men on charges of disorderly conduct.

One was J. V. Kenneth Morgan, 34, of 206 Chingquapia Village, Alexandria, called his "deputy commander" by George Lincoln Rockwell, the self-appointed leader of a new Nazi group in Arlington.

Rockwell was present yesterday but was not arrested.

Charged along with Morgan was Irving Berman, 48, of 831 Villa Ridge rd., Falls Church, an engineer, who had been active in Jewish community affairs.

First Precinct Sgt. John S. Trodden said Rockwell was handing out leaflets at 13th and F sts. nw. when Berman walked up and told him: "I'll take all of them from you." Berman then grabbed a handful, police said.

The pamphlets were described as "abusive literature condemning Negroes and Jews" by First Precinct Pvt. B. A. Gainey, who made the arrests.

An Berman turned away, police said, "Morgan in turn tried to take the stack of leaflets from him."

Both Berman and Morgan posted \$100 collateral for appearance in Municipal Court on Tuesday.
