U. S. Nazi Mobbed, Mayor Bans Rally

 Mayor Wagner yesterday vetoed plans for a rally in Union Square on July 4 by George Lincoln Rockwell and his American Nazi party. A half-hour before the Mayor issued his statement which charged Mr. Rockwell with intent to "incite a riot," a special detail of detectives hustled the self-styled Nazi leader aboard an air liner bound for Washington. The former Navy pilot, who lives in Arlington, Va., was placed in protective custody earlier in the day after he was threatened by an angry mob in the rotunda of the State Supreme Court building. Curses and threats echoed off the marble walls of the court building when Mr. Rockwell attempted to make a statement for television newsmen. Some persons pushed forward and tried to spit upon him while others shouted, "You want to gas all Jews." Police and court attendants quickly hurried Mr. Rockwell to safety in a rear office. Mayor Wagner denied Mr. Rockwell's request for a permit to use Union Square after a fifteen-minute conference with Parks Commissioner Newbold Morris and

other city officials. The Mayor's statement, which he said was also issued in his capacity as the city's chief magistrate, declared: "Information supplied to me by qualified sources shows clearly that Mr. Rockwell's intent is to incite a riot by preaching in a city where people of all races live peacefully together, by preaching a philosophy of race hatred and violence."

Would Be "Stoned"
 "Left to their own devices, the people of the city will stone Rockwell out of town."

"There is not a decent, responsible citizen in the city who would follow him in his preaching. There are millions who have friends and relatives who died because of this race hatred either as unarmed victims or as soldiers fighting for freedom."

"We have in this city the largest and best police force of any municipality. It can quell any riot but no police force in the world can stop a riot from starting. In this case, every fact we have shows Rockwell's presence as a preacher of race hatred will cause a riot the police will have to quell."

"Half Penny Hitler"
 "This is an invitation to riot and disorder from a half-penny Hitler. The invitation is declined. Mr. Rockwell will not speak here on the Fourth of July or any other time in terms of race hatred and race extermination."

Several officials of the Jewish War Veterans who were present, thanked the Mayor and then reported to about seventy-five of their followers outside City Hall on the success of their efforts to bar Rockwell's rally.

When asked later whether his decision was not a violation of free speech, Mr. Wagner said, "I'm taking this position as a man responsible for seeing we have law and order in this town and it is not a question of freedom of speech." He also said he had decided to deny the permit last Monday but delayed the announcement because Commissioner Morris was out of the city.

The mob scene at the Supreme Court building occurred when Mr. Rockwell emerged from a court room where Justice Vincent A. Lupo was hearing legal arguments by attorneys for civic and veterans groups seeking to halt the rally.

"Kill Him"
 Witnesses said a crowd of nearly 100 persons gathered around the spot where the "Nazi" leader was being interviewed by television newsmen. Suddenly a voice shouted, "Throw him out! The crowd became unruly, pressing forward amid the tangle of cameras, lights and television cables. "Kill him!" yelled another voice at the rear of the throng.

At this, a city detective yelled, "Get him out of here." Several plainclothesmen hurried Mr. Rockwell down a corridor and into an office. Justice Lupo ordered him placed in protective custody and twenty policemen later escorted Mr. Rockwell out a side door and into a waiting taxicab.

30 Ask to Be Heard
 The court hearing began with a routine request from Assistant Corporation Counsel Arthur F. K. Hendrikson for an adjournment until Friday or Monday. He pointed out that Parks Commissioner Morris had been away from the city but had an appointment with the Mayor yesterday afternoon to discuss Mr. Rockwell's request for a permit.

The session turned into a hearing automatically when Justice Lupo gave the floor to City Council President Abe Stark, who was one of about thirty attorneys and other persons crowded around the bench. All demanded the right to be heard.

Rockwell Defends Party

When Mr. Rockwell's turn came, he defended the objectives of the American Nazi party and said: "Contrary to newspaper reports we are not trying to exterminate anybody but we are trying to eliminate communism. We want to shock the American people into the awareness of the extreme danger of what is going on."

Mr. Rockwell, a Navy flyer in World War II and the Korean conflict, said there were thirty "troopers" in the movement and that "more are joining every minute." He denied that the American Nazi party is anti-Jewish or anti-Negro but said it stood against "Communist Jews."

Ousted From Navy Reserve

"We feel sorry for the Negroes because they are being used by the Communist Jews," he said.

The Navy announced last February that Mr. Rockwell had been discharged from the Naval Reserve, where he held the rank of commander, because of his "civilian activities." The Justice Department revealed earlier this month that it is investigating the American Nazi party and its leader. The group has not been placed on the Attorney General's subversive list.

Picketed White House

Mr. Rockwell was identified as the leader of eight men dressed in khaki and wearing swastika armbands who picketed the White House on June 11 to protest Israel's detention of Adolf Eichmann, wartime Nazi leader who allegedly planned the extermination of 6,000,000 Jews.

A Parks Department spokesman said the American Nazi party made a written request on May 17 to hold a rally in Union Square on July 4 from 3 to 5 p. m. The Jewish War Veterans two days later asked to use the square for a rally on the Fourth at 2 p. m. There were three other similar requests this month; from the Committee to Protest Racial Defamation, the United Jewish Survivors of Nazi Persecution, and the National Maritime Union of America.

Issue for Parks Dept.

Commissioner Morris had indicated earlier that there were no grounds for denying Mr. Rockwell a permit unless Police Commissioner Stephen P. Kennedy determined that it would be unsafe. Mr. Kennedy replied that the decision to issue the permit rested entirely with the Parks Department but that his department would furnish all the protection required.

With the only public support of Mr. Morris's position coming from the American Civil Liberties Union, the Parks Commissioner was under increasing pressure from various groups and individuals to withhold the permit.

Would Outlaw Party

State Sen. Joseph Zaretzki, Manhattan, Senate minority leader, announced that he would introduce a bill at the next session of the Legislature to outlaw the American Nazi party. He said the bill would be "democratic action in defense of American principles and American lives."

Publicity Is His Life-Blood; Now He's a Man to Watch

GEORGE LINCOLN ROCKWELL got what he came for in New York: nationwide publicity.

As a result, those who have followed his career say that this self-styled leader of "The American Nazi Party" can no longer be written off as a nut or a crank.

His potential as a troublemaker has suddenly expanded; he will now be a man to watch.

What kind of a man is Rockwell?

In the absence of a psychiatric report, it is still clear that any man who goes around talking about deportation of Negroes to Africa and gas chambers for Jews, any man who flaunts Nazi flags on his doorstep, dresses his "storm troopers" in Nazi uniforms and holsters .45s, prints racist leaflets in his home and incites riots in Washington and New York—such a man is, at least, dangerous.

He was already a potential danger two years ago at the time of the racist bombing of the Jewish synagogue in Atlanta. He was never officially linked to that bombing. But police found a letter which he had previously sent to one of the five indicted men. The letter mentioned "a big blast" (picketing, said Rockwell) and declared:

"We are finally beginning to do what we have all so long talked about, mostly thanks to one man—the fat cat—who is putting \$\$\$ where his mouth is . . ."

Rockwell has tied in with a number of racist groups in the past and has usually managed to fall out with them. Some of them won't touch him with a 10-foot pole—not because they don't see eye to eye on his race-hate, but because they consider themselves 100 per cent Americans and they just can't stand his Hitler routine. Hitler was a foreigner.

But Rockwell's Nazi act, preposterous as it has seemed till now, is really a measure of his talents for self-publicity. It has shock value; it irritates, it disturbs, it's audacious. It makes people pay attention in a way they otherwise wouldn't, even if Rockwell were well-financed—and had a large following—which he doesn't. Not yet. (He may have all of a dozen "storm troopers."

He was always publicity conscious. "When I was in the advertising game," he once remarked, "we used to use nude women. Now I use the swastika and storm troopers. You use what brings them in."

Thus, in his Arlington, Va., home, he would exhibit a large Nazi flag visible from his living room, dress his followers in Nazi uniforms, burn candles for Hitler, and have "man-to-man" talks with any kids he could lure into headquarters.

When the kids passed him up and the neighborhood snubbed him and the local newspapers ignored him, he blew his stack and called the papers demanding to know why he wasn't getting coverage. He has also been known to complain about his personal safety in the past. "We've gotten 300 calls from people threatening my life, my wife and even castration of my children," he claimed at the time of the Atlanta bombing.

Having been ignored for a long time, the need for publicity has been his constant goad. He sued Drew Pearson for \$500,000 and told Pearson in a pre-trial deposition: "Your time will come. Nothing will save you from the gas chamber." Rockwell then added, there's a big market for Nazism in Europe today: "There are 20,000 ex-SS men running around Europe and once you get it into your heart, you don't lose it."

Where Rockwell got started on his Nazi binge, how much of it he believes, and how much of it is the old come-on for contributions from bigoted fat cats—that remains Rockwell's business. And with the publicity he's got in New York, business will probably start picking up.

Biographical data on George Lincoln Rockwell is sparse. He appears to be the son of "Old Doc" Rockwell, popular stage and radio comic of the 1920s and 1930s. He is 42, was born in Bloomington, Ill., attended Hebron Academy in Maine, studied at a school of design and was a junior at Brown University when he entered the Navy in World War II. He served as a naval pilot. (He says he also served in the Korean War.)

Early this year, he was discharged from the Naval Reserve for his "Nazi Party" activities. He held a reserve rank of commander.

He has been married twice and has fathered a number of children, but none presently live with him. His second wife, an Icelandic girl, returned home with the children, reportedly under pressure from her family, who are in the Icelandic diplomatic service.

By trade, Rockwell is a printer. He is a capable writer, a competent cartoonist and has a working knowledge of layout and design. He is 6 feet 1, well-built, wavy-haired, dark-faced, an easy talker. He moves from friend's home to friend's home.

Those who have kept close tabs on him do not low-grade his intelligence. He may have been a two-bit demagogue before he came into New York, and he might have stayed that way, talking in an empty street in Union Square on the Fourth of July. But he got what he wanted: publicity about a near-riot. And now George Lincoln Rockwell will be heard from again.

The piece at the left, from the ultra-Jewish New York Post, should bring a whoop of joy from every person who loves America and the White Race, —and hates treason and race-mixing.

In studying this catastrophic fifty years, we discovered that there was plenty of opposition to the Jews from men with money and power, but the Jews were able to smash and humble EVERY one of them by one or more of four methods.

The first and instant reaction of these apostles of "free-speech" and "tolerance" to anybody who's free speech included exposures of Jewish villainy was and is economic terrorism. Men like Henry Ford, who did his best to stand up to the Jews, found themselves cut off from money and credit and hounded out of business until they apologized. Small men with jobs, who try to expose and oppose Jew villainy find themselves and their families without an income as they are hounded off the job anywhere.

The second Jew method for dealing with those who expose their conspiracy is "press black-out", —the "silent treatment". The Jews make use of the business control they have gained over all media of publicity and information to give the impression that the "exposer" does not exist. While meetings and activity of Negroes, Jews, liberals, reds, etc are noisily reported and fulsomely praised or faintly damned, activity of rightists and pro-Americans is utterly ignored until the discouraged patriots get tired of talking to empty seats and quit. This is the basic Jew technique.

The third Jew method for stopping opposition is the "smear". If the opponent is too famous to be ignored, he is blasted into silence by being called names and "linked" to filthy activities, —always just on the borderline of libel. This is the method used by the Jews with Lindbergh, when he put the finger on them, —and also with MacArthur, McCarthy, Father Coughlin and other great American Patriots. Usually, the term "anti-Semite" is enough to do the trick, as it has with the cowardly Russell Maguire, publisher of Mercury Magazine, —but if this is not enough, as it was not with the fighting Father Coughlin, —then they bring the big guns to bear with the accusation that the victim is a "NAZI"! Until our advent, this was always 100% successful.

The number three Jew trick of shouting "NAZIS!" at us, is delightfully useless to them here. We simply and gleefully reply, "You're damned right we are Nazis, and we shall shortly give you Jew traitors the gas chamber like the Rosenbergs!". The result is that the Jews are "dead in the water". They ain't thunk up an answer to THIS one yet.

Finally, the very "terribleness" of our approach and symbols has insured that only the TOUGHEST of YOUNG FIGHTING MEN will join us. The talkers and hobbyists don't last long around here. As a result, the Jew terror is useless to shut us up. It only goads us to finer and sterner efforts.

And with all of this, we are so carefully and scrupulously legal and PRO-American, the Justice Department, the Marine Corps, etc, cannot find any possible way to declare us "subversive". They can't railroad us to prison or the lunatic asylum because we have taught them the lesson over and over that we are not boobs in court, and will make such brutal efforts back-fire on them, —as they have.

We have even managed to SPLIT the Jews so that they are fighting each other, —instead of them being always united, —as they usually are, while WE fight each other, —as we always have. Half of the Jews say "let them speak, or OUR rights to preach race-mixing and communism will be in jeopardy", —while the other half says, "Stop them ANYway at all, —we are half-way to the gas-chamber already! If they speak, they will CONVINCED people, and then we are DONE!"

Both of them are RIGHT!

And that is what the mournful little piece at the left tells the Jews. It says to them: "THIS guy is NOT a crack-pot or a coward or an amateur like all the other ones have been. THIS guy is a professional, intelligent, dedicated and SUCCESSFUL expert in the business of Jew-fighting!"

And that is why good Americans should REJOICE! Forget the symbols, the name, the unimportant things, and see what we are fighting FOR: America, our Constitutional Republic, our White Race and our Christian Culture, —and what we are DESTROYING, —Treason, Race-mixing, and Jew Communism. For the first time in FIFTY years, White American, we have the Jews on the run and confused! Stand with us, and we will "delouse" this great Nation and do what seemed almost impossible a year ago, —give AMERICA back to the AMERICANS!
