It grieves my heart to be forced to write this letter to you. I have no choice. We are in DESPERATE TROUBLE. All of us worked long and hard to get this latest RAISE THE BANNER Action Report to you before the big rally in San Francisco last August 13th. We couldn't mail it, for lack of money for stamps. On the 15th our rent was due. We needed \$225.00, and WE DIDN'T HAVE ONE CENT! Our men in Viet Nam can't fight the Communist enemy when they are deprived of ammunition. Neither can we. OUR ONLY "AMMO" IS THE MONEY YOU SEND US. WE CAN'T FIGHT WHEN WE ARE PENNILESS, AND NOW IS WHEN YOU NEED US TO FIGHT FOR YOU. EVERY NIGHT NEW RACE RIOTS BRING TOTAL RACE WAR, TERROR, ANARCHY, & COMMUNIST REVOLUTION NEARER & NEARER...TO YOU! Your enemies are organized, prepared and trained. Your enemies are financially subsidized. Still our Leadership has given birth to hope, and I promise will bring Victory. Thousands of people are joining the White Guard. We are supporting the re-activation of the Klan in California. Nazi Victories all over the Nation. Now more than ever America needs a strong Nazi Party. Now more than ever we need your strong help. This near depression has hurt us terribly. In the past three months we have just barely got in enough to survive from day to day. This means our total income has been almost nothing. I repeat, almost nothing. I am ashamed to have to admit this. I swear to you, we need every bit of help you, and everyone else who receives this letter, can give, or we will lose this Headquarters.

We have been in desperate situations before, and always there has been a last minute miracle. I expect that Providence will provide us with the best solution to our seemingly hopeless situation. Perhaps you will be the instrument of Destiny that will help save our Headquarters in this special hour. No matter what, do not fail to give. I plead with you, do not fail to give in response to this letter. This Cause will not be destroyed by its enemies, because it is the Eternal All-Father's work. It can be destroyed and betrayed, however, by those who fail to answer this letter or who fail to give support to the sacrificial Christian Patriots who lead this dynamic movement. Christian Patriots behind the Iron Curtain were shot and imprisoned, not because of the strength of the enemy, but because of the neglect of good, respectable people who fail to sense the danger.
