### The Time Seems to Have Come to Put the Rockwell Lunacy on the Subversive Roster

The press and radio of Havana, Moscow, and Communist China are stressing George Lincoln Rockwell's American Nazi movement in anti-American propaganda to such an extent that the State Department and the U. S. Information Agency are concerned. In the guise of fighting Communism, Rockwell has actually provided the Sino-Soviet bloc with a chance for dramatic smear attacks on the United States. Portraying America as "racist" and "Nazi," Communism is exploiting the existence of an American "party" that openly espouses nazism.

Such propaganda exaggerates the size of the tiny Nazi group. It omits the fact that Rockwell and nine of his storm-troopers are now in a New Orleans jail.

The Justice Department is quietly probing Rockwell's anonymous benefactors, his sources of income.



OFFICIALS, MEANWHILE, have renewed consideration of placing the Nazi party on the Attorney General's list of subversive organizations. In their view, such a listing would diminish Rockwell's support, and authorize the Government to deny Federal employment to Nazi adherents.

Liberal groups last year opposed listing the Nazis as subversive on grounds that Rockwell might obtain a hearing that would afford him a chance for some publicity. Now that Rockwell has got worldwide notoriety, a feeling is growing that the previous tactical approach is outdated and ineffective.

Virginia authorities, citing the absence of the Nazis from the official U. S. subversive list, justified issuance of a charter "legalizing" the location in Virginia of the national Nazi headquarters.

The Attorney General's list, deplored by many liberals because of "civil liberties" considerations, exists as a fact of life. Why should the Nazis be afforded immunity? That is the emerging question. The argument about a listing giving Rockwell "publicity" is waning. The "hush-hush" strategy has demonstrably failed because the Nazis have obtained tremendous coverage.

U.S. GOVERNMENT INFORMATION officers told this correspondent that America should immediately list the Nazis as equally subversive as Communists. They said this would be "a blow at racism, and enhance the American image abroad."

Ironically, the West German Government has just revealed a view that the United States has been too soft on the American Nazis—because such coddling has facilitated Communist attacks on N.A.T.O. and Bonn's relations with Washington.

The Adenauer Government this month banned further shipment of Nazi "souvenirs" to Rockwell. Shipments to American Nazis had included storm-troop uniforms, S.S. insignia, ceremonial S. S. daggers, holsters for Luger pistols, and propaganda items including Hitler's "Mein Kampf." Bonn invoked a law prohibiting export of goods "likely to damage the reputation of the Federal German Republic abroad."

American firms, profiting from a lively import trade in Nazi "souvenirs," actually contracted with a firm in Solingen, West Germany, to resume manufacture of S.S. daggers like those of the Nazi regime. German exporters sought Nazi uniforms and trappings to fill the demand from America.

The Communists made clever use of Rockwell's recent foray into the South. Denouncing America for racist outrages in Alabama, Radio Moscow reported on "hooligans with swastika armbands . . . the American Nazi Party."

From Franklin, through Harry and Ike and now John, America and the White Race have been driven steadily down the road to bankruptcy, integration, moral decay, communism and national chaos!

The enemy has gotten too BIG for us. You can't beat his TV, his movies, his magazines and his newspapers with your pamphlets and private "rallies" full of people who already know the score. We have been talking to ourselves for too long, --isolated and ostracized by the enemy's "silent treatment", -his control of the press to insure that no news of opposition to Jewry, and the supporting facts, ever is allowed to be printed. The idea of the Jews is to create an atmosphere of defeat, despair and cold fear. The "Conservatives" who try to fight Communism without mentioning its authors, Jews, CONTRIBUTE to that paralyzing fear by saying, in effect, to the millions who know the truth about the Jews, that even powerful millionaires like Maguire, cannot DARE to fight Jews openly.

Therefore, we set out to use the principle of Jiu Jitsu, --to force the enemy to use his own strength against himself. At the same time, we were determined to prove to Americans that you CAN stand up and DEFY the Jews, -and survive!

By fighting as "NAZIS", under the SWASTIKA, we FORCED the Jews to publicize our defiance and some of our facts in their OWN press, and make the MASSES conscious that there IS organized, successful and all-out opposition to the Jewish terrorists and brain-washers. They could NOT hide NAZIS MARCHING in the streets, and our arrogance and success has nerved up millions of frightened little people all over America to come out from under the bed for the biggest "right wing" resurgence in years, -just as we predicted and planned three years ago.

In spite of the "It-can't-be-done" brigade, we have built an international and a national organization. In a few months, we will utterly smash their morale by marching into their "sacred" red stronghold, Union Square, New York City, backed by the whole power of our government, as the negroes marched into Little Rock High School.

The Communist WORKER has already said "If Rockwell is successful in speaking in Union Square, it will set back the forces of progressivism and integration ten years!" ....and you know what Communists mean by "progressivism"! --and we will be successful!

We have been successful at everything else we have planned. Here is a list of some of the victories we have WON for the White Man, -for YOU and our Christian American Republic:

1. We have DESTROYED the Mental Health Octopus they were readying to get rid of right wing leaders. Since I won my way out of their insane-asylum and courts as an open NAZI preaching the gas-chamber for traitors, it is impossible for them to railroad YOU or others who discover the facts about Jewish treason to the bug-house as a nut. If it is not "nuts" to be a NAZI, it cannot be "nuts" to be anti-Jewish, as they had hoped.

2. Showed the MASSES of people that Jews do not protest anything the Communists do, no matter how un-American and vile, but that they try to kill anybody who points out the Jewish leadership of Communism in spite of their hypocrisy about "free speech".

3. Forced the "liberals" to expose their hypocrisy to the MASSES by demanding our rights as Nazis. If the liberals agree that we do have the right to preach gas-chambers for Jew traitors, (as their doctrines demand), then we spread the facts about the Jews, and can't help winning the people. If they deny our rights, they expose themselves to the people for just what we say they are!

4. Broken the Jew-terror in the streets. In cities from Boston to New Orleans, we have insisted on the rights of the White Christians to speak and picket as well as the Communists, NAACP, CORE, Peace-marchers and other red-front outfits. We have faced their thousands of murderous, screaming Jews and Negroes, and beaten them!!

5. Proved that the courts are basically honest, so that we can win back and maintain our White Christian American Republic legally. Even with a Jew police head, Jew D.A., Jew judge, Jew warden and Negro guards in the prison, we WON in the Jew-ridden city of Philadelphia, as we have won in all other cities. We have to spend time in jail, get some beatings and lose a lot of bail money, but the courts stand up for us every time in the long run, and the policemen and FBI see what is going on, so are mostly with us, personally.

6. Won over the YOUTH! Most other right-wing gatherings look like convocations of the class of 1885. But hundreds of young Americans come to us to FIGHT, for adventure! The LAST thing we can expect is that masses of fighting YOUNG men will be attracted by stodgy "conservatism" and stories about taxes and economics. They cannot resist the danger and challenge of the Nazi party.

7. Proved that there is a SOLUTION to the Negro problem, other than murder or civil war. Only the blind will not see that "Segregation" is dead and cannot be revived with today's educated and aggressive Negroes. But millions of Negroes have shown that they will not only accept, but are eager for SEPARATION, as Elijah Muhammed's huge and growing following proves. Only the American NAZI Party can WIN the col-

ored masses from the Jews who now use them as a battering ram against us, and get them out of our schools, cities, towns, restaurants, etc, at the same time!

8. Gotten rid of the highest Soviet spy ever found in America. I turned in the facts on Valentin Ivanof, first secretary of the Soviet Embassy in D. C., to the FBI. But nothing happened, as with so many FBI reports which are just filed, until I got an honest reporter to publish the story. It hit national headlines, and the Soviet spy was on his way to Russia the next morning.

9. We have made it legal and respectable to be a NAZI! We have fought for and won all licences necessary to run a bona fide political headquarters in Arlington County. We have fought for and won a CHARTER from the Commonwealth of Virginia, and have even established a bank account in the Party's name, and are taking an advertisement in the telephone-book yellow pages!


