TEN MINUTES' drive from the White House across the Potomac river is the headquarters of the American Nazi Party and its commander, the man on the right, George Lincoln Rockwell. He claims 1,500 followers, mostly college boys and girls. More important, he says his movement has links with Fascist groups in Germany, Sweden, Britain, Australia, the Argentine and many other countries. Is there, in 1960, any international link-up behind the recent outbreaks of Fascism? The Express foreign service has carried out this investigation:—

**THE FOUNTAINHEAD** of post-war Nazism in Germany. There Fascist ideology has managed to survive defeat, world-wide hatred, and de-Nazification.

**COLIN LAWSON** reports from **BONN:**

THERE are 30 or 40 neo-Nazi parties here, which publish dozens of weekly and monthly magazines and papers. These are some of the men behind them:—

of the new Nazis. They include Generals Karl Wolff, "Panzer" Meyer, and the notorious Sepp Dietrich.

Intelligence officials believe that amalgamation between these movements is being planned.

THE GERMAN Fascists have links with Fascists in many

other countries in Europe. One clue led from Germany to Italy....

**ROBIN STAFFORD** reports from **ROME:**

A TOP member of the Italian Fascist-type revival told me last night that there is a kind of Fascist International in most European countries known as the European New Order, dedicated to making Europe a pan-Fascist area.

He is dark, wiry, 30-year-old Nino Capotondi, captured by the British in Italy when he was fighting with a Blackshirt regiment at the age of 15.

He travels to Germany to meet liaison men of the New Order group.

The Fascist groups in Italy had 1,500,000 votes at the last

election. Capotondi's group cannot officially proclaim itself a pure Fascist party because of Italian law.

Like the pre-war Nazis, they have "study groups," "sports meetings," and other assemblies.

THE Italian group keeps in contact with foreign Fascists as far afield as the Argentine....

**JACK COMBEN** reports from

**BUENOS AIRES:**

TWENTY miles outside Buenos Aires, in the riverside suburb of Tigre, there is an old house which headquarters the Ruderklub Teutonia (Teutonic Rowing Club). Besides being a rowing club it is also the Argentine headquarters of the neo-Nazis among the 500,000 Germans here.

Every week-end German youths aged 18-28 attend lectures extolling the virtues of Nazism. All are pledged to serve the interests of the Fascist International.

The club is run by Heinrich Wirt, son of the German-Argentine General Wirt. The Nazi set-up in the Argentine was organised after the war by Nazi Professor Johannes von Leers, now in Cairo.

Reports from Cairo say that veteran Nazi propaganda official von Leers lives in the Cairo suburb of Meadi and heads a group of former ex-Nazi exiles in Egypt.

BACK ACROSS the Atlantic to France....

**WILLIAM HAMSHER** reports from **PARIS:**

ONE of the main Fascist-type movements in France is that led by Charles Luca, a

publisher in his late thirties. His party is the 'French Socials Party' which claims links with neo-Nazi movements in Germany, Spain, Belgium, and Scandinavia. It has a membership of about 20,000.

Luca describes himself as secretary-general of the French section of the European Movement. This is the thinking branch of international Fascism. Luca is a nephew of Marcel Deat, the Nazi-saluting Frenchman who stood high in State councils when Hitler occupied France.

**VIENNA:**

AUSTRIA'S State Police think that the recent wave of neo-Fascism is directed by some international organisation with headquarters in Scandinavia—particularly Sweden.

**CHRISTOPHER WOLLIN** reports from **STOCKHOLM:**

THERE are nine neo-Fascist movements in Sweden. Most members are young. Average age is about 24.

The centre of these activities is the town of Malmoe, where the neo-Fascist organisation

### Never Forget What Hitler Meant

WASHINGTON — The mess that the world is in currently is stimulating, I am afraid, some rather musty thinking. There are those who openly or covertly are suggesting that all would have been better in this vale of tears if we had let the unlamented late Herr Adolf Hitler beat the Russians.

Not so long ago, I listened to a TV panel discussion in which some generals were reminiscing about the war and although none of them came right out and said so, the implication of what they said left the unmistakable impression that the West had made a mistake in backing the Russians against the German madman.

The newspaper columnist, Inez Robb, recently wrote a column about the anti-Semitic outrages in Germany and elsewhere and went on to suggest that maybe American children as well as Germans should be taught some of the facts of life about Hitler. Her suggestion was greeted with hoarse outcries of rage from certain quarters which in bombarding her with protests raised the question: "Why pick on Hitler?"

WHY INDEED? It may be well to remind ourselves on occasion that for ruthless, pre-conceived, planned, methodical, dedicated and inhuman slaughter Hitler probably stands without a peer in the history of mankind. The saddest of commentaries about the times in which we live is that his only possible rival for the crown of prime butcher is Josef Stalin — and even Stalin might be hard-put to press his claim against Hitler's outstanding credentials for the title of King of Murders.

Those who maintain — and there are increasingly more of them — that this world would have been a better place if the Nazis rather than the Grand Alliance had triumphed in World War II are simply wallowing in a cloud of historical opium. Any rational, thinking person can only shudder at what might have happened had Der Fuehrer crushed his adversaries.

For the Russians it would have resulted in the greatest bloodletting of all times, for Hitler was not the sort of man who would show mercy to fallen opponents.

For the continental Europeans it would have meant the abandonment of all hope for freedom and the establishment of permanent puppet governments as corrupt as they would be harsh, as brutal as they would be immoral.

FOR GREAT Britain and the United States, such a victory would have meant either ultimate capitulation to the Nazi forces now dominating the land mass from the North Sea to the China Sea, or at best a long and weary struggle which would inevitably have taken the form of all-out nuclear war.

The triumph of Hitler would have been a triumph for the concentration camp, for the gas chamber, for all of those loathsome individuals who cherish power above justice and irrational persecution above charity.

Let there be no mistake about it. The world would not have been a better place if Hitler had won. It would have been a whole lot worse off. American children when they are being taught why the United States entered and fought World War II ought to be told just that.

The world may not be any Garden of Eden today, but it is a far, far better place than if Adolf Hitler and his bunch of paid exterminators held sway over any part or all of the globe.

On Learning to Live With Our Nazis

TWO MEN were arrested recently after a dispute at 13th and F sts. nw. One of the men was passing out hate literature for the neo-Nazi group of which George Lincoln Rockwell is the self-appointed leader.

The other man tried to stop the distribution. As you know, my sympathies are with the man who wanted to halt the spread of poisonous doctrines. But I wish he had chosen some other way to do it.

Most of us are opposed to Nazis and other extremists. We wish they would go away and stop trying to make us over in their image. Sometimes they irritate us to the point that we're tempted to take action. But we should make sure it's action that's consistent with our principles.

Those who are the specific targets of bigoted attacks have a special responsibility not to let themselves be goaded into unseemly conduct. One who is provoked into dealing with Nazis and

Communists on their own terms permits the bully boys to drag him down to their level.

So long as our Nazi and Communist neighbors remain within the law, they have a right to speak and write as they choose. If they violate the law, they should be brought to book through due process, not by direct action.

It is true that when we permit them to speak freely we run the risk that their poison will have some effect upon the young, the emotional, and the naive among us. The proper antidote is a resolute demonstration that we really believe in free speech, and in the right to disagree which is inherent in it.

We have faith in the principles set forth in our Constitution, and we are prepared to live by them. In any competition between Americanism and totalitarianism, we know that American principles will win out, and emerge stronger than ever for having been put to the test.

This week we will celebrate the birthday of one of the men who helped shape our views about freedom, and about the inherent dignity of every human being. I can't help wondering what Abraham Lincoln would have thought about George Lincoln Rockwell.

As you will see on the other side of this sheet, the Jews in the DC area, —the only place so far they have had to admit we exist, are getting desperate and hysterical as we expose them for the hate-filled conspirators and terrorists so many of them are. MILLIONS of Americans are beginning to say "Hitler was RIGHT!" as a direct result of our efforts, and the Communist-Zionist Jews are SCARED!!! # Hate Tracts Immune Says Ruling

Corporation Counsel Chester H. Gray told the District Commissioners yesterday that they are not empowered to halt distribution of "hate literature" on downtown streets unless the distribution shows signs of causing public disorder.

The question was raised after members of George Lincoln Rockwell's American Nazi party began handing out pamphlets attacking Negroes and Jews.

Gray said that while the Nazi literature is offensive, insulting and abusive it is not obscene and does not violate District libel laws.

Metropolitan police were instructed not to interfere with the peaceful distribution of the pamphlets unless they could see a clear and present threat to public disorder.

# Jewish Lawyer Defends Virginian Accused of Anti-Semitic Activities

At a United States Attorney's hearing yesterday, a Jewish lawyer defended the right of George Lincoln Rockwell's American Nazi Party to distribute anti-Jewish handbills in downtown Washington. The lawyer, David Israel Shapiro, was assigned the case by the American Civil Liberties Union and served without fee.

Shapiro said he took the case because of his concern about an individual's right under the Constitution to distribute literature.

"I believe in that right, no matter how strongly I might disagree with the contents of the literature," Shapiro said.

"And as distasteful as I found the literature in this case, I find even more distasteful any attempt to prevent its distribution."

Shapiro agreed to take the case after ACLU director Lawrence Spicer told him the defendant could not find another

lawyer. Spicer accompanied Shapiro to the hearing.

Shapiro represented Nazi Party Deputy Commander J. V. Kenneth Morgan, 34, of 296 Chinquapin Village, Alexandria. Morgan was arrested Saturday at 13th and F sts. n.w. after a scuffle with Irving Berman, 48, of Falls Church. Both men were charged with disorderly conduct and posted \$100 collateral.

Police said Berman grabbed a stack of pamphlets from Nazi Party Commander Rockwell and a scuffle developed between Berman and Morgan. Rockwell took no part, police said.

While Shapiro was in the hearing defending Morgan yesterday, Rockwell was outside in the hall explaining that his party believes about 90 per cent of American Jews will have to be thrown into gas chambers.

Rockwell testified after Morgan. When they emerged from the hearing, Morgan said, "I believe that fellow Shapiro is really giving a good fight for us."

"He certainly is," Rockwell said. "And I've got unbounded

respect for Berman, too. Indeed I do. We respect his guts. He's got plenty of money and he could have hired someone to do it, but he came right up to us himself. He attacked the Nazi Party."

Assistant United States Attorney William W. Greenhalgh, after conferring with United States Attorney Oliver Gasch, postponed a decision on whether additional charges should be placed against either Morgan or Berman, Assistant Corporation Counsel Clark King scheduled a hearing Feb. 18 on the disorderly charges.

As Rockwell and Shapiro parted at the courthouse door, Rockwell raised his arm and said "Selg Heil!"

Berman, a civil engineer and builder, said he did not think the Constitution guaranteed the right to advocate putting men in gas chambers.

He said he was shocked and dumbfounded when he found the American Civil Liberties Union representing Morgan. He said, however, that he still has great respect for the ACLU.

# 2 Arrested Scuffling for 'Hate' Tracts

A dispute over the distribution of anti-Jewish and anti-Negro pamphlets on a downtown street corner yesterday ended in the arrest of two men on charges of disorderly conduct.

One was J. V. Kenneth Morgan, 34, of 296 Chinquapin Village, Alexandria, called his "deputy commander" by George Lincoln Rockwell, the self-appointed leader of a neo-Nazi group in Arlington.

Rockwell was present yesterday but was not arrested.

Charged along with Morgan was Irving Berman, 48, of 831 Villa Ridge rd., Falls Church, an engineer, who had been active in Jewish community affairs.

First Precinct Sgt. John S. Trodden said Rockwell was handing out leaflets at 13th and F sts. n.w. when Berman walked up and told him: "I'll take all of them from you." Berman then grabbed a handful, police said.

The pamphlets were described as "abusive literature condemning Negroes and Jews" by First Precinct Pvt. B. A. Gainey, who made the arrests.

As Berman turned away, police said, "Morgan in turn tried to take the stack of leaflets from him."

Both Berman and Morgan posted \$100 collateral for appearance in Municipal Court on Tuesday.

## Sieg Heil!

The fracas which developed downtown the other day over George Lincoln Rockwell's distribution of some scurrilous handbills was perhaps inevitable. Rockwell is the self-styled fuhrer of the American Nazi Party. The handbills defamed Negroes and Jews with unbridled viciousness. Not surprisingly they incensed a passerby named Irving Berman who tried to take a pile of them away from Rockwell. A scuffle ensued between Berman and a Rockwell henchman named Morgan. Police arrested Berman and Morgan, charging both with disorderly conduct.

So far as Berman's conduct is concerned, it will certainly have, and deserve, the sympathy of most Americans. Nevertheless, it entailed a breach of the peace for which the police were justified in arresting him. Although the provocation was very great indeed, he should not have used force to combat lunacy.

Morgan asserts that he was merely defending Rockwell and his handbills, a task which should have been left to the police. But because of the possibility that the charge of disorderly conduct lodged against him was inspired by the inflam-

matory contents of the literature, the American Civil Liberties Union offered him legal aid. The ACLU is, of course, championing not Rockwell or Morgan or their ugly ideas but simply their constitutional right to express ideas, however odious.

Handbills such as Rockwell's present a real danger of fomenting disorder. The theory of the First Amendment, as we understand it, is that it is, on the whole, safer for society to face that danger than to embrace the danger that would arise from the suppression of obnoxious utterances. The police can deal with disorderly conduct and can protect the community from its consequences. But a society cannot be genuinely self-governing if the clash of conflicting views which is the dynamo of the democratic process is dampened by police interference.

There was no clear and present danger in this situation that Rockwell's opinions would give rise to an evil which the forces of law and order could not readily control. The plain business of the police was, we think, to protect him in the exercise of a constitutional right. It is true that the Supreme Court in the *Beauharnais* case in 1952 upheld by a 5-4 split an Illinois statute prohibiting group libel; and the language of abuse employed by *Beauharnais* was far milder than that employed here by Rockwell. But the District of Columbia has no group libel statute. It is far better, and safer, we believe, to rely, as an antidote for poisonous ideas, upon counter-argument and upon the good health and good sense of the American people.

Most patriots are familiar with the Communist-aiding American Civil Liberties Union, and its termite-like work on our Constitution and Security. But even this nasty machinery can be made to grind up its own perpetrators by sufficiently RADICAL opposition tactics. For FORTY years the ACIU has been battling for the "rights" of Communists to destroy America and the White Race, with only a minor excursion into the other side of the fight now and then to keep the game from getting TOO obvious. When we demand protection for OUR rights to attack the usurpers and traitors themselves, the manipulators are not only put on the horns of a dilemma, -but they are actually are tempted to "use" us to show their absolute "neutrality" and utter dedication only to the PRINCIPLE of free speech, etc. -which is what they are doing now. But meanwhile, we are also using THEM, -because we are no good to them without PUBLICITY for their noble "neutrality", and the pinko Washington Post dutifully editorializes in a lofty and noble manner, of course, on the subject. Not only do we get excellent free legal aid, make a slam-bang fight for the Party, -but we also continue to FORCE publicizing of our fight for America and the White Race. We, too, can be ruthless and arrogant!

On this page is the "first robin of spring" for the American people, -the first sure sign that we have BROKEN THROUGH the rotten Jewish "paper-curtain" known to every patriot who has ever tried to oppose the Jewish Communist-Zionist Conspiracy.

We have been operating as NAZIS, openly, with a red-floodlight SWASTIKA BANNER and armed, uniformed Storm Troopers for over one year, now, and the Jews have gone to unbelievable lengths to keep us "localized" and silenced according to their infamous "quarantine" system of making no mention of anti-Jewish patriotic activities in the entire public information complex of newspapers, TV, magazines, etc. -which they control with a steely grip. Then, for three MONTHS, while the press was hysterical about every little swastika smeared on a privy in Podunk, we were handing out NAZI leaflets, with SWASTIKAS, on the main streets of Washington, D. C., in spite of every kind of threat and intimidation. NOT ONE WORD OF THIS WAS MENTIONED, -until so many thousands and thousands of people SAW us, and HEARD about our OPEN NAZI activity, that the dirty quarantine method of the Jews was SMASHED.

Too many Americans SAW what was going on, and began to wonder if our charges of press control might not be TRUE, when the proof was so obviously before their very eyes.
