Career Soldier, Daniel O. Honaker, with fifteen years of unblemished service in the U.S. Army, was given an Honorable discharge for the convenience of the government last month because of membership in the American Nazi Party. At first, Sgt. Honaker filed suit in the Federal court and was granted a temporary injunction against the Army to show cause why he is being discharged. Judge Leonard Walsh dismissed the suit on the grounds that the Dept. of the Army has the power to effect the discharge without any explanation.

## SOUTH AFRICA

Bishop Ambrose Reeves of Johannesburg, South Africa, a left-wing liberal who used the church to spread his perverted ideas, was deported by the Nationalist Government for his subversive activities which were climaxed by a book he wrote entitled "The Agony of South Africa." In his book, Bishop Reeves intentionally misrepresented police action which was taken against hoardes of screaming black savages who were rioting for "freedom" in Sharpeville last march.

## YUGOSLAVIA

The United States has pledged 100 million dollars to Yugoslavia in order to stabilize that country's currency and to bring the reds closer to the West, while our economy begins to topple, and unemployment rises to over four million.

## ISRAEL

The Israeli government has announced that Adolf Eichmann will be put on display in a glass cage during his upcoming trial.

## GERMANY

The communist paper, the Worker, is urging its readers to wire the president to annul the appointment of one-time Nazi General Adolf Heusinger as chairman of the Permanent Military Committee of NATO. The appointment would require the General's presence in Washington.



## PARTY OFFICERS FILE COMPLAINT

On December 30, 1960, five party members filed suit in Federal Court against Interior Department officials, District of Columbia officials, and three officials of the Anti-Defamation League. The suit is a 'Complaint for Conspiracy, False Arrest, and Deprivation of Civil Constitutional Rights under Title 42, Sections 1981 through 1986, U.S. Code: Motion for Temporary Restraining Order and to show cause for Permanent Injunction; and motion for a Mandatory Injunction.

In the Complaint, the party members state that they have been denied their right to freedom of speech; have been falsely arrested; have been made to appear as criminals and insane persons; and have been 'the victims of a conspiracy which sought to deprive them of their constitutional rights.

The five members are Commander Rockwell, Major Morgan, Captain Colton, Lt. Foss, and Lt. Patler.

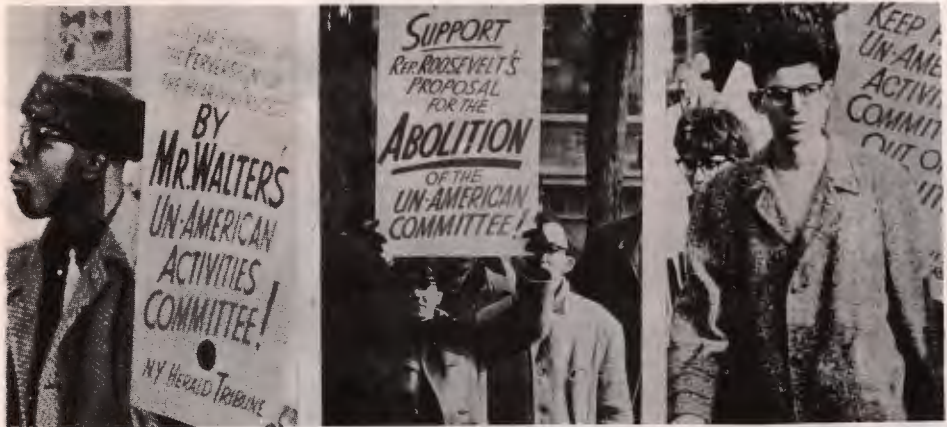

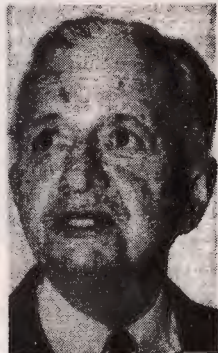

## COURT VICTORY in Kennedy picket case

On December 16, 1960, Chief Judge John L. Smith Jr., of Municipal Court held that Commander Rockwell and four of his Storm Troopers were not guilty of disorderly conduct when they picketed Kennedy headquarters in Washington.

Judge Smith's decision came after hearing two hours of testimony from Storm Troopers, police and other witnesses. The Storm Troopers were all charged with disorderly conduct while picketing in front of Kennedy headquarters last November.

Police acted after several Jewish businessmen protested and informed police that they would take things into their own hands if the picketing was not stopped.

Police ordered the troops to stop picketing. All obeyed except Lieut. Foss who remained to test the constitutionality of the order. He was fined.

## **THE BRAVE STAND ALONE**

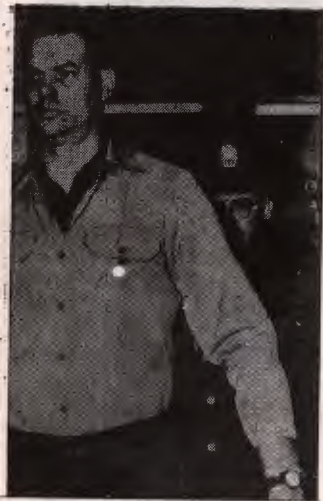
(The following are excerpts from an eye-witness report delivered at a party meeting one week after the riot.)

...on Sunday afternoon a huge mob began to gather outside the theatre showing Exodus. We observed the mob from our hotel room which was located across the street, six stories above....

...three hours before the picket, we lost telephone contact with the truck load of troopers who were driving all the way up from Virginia...

...two o'clock was the scheduled hour of our appearance for the picketing. Time was running out and still no word from the troops in the truck. We could only guess they had been intercepted by the police. We looked out of the window of our hotel room...the crowd was increasing to huge and menacing proportions every minute.

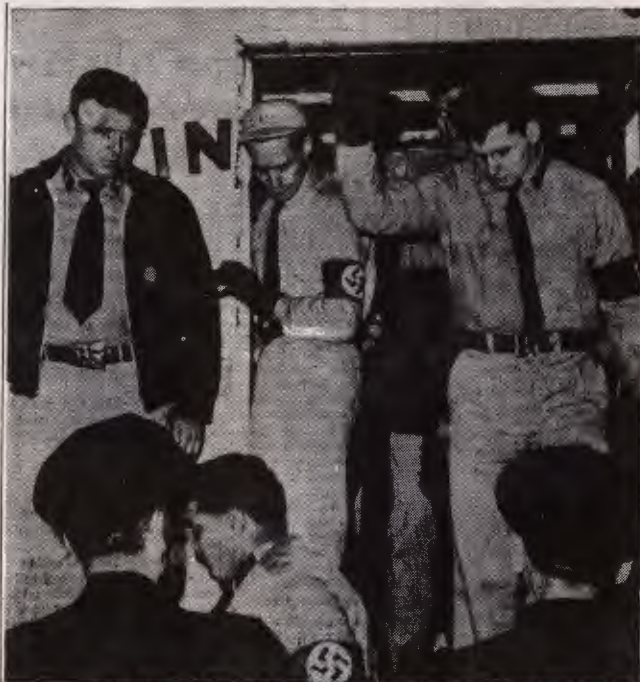
....The Commander was faced with an enormous decision..before the four faithful storm troopers who had accompanied him up to Boston in advance of the full troop, The Commander displayed the intrepidity and genius that he always demonstrated when confronted by unsurmountable obstacles...he announced to us that **HE WOULD GO DOWN INTO THE STREET AND FACE THE HOWLING MOB HIMSELF!**

## INTO THE CROWD

...we left the hotel room, the Commander leading us, right out into the street. He pushed his way through the teeming thousands...

...stopping only when he reached the front of the theatre. Once there, the Commander took off his coat and displayed himself in full Nazi uniform.

He asked a police officer where he should picket, The police officer, not facing the Commander, thus being unable to recognize him, blurted out: "across the street!"

....across the street were thousands of Jews..... picketing, screaming and threatening violence. The Commander took one look at the huge mob and marched straight across the street into the hoarde of Jews.

The four troopers who were with him quickly followed.

## SURROUNDED

.....before we knew it, we were surrounded. Jews were shouting, punching, and kicking. The Cmdr., and troopers were engaged in fist fights...Jews were pulling and grabbing...pouring in from all sides. Police were battling the mob of Jews with night sticks.... mounted police were galloping through the crowd pulling Jews away and clubbing others....pears and eggs were being thrown striking both police and rioting Jews.

...the pressure of the mass of people concentrated in that one area was almost unbearable..

Police moved in and formed a cordon around the Commander.... pulling him out of the fight. The Commander and troopers were then taken to police headquarters.

En route to Police headquarters, the Commander's armband, necktie, belt and Naval war decorations were taken by the police. The mob did not rip off his armband, as newspapers falsely reported....

While the Commander was being taken to Police Headqtrs, the truck load of troopers, who had driven from Virginia, all the way up to Boston in the bitter cold, arrived on the scene. They were escorted to Police Headquarters, where the Commander was giving a mass news conference....

We left Boston with a solemn promise: **WE WILL RETURN!**

## HORST WESSEL LIVES AGAIN!

Thirty-one years ago, on February 23, 1930, one of Adolf Hitler's Storm Troopers, lost his life during a brutal street fight with communists in Berlin. The Storm Trooper's name was **HORST WESSEL**. Because of his supreme sacrifice, Horst Wessel became a national hero and martyr of the National Socialist Movement in Germany. The famous Horst Wessel marching song was written and sung in honor of the courageous youth who died at the age of twenty-three.

And now, after more than three decades, his heroic spirit lives again.

On the evening of December 4, 1960 Lieutenant Patler's wife gave birth to a nine pound seven ounce baby boy. That same evening, during a party meeting, Lt. Patler proudly announced the birth of his son and the name he had given him: **HORST WESSEL PATLER!**
