## PRESS TO "QUARANTINE" ROCKWELL DEATH TRIAL:

They are still afraid of Lincoln Rockwell — even in death.

Word has been passed to the Washington press corps not to feature the trial of his accused assassin, regardless of the outcome. Only brief, cut-and-dried notices will be released during the trial, to be buried deep inside the paper, with a final bland announcement of the verdict. Hopefully, on their part, John Patler will be found guilty, the case will be closed, and Rockwell will be forgotten.

The trial, now scheduled for November 27, was delayed one week to allow Arlington police and court officials to take advantage of the opening of hunting season on the 20th. During this time, the enemies of the late Commander have not been idle.

We have it straight from the mouth of an honest reporter that the owners and publishers of the communications media of the Washington area — and possibly of the nation — have agreed to a policy of "quarantine." This policy has been made forcefully clear to all editors, writers and broadcasters. Anyone familiar with the methods of news-control used by the Apparatus which runs this country will recognize immediately the hidden hand of the Anti-Defamation League of B'nai B'rith in this tactic. (See, "Quarantine," inside this issue). We can report, without fear of contradiction, that it was, indeed, ADL which masterminded this maneuver, and which is insisting on its use in this instance. They have a vital interest in the outcome.

I want to thank all of you for everything you have done to defend me and help prove my innocence.

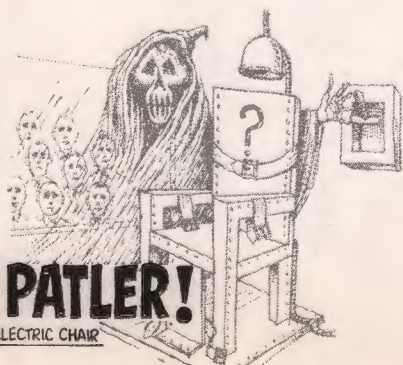
This whole thing is a horrible and unbelievable nightmare! !

## QUARANTINE . . .

The Washington press cannot deny that it has systematically controlled all news pertaining to George Lincoln Rockwell. They were squealed on in 1965 by the "Columbia Journalism Review," published by the graduate school of Journalism at Columbia University, hardly an anti-semitic source. In an amazing article in the May issue, Washington correspondent Benjamin H. Bagdikian clearly charged that the three Washington dailies apply a "quarantine to news about George Lincoln Rockwell's American Nazi Party with the conscious objective of denying the Nazis publicity and minimizing their impact." Those are his words, not ours; and he said even more:

Who is to decide whether Nazism is an issue in this country? And how is anyone to know, if it is quarantined from public study? If it is not an issue then there is no danger in playing news of Nazis in the normal way . . .

(Rockwell) is not an ordinary soapbox shouter . . . he is a resourceful leader who has been the subject of many manhours of official worry by the Department of Justice, the metropolitan police and the district commissioners, and of unofficial attention by university officials, and by American Civil Liberties Union leaders . . .

If the elite are worried about Rockwell as a problem, the citizen ought to worry, too. If the elite think the citizenry may come out the wrong way, then what is needed is more news, not less.

Mr. Bagdikian's choice of the word "quarantine" was deliberate. It is the euphemism for CENSORSHIP chosen by the American Jewish Committee for silencing its critics. They are quite blatant about applying it. They have even described it in their own publications. Below are some utterances of Dr. S. Andhil Fineberg, chief exponent of the "quarantine":

The quarantine treatment of rabble rousers pioneered by the American Jewish Committee and since 1947, generally employed by all major community relations organizations sought to keep the unknown bigots from obtaining free publicity . . .

The response of AJC's Washington Chapter as well as most of the community leadership to Rockwell's attempts to gain attention in the nation's capital in 1960 was an appeal for quarantine . . .

The only method that has routed Rockwell successfully was quarantine, as practiced in Detroit in 1961, and in Los Angeles this year . . .

The freedom to relegate Rockwell and his ilk to insignificance is as fully assured as their right to speak . . .

Due to the persistent efforts of those who flagrantly violate the quarantine of Rockwell (Jewish War Veterans, editor), he may continue in the news for a long time . . .

It will take more than the desire of collegians for a bit of sensation or of street mobs that are lured as moths to a flame, to elevate . . . the half-penny Hitler. Eventually the freedom to laugh at Rockwell as a posturing buffoon, will overtake him.

But not many people were laughing. Could it be that the American Jewish Committee got tired of waiting ?

## The Question they don't want asked--

# WHO KILLED ROCKWELL ?

A preliminary hearing for John Patler, the man accused by the Commonwealth's Attorney of Arlington County in the murder of George Lincoln Rockwell, was held on September 28, 1967. During the hearing, it was more-or-less established that the weapon now in the hands of the Arlington police, and described by them as the murder weapon, is, indeed, the pistol which was used to kill Rockwell. We could feel much more confident about it if the ballistics expert from the FBI had not been so hesitant and fumbling in his testimony, and so obviously bent on convicting Patler. But, in all fairness, it does appear that this is the weapon, and there can be no doubt that this same weapon WAS AT ONE TIME ON THE PREMISES OF THE AMERICAN NAZI PARTY, and probably acquired therefrom for the purpose of the shooting. We reproduce below the file card prepared by the Security Officer of the American Nazi Party in 1963 at the time the weapon was first listed, for reporting to the Arlington police:

Robert Lloyd

German Mauser 30 cal. Military Pistol

Serial No. 9811

Congratulations to the police on finding the weapon! It was located by sight on the second day of search, in an area intensively covered the first day with mine detectors; a fact which Thomas Morris, one of Patler's attorneys noted to the press (but which was not reported) leaves open the possibility that the weapon was planted on the scene — possibly even after the real murderer had heard on the radio or TV that Patler had been picked up. If he were smart, and he must have been, HE KNEW NOW WHO TO FRAME. He had the perfect "patsy."

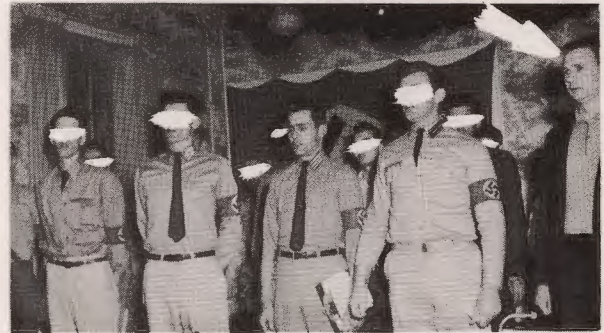
Several readers wrote to us, after seeing newspaper accounts of the hearing, stating that although they tend to agree with our belief that Rockwell's murder was the work of a terrorist band, and not one of his own men, they fail to see how such a band could acquire this weapon from the Nazi barracks. In addition, they were confused by some of the conflicting "testimony" attempting to implicate Patler. To keep the record straight, THE GUN WAS NEVER CONCLUSIVELY LINKED TO PATLER. Only circumstantial evidence was introduced, which, until such time as Patler is POSITIVELY LINKED, leaves open the possibility that SOMEONE ELSE FIRED THE SHOTS. We say it was a professional terrorist, IN CAHOOTS WITH OTHER TERRORISTS.

Rockwell's organization was never difficult to join. During the nine years of its existence, hundreds of members passed through — some staying only hours, others days or weeks, and a select few for years. There was a weeding out process, stricter at times than at others, but almost anyone was tolerated for at least a thirty day trial period. An astute spy or troublemaker could learn a lot even in that short a period of time. There is direct evidence that at least one paid

informer stayed much longer, and eventually even became Rockwell's chauffeur!

Just as with the selection process, the control of firearms also fluctuated in its effectiveness. At times, there was no control at all; and, just prior to the assassination, seems to have been extremely lax, when more weapons than ever before were being accumulated by individual members and by the organization itself. Almost anyone who was on the premises for any length of time COULD EASILY HAVE ACQUIRED THE PISTOL WHICH WAS USED IN THE KILLING. In fact, no one seems to know exactly when the pistol disappeared from the barracks. The owner of the weapon had moved to another city, and testified in court that he had not seen it since 1964.

Certainly anyone intending to kill Rockwell as a terrorist gesture would join his group, learn the patterns of his movements, note security precautions to be overcome, plan his alibi, prepare for his escape, etc.

As an example of how an "enemy" might have infiltrated and attempted to learn just such information, we print herewith a photograph of "William Goble," paid informer of the Anti-Defamation League, who joined the American Nazi Party (perjuring himself on his sworn and notarized application form), made himself available full-time by pretending to be "unemployed" because of a broken arm, who offered his automobile for transportation, and who eventually chauffeured Rockwell on many occasions (yes, with a "broken arm.") Complete information on Mr. Goble, his real name, name of the agency which hired him for ADL, his present whereabouts, photostats of his confidential reports, etc., are available to any legitimate police or investigative agency which might have the guts to look further into this matter (the Arlington police have had the information all along, but apparently have done nothing with it).

IT WOULD NOT HAVE BEEN DIFFICULT AT ALL FOR A GROUP DETERMINED TO STOP ROCKWELL TO HAVE ACQUIRED THE MURDER WEAPON, nor would it have been difficult for them to plant "evidence" against John Patler, once they knew he was the suspect the police had in custody. The example of "William Goble" proves this point.

And, we might add, THE MURDER WEAPON WAS ON THE PREMISES OF THE AMERICAN NAZI PARTY AT THE TIME "MR. GOBLE" ARRIVED THERE AS A HIRELING OF THE ANTI-DEFAMATION LEAGUE.●

It is not difficult for ADL to obtain cooperation from the Washington press—it is 99 and 44/100 pure. Pure Kosher. Hardly a news item reaches the public without at some stage being edited by a Jew. The scant remainder of the press consists of graduates of the "new school" of journalism. To ease the consciences of these Liberal reporters, usually so loud in support of "free speech," the Masters of the Press have explained to them that Rockwell was never a great force in American politics, anyway, and therefore is undeserving of any real attention. We must keep the news in "perspective," they have been told.

An additional rationalization for ignoring the trial, is that courts in the past have objected to news stories which might prejudice prospective jurors against the defendant. Some defendants, found guilty by juries, have later been freed by judges because of pre-trial publicity, especially if this publicity were extremely detrimental to the man on trial. The press certainly does not want to run the risk of having a meticulous Virginia judge free John Patler after they have so cleverly convicted him in their news columns. They became conscious of their civic duty, and their possible infringement of Patler's rights, however, only after they were dead certain he was guilty in the public's mind. The "Washington Post" has led the attack. At one time they ran a photograph of an accused thief, claiming it was Patler. They quickly retracted the picture, however, when a judge in nearby Maryland declared a mistrial in the case of a Hell's Angel-type motorcyclist, because the prosecutor showed the jury a photograph of the young man in his "uniform."

Apparently it has never occurred to the press that no judge has ever released a defendant because of publicity that has been FAIR AND UNPREJUDICED. But to report fairly seems beyond their abilities, espe-

To the press, the Rockwell murder is an open and shut case. They do not want any further controversy or discussion, lest it turn into another "unsolved issue" in the public's mind. For, after all, if John Patler is not convicted, and no other suspect is available, then **WHO DID SHOOT ROCKWELL?** One could only suppose that **IT WAS ONE OF HIS ENEMIES.** And the press — especially the Jewish press — desperately do not want this question asked. They are taking every precaution to see that it is **NOT ASKED.** They have their "patsy" and they want him **CONVICTED.**

We confidently predict, however, that this paper curtain **WILL BE SMASHED.** We are confident because we intend to **SEE THAT IT IS SMASHED!** We shall do this, first of all, by putting on the public record that such a "quarantine" exists, and by exposing the nefarious agents behind this unfair and unethical censorship. Secondly, we shall see that John Patler's side of the story is given a chance to be heard. Lastly, but most important, **WE SHALL SEE THAT COMMANDER ROCKWELL'S MEMORY IS NOT BURIED WITH HIS MORTAL REMAINS.**
