- ATTENTION ALL PATRIOTS -

Former Navy Commander George Lincoln Rockwell (ace Jap fighter has just been falsely branded an "incompetent person". This means that he will be legally declared insane and railroaded to an insane asylum where one of the following fates will be his to endure: (1) Rot and die the slow death of neglect which thousands are experiencing in mental institutions; or (2) upon his highly intellectual brain will be practiced sadistic electric shock and or deliberate paralyzing brain surgery in such a barbarous manner, that never again will he draw a sane breath. The conspirators who seek to have this patriot committed are the same people whom Jesus was upbraiding in St. John 8:44 (Jews of course.)

Psychiatrists, (hired by the conspirators who fear Mr. Rockwell) have claimed (falsely of course) that Comdr. Rockwell is crazy. They say he is dangerous and should be confined in a mental hospital. We informed patriots know that Mr. Rockwell is dangerous - very dangerous - dangerous just like we are dangerous to the Black and Red enemies of America!

These Christ-killers have failed at every previous attempt to stop Comdr. Rockwell, so, now as a desperate last resort measure, they have employed the age old diabolical scheme of legally questioning his mental stability. This evil plan is, of course, calculated to put Mr. Rockwell behind iron bars on a lock-ward of some mental hospital where his voice will be forever silenced.

Unknown (or disbelieved) by many of we White Americans, there are untold thousands of martyrs and patriots who have been victimized in exactly this same manner. I am one of them. Wake up Mr. and Mrs. White American, these things are happening every day right here in America in our nigger-integrated Veterans Hospitals all over the country. I was very fortunate that I finally managed to escape from the living hell (V.A. Snake Pit) in which I was held a mental prisoner (under the false guise of a mentally disturbed patient) for nine hellish months without civil rights or any hope of freedom. My thanks to God and a handful of loyal friends during that distressing ordeal. The very person in whom I had placed all my trust betrayed me and turned her back on me during the darkest hours of my life. She is sorry now and wants my forgiveness. I do forgive.

In recent months the treacherous "American Mental Health Society" has been exposed to some extent, but the other half of the ugly story is yet to be told. We salute "American Mercury Magazine" and others in this particular connection.

Commander Rockwell IS NOT insane. He is far from being crazy, matter of fact, he is one of the most SANE persons I know of and certainly one of the bravest! In addition to that - Now hear this - If Comdr. Rockwell was crazy and dangerous (in the sense of being violent) do you think he would be free to walk the streets until July 27 th ???!

Listen to this and then draw your own conclusions. The fearless Apostle Paul was falsely accused of being insane (Acts 26:24) because he dared to preach the cold hard facts - the untarnished TRUTH. Because he, (like Mr. Rockwell) publicly exposed Satan and his human agents (Jews) - because he was bold, defiant and courageous - because he pulled no punches - because he publicly aired the evils of that day.

The Jews hated Paul because he got right down to brass tacks and made

personal issues of matters - he called names and was not afraid to call a Jew a Jew. Paul's attitude was: "If the shoe fits, wear it!" He was a fit subject for a straight jacket in exactly the same sense that Comdr. Rockwell is today. And the reasons WHY ARE EXACTLY the same, i.e. : because the agents of Satan fear Mr. Rockwell just like their forefathers feared the Apostle Paul who fearlessly and continually exposed them and their evil deeds to the general public.

Even Christ himself (the very Son of God - the Fountain Head of all TRUTH and Wisdom) did not escape an attempt made by the Jews to falsely brand Him (Christ) "An Incompetent Person" (Mark 3:21) Why? Because they feared Him! Christ was too smart for them, He was too good for them - too true and too convincing. Hence it became necessary for them to get rid of Him and so, accordingly, they conspired against Jesus, said He was "beside Himself" (insane) and did seek to restrain and confine Him. Failing in this plot, they finally arranged His "legal" murder upon the Roman Cross. "D.C. government acting under intolerable pressure from Jews attempting to have me committed to insane asylum for exposing and fighting Jewish Communist race-mixing treason (stop) I have only until July 27 to prove I am not insane for fighting for White Christian America like our forefathers did (stop) Expense of my own psychiatrists and court costs are far beyond our means (stop) Jews' plan if I fail will mean commitment and probably needle injections by Jew doctors. Will also mean no white man will again dare to attack and expose Jewish power machine like we are doing (stop) Fear will grip the hearts of all patriots (stop) Please tell White friends that we must - repeat must have immediate funds to continue all-out fight and stay out of hands of Jewish psychiatrists or it will happen to all of us (stop) Yours for White Christian America - signed, George Lincoln Rockwell, Comdr. ANP"

The testimony of true psychiatrists is going to be very expensive. The cost of lawyers will also come high. Doctors and attorneys do not sell their testimony and advice cheap. George is over a barrel now and they know it. They will push a hard financial bargain. The doctors and lawyers working for George will naturally take advantage of George's adverse circumstances.

This is not a cheap, slick, underhanded scheme to solicit funds for any organization. This is a desperate appeal to patriots everywhere to help George Rockwell win his sanity FIGHT. This is a must if the fight for Christ, America, and the White Race is to continue.

No patriot in America is making a better fight than Comdr. Rockwell. Many Segregation leaders freely admit that he's way out front of all the rest of us and this also is my personal conviction. But the main issue at the moment is not his crusade and the segregation victories he's winning - the matter of paramount concern at this moment is his personal safety. His SANITY FIGHT, must be won first before he can proceed. If he loses his SANITY BATTLE, he forever will be out of the fight and probably put to sleep with a lethal needle in a mental hospital. If this occurs, the noble Cause of States Rights and Segregation is lost - forever lost!

With tears in my sleepy eyes at this moment and with a prayer on my fevered lips, I lend the "voice" of my tired pen to the full support of Comdr. Rockwell's SANITY FIGHT. I am in ill health and my fighting spirit is at low ebb due to personal circumstances, but I beg you patriots to please believe me when I say - I know of what I speak. I should! I was a victim

of a similar conspiracy. I lived my knowledge the hard way - the way of slow death. It was not acquired at a lecture or learned from a story book. Read "Hell's Cauldron", "Scandal In The Veterans Administration" and "Veterans In A Snake Pit."

Please, please in the name of God and the White American race, won't you kindly send at once a 5 or 10 dollar bill (even a buck will help him) to this ardent citizen soldier - mail to - 928 N. Randolph St. Arlington, Va.

Remember, this is just as much your fight as it is his. We all have White husbands and wives - White sons and daughters whom we must protect from this ever creeping "BLACK PARALYSIS" that threatens to destroy us. If you segregation, States Rights people let George down now in his darkest hour of need, I will panic with justifiable fear. In the best interests of my own life I will be forced to resign and withdraw my efforts for States Rights and Segregation because I know if you desert him when he's in serious trouble, you would let me down too. And frankly friends, I'm getting tired of losing jobs, making enemies, being broke, going to jail, being victimized in mental hospitals due to Red conspiracies, going to bed hungry many nights and suffering from heart attacks. I am tired of losing sleep and working my fool self to death for a generation of complacent Whites who seem to thrive on apathy and indifference.

Want you please help spread this dire emergency appeal. Ask your editors to reprint this appeal in all rightist newspapers. You yourself can make copies of this appeal and send to all persons who share our convictions. Get on your telephones and go to work - spread the news of this Jew conspiracy and the urgent need for financial assistance in this particular case. And remember, the time is so very short. 
LATE FLASH!!!
