

# EMERGENCY

*Jew-dominated  
Philadelphia resorts to  
terror and legal persecution in  
effort to stop American Nazi Party.*

As I write these words, three great American patriots are suffering beyond my power to describe, -just because they were THINKING about exposing Jewish treason. They are locked up in the Philadelphia County Prison.

Schuler Ferris went to West Point, won almost every honor including all kinds of atheletic trophies, and is a retired Marine Captain. Ray Goodman (Gentile) and Ralph Forbes, the other two, are also servicemen. The first two are NOT even members of the American Nazi Party, --but they were brutally seized in a PARKING lot, as they got out of their car in Philadelphia to picket "Exodus", a movie which is so red and vicious that the American Legion has asked all its members to protest it and to picket it.

The Jewish district Attorney of Philadelphia, Paul (Isadore) Chalfin, called me Wednesday morning and said any attempt by the American Nazi Party to picket Exodus in Philadelphia would be considered "inciting to riot", and we would be arrested. I wired him back that we could not be intimidated by illegal police tyranny any more than by Jew Communists or Black Hoodlums, and that we would picket as planned, peacefully and lawfully.

But Philadelphia sent two car loads of detectives down here, and chased me all over town, with the obvious intent of following us so they could arrest us as soon as we got into Philadelphia. Nevertheless, I managed to slip Ralph Forbes, one of our loyal troopers, aboard a train with some signs, -and we had men in other cities on the way.

The Fighting American Nationalists, an organization we used to consider sort of "sissy" because they won't mention Jews, also sent two men up, -Ferris and Goodman. We painted their signs for them.

My lads from New York and New Jersey were SEIZED and arrested at the Pennsylvania border, dragged to police stations, mistreated, interrogated Soviet style, and most of them were finally thrown back across the borders.

But Forbes, Goodman and Ferris were ILLEGALLY arrested before they did anything at all, by JEW and NEGROE policemen, brutally yanked here and there, frozen, subjected to unbelievable mistreatment, forced to go without food or water or even a smoke, denied the right to make a call to their worried families, and even denied an attorney. During the night, a Jew policeman\*appeared at the bars of Forbe's freezing cold cell, thrust his pistol through the bars hysterically, and screamed he was going to kill one Nazi there and then. Forbes cooly talked him out of it by pointing out that he was only a little fish, and would become a BIG martyr. Ferris was attacked with severe diarreah, but was denied the commonest facilities. Finally he was forced to parade before jeering Negroes and Jews naked, -to get some toilet paper.

The next morning, all of the hundred or so rioters who had come to kill us at the scene of picketting, and who had been discovered carrying guns, knives,

eggs, clubs, lead pipes, etc, --were ALL LET GO, or held in only \$300 bond, while OUR man and the boys from FAN, --who had done NOTHING, remember, were charged with serious felonies, and held in \$10,000 bond, --which is impossible for them to raise. They were denied a Court Appointed attorney, because, they were told, they had public Defenders, --but the later were unavailable because they had "property! , ---their CARS!

When we sent men to Philadelphia to talk to them or get lawyers, --THESE MEN WERE SEIZED, and run out of town!!!!!! I called the District Attorney, and the first words he said to me were "I'm a JEW!" --as if that were necessary. His City Solicitor, it seems, is also a Jew, --named Berger, --as is the Chief Inspector, another Jew named Goldstein. Since then, we have discovered that Philadelphia is WORSE THAN NEW YORK! Israeli stars hang from most of the lampposts in honor of the United Jew Appeal! These lovers of free speech, academic freedom (for reds) and "brotherhood", --with emphasis on the "hood", --are taking out the hatred they have built up for us over two years, now, --on these helpless lads in the Philadelphia County Prison, --where the population is 84% black, --and the administration is obviously loaded with God's "chosen" subverters and traitors.

All of this happened, fellow White Americans, -because we gave those Jews such a TERRIBLE beating in Boston, the week before. We smashed the "paper-curtain" to tiny pieces up there, and exposed the Jewish nature to MILLIONS and millions of people right on the Jew TV and in the Jew Papers. They have no answer to our exposures and dramatic tactics except naked VIOLENCE, -which reveals exactly the kind of TYRANTS they are. A few more "Boston Egg Parties", and we will have the Jews on the ropes. Our utter fearlessness in the face of their vile terror in Boston won us almost the whole Police Force, and was more than the Kikes could hide. The publicity for the FACTS about Jewish Communism, etc, which they HAD to give us, set MILLIONS of Americans thinking, --more millions than we or any other Patriotic outfit could EVER reach with all the papers and pamphlets ever published since World War II. For less than \$400, twenty-six incredibly brave Americans won for YOU a hearing on the Jewish question, in spite of the "paper curtain" of the Jew-controlled press, and the tens of thousands of Jew hoods and murderers.

In the works now is a carefully prepared and documented story of the Boston and Philadelphia strikes, but I had to get something out immediately because of the boys in that vile Jew-controlled, black-filled prison in Philadelphia! We need HELP.

What has been done so far has been done strictly on guts and pennies.

Our technique has been PROVED. We FORCE the yids to publicize OUR facts, the facts America needs so desperately to know and which we have been passing back and forth to each other for so long, -by such dramatic and daring tactics that the Jews must either publicize them, --or stand exposed for the press tyrants they are.

We also FORCE the Jew ACLU to fight for us and lose thousands of members, --or stand naked as a Red front which defends only the civil rights of Communists. Right now we have them squirming on the spot. They got ALL the Jews and Negroes in the Philadelphia riot released outright or on small bail, -but refused to help our men. Now we shall force them to fight, -or convict them publicly as helping only reds, blacks and jews.

I have no time to make the kind of documented appeal I would like to make. I will include herein a few pictures of the Philadelphia episode, and I will ask our friends now to pitch in and help us FIGHT, -as we never did before. I am not afraid of the wretched tyrants, and will personally tear into them in the Philadelphia Courts, as we have everywhere else. They must learn that this is AMERICA, not MOSCOW or ISRAEL, --and they will learn that Americans will NOT be run out of anyplace in America by Jewish terror, legal or physical. Please send us the cash ammunition without which I can do nothing. For every penny you send us, we add a ton of guts and faith and FIGHT, --and the result is the miracle which is at last WAKING UP and STIPRING AMERICA to STAND UP AND DEFEND ITSELF! Not one penny spent with us goes for PRIVATE meetings or to pass papers to those who already know what is going on. It is time to FIGHT, -and we pray our friends to
