Fellow White American:

When I wrote to some of you recently appealing for funds for our new Party Headquarters, I expressed the hope that I would not find it necessary to appeal to you again. Unfortunately, I must now do just that.

First let me give you the good news that we have proceeded with the purchase of our new building, and as soon as all the business details have been completed the Party will publicly open its new Headquarters.

Now for the bad news:

Last week one of our most valuable and loyal Party officers, Chris Vidnjevich, was arrested and jailed in Maine following a gunfight with a notorious Boston gangster. Following the receipt of information that John Patler may have conspired with others in the murder of Commander Rockwell, Capt Vidnjevich decided to place the house of this underworld figure, who is a known associate of Patler's, under observation in the hope of obtaining some lead as to the source of the funds behind those involved in the assassination.

Tipped off that his house was being watched, the gangster seized an armload of weapons and gave chase to Vidnjevich in his car. Captain Vidnjevich tried to elude his pursuer, but, having a slower automobile, was finally forced to begin exchanging fire with the well-armed gangster. The police intervened, however, and Capt. Vidnjevich was charged with assault with intent to kill, as soon as his Party membership was discovered. He is now being held in a Maine jail, with bond set at \$10,000, while awaiting trial.

Due to the clear-cut evidence of self-defense, we are confident that Capt. Vidnjevich will be exonerated when his case comes to trial, probably in April. He has so far evaded every such attempted frame-up, including his recent ordeal in Louisville where he was charged with "criminal syndicalism" and faced a possible 21-year prison sentence, merely for distributing "White Power" placards to White citizens there.

Meanwhile, however, it is absolutely essential that we raise the \$10,000 needed to free Capt. Vidnjevich until his trial, so that he will have the best possible opportunity to prepare his defense.


The Party has always made every effort to protect its own, and we must continue to strengthen this tradition by freeing Chris Vidnjeovich immediately. To do so, however, we must have help. Every spare penny has been tied up in the purchase of our new building, and we are temporarily without capital resources of any kind. Every Member and every Supporter who can lend us funds for a few weeks is being asked to do so. All contributions toward Capt. Vidnjeovich's bail will be carefully recorded, used only for that purpose, and returned promptly upon final settlement of the case.

It should be noted that Capt. Vidnjeovich has been under a bond of one sort or another as a result of his activities, during most of the past five years, including a \$10,000 bond in the "criminal syndicalism" charge, and has never forfeited a penny by failing to appear in court. Consequently, money lent for his bond may be considered as completely secure.

Whether you can lend us \$5,000, or only \$50, please consider the urgency of this request and do all you can as soon as you can.
