

SPECIAL YEAR-END REPORT

Fellow White Man:

In the last couple months our Party has scored staggering victories over Jew-Communist subversion through public exposure---both nationally and here locally. Most of you will be reading about national successes in coming issues of THE STORMTROOPER and THE ROCKWELL REPORT. I want to mention three separate occasions on which we called the bluff of Jew traitors here in Chicago and FORCED the press, radio and TV to give us publicity, despite standing orders from the ADL and AJC to keep us out of the headlines.

(1) On 9 November Elizabeth Gurley Flynn, notorious Chairman of the U.S. Communist Party and one of the vilest traitors alive today, was having a "birthday party" at the Hamilton Hotel. We decided to attend. Six of our best Stormtroopers demonstrated for more than two hours, calling public attention to Red treason in its midst. Scores of Jew bystanders showed their true colors by frothing, spitting and uttering the filthiest four-letter words they could find. White passersby were glad to see some Rightwing opposition, and were thoroughly repulsed by this disgusting display of kosher behavior. At one point the Chosen Ones threatened violence, but were unnerved when they learned that plainclothes Nazis were on hand, as well as the troopers in the picket-line.

(2) On 11 November the Communist-fronting "Jewish Cultural Club" met to deal with "Nazis, racists and anti-Semites" at the Fine Arts Building. They had boasted we wouldn't dare show up in the street that afternoon. But Nazis are not Boy Scouts, and cannot be bullied. When we appeared with placards exposing this known Communist front, we forced hundreds of the vilest Jews to crawl out from under their flat rocks and show their ugly faces to the American public. When they had us outnumbered 100 to 1 they got brave and attacked. Although we went through three successive riots that day and faced overwhelming odds, every man stood his ground. Group Leader Sam Bartlett, who was trampled by 20 of the most "heroic" Jews you ever saw---leaving both eyes badly swollen and one or two ribs busted---refused to quit and fought on with us in two more fights, despite excruciating pain. But those Jews who had come to deny us our rights didn't all get away unscathed. Each time a couple hundred of them would attack, eight or 10 would go hobbling or be carried away wailing that we hurt them! Despite our lumps and broken bones, we felt like victors that day as we saw so many kosher bottoms sprawled out along Michigan Avenue for the first time.

(3) On 30 November a notorious Red, Mandel Terman, was giving a talk and showing movies on how nice it is in Russia inside the Sherman House. While Terman spoke inside, his Jew co-racials were threatening violence against our Nazi pickets outside. For over three hours a crowd of several thousand screaming, hysterical Jews practiced "brotherly love" against these White Christians by tossing lighted cigaret butts in their faces and spitting on them in a manner prescribed by the Talmud. Our men took it all without batting an eyelash. Finally, as they were climbing into our converted paddy-wagon, several "brave" Jews jumped Troop Leader Chris Vidnjevič from behind. The Police moved in quickly to break up the scuffle---and arrested OUR five men, NOT the Jew assailants, who were told to get lost in the crowd!

In all three episodes our fighting methods paid off, and we received thousands of dollars worth of free space in the newspapers and free time on radio and TV. Following all this publicity we have been literally besieged by fresh inquiries from interested persons who didn't know how to get in touch with us before. Every day we see more and more signs that the White Man in this city is finally WAKING UP!

But nothing is gotten for nothing, and in this case five White men face heavy prison sentences for the "monstrous crime" of picketing a Communist meeting. Some people ask us, is it really worth it? Is it worth facing jail and physical attack just to protest Red treason? Is it worth the loss of job and career to stand up for what you know is right? And the Jews ask, how can you do this thing if no one is paying you? (The five men arrested have just been ordered to undergo psychiatric examination, for obviously anybody who is genuinely concerned about Communist subversion must be nuts!)

Fellow White man, make no mistake. This fight is worth every bit of the worst the Jew traitors can dish out. Every time we go out into the streets and come face to face with these totally depraved HUMAN-LIZARDS, we realize once again what the White Man is up against, and why WE MUST WIN if our children are to have any kind of future whatsoever. We are not in this thing for kicks, for money, for our health or for the fun of it. We are in this fight because there is a WAR going on, in which the White Man has his back to the wall. There are no easy ways out. The alien Jew traitors who have a DEATH-GRIP on this country must GO, and they're not going to go if we ask them nicely to leave. There's going to be a terrific struggle. As in all wars there are casualties, and this one is no exception. We realize that most of us will get hurt sooner or later in one way or another. Many of us have already lost jobs, given up promising careers, lost wives and families, gotten lumps and bruises and gone to jail---to do a job that HAS TO BE DONE BY SOMEBODY. We aren't asking for pity, sympathy or laurels. All we want is a chance to free our country and our people from the stranglehold of Jew rule by the target-date--1972.

Already the guilty Jew criminals can smell that gas! They are alarmed by the vast strides the American Nazi Party has made in recent months; and they are even more worried about the things we have in store for them in coming months. The columns of Jew publications these days are filled with tales of fear and woe as they see the White Man slowly rising to race consciousness and knowledge of his latent POWER. They are becoming DESPERATE

They were desperate when they arrested five peaceful pickets outside a Communist meeting on charges of "mob action." Right now these men--- G/L Sam Bartlett, T/L Chris Vidnjevic and Stormtroopers Ray Schultz, Earl Kujak and Bob Millay---each face from one to five years if convicted for anti-Communist picketing. Bartlett and Vidnjevic face separate charges stemming from their Rightwing beliefs. These men now face the nightmarish prospect of spending Christmas in the filthy hell-hole that is Bridewell Prison---unless we can secure adequate legal counsel for them.

Ordinarily we don't ask for support outside our regular membership. The normal running expenses over at our headquarters are taken care of through the sacrificial efforts of the members, and we do not ask for help here. But the additional legal expense we now face has put an enormous drain on our modest finances, so we now owe on the rent and fuel bills. Unlike well-heeled opposition groups, we don't have any "fat cats" to whom we can turn, but must count on the support of people like you. Frankly, we URGENTLY need your help, and I am appealing to you as one who has shown interest in this movement in the past, to lend whatever aid you can muster at this time.

If everyone getting this letter will take but a few minutes out from his or her Christmas shopping to respond immediately, I'm sure we can make this season a little merrier for the five selfless, dedicated young men I have just mentioned. A self-addressed envelope is enclosed for your convenience, and we would sincerely appreciate any support you can give---Large or small, known or anonymous. May we count on your early response?

On behalf of the men here at Headquarters and local members I wish to extend to you and yours a very Merry Christmas and a Prosperous New Year.
