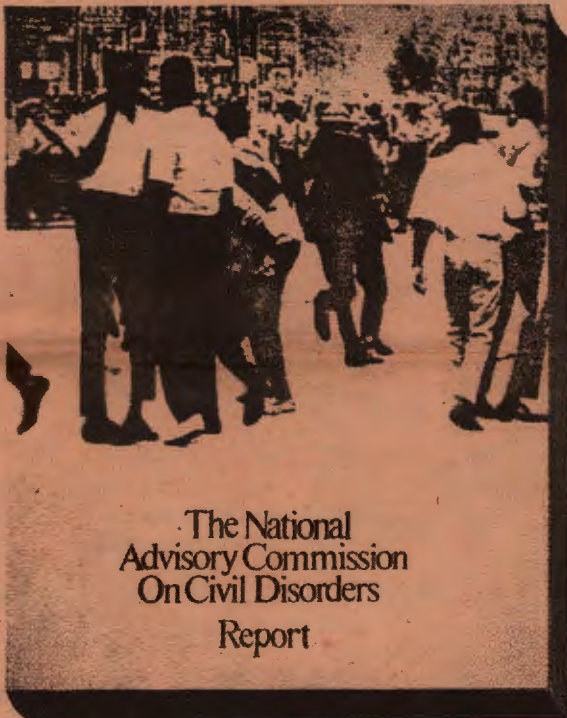

# RIOT COMMISSION REPORT BACKFIRES

## Whites Openly Protest L.B.J.'s Charging Them Guilty Of Riots



The National Advisory Commission On Civil Disorders Report

250,000 Word Attack Against White People Cost Taxpayers \$1 Million.

Lyndon Johnson appointed 11 left-wing extremist liberals to make up the Commission on Civil Disorder. They were people like Gov. Otto Kerner, negro Roy Wilkins, Mayor Lindsay, Atlanta Police Chief Herbert Jenkins, negro Sen. Edward Brooke, Detroit Mayor Cavanagh, Cleveland's negro Mayor Carl Stokes, Milwaukee's Mayor Henry Maier and a few others. These were the window dressing blue ribbon front for the treason of David Ginsburg.

The committee of big names did not write one single word of the commission report and no doubt most did not read all of its 250,000 words. Yet they signed and gave their stamp of approval to its attack upon the White People of America. Its real author was the commissions full time Executive Director, David Ginsburg. During his seven month investigation of the riots he was given a \$1 million budget and 200 staff employees.

Ginsburg is a long time member of the socialist Americans For Democratic Action. He has become wealthy as a Washington lawyer who has an inside track with the government. This allows him to obtain special favors for his chosen clients. He represents oil barons, foreign governments, railroads, etc.

### ATTACKS WHITE PEOPLE

Ginsburg leveled his most vicious attack against the White race when he wrote in the report that White Americans are directly responsible for the filth and slums in which the negro lives: "White institutions created it, White institutions maintain it, and White society condones it--White racism is essentially responsible for the explosive mixture which has been accumulating in our cities since the end of World War II."

There you have it, LBJ's Jewish director of the Riot Commission placing all the blame for negro looting, burning and murdering on the innocent White people. The idea of blaming the White people for ALL the crimes of the negroes was first thought up by a diabolical Jew named Israel Cohen. He was a Communist theoretician back before World War I. It was in 1912 when he wrote his plan called "A Racial Program for The Twentieth Cen-

ture." We now quote from its exact words as found in "The Congressional Record."

"We must realize that our Party's most powerful weapon is racial tension. By pounding into the consciousness of the dark races that for centuries they have been oppressed by the Whites, we can mold them to the program of the Communist Party. The terms colonialism and imperialism must be featured in our propaganda. In America we will aim for a subtle victory. While inflaming the Negro minority against the Whites, we will en-

welfare.

2.) Creation of 2 million jobs by the federal government so that every negro who wants some kind of work is assured of a job. This would amount to a giant W.P.A.

3.) Provide a Guaranteed annual wage to all negroes who refuse to work.

4.) Build 6 million new dwellings for negroes with either low or free rent.

5.) Urged widescale retaining of police and national guardsmen so that they will not shoot negro rioters, looters and burners.

This is just the highlight of some of the more important recommendations Ginsburg presented to the 11 member Riot Commission, which they all dutifully signed.

### LEADERS BLAST REPORT

Many conservatives were quick to blast this subversive Commission report. It was easy to see that LBJ and the Jews had this time gone too far. Political leaders immediately sensed the outrage of the American people. CONGRESSMAN L. MENDEL RIVERS of Charleston, S. C., said "The Commission is trying to buy law and order. We have already found out that we couldn't buy friendship with foreign aid. The first standard must be respect for the law, and violators must be swiftly punished. Massive doses of federal spending in our cities is useless. The Commission has only gained us contempt from the agitators and seditious who want to loot and burn our cities."

THE WALL STREET JOURNAL: Was notably irate at the Riot Commission charge that White people caused the riots. They said it would be better to say, "Poverty aid programs cause riots." They added that, "Telling the Negro that we failed to give our fellow citizens a fair chance, did not let him develop his capacities and kept the gates of opportunity closed" is simply encouraging the negro to riot.

The most true statement by the Wall Street Journal was, "The closest you can come to sociological dynamite is to promise people a Great Society and then deliver small handouts." They stress the negro has had every possible opportunity and even

deavour to instill in the Whites a GUILT COMPLEX for their exploitation of the Negroes. We will aid the Negroes to rise to prominence in every walk of life, in the professions and in the world of sports and entertainment. With this prestige, the Negroes will be able to inter-marry with the Whites and begin a process which will deliver America to our cause."

This plan has been adopted by B'nai B'rith's Jewish Anti-Defamation League. This is the thought which is hammered away in Ginsburg's Riot Commission report. The White people of America are supposed to fall down upon their knees and beg the negro for forgiveness.

Ginsburg calls for the following actions to raise the negro to a life of luxury:

1.) The Spending of \$10 Billion a year on poverty aid and

## Knoxville Politicians Accomplices In Murder Of Cab Driver

On March 9th a White cab driver was murdered by a frenzied mob of Black Power demonstrators. Young 27 year old A. J. Boruff was an employee of the Knoxville Checker Cab Co. He was dispatched on a call to pick up a passenger at the local negro Knoxville College.

Arriving at the campus he was met by a hail of rocks. Young Boruff radioed for police help. He reported himself trapped by rock-throwing negro youths. The cowardly action of local police officials which followed, has made them accomplices to murder. Instead of immediately rushing police help to a distressed citizen, they phoned Dr. Robert Owens, president of the negro college and asked him if it would be O.K. for them to send police

 more help than any other minority who came to this land. They say that it is the federal government and the ultra-liberals who are causing the Black Revolution.

CONGRESSMAN WATKINS ABBITT of Virginia said, "Those who rioted and caused damage running into millions of dollars should not be classed as heroes. The Presidents commission somehow justifies the disorder, rioting, pillage and arson."

CONGRESSMAN ALBERT WATSON of S. C., wanted to know how Ginsburg was able to give Bantam Books Inc. copies which we reprinted in book form before Congress even had copies. He wanted to know how Bantam Books was able to be issued a copyright on a public document and if the government was being paid for the book. Over 100,000 copies were printed and many flown overseas for sale before Congress saw the official copy. Watson also wanted to know if other book companies were allowed to bid on the Government report. It should be noted that Bantam Books, Inc. is owned by Jews. Thus far the Jew David Ginsburg has refused to answer Cong. Watson's questions.

MAYOR RICHARD J. DALEY of Chicago is becoming more and more worried over threats by Black Power advocates to disrupt the coming Democratic convention this Summer. He commented on the Riot Report, "I am amazed that the Report does not criticize the criminal elements that take part in riots."

## THOSE WHO SUPPORT THE RIOT REPORT

Martin Luther King had high praise for Ginsburg's report and said, "America will be destroyed if the Negro is not brought into the mainstream of life."

WHITNEY YOUNG, JR., Director of the Urban League said, "This report proves that our nation stands on the brink of disaster. I also want to praise the Commission for pointing out that the real problem is White racism and the bigotry of White people."

H. RAP BROWN head of SNICK said from his New Orleans Parish jail cell, (where he is trying to raise \$100,000 bond to get out), "The members of the commission should be put in jail under \$100,000 bail each, because

they're saying essentially what I've been saying all along."

NATIONAL COUNCIL OF CHURCHES, President Dr. Arthur S. Flemming hailed the findings as "courageous" and pledged that the Council's 34 church demoninations would give vigorous support to helping implement its basic recommendations.

JEWISH ANTI-DEFAMATION LEAGUE, National Chairman Dore Schary said his organization "Stands squarely behind the commissions analysis of the causes of our 1967 violence and its recommendations for changing the present suicidal course of American society."

FLOYD McKISSICK, head of CORE said, "This is an important moment in the history of this country. Whites have finally admitted their racism."

## CONCLUSIONS

We have given you about the most conclusive and only published report on those who spoke out for and against the Riot Commission findings. We believe that it is now clear that LBJ, Wilbur Cohen and Hubert Humphrey have been beaten down by White indignation. There can be no doubt that the Jewish Anti-Defamation League and Ginsburg had hoped that the report would have silenced all opposition to the Great Society program.

The fact that even LBJ decided not to openly endorse the Commission report actually signals a great victory for the White race. No longer will the liberal establishment be able to implant the psychological guilt complex within the minds of our people that we are the guilty ones. The truth is now out and our people will place the shoe on the foot of those who are REALLY GUILTY of the Race riots-- they are the Jews, liberals, LBJ and National Council of Churches who have promised the negro "pie in the sky" and have failed to deliver. The time has come to cease appeasing the negro and get tough with him. The police in Orangeburg, S. C. have shown us how to put down riots. Once the Black insurrectionists were gunned down by the law officers, peace returned -- we predict there there will be no more trouble in Orangeburg, nor any other city which acts with such resolute firmness.

 to the rescue.

Dr. Owens (a negro) told them not to send police as it might inflame the demonstrating students. In the meantime young Boruff was dragged from his car; taken into the school yard; stood up against a wall and murdered in cold blood. He was shot twice in the heart with a small caliber pistol. Negroes then set his cab on fire. When fire trucks rushed in, they were driven off with another hail of rocks.

Police still had not come to the aid of the cab driver or the fireman, because they did not want to hurt the murdering mob's feelings. It was a fantastic four hours after the death of A. J. Boruff before the timid police meekly approached the campus and found the bloodied corpse of

young Boruff. No arrests were made and the negro college president said he "felt a personal guilt" in this murder.

## THE REAL CULPRITS

Those who are actually guilty are the mayor of Knoxville and the police officials who refused to go to the aid of a young white man, the father of two small children, and a third expected this April. This was the most outrageous example of non-feasance in office we have ever heard of. There should be a thorough investigation of this tragedy. All those guilty of withholding police help from saving A. J. Boruff should be impeached from office.

To date, no such investigation or hearings have begun in Knoxville, Tenn. The FBI has not entered the case because they say: "Mr. Boruff's civil rights were

# New Jersey Riot Report

## The People Speak Against Riot Report

President Lyndon Johnson has been shocked and taken aback by the strong public reaction against his recent Presidential Commission on Riots. Many people, including Bobby Kennedy, wondered why LBJ waited so long to comment on the report of his Riot Commission. It didn't take Richard Nixon long to see that the White people were very much angered at being blamed for all the crimes of the negro.

Nixon came out and said the White people are not at fault. This shut LBJ up fast. He quickly decided to keep his peace until his poll takers could survey the feelings of the man in the street. One liberal New York newspaper published a series of letters from their readers "The People Speak" on the question. One said: "Why did Detroit and New Haven, with the most liberal and expensive poverty-aid programs have such serious riots?" signed Ex-Liberal. Another published letter said: "The President's riot panel is guilty of the vilest smear ever perpetrated upon the decent law-abiding citizens of this country. Placing on us the blame for last Summer's urban riots, pillaging, looting and destruction resulting in 83 dead and more than a billion dollars worth of property destroyed. Blaming the White people is a contemptible slur. This report can only play into the hands of the genocidal black supremacists and their so-called "moderate allies." Signed, "Not Guilty."

Another irate Whiteman wrote: "So I'm responsible? I'm White in the lower middle income bracket. I went to night school to be able to obtain a better paying job, and when I did I fled from a so-called Brooklyn ghetto to the suburbs to get my children away from a sordid environment. Between 20% and 30% of my income is paid in various taxes to support a welfare state whose questionable benefits I'm disqualified from receiving because I work. I don't hate anyone, I've never been arrested, and I support our police. Yet I am guilty of the negro riots according to LBJ's

not violated." In fact, we know of no racial murder of any White man that was ever investigated by the FBI. The reason being that White people have become second class citizens and LBJ and Ramsey Clark are only interested in protecting "those wonderful negro voters."

Let us as White people remember the murder of 27 year old A. J. Boruff. No one has been arrested in this case, but we do know who the real murderers are.

The Black revolution will continue to grow and take White lives as long as spineless politicians cower before the negro and fall on their knees for the Black vote. The time has come for all Whites to rise up and kick out of office those who have betrayed our race.

Two extreme racial riot reports have recently been issued to the press. While details of the contents of the reports were released to the public, the exact identity of their authors has for the most part remained anonymous.

## THE NEWARK, NEW JERSEY REPORT

Next to Detroit, last Summer's worst riot was in Newark,

N. J. Some 26 negroes were shot dead by police and National Guardsmen, while the negroes burned down \$10 million worth of buildings. After the rebellion was put down, Gov. Richard J. Hughes named a "blue ribbon" committee to investigate the causes of the riots.

He named a Jew, Sanford Jaffe, as Executive Director on the Commission on Civil Disorder. It was his job to write up the final findings of the commission. The report found as follows:

## LBJ BACKTRACKS

It didn't take our two faced President long to switch his stand. Suddenly he had Hubert Humphrey come out and say the riot commission had made a "mistake." White people are not to blame for the riots. Wilbur H. Cohen, LBJ's latest appointment as Secretary of Education, Health and Welfare also chimed in: "Whites are not to be blamed for the riots."

Yet, the American people all realize LBJ authorized and stacked this commission and knew of its findings. In fact there is nothing in the report he didn't approve of. He now is crumbling under the pressure of outraged public opinion.

1.) National Guardsmen used excessive and unjustified force in shooting negro rioters and looters.

2.) Local police have a deep-seated antagonism toward negroes, which was mainly responsible for the disorders.

3.) Proposed better housing and more jobs for negroes.

4.) More negroes on the Newark police force.

5.) A civilian review board to hear negro complaints of "police brutality."

6.) A requirement that all uniformed policemen wear name tags at all times while on duty, so that negroes can file "police brutality" charges against them.

7.) Elimination of bail so that negro rioters, looters and criminals can be released from jail as soon as they are arrested.

8.) (We must quote the following actual words of the commission or our readers will not believe it.) "Widespread violence in the nation's urban slums would have happened sooner had not the Negro been patient and forbearing."

9.) Absolved the negro of any blame for the riots and said there was no organized conspiracy behind the rioting.

There you have it dear reader, as written by the Jew, Sanford Jaffe. He is pictured on this page standing over his 500 page report as they are passed out to the press.

This is but another example of Communist writer, Israel Cohen's statement that, "We will instill a feeling of guilt in White people" -- when it comes to racial matters. This is reverse psychology. No matter what the negro does -- it is the White people's fault. If they burn down our cities -- we asked for it. If they rape our White women -- we deserve it. who can afford the trip. Both these countries have long had extreme socialist governments. They have used all the press, educational and communications outlets to brainwash their young people with the insane and discredited theory that there are no differences between the races.

It seems they have been successful during the past 25-year campaign to destroy their own race. Young White girls in these countries have answered questionnaires on the race question,

had been out in the sun too long. They were taught absolutely nothing about the negroes lower I.Q., his much lighter brain, thicker skull casing, stench glands or dominant Black genes, etc., etc.

They know nothing of the uncivilized nature of the negro; that he has no culture or morals. Many of the negroes today who have money are in the entertainment field. They go to Sweden, attend dances, or socialist or anti-war meetings and intro-

duce themselves as some kind of 'star' from the U.S. Often they tell the beautiful young girls surrounding them that they can make them starlets back in the States.

As examples of this deliberate racial suicide on the part of our own deluded kinsmen abroad is the marriage of Quincy Jones and his wife, Ulla. They met in Stockholm. They have one mulatto daughter. Jones was hired by Jewish movie producers to write the music to "In Cold Blood" and "Banning."

Negro basketball star, Wilt Chamberlain, went to Sweden and brazenly advertised in the Stockholm newspapers for a 'live-in maid' to come back to the states with him. He found a 6'2" Swede who now lives in and keeps clean his 5-room New York apartment. Of course, we all know how Sammy Davis Jr. married the Swedish movie star, Mae Britt. There are many other negro men with money who have gone to Sweden, where free sex and socialism have made White women easy pickings for them.

France, England, Germany, Italy and other European countries who have had experience with negro occupation troops have learned what beasts these inferior negroes really are.

### DESERTER SAYS SWEDES WAKING UP

While many White Americans have been shocked and saddened by the pro-communistic and race-mixing debauchery going on in Sweden, good news has finally arrived that the young Whitemen of Sweden are finally waking up. We have received reports that White Swedes now strongly resent the sight of ape-like negroes consorting on the streets of Stockholm with White girls. They are well aware of what the negro is after. Instinctive racial pride seems to be taking hold once again in Sweden.

As proof of this statement we have the remarks of Pvt. Ray Roy Jones of Pontiac, Mich. He was the first American GI to desert and seek asylum in Sweden. The 21-year-old soldier married a 17-year-old German girl who had ventured to Sweden to attend an anti-war congress. They have a very black 3-month-old baby. Jones said he wanted to take his White wife back to the States because:

"The Swedes have a natural prejudice against Black people and know nothing about non-Whites. Sweden is very bad for the Black people and there is increasing hostility among young White men there."

Jones says he wants to fight race discrimination in America. He may have a long wait before joining the Civil Rights cause as he faces 10 years in a military prison as a deserter. But military courts have been very lenient due to pressure from LBJ and most receive only 1 to 2 years.

As this is written, the Civil Rights Open Housing Bill is in the U. S. House of Representatives. This bill is the gravest threat to your property rights ever introduced in the Congress. promise" Open Housing Bill as drafted by that arch-traitor of all time, Sen. Everett Dirksen. ### REPORT NIXON INVOLVED

Heavy pressure is reported being leveled at House Republican leader Gerald R. Ford of Michigan. We realize that many conservatives, including some of our readers, support Nixon for President. But there can be no doubt that he is one of the main forces pushing the Open Housing Bill and wants the Republican Party to be able to claim 'credit' for its passage. Warn him that if he is successful in enacting forced Open Housing into law he will lose the election. White people are no longer going to support politicians on the basis of choosing between the lesser of two evils.

# LBJ's Criminals Get Off Easy

## Activities Of Israel's Secret Intelligence Service

Despite the small size of Israel, she maintains a world wide intelligence network. Her agents are everywhere. They work through the local organized Jewish communities. The super-secret Jewish businessmen's fraternal order, B'nai B'rith, also works hand in glove with Israeli intelligence agents. That is why the Jews brag that they are a nation within a nation. Their allegiance is to Israel first.

The chief job for Israeli intelligence is to use local Jews in every nation as a powerful political force to gain foreign aid and arms for Israel. They seek to coerce politicians to do the bidding of Israel. They seek to sabotage Arab nations and cut off their aid. They also seek to subvert nations and organizations which oppose Israel's aggressive actions.

### THE HUNT FOR GERMANS

The Jews have been called the most arrogant people on earth. Their hatred for the German people and continued acts of vengeance against them are cause for alarm by all free peoples. The completely illegal kidnaping and murder of Adolf Eichmann shocked the world. Other German people have been shot and injured by bombs sent through the mails by Israeli intelligence.

A typical case came up in Munich, Germany recently. Heinrich Mueller was the last head of the German Secret Service during world war II. He disappeared during the last days of the fighting. His wife Sophie Mueller is today a saleswoman in Munich.

Publicity recently broke when two Jews were arrested while searching her apartment. She was ill in the hospital. These were not ordinary Jews, but two members of the Israeli Ministry of Labor. They were carrying photographic equipment and walkie-talkie radios. Police arrested them at the scene and their names were given as Baruch Shur, 39, and Daniel Gordon, 38. They admitted they were seeking leads as to the whereabouts of Heinrich Mueller so that their intelligence agents could kidnap him.

The two were imprisoned for three months for house breaking and then released to return to Israel. The only other nation practicing such criminal activity throughout the world is Soviet Russia. Israel has been branded a "bandit state." The Jews feel above the law and care nothing about trampling under the rights of others. We hope that firmer action will be taken by the proper authorities against the illegal activities of Israeli intelligence. This terror machine is a branch of International Jewry. They finance and cooperate with illegal activities of those secret agents. Therefore, you local Jews must share the collective guilt for the crimes committed by the state of Israel.

## Jew Heads 'Cosa Nostra'

There are many criminal elements in America. The Jews have their own brand of criminals and they fall into a special category. There are almost no Jew bank robbers or assault and robbery men. Jews simply do not take part in crimes of violence. Instead, they engage in swindling and cheating. This is much closer to traditional Jewish racial characteristics.

Many people have been led to

believe that the biggest crime syndicate in America is run by Italians. The Jew controlled press has even given it an Italian name, "The Cosa Nostra." The truth of the matter is that this biggest of all crime organizations is run by the Jew, Meyer Lansky. He makes his headquarters in Miami Beach (where he owns three of the hotels.) Lansky has actually made BILLIONS of dollars off gambling rackets, loan-sharking and narcotics. He also secretly controls gambling casinos in Nevada and has been charged with 'skimming' money off the proceeds before state auditors count it for taxes. These amounts run into the millions of dollars annually.

In New York City Max Lowenstein runs his loan-shark racket, where one can end up paying up to 25% interest per week. Meyer Lansky is 65 and has never been convicted of a major crime; yet it is said he has some 5,000 criminals working in his vast operation. He has been called the financial wizard of the underworld and the "gambling king of America". Investigators call him the "most powerful racketeer in this country."

### THE SMALL FRY

There are many con games and swindles practiced by Jew businessmen to insure their business ventures against loss. The biggest fraud can be explained in this well founded joke: "Izzy Rosenbaum asks his friend Abe, 'Did you hear about Saul Cohen's warehouse fire?' " Abe answers, "When did it happen?" Izzy replies, "Next Thursday." " Jews have a notorious reputation for

hiring professional 'torches' to completely burn down their business so that they can collect the insurance and recoup losses from poor investments.

### THE BAD MEAT RACKET

New York City has more meat and weight scale inspectors than any city in America. Jew shop keepers are notorious for fixing their scales to make the meat weigh more than it actually does. Selling inferior meat is one of their oldest rackets.

Recently the Feldman Veal Corp. of New York City was charged with selling 24,330 lbs. of veal to West Point which was two grades inferior to what they agreed to deliver. Their bid for the sale was \$16,000. Under the law the company who lost the bidding could check the quality of the meat. It was a case of pure fraud. If found guilty Feldman can be given up to 22 years in prison and a \$22,000 fine. But usually they get off with a light fine and suspended sentence. Oscar Meyer is another giant Jewish meat packing company. Your editor has personally toured their largest plant in Davenport, Iowa. We found the department packaging their wieners, and processed meats to be in an unsanitary condition. Many substandard animal scraps were being used which should have been thrown away.

Recently Ralph Nader, author of "Unsafe at Any Speed" said many processed meat products were "made up of inferior meat scraps which are unfit for human consumption." He said he would not eat hamburgers, frankfurters or sausages.

This past Nov. 30 a very big Jew meat fraud was discovered in Canada. It seems that a dealer in dog food in Montreal named Francois Peetroons sold \$6,000 worth of dog food to the Jew Beril Oppenheim. Peetroons owns MDG Animal Food Co., and became suspicious when Oppenheim asked him to stamp the meat as lightly as possible with the required stamp which reads, "Unfit for Human Consumption."

Oppenheim owns St. Lawrence Meat Co., and he supplies hamburger meat to many restaurants in Canada. He explained to Peetroons that the dog food was going to be resold to the Canadian Government to be fed to Eskimo dogs in the far north. Further he explained that "the meat must be stamped lightly because the government didn't care too much for the black dye on the meat." Peetroons couldn't believe this story and reported it to the government. Whereupon Oppenheim was quickly arrested. He has hired Myer Gross to defend him. The Jew, Gross, said Oppenheim was innocent; that he didn't know Peetroons was selling him dog food. The big question is just how many of we 'Goyim' (or dogs to the Jews) are eating Oppenheim's "grade A dog meat."

## Bobby Baker, Ginzburg & Gilbert Cases

During the past four years a number of staunch political supporters of Lyndon Johnson have been caught red handed committing crimes of cheating, swindling and fraud. The following is a study of just a few of the more notorious cases. The most interesting point in the cases is that none of these men were sentenced to more than 3 years in

### THE FANTASTIC

#### EDDIE GILBERT CASE

Edward M. Gilbert (he changed his Jewish name to a Christian sounding one) was known as the young financial wizard of Wall Street. In 1962, Eddie Gilbert was worth \$23 million on paper. He was a speculator who hit it rich. At that time, he was president and majority stockholder of the famous E. L. Bruce Flooring Company. By acquiring the majority of the stock (on margin) he was able to kick out the Christian executives of the company and install himself as president.

His greed surpassed itself and he wanted millions more -- FAST! Eddie decided he wanted control of the Celotex Corp. (They produce building materials, which the E. L. Bruce Co. could easily use) The only trouble was that Eddie Gilbert wanted to own this company in his own name. He began making large purchases of Celotex stock on margin. (Whereby you only pay a percentage of the list sale price for the stock --with the balance to be paid later.) This is actually how he took control of the E. L. Bruce co.

In May of 1962, the stock market took a sharp dive and the brokers called in margin (cash) from Gilbert. The banks had extended his credit as far as they could for his original purchases. Then through a complicated book-keeping set-up he transferred (illegally) almost \$2 million dollars in E.L. Bruce money into his own name. The market failed to rise and the huge shortage became apparent to other officers of the E. L. Bruce Co.

Eddie Gilbert then took all the cash he could get his hands on and bought himself a one way ticket to Brazil. Later that month he was indicted for embezzlement and fraud. He refused to return from Brazil until four years later. Then, broke, he returned to face the music. His lawyer, the Jew Arnold Bauman told the court Eddie had an honorable discharge from the U.S. Army and was a big contributor to the DEMOCRATIC PARTY OF NEW YORK STATE!

#### THE JEWISH SAFETY VALVE

Why is it that Jew businessmen are by far the heaviest contributors to the Democratic Party? Could it be that this is their way of buying protection from possible future prosecution when caught in the error of their ways? The Jews know that most federal judges were appointed by Democratic presidents. All the federal prosecutors definitely are appointed by Democrats. prison -- yet they all could have been given from 15 to 95 years.

### THE BOBBY BAKER CASE

Election year is coming up and LBJ is very happy that most people have forgotten the case of Robert G. Baker. He was the former secretary to the Senate Democratic majority and a personal protege of former Sen. Lyndon B. Johnson. It was Jan. 29, 1967 that he was given 1 to 3 years in prison, being convicted on all counts of tax evasion, conspiracy, larceny and fraud.

Bobby Baker could have received up to 20 years imprisonment. The trial was long delayed, and would have never occurred at all if it were not for the constant demands from the great Sen. John Williams of Delaware. LBJ said that the first person he saw in the morning and the last one at night was Bobby Baker; that's how close he was to his Senate aide. It is predicted that he will spend not more than nine months in prison. He is now in the motel business and other businesses while appealing his case.

Still a deep dark mystery is the death of Carol Tyler, his secretary, whom he kept in a large home with another girl -- all expenses paid -- in Washington to entertain his out of town visiting business friends. Miss Tyler was accused of being his closest companion during all of these criminal dealings. While investigators were trying to reach her she was living in Baker's plush Carousel Motel on the Maryland coast. A friend of Bobby Baker's took her for a ride in a small private plane out to sea, almost in front of the now infamous Carousel -- the plane's

ter serving only 9 months. Still he thought this was a stiff sentence and the press said he had "tears in his eyes" when he heard it pronounced. But the judge gave him two weeks to wind up his business affairs before going to prison. His last words to the press on his mete-

oric rise on Wall Street were, "I can say with all humility that I am a mathematical genius. I love figures, and I turned them to my advantage."

The above is an outline of exactly how many rich Jews take over successful Christian businesses. They buy huge amounts of stock (on margin) and try to find dissatisfied Christian stockholders to vote them in charge of the company. They will promise you anything for your proxy vote. If this fails, a group of Jewish businessmen will join together for a raid on all available stock to try and swing the stockholders' vote away from the incumbent management. Often it takes from 20 to 30 percent of the stock to gain control of the management of a company. Once this occurs, the Christian company is quite often lost to Christian control for all time. When one Jew later wants out, he will turn it over to another Jew; if the company still has any value at all.

LAST, BUT NOT LEAST, TWO MORE FAMOUS JEW CASES  
Ralph Ginsburg, publisher of the defunct and obscene Eros magazine, was sentenced to 5 years imprisonment on June 14, 1963. He was found guilty of using the mails to transmit obscene material. (Some of it included full page pictures of naked negro men kissing naked White girls.)

It is now almost five years after his original sentence -- and Ginsburg is still free on appeal bond. The U.S. Supreme Court even found him guilty. But Ginsburg's slick Jewish lawyers went back to the original court and demanded a reduction of the sentence. (All Jew criminals believe their sentences are too stiff and want them reduced.) Ginsburg was turned down by the local judge in the case and now is appealing back to the high court that the sentence was too severe. Thus the cause of justice has been delayed five years and Ginsburg is still publishing obscene literature!

# Negroes Desert Under Fire In Viet Nam

## Proof Of Negro Soldiers' Inferiority

### WORLD WAR I

Here are the facts: The records of World War I reveal that approximately 350,000 negroes served in the armed forces, about half of whom served overseas. From these, two Negro infantry combat divisions--the 92nd and 93rd divisions -- were formed. Both divisions were under German fire in 1918, and altogether about 40,000 negro troops were exposed to combat conditions. Did they distinguish themselves? Let us take the words of a high-ranking white officer of the 92nd

member the infamous Leopole and Loeb case of 1924. Two young homosexual Jews, named Nathan Leopole and Richard Loeb, tied up their young 14-year-old Jewish friend, Bobby Franks, and slowly tortured him to death. The fiendish murder shocked the nation. Their fathers were both millionaires and were able to hire the famous defense lawyer, Clarence Darrow, thus the two young Jews did not get the noose in Chicago, Ill. where the murder occurred. But the trial judge gave them life imprisonment and stated that they should never be allowed to go free because of the unusual and perverted way in which the young Franks youth was tortured to death.

After serving 33 years in prison, Nathan Leopold was granted a pardon in 1958. Richard Loeb was killed by a Christian prisoner whom he had tried to seduce some years earlier. Believe it or not, Leopold was given a job with the U.S. Department of Health. He is now its Research Director in Puerto Rico. In 1961 he married the widow of a San Juan doctor. Still a Jew, he was out to make money off what the press called "Most Famous Crime of the 20th Century." He has written a book about his life called, "Life Plus 99 Years." That's what the judge gave him and he is proud he finally beat it. No doubt Hollywood will one day make a "Bonny and Clyde" type bleeding hearts movie on his life. Thus the fruits of Judaism continue to be bestowed upon America.

division, Colonel Allen J. Greer, who had described the combat record of the division as follows:

"The record of the division is one which will probably never be given full publicity, but the bare facts are about as follows: We came to France in June, we were given seven weeks in the training area instead of the four weeks in training areas as usually allotted, then went to a quiet sector of the front. From there we went to Argonne, and in the offensive starting there on Sept. 26, had one regiment in the line, attached to the 38th French Corps. They failed there in all their missions, laid down and sneaked to the rear, until they were withdrawn. Thirty of the (negro) officers of this regiments were reported either for cowardice or failure to prevent their men from retreating and this against very little opposition. The French and our white field officers did all that could possibly have been done; but the troops were impossible."

The Total number of negroes who died in action in World War I was less than 900.

By way of comparison, 50,510 white American troops died in battle, or from battle wounds. In other words, Negro troops, who constituted about 8% of our armed forces in World War I, suffered less than 1/50th of the combat dead.

The total number of negroes killed in action in World War II probably did not exceed 200.

(There was a 99th negro Fighter Squadron and the 323rd negro Fighter Group in the Air Force. Neither seems to have suffered any casualties.)

When we consider that 701,178 negroes served in the Armed Forces during the recent war, the 500 negroes killed in action is decidedly unimpressive, and especially in view of the more than 200,000 white troops who died in battle. Certainly these statistics -- if even approximately correct -- would not justify the exorbitant claims made by propagandists who seek to lionize the negro soldier and make him appear to be a hero.

### BAD FOR MORALE

The morale and effectiveness of America's armed forces can in no imaginable way be improved by the forced introduction of black troops into all - white military units. In fact, the enemies of America would like nothing better than to see our combat units saddled with great numbers of negro troops, knowing that in the crucial moments of combat the presence of large numbers of these fearful, hysterical blacks in front-line combat units could not fail to decrease the fighting efficiency of our armed forces. Perhaps that is the main reason they are being put there.

GENERAL C. C. BALLOU  
At the conclusion of World War I, General C. C. Ballou, war-time commander of the 92nd negro infantry division, was order-

During World War I, Gen. Pershing discovered that negro troops would desert their posts when under fire. They were given supply and service jobs during most of that war. The same was U.S. Army policy during World War II and few negroes died.

A negro armored division was used only once during the battle in Italy. As soon as the Germans realized that they faced negroes on one battleline, they counter-attacked. The negroes abandoned their weapons and fled. Miles from the front they passed White troops moving up to fill the gap in the line -- the negroes were still running.

Gen. Mark Clark and others testified that negroes were poor soldiers and should not be integrated with White troops during the Korean War. He said they would either run, or hide in their trenches, refusing to return the enemies' fire. Thus leaving the burden of the fight on the unmanned Whites left in the Company.

Negro deaths soared during the Korean war. The explanation was given that the negroes would reveal themselves to the enemy by jumping up from their fox-holes or other cover to run to the rear, thus making easy targets for the enemy.

### NEGROES PROTEST DEATH RATE IN VIET-NAM

During 1966, the death rate of negro troops in Viet-Nam was 16 per cent. Civil Rights groups in America said that the Army was using the negro soldier as 'cannon fodder' because negroes are only a little over 10 per cent of the U. S. population.

Lyndon Johnson does not want to lose any negro votes and therefore ordered the Jew Jack Moskowitz, Deputy Assistant Secretary of Defense for Civil Rights to somehow lower the negro death rate in Viet-Nam. Moskowitz found that negroes were only 10.6 per cent of the fighting soldiers in Viet-Nam. This would be in line with their population ratio in America.

He then began a campaign which could be called discrimination against White troops. Moskowitz actually ordered Army field commanders to lower the negro death per centage and see to it that White deaths were raised. He wanted the figures to look good for the Black Bloc vote back home.

The Department of Defense then weeded out several thousand negro troops and let them return to the states. But, their White co-fighters were kept on the front line. The results were that Moskowitz was able to lower the total negro fighting forces in Viet-

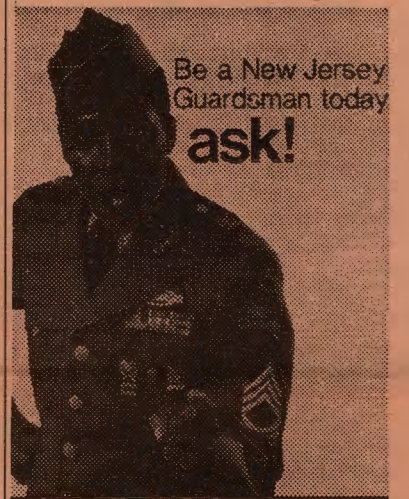
ed by the Army to submit a written report on the "... capacities, abilities, and future possibilities of the negro soldier." He wrote . . . "I forgot that the average negro is a rank coward in the dark, and I subsequently realized to the full how worthless this trait renders him in the service. . ."

But in spite of its adverse experience with negro troops in both World Wars, the Army has not only been forced to accept them into service, but is now compelled to integrate negro troops into white units.

Nam to 9.8 per cent; less than the percentage of negroes residing in America. Yet, he was astounded to discover the negro death rate on the front line was only lowered to 14.1 per cent. The negro pressure groups are still not satisfied and they are demanding that LBJ lower the negro death rate further. Negroes bitterly complained they were not allowed to prove their fighting ability in World War I and II. Now that they have been given their equal rights on the front line, they want out - and fast.

Of course, there is only one reason for the high negro death rate in Viet-Nam. They are once

again proving themselves inferior soldiers under combat conditions. When the action begins many of them jump up and run. They desert the White soldiers and hasten to flee military action. There can be no other deduction concerning this problem. We of the NSRP wish that the negro could share his responsibility in fighting for America. But, we must recognize they are inherently inferior beings. Negroes should be excluded from the U.S. Army. This will bring back a better fighting spirit and morale on the part of our White soldiers. There would be a lessening of White deaths because they would not be let down by a lack of negro fire power. White soldiers also despise having to live with these scared and shivering blacks.

The negro has once again been given the opportunity to prove his 'equality,' and has failed. Our leaders must take recognition of the facts of life and cease the folly of trying to integrate the Armed Forces at certain percentage rates so as to lower the negro battle death rate to Moskowitz's desired 10.5 per cent. Actually, such playing politics with death rate figures is another reason we can't win the Viet-Nam war. LBJ is more interested in appeasing both Communists and minorities than in winning the war.

### Israel Backs Out Of Agreement To Pay For USS Liberty

Admiral Ephriam P. Holmes has announced that the Navy will deactivate the U. S. S. Liberty. They say it would cost \$11 million to repair the ship from damages suffered by the sneak Israeli attack. The Navy said this amount will be billed to Israel.

\$3.3 million has already been requested of Israel to cover death benefits for the survivors of the 34 dead U. S. sailors. At least 25 of them were killed when the Jews sent a torpedo into the hull of the ship they knew to be friendly.

All American citizens should be concerned over the fact that Israel has arrogantly refused to pay the \$3.3 million to the families of the dead young men. It pains me to see that even your bold newspaper doesn't know all the facts concerning the late tyrant-murderer of Russia known to the world as STALIN. Let me here once and for all clear the Jewish smoke screen about the matter.

First of all, it is a universally known fact in the U. S. S. R. that Stalin's real name was Iosif David Vissarionovich Djugashvili also Bar Kochba (a legendary Jewish revolutionary during the Roman times).

Now let us see what does the name mean in plain Christian language.

His predecessors came from Portugal (after the expulsion of the Jews from Portugal) and settled in Georgia (Trans-Caucasia). "Stalin" only mutilatingly seems to be a Russian name. There is no such word in the Russian language, anyhow, I must straighten this falsehood once and for all, too.

And so the name known to all the peoples of the U. S. S. R. was as Iosif David Vissarionovich Stalin (Bar-Kochba).

Furthermore, he was married the first time to a Jewess by the name of Katy Schwanitz, better known by her also changed name of Ekaterina Shvanidze (to appear Georgian, also). In conclusion, I'd like to mention what "Svetochka" (Svetlana) forgot so conveniently to mention, namely the #3 official wife of her "famous" (with the preposition of "IN" in front of the word) "papa" Djugashvili... another infamous Jewess by name of ROSA KAGANOVICH, a sister of the most powerful Jew in the U. We of the National States Rights Party are actively building a White power political structure that will rule America when we are elected to local and national political power. During the past years, we were greatly helped by a number of publications who suffered the same financial and other problems we experienced. They merged with us, helped us research articles and our combined circulation made our movement all the more sound. Some of the publications that joined with us were, "The Georgia Tribune", "The Rebel", "The Virginian", "The American Digest" and "The X-Ray".

We now have produced our 100th edition. We know that you glory and thank God with us as we mark this day. Great events are ahead for the White race and this movement. We can feel the awakening of our people and our day of victory is near at hand.



### LOUIS E. WOLFSON CASE

Louis Wolfson is a staunch LBJ backer and millionaire Jew from Jacksonville, Florida. A former junk dealer, he became rich by buying controlling interest in various companies and utilities and using their assets to buy other companies. He has been accused of extending the credit of many of these businesses beyond their ability to pay, and then bankrupting them. Of-

ten they went bankrupt from his paying himself fantastic salaries -- into the hundreds of thousands of dollars -- money creditors could not touch. That's when he would bankrupt the drained company. Some of the creditors were ruined financially, but not Wolfson -- his millions grew and grew.

This is a typical Jew business trick, but Wolfson has destroyed more businesses than most. The supremely confident Wolfson went too far when he illegally sold 690,000 shares of unregistered stock of the Continental Enterprises, Inc. (created from the assets of Wolfson's Capitol Transit Corp.) for \$3.5 million. The 55-year-old Wolfson could have been sentenced up to 95 years in a federal penitentiary, being found guilty on all 119 counts, but the judge let him off with only 1 year and a \$100,000 fine. Wolfson is now free pending an appeal, on a \$850,000 bond.

### JEWISH COMMUNITY RALLY TO HIS DEFENSE

The Jewish community in Jacksonville, under Isadore Greenberg, has rallied to the convicted Jew's defense. They have cir-

culated petitions and are raising funds to back Wolfson. They are also demanding that Wolfson's sentence be reduced to a suspended sentence. They say that they are doing this because of Wolfson's devotion to Democratic and civil rights causes.

To emphasize Wolfson's active participation in Jewish activities, we quote from a speech he delivered before the Jacksonville Jewish Community Center last September. He challenged the young Jews of Florida to: "weed out violence, hatred and discrimination from the community and the state. Apathy is allowing hatred and violence to breed openly."

Wolfson told how he maintains a policy of strict nondiscrimination in all his various businesses. He claimed he was instrumental in getting the Florida state government to appoint Jews and negroes to office for the first time under the administration of Governor Fuller Warren. (Wolfson helped finance his campaign)

Wolfson warned his fellow Florida Jews that Anti-Jewish forces might one day take over the U.S. Government if they let their guard down. He quoted a recent poll that showed 22 per cent of the French wanted the Jews expelled from their country. He also said, "We must keep a close eye on West German Chancellor Kiesinger, because he was a Nazi from 1933 to 1945."

Wolfson began his rapid climb when he obtained stock control of Merritt-Chapman & Scott, Inc. 20 years ago. This is a worldwide construction company. He used his capital stock to try and buy control of Montgomery Ward & Co. He failed, but came out with a profit of \$750,000 when he unloaded his stock in Montgomery Ward. In 1958, Wolfson sought to ruin American Motors Corporation by manipulating their stock for his own profit.

In the case where Wolfson was convicted, the prosecutor, Michael F. Armstrong accused Wolfson of adopting the attitude that, "if you're going to steal, steal big." Wolfson's lawyer, the Jew, Milton S. Gould, said Wolfson was a public spirited citizen who gave to the Democratic Party and built a high school stadium in Florida which bore his name. The judge let him off with one year. The Jews are still outraged. They are demanding the sentence be suspended because it was 12 months longer than they expected Wolfson to receive.

## The Jewish Charity Racket

Raising money for phony charities is an old Jewish pastime. During the recent Arab-Israeli war several phony Jewish Collection Drives were organized. In Los Angeles, one fly-by-night Israeli charity raised over a hundred thousand dollars before so-called "recognized" Israeli charities ran ads in the press warning Jews that little of the money going to the 'up-start' Jewish groups would ever end up in Israel. Jews are highly organized and have a tight knit

control over all Jewish activities, yet some of them are not above cheating on their own kind.

Last summer a new charitable organization was issued a tax exemption by the federal government. It was called the "Social Security Foundation of the Philippines, Inc." The executive director was listed as David Roth. Its worthy goals were listed as "Distribution of food and medical supplies to the poverty-stricken areas of the Philippines."

Roth's foundation then opened

up a flashy office at 37 West 29th St. in New York City. From there he solicited drugs and medicines free from such pharmaceutical houses as Colgate-Palmolive Co., American Home Products, Merck & Co., Sharpe & Dohme and Conal Pharmaceuticals. Soon he had stockpiled some \$5 million worth of drugs in his newly acquired warehouse at 621 West 27th St.

All of a sudden, the above-named companies found their drugs being peddled by indepen-

dent jobbers all over Europe at cut-rate prices. It didn't take them long to trace the drugs back to Roth. Nothing had been shipped to the "poor, sick starving people of the Philippines." The U.S. Government quickly moved in and charged Roth with obtaining a fraudulent tax exempt status and of defrauding the people of the Philippines.

It also was charged that some of the drug companies were taken in by the impressive list of prominent names which Roth had forged to letters sent out by his phony foundation.

Last, but not least, we should note that back in 1964, the enter-

prising Roth lost his license as a registered pharmacist. He pled guilty before the State Supreme Court to having received stolen property. He received a suspended sentence. There are a million more Roths around; maybe 6 million, and they are all scheming day and night how to swindle you and continue to exist without performing any labor. Thus, we end today's study of the thieves among us.

He has vast plans for re-zoning school districts, enforced busing and building educational parks to bring about the mongrelization of the White race. To give you some idea of his vast power, Cohen has 100,000 federal employees under him. Cohen has spent all but 5 of his last 32 years in government departments.

Thus, we find that Lyndon Johnson's latest appointments are both Jews. Cohen to head H.E.W. AND Gen. Abrams to take over the Vietnam War. Only Israel can boast more Jews in their government, but the U. S. may yet push them out of the front running.

## LBJ To Appoint Gen. Abrams

Plymouth sponsored a T. V. special on April 2nd, starring the blonde British singing star, Petula Clark, and negro civil rights radical Harry Belafonte. # THE DEATH OF A COMMUNIST JEW

This article is being written to expose the 'Big Lie' that Communism is not a Jewish movement. International communism was created by international Jews such as Karl Marx, Leon Trotsky, Lenin, Kaganovich and many others.

## U.S. Communist Party Honors Jew

The American people continue to be brainwashed by the daily press to the effect that Communism has turned against the Jews. Those of us who study "The Worker" realize that Communism is still totally in the hands of the Jews. The reason for the propaganda campaign is that Israel is pretending to be 'Anti-Communist.'

They are doing this to force Americans to send massive aid to Israel while forcing the Arabs into the Arms of the Communists. Zionism and Communism are both Jew dominated movements. If Soviet influence grows in Arab nations due to U. S. support of Israel, Jews will be indirectly in control of both sides.

**COMMUNISM STILL JEWISH**  
The Worker carried a story on Feb. 11 on a big party they gave for "a veteran Communist leader." He is the Jew, William Weinstone, who was celebrating his 70th birthday. The Chairman of the New York State Communist Party, the Jew Gil Green saluted Weinstone as one of the best recruiters the Party ever had. Green told how Weinstone was a leader in the Socialist Party during World War One and a founding member of the U. S. Communist Party in 1919.

Weinstone also took the podium and said: "Despite persecution and difficulties we built the U. S. Communist Party. Today's young people, along with veterans and peace fighters will carry on in the tradition of the communist movement to the victory of socialism in the United States."

Gill Green also revealed that it was Weinstone who "was a leading participant in the 1937 Flint, Mich., sit-down strike, which paralyzed the auto industry."

At this moment the only daily Communist newspaper in America is "The Morning Freiheit". This is a Yiddish journal for Communist Jews only. Its editor, the Jew Paul Novick praised Weinstone as being: "steeped in the great progressive traditions." Next came Esther Carroll of the Jewish Garment Workers Union who said Weinstone's boldness had given much encouragement to Jewish women.

Thus ended a typical ALL JEWISH COMMUNIST meeting in New York City. Yet the daily press can spout the fabricated lies to the effect that "the poor Jews are being persecuted in Russia." A close study of any Communist Party in any nation will find it a Jewish movement.

U. S. Reds have announced that their twice weekly newspaper, "The Worker" will soon publish daily. Beginning May 1st, they will change the name of their paper to "The Daily World". This is possible because a millionaire Jew named Kaplan died and left one million dollars to the founding of a new communist daily newspaper in America. Thusly, Jewish Communism marches on.

On March 21, an important Communist Jew died. His name was Gerhardt Eisler. He was given a big state funeral in Communist East Germany. Now we shall tell you why he was one of the most important Communist agents in the world.

Gerhardt Eisler was born in Leipzig, in what is now East Germany. His father was a professor of philosophy at the university there and taught socialist revolutionary theories that no one really understood before World War I. After that war in 1918, Gerhardt Eisler was one of the first to join the Communist Party in Vienna. His older sister, Elfriede, also joined and his brother, Hanns, became a successful composer of revolutionary songs.

It was 1921 when he became a secret agent for the Communist Comintern. He was sent to China disguised as a journalist, but actually worked against Chiang Kai-Shek. After that Red uprising failed, he returned to Germany where he was an organizer for the Communist Party. When Hitler came to power and outlawed the Communist party Eisler fled to Spain.

During the Spanish Civil War, he was appointed a "political commissar" and participated in many of the anti-Christian atrocities that occurred at that time. After Franco came to power, Eisler fled to France where he organized the Communist underground against the Germans in many of the occupied countries.

It was 1941 when Eisler made his way to America through Mexico using forged identification papers. Moving to New York

City, he became the mastermind behind the U.S. Communist Party and the Daily Worker. When Louis F. Budenz, former managing editor of the Daily Worker turned Anti-Communist he went on the radio to charge that the "real boss of the American Communist movement was Gerhardt Eisler." He held no title, or official office in the Party, but Budenz charged, "U.S. Communist leaders never see Eisler, but follow his orders implicitly." Eisler was the secret representative of the International Communist conspiratorial organization called the Comintern.

Eisler was later arrested and charged with perjury and using a false passport to gain entry into America. He was sentenced to 4 years in prison. He appealed and was allowed to go free under a \$23,500 bond. Then he made

the front pages in our press when he jumped bond and fled to Russia on a Polish ship on May 7, 1949.

A short time later, Eisler turned up in Communist East Berlin and was appointed a member of the East German Central Committee and made chairman of the radio and television committee. He therefore became the official propaganda minister for Communist East Germany. He specialized in propaganda broadcasts to the West. He held this position until his death last month.

Eisler's wife, a Jewess, the former Bruenhilde Rothstein, is today still an important Communist. She is the editor of the important East German Communist magazine, "Das Magazin." Last month the Red flags of the East German Communist Party were lowered to half mast in honor of the dead Communist Jew, Gerhardt Eisler. With his end, we also put to rest the BIG LIE that Communism has turned against the Jew.

Communist Jews are highly honored in all communist nations. The fact the press and politicians seek to hide here is that both Communism and Zionism are Jew-founded and Jew-led movements. The mother of Theodore Herzl, founder of modern Zionism, said in Russia many years ago, "I have one son who is a Communist revolutionary. If he is successful the future of the Jew is secure. If my other son, Theodore, succeeds, our people will have a homeland." Both were successful and today the Zionist Jew and Communist Jew work secretly to-

gether to divide the world into two camps -- both under the ultimate domination of International Jewry.
